To the Honorable Members of the Illinois Senate 96th General Assembly

Today I return Senate Bill 1905 with my specific recommendations for change. I appreciate the hard work of the sponsors and the Task Force on Health Planning Reform in passing this monumental bill and for the opportunity to further their efforts with this amendatory veto.

Since the task force completed its work, our State's budget deficit has grown. In the midst of this unprecedented crisis, we all must work together to limit State spending and eliminate waste and inefficiencies in government. We cannot, at a time when we are confronted with the possibility of furloughs and pay cuts for existing state employees, expand government any further than is necessary. This amendatory veto preserves the substantive reforms recommended by the General Assembly and the task force but minimizes the fiscal impact on our State.

The Board is scheduled to sunset tomorrow. With the cooperation of the General Assembly, we can adopt these aggressive reforms and insure that there is not a lapse in the Board's operations. It is essential that this bill be approved by the General Assembly today so that I can certify the changes prior to the sunset of the Board.

Therefore, pursuant to Article IV, Section 9(e) of the Illinois Constitution of 1970, I hereby return Senate Bill 1905, entitled "AN ACT concerning State government.", with the following specific recommendations for change:

on page 33, line 17, by deleting "The members shall include a"; and

on page 33, by deleting lines 18 through 24; and

on page 37, by replacing lines 10 through 14 with "(g) The State Board, through the Chairman, shall"; and

on page 65, by replacing line 8 with "<u>Health Facilities and Services Review Board Illinois Health Facilities Planning Board</u> on a form prescribed"; and

on page 78, line 22, by replacing "subsections (a-15) and" with "subsections (a-10) and".

With these changes, Senate Bill 1905 will have my approval. I respectfully request your concurrence.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 18

WHEREAS, On January 1, 2009, Public Act 95-773, known as the Cindy Bischof Law, took effect; and

WHEREAS, The Law requires that when a person is charged with a violation of an order of protection, the court shall order the respondent to undergo a risk assessment and based on the results of the risk assessment and the other circumstances of the violation, it permits the court to order that the person, as a condition of bail, be placed under electronic surveillance and it permits the court to order an offender who is sentenced to probation or conditional discharge for a violation of an order of protection to be placed under electronic surveillance; and the Law requires that, as a condition of parole or mandatory supervised release, a person convicted of a violation of an order of protection must be placed under electronic surveillance; and

WHEREAS, The Law requires the supervising authority to use the best available global positioning technology to track domestic violence offenders; and

WHEREAS, The General Assembly finds that a Task Force to facilitate the implementation of the Cindy Bischof Law is necessary; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Cindy Bischof Law Implementation Task Force is created within the Illinois Department of Corrections; and be it further

RESOLVED, That the Task Force shall consist of 22 members appointed as follows:

(1) 2 members appointed by the President of the Senate of which one member shall be a

Senator and one shall be a member of the public;

- (2) 2 members appointed by the Minority Leader of the Senate of which one member shall be a Senator and one shall be a member of the public;
- (3) 2 members appointed by the Speaker of the House of Representatives of which one member shall be a Representative and one shall be a member of the public;
- (4) 2 members appointed by the Minority Leader of the House of Representatives of which one member shall be a Representative and one shall be a member of the public;
 - (5) one member representing the Illinois Attorney General appointed by the Attorney General;
- (6) one member representing the Administrative Office of the Illinois Courts appointed by the Director of the Administrative Office of the Illinois Courts;
 - (7) one member representing the Office of the Governor appointed by the Governor;
 - (8) one member representing the Illinois Family Violence Coordinating Council appointed by that Council;
- (9) one member representing the Illinois Department of Human Services, Bureau of Domestic & Sexual Violence Prevention appointed by the Secretary of Human Services;
- (10) one member representing the Illinois Department of Corrections-Parole Division appointed by the Director of Corrections;
- (11) one member representing the Illinois State's Attorneys Association appointed by that Association;
- (12) one member representing the Illinois Association of Chiefs of Police appointed by that Association;
- (13) one member representing the Illinois Sheriffs' Association appointed by that Association;
- (14) one member representing the Chicago Metropolitan Battered Women's Network appointed by that Network;
- (15) one member representing the Illinois Coalition Against Domestic Violence appointed by that Coalition;
- (16) one member representing the Office of the Cook County State's Attorney appointed by the Cook County State's Attorney;
- (17) one member representing the Illinois Probation and Court Services Departments appointed by the Director of the Administrative Office of the Illinois Courts; and
- (18) one member representing the Cook County Adult Probation Services Department appointed by the chief probation officer of Cook County; and be it further

RESOLVED, That the Task Force shall choose its chairperson and such other officers as it deems necessary; and be it further

RESOLVED, That the Task Force shall facilitate the implementation of the Cindy Bischof Law and study the progress of implementation of the Cindy Bischof Law; and be it further

RESOLVED, That the members of the Task Force shall receive no compensation as members of the Task Force but may be reimbursed for actual expenses incurred by the members in performance of their duties as members of the Task Force from appropriations made for such purpose; and be it further

RESOLVED, That the Task Force shall make its recommendations on the progress of implementation of the Cindy Bischof Law and shall submit a report of its findings to the Governor and the General Assembly by September 1, 2009 and shall make quarterly reports to the Governor and the General Assembly thereafter.

HOUSE JOINT RESOLUTION NO. 31

WHEREAS, The economic downturn is having a critical impact on everyday Americans who are struggling to maintain or find jobs in an increasingly difficult environment; and

WHEREAS, Those same Americans are the taxpayers that provide the revenue needed to operate essential government services; and

WHEREAS, Congress has approved and President Obama has signed into law a taxpayer-sponsored economic recovery package that will provide billions of dollars to help economically devastated cities and states immediately provide jobs to millions of out-of-work Americans through considerable infrastructure rebuilding, green energy projects, and other projects that will require manufactured components; and

WHEREAS, Our taxpayer dollars should be spent to maximize the creation of American jobs and to restore the economic vitality of our communities; and

WHEREAS, Any domestically produced products that are purchased with economic recovery plan moneys will immediately help struggling American families and will help to stabilize our greater economy; and

WHEREAS, Any economic recovery plan spending should, to the extent possible, include a commitment from the State to buy materials, goods, and services that are produced within the United States, thus employing the very workers who pay the taxes for the economic recovery plan spending in the first place; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the State will work to maximize the creation of American jobs and restore economic growth and opportunity by spending economic recovery plan funds on products and services that both create jobs and help keep Americans employed; and be it further

RESOLVED, That the State commits to purchasing only products and services that are made or performed in the United States whenever and wherever possible with any economic recovery moneys provided to the State by the American taxpayers; and be it further

RESOLVED, That the State will publish any requests to waive these procurement priorities so as to give American workers and producers the opportunity to identify and provide the American products and services that will maximize the success of our nation's economic recovery program.

HOUSE JOINT RESOLUTION NO. 42

WHEREAS, School leadership is second only to classroom instruction among school-related factors influencing student learning; and

WHEREAS, The 95th General Assembly adopted House Joint Resolution 66, which directed the State Board of Education, the Board of Higher Education, and the Office of the Governor to jointly appoint a task force to recommend a sequence of strategic steps to implement improvements in school leadership preparation in this State; and

WHEREAS, The Illinois School Leader Task Force submitted a report to the General Assembly in February of 2008 outlining specific strategic steps to reform Illinois school leader preparation programs with the goal of increasing school improvement through instructional leadership; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that based upon the recommendations set forth by the Illinois School Leader Task Force report, the State Board of Education, in collaboration with the Board of Higher Education, shall prepare legislative recommendations to restructure school leader preparation and certification programs in this State; and be it further

RESOLVED, That that these recommendations may include, but not be limited to, the following:

- (1) reviewing the educator certification structure to more accurately include a professional educator license to reflect essential skills required of school leaders, specifically those of pre-kindergarten through secondary school principals (PK-12);
 - (2) aligning redesigned programs with national principal preparation standards;
- (3) increasing certification and licensure requirements to include 4 years of teaching or school service personnel experience on a valid and appropriate certificate;
 - (4) ensuring appropriate faculty resources;
 - (5) establishing quality partnerships with PK-12 school districts;
 - (6) strengthening candidates' internships and residencies;
 - (7) revising formative and summative assessments;
- (8) designating principal candidates graduating from redesigned school leader preparation programs and successfully passing the State performance-based assessment to receive an endorsement specific to PK-12 principalship;
 - (9) enabling educators currently holding a general administrative endorsement to retain the endorsement and continue to serve as a principal;
- (10) directing all institutions of higher education that prepare principals to submit their redesigned programs for State Teacher Certification Board approval no later than July of 2011; and
- (11) stipulating that all principal candidates must complete a redesigned and approved principal preparation program and pass the State performance-based assessment beginning in 2013 to receive a State principal endorsement; and be it further

RESOLVED, That work will already be underway to begin the redesign; and be it further

RESOLVED, That the State Board of Education shall present its legislative recommendations to the General Assembly by February of 2010; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Chairperson of the State Board of Education and the Chairperson of the Board of Higher Education.
