WHEREAS, Reopening Meigs Field would also relieve the congestion problems routinely seen at Midway Airport and O'Hare International Airport and would lead to the creation of many jobs; and

WHEREAS, Most people who traveled to Meigs Field came to the City of Chicago to conduct business or to attend conventions within the city; reopening the airport would reestablish this economic opportunity and aid the various convention centers throughout Chicago, including McCormick Place; and

WHEREAS, The revitalization and reopening of Meigs Field represents a golden opportunity for the people of the City of Chicago and the State of Illinois to improve the economic climate of the City of Chicago and the State, create countless new jobs for Illinois workers, and to bring an iconic symbol back to the City of Chicago; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the City of Chicago to repair and reopen Meigs Field Airport as soon as possible in order to bring much-needed resources and jobs to this State; and be it further

RESOLVED, That suitable copies of this resolution be presented to Chicago Mayor Richard J. Daley and each member of the Chicago City Council.

To the Honorable Members of the Illinois Senate, 96<sup>th</sup> General Assembly

Today, I return Senate Bill 2499 to the Illinois Senate, vetoed in its entirety.

I commend the sponsors of this bill for their commitment not only to the constituents they represent, but also to all of the citizens of our State. They are tireless advocates for their communities with a genuine interest in improving education in their districts and beyond.

Senate Bill 2499 amends the School Code to specify that starting with the 2010-2011 school year, if a school district's boundaries span multiple counties, then the Illinois State Board of Education must use the limiting rate and individual rates by purpose for the county that contains the majority of the school district's Equalized Assessed Valuation.

For Fiscal Year 2011, the General State Aid remains fixed at the same level as the previous two years. School districts in Illinois have not had any increase in general state aid despite increasing costs. In addition, districts face delayed payments for special education programs, early childhood education block grants and transportation services. Many have received less than half of the payments that are owed to them for FY 2010. Both of these factors have resulted in a significant drain on school resources and districts are faced with difficult choices on maintaining programs. I cannot approve a measure that will boost General State Aid to one district at the expense of all others.

As Governor, I have fought to ensure adequate resources for students in every school district in Illinois. Despite the most difficult fiscal conditions in our State's history, I have maintained the foundation level at \$6,119. Approving this bill means lowering the foundation level in every other school district in the State—which I cannot approve of at this time.

I truly believe that in the near future, we need to evaluate the way that we fund education in Illinois. Financing a 21<sup>st</sup> century education with a 19<sup>th</sup> century funding model is not beneficial to students and is not fair to taxpayers. However, making piecemeal changes will not fix the system. I look forward to genuine reform in the context of a much broader discussion of funding our State's priorities.

Under fee-for service reimbursement plans, this increases the overall cost of health care for patients. In short, citizens will pay more for health care services.

As Governor, I am committed to protecting affordable and accessible health care for the people of Illinois. The bill before me today does not go far enough to protect patient choice, restrict feesplitting practices, and limit self-referrals within the health care industry. Senate Bill 2635 also incents medical professionals to increase the volume of services provided. There is broad consensus among health policy analysts and economists that in order to restrain the explosion in our nation's healthcare expenditures, we must eliminate incentives which drive volume of services. I cannot approve a measure that promises to raise health care costs in Illinois.

Therefore, pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I hereby return Senate Bill 2635, entitled "AN ACT concerning professional regulation." vetoed in its entirety with this statement of objections.

This legislation would allow Illinois to join the Interstate Insurance Product Regulation Compact to ensure uniformity of group annuity, life insurance, disability income and longterm care insurance product approval standards. I understand the Compact is aimed at raising standards for consumers and improving the efficiency of insurance product review, and I commend the sponsors for their hard work on behalf of the citizens of Illinois.

Senate Bill 2544 will require the State to expend significant resources and time to adopt the Compact immediately upon signing. Implementing Senate Bill 2544 immediately is too burdensome given this period of unprecedented financial strain. Immediate implementation would result in the unnecessary shift of personnel and other Department resources from federal law compliance efforts, including health insurance reform. Such shift of personnel and resources would be detrimental to employers and families who purchase health insurance in Illinois, and to the industry that sells insurance. For that reason, I recommend delaying the effective date.

This legislation would change the bearer of the burden of proof of death from the life insurance company to the claimant. Before proceeds are issued, a claimant must establish the fact of the insured's death, the claimant's identity and the claimant's interest in the insurance proceeds. Families grieving after the loss of a loved one should not be subjected to an administratively onerous process to meet this burden of proof that may result in delayed life insurance payments. Some of these families will need the policy proceeds to continue caring for survivors of the deceased. For that reason, it is imperative I recommend the due proof of death standard be changed to protect consumers.

Therefore, pursuant to Article IV, Section 9(e) of the Illinois Constitution of 1970, I hereby return Senate Bill 2819, entitled "AN ACT concerning insurance." with the following specific recommendations for change:

on page 6, by replacing lines 1 through 11 with the following:

"of due proof of death and not later than 2 months after the receipt of such proof. The policy may require that due proof of the death of the insured shall consist of a certified copy of the death certificate of the insured, or other lawful evidence providing equivalent information, and proof of the claimant's interest in the proceeds."; and

on page 6, line 17, by replacing "the rate" with "the annual rate"; and

by replacing line 20 on page 6 through line 6 on page 7 with the following: "is made within 15 days after the latest of the following to occur:

(1) the date that due proof of death is received by the company;

(2) the date the company receives sufficient information to determine its liability, the extent of the liability, and the appropriate payee legally entitled to the proceeds; and

(3) the date that legal impediments to payment of proceeds that depend on the action of parties other than the company are resolved and sufficient evidence of the same is provided to the company; legal impediments to payment include, but are not limited to (i) the establishment of guardianships and conservatorships; (ii) the appointment and qualification of trustees, executors, and administrators; and (iii) the submission of information required to satisfy State and federal reporting requirements.

is made within fifteen (15) days from the date of receipt by the company of due proof of loss. This provision need not appear in the policy; however, the company shall notify the beneficiary at the time of claim of this provision. Senate Bill 3084 requires all persons who have committed what is now considered to be a sex crime to register on the Illinois Sex Offender Registry, no matter when the offense occurred. Because the registry was not created until 1996, many individuals who have committed heinous crimes were never required to register or obey the restrictions that accompany being a sex offender. Senate Bill 3084 seeks to rectify this problem, and I applaud the sponsors' intention in undertaking this task.

I believe it is imperative to make sure that all offenders who should be registered as a sex offender do so. When the registry was first created in 1996, the Illinois State Police retroactively checked records for the preceding 10 years. As a result, this legislation addresses those who committed offenses at least 24 years ago. This undertaking will require properly. Additionally, Illinois is in the process of complying with the Federally-enacted Adam Walsh Act. Among other things, the Adam Walsh Act requires law enforcement to check an individual's record for retroactive sex offender registration only after that person is convicted of a felony. My recommendations below ensures that our State is compliant with this federal law.

The sponsors of this legislation have worked hard to protect the people of our State. I commend them for doing so and share their goal. Accordingly, I am pleased to honor their request for this amendatory veto and look forward to working with them in the future on this very important issue.

Therefore, pursuant to Article IV, Section 9(e) of the Illinois Constitution of 1970, I hereby return Senate Bill 3084, entitled "AN ACT concerning sex offenders." with the following specific recommendations for change:

on page 10, line 2, by replacing "law; or" with "law; or"; and

The court or supervising officer shall require the person to read and sign such form as may be required by the Department of State Police stating that the duty to register and the procedure for registration have been explained to him or her and that he or she understands the duty to register and the procedure for registration. He or she shall register in person within 3 days after notification by his or her supervising officer or the court as provided in Section 6 of this Act. Any person unable to comply with the registration requirements of this amendatory Act of the 96th General Assembly because he or she is confined, institutionalized, or imprisoned in Illinois on or after the effective date of this amendatory Act of the 96th General Assembly shall register in person within 3 days after discharge, parole, or release."; and

on page 22, by replacing line 16 with "shall register for a period of 10 years after conviction or adjudication"; and

on page 22, line 17, by deleting "date of this amendatory Act of the 96<sup>th</sup> General Assembly"; and

on page 22, by replacing line 21 with "this provision shall only revive the period of"; and
