WHEREAS, The Neighborhood Recovery Initiative is a program under the Illinois Violence Prevention Authority; and

WHEREAS, In October 2010, the Governor launched the Neighborhood Recovery Initiative; and

WHEREAS, The Neighborhood Recovery Initiative, the Illinois Violence Prevention Authority, or both have received at least \$94 million in State funding from the General Revenue Fund in FY11 and at least \$12.5 million in State funding from the General Revenue Fund so far in FY12; and

WHEREAS, In administering that initiative, the Authority is to work closely with its local government officials; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of the State moneys provided by or through the Illinois Violence Prevention Authority to the Neighborhood Recovery Initiative under contracts or grant agreements in Fiscal Year 2011 and in Fiscal Year 2012; and be it further

RESOLVED, That this performance audit include, but not be limited to, the following determinations:

- (1) the purposes for which State moneys were provided to the Authority for the Neighborhood Recovery Initiative;
- (2) the relationship between the Safety Net Works program and the Initiative;
- (3) the nature and extent of monitoring by the Illinois Violence Prevention Authority of how the Initiative used the State-provided moneys and whether certain residential communities of similar crime rates were excluded;
 - (4) the actual use of State moneys by the Authority, including the identity of any sub-recipients and the amounts and purposes for employment;
- (5) the number of positions paid through the Initiative by organizational unit, job title, function, and salary and whether employees completed and filled out appropriate timesheets;
- (6) the number of positions supervised or managed by each management position and whether any of those employees are supervised or managed by more than one management position;
- (7) whether, through a review of available documentation, the Initiative has met or is meeting the purposes for which the State moneys were provided, with specific information concerning the Initiative staffing levels, hiring procedures, and its compensation of employees; and
- (8) whether the Initiative is in compliance with the applicable laws, regulations, contracts, and grant agreements pertaining to the Initiative's receipt of State moneys; and be it further

RESOLVED, That the Illinois Violence Prevention Authority and any other State agency or other entity or person that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office in its audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as practical and report his findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Auditor General.

Senator Haine offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 40

WHEREAS, Interstate 64 is a major thoroughfare in the United States interstate system of roads which, in part, connects rural Southern Illinois with St. Louis, Missouri; and

WHEREAS, On November 23, 2007, the day after Thanksgiving, Jessica and Kelli Uhl were traveling home from visiting with their father and stepmother; while traveling on Interstate 64 in heavy traffic, the girls were struck by an oncoming Illinois State Police vehicle that was traveling at an estimated speed of 126 miles per hour; and

WHEREAS, The trooper operating the vehicle at this high rate of speed was reportedly using his onboard computer and cellular phone when he crossed the median and struck the girls' car; and

WHEREAS, Both 18 year old Jessica and 13 year old Kelli were killed in the crash; a pregnant woman and her husband in another vehicle were also struck and sustained injuries; and

WHEREAS, The State trooper was convicted of 2 felony counts of reckless homicide in the deaths of Jessica and Kelli, and 2 felony counts of aggravated reckless driving resulting from the injuries to the other couple involved in the accident; as a result of the felony convictions he was forced to resign from his position as a State trooper and had his driver's license revoked for 24 months; and

WHEREAS, The girls' mother, Kim Schlau, has left her career to focus on promoting awareness of the dangers of distracted driving and now works with recruit classes and police organizations around the country; her goal is to offer a personal account of the repercussions and dangers of negligent pursuit driving in an effort to educate officers and first responders, and prevent these tragedies from happening to other families; and

WHEREAS, Since the accident, the Illinois State Police have limited the use of personal cellular telephones by on-duty troopers and have implemented a four-tier system specifying how fast troopers may travel while responding to emergency calls; and

WHEREAS, A memorial has been placed on Highway 158 in honor of Jessica and Kelli under the fatal accident memorial marker program; the memorial contains Jessica and Kelli's names and admonishes drivers that "Reckless Driving Costs Lives"; however, the sign is not visible from Interstate 64 and will be removed in 2 years unless legislation is passed to make the memorials permanent; and

WHEREAS, It is fitting that this body join in honoring the memory of Jessica and Kelli Uhl and in promoting awareness of the dangers of reckless driving; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the section of Interstate 64 between Exit 19A at Illinois Route 158 and Exit 23 at Illinois Route 4 be renamed the Jessica and Kelli Uhl Memorial Highway; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the Jessica and Kelli Uhl Memorial Highway; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Secretary of the Illinois Department of Transportation and to the family of Jessica and Kelli Uhl.
