WHEREAS, Over the past 49 years, the nation has been observing National Poison Prevention Month to help prevent accidental poisonings and to provide tips for promoting community involvement in poison prevention; and

WHEREAS, The Illinois Poison Center is a mainstay in the emergency medical care system of this State and is recognized nationally for its contributions to poison treatment and prevention; and

WHEREAS, The Illinois Poison Center is a key component of the State's bioterrorism readiness network, standing ready to assist the Department of Public Health and local authorities in the event of a biochemical or radiation incident; and

WHEREAS, Fifty percent of the nearly 90,000 poisonings reported last year to the Illinois Poison Center involved children under the age of 6 and could have been prevented; and

WHEREAS, More than 90% of the calls received from the public are treated over the phone, quickly and safely by experienced, highly qualified staff of the Illinois Poison Center; and

WHEREAS, The Illinois Poison Center saves this State more than \$50,000,000 in unnecessary health care costs; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we hereby proclaim March 2012 as Illinois Poison Prevention Month in Illinois and encourage all citizens to learn more about the Illinois Poison Center's prevention programs that alert citizens on the continuous problem of accidental poisonings and steps that can be taken to create healthy and safe home, play, and work environments.

#### SENATE RESOLUTION NO. 585

WHEREAS, The 97th Illinois General Assembly passed Senate Bill 1533 and House Bill 691 with super-majority votes in both legislative chambers; Senate Bill 1533 became law on July 13, 2011 as Public Act 97-96, and House Bill 691 became law on December 8, 2011 as Public Act 97-630; and

WHEREAS, Public Act 97-96 set forth a detailed framework for the development of a clean coal brownfield facility, commonly known as the Chicago Clean Energy project, that included a provision requiring the Illinois Commerce Commission to approve the final sourcing agreements between the Chicago Clean Energy project and gas utilities for the purchase of substitute natural gas; and

WHEREAS, Public Act 97-630 was enacted as "trailer legislation" to Public Act 97-96 with the intent to: (1) address statutorily unauthorized early termination provisions that had been included in the final draft sourcing agreements transmitted to the Illinois Commerce Commission by the Illinois Power Agency; and (2) clarify the limited role of the Illinois Commerce Commission in approving the final sourcing agreements between the Chicago Clean Energy project and gas utilities; and

WHEREAS, Pursuant to Public Act 97-630, the Illinois Commerce Commission in reviewing and approving sourcing agreements was only to: (1) fill in the blanks in the final draft sourcing agreement based upon the previously established capital costs, operations and maintenance costs, and the rate of return for the Chicago Clean Energy project; (2) remove 2 statutorily unauthorized early termination provisions from the final draft sourcing agreement; and (3) correct typographical and scrivener's errors; and

WHEREAS, No statutory authority was given to the Illinois Commerce Commission to modify the terms of the final draft sourcing agreement or impose other obligations upon the Chicago Clean Energy project beyond the limitations set forth in Public Acts 97-96 and 97-630; and

WHEREAS, The Illinois Appellate and Supreme Courts have consistently held that, because administrative agencies are creatures of statute, they possess only those powers expressly delegated by law, and they may not act beyond their statutorily delegated authority; and

WHEREAS, The Illinois Appellate and Supreme Courts have consistently held that public policy in Illinois is expressed by the General Assembly, and it is not the province of an administrative agency to inquire into the wisdom and propriety of the legislature's act or to substitute its own judgment for that of the legislature; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we express serious concerns that the Illinois Commerce Commission Order entered on January 10, 2012 in Docket No. 11-0710: (1) modifies the final draft sourcing agreement with respect to recovery of costs despite the Commission lacking statutory authority to do so and despite the statutory language and legislative intent of Public Act 97-96 to provide full cost recovery to the Chicago Clean Energy project; (2) fails to delete one of the 2 provisions for early termination that were contained in the final draft sourcing agreements submitted to the Commission by the Illinois Power Agency; and (3) imposes an obligation to secure a third-party guarantee that is contemplated nowhere in statute, that exceeds the limited role envisioned for the Commission, and that is in addition to the substantial

consumer protections already set forth in the statutory framework for the Chicago Clean Energy project; and be it further

RESOLVED, That we urge that the Illinois Commerce Commission rehear the matter and, upon rehearing, the Commissioners of the Illinois Commerce Commission reach a decision that reflects statutory directives and the intent of the Illinois General Assembly in passing Public Acts 97-96 and 97-630; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Commissioners of the Illinois Commerce Commission, the Director of the Illinois Power Agency, and the Governor.

#### SENATE RESOLUTION NO. 586

WHEREAS, Modern medicine has made amazing advances in fighting pediatric cancer and pediatric cancer survivors are faced with a unique set of problems because of these advances; and

WHEREAS, Cure rates for pediatric cancers have risen dramatically during the past 20 years; it is estimated that one in every 900 adults, aged 16 to 44, is a survivor of pediatric cancer; and

WHEREAS, Almost 70% of children that are diagnosed with brain cancer survive treatment today; this statistic calls into focus the need to look at a child's quality of life in the years following treatment; and

WHEREAS, Pediatric cancer survivorship can come with a price in the form of long-term medical, financial, psychosocial, and neuro-cognitive problems due to chemotherapy, radiation, or surgery; and

WHEREAS, The major expenses of a pediatric cancer diagnosis and treatment program are associated with the direct costs of medical care, including charges for hospitalizations, clinic visits, medications, tests and procedures, home health services, services of doctors and other professionals, and other treatment, including surgery, chemotherapy, radiation therapy, and bone marrow or peripheral stem cell transplantation; and

WHEREAS, Even well insured middle-class families with health insurance can find themselves in financial distress because of a single catastrophic illness; even when insurance doesn't run out, health care costs can be staggering for the families of children with cancer; and

WHEREAS, The State of Illinois recognizes that amazing advances have been made in the treatment of pediatric cancer and survivor rates; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the week of March 25-31, 2012 as Pediatric Cancer Survivorship Week in this State.

Senators Radogno - Righter offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 43

WHEREAS, In an effort to address unsustainable growth in the Medicaid program and to improve the care provided to Medicaid enrollees, a bipartisan group of legislators worked with the Department of Healthcare and Family Services to craft comprehensive Medicaid reforms in early 2011; and

WHEREAS, Governor Quinn referred to these reforms as a "landmark achievement" when he signed them into law on January 25, 2011 after they had passed the Senate by a vote of 58-0-1 and the House of Representatives by a vote of 111-4-2; and

WHEREAS, Included in these landmark reforms were provisions to require Medicaid applicants to submit one month of income data and proof of Illinois residency when applying for Medicaid coverage; and

WHEREAS, The Department of Healthcare and Family Services has not implemented these key reforms due to communication from the Centers for Medicare and Medicaid Services indicating that the residency and income verification may violate Medicaid Maintenance of Effort (MOE) provisions contained in the Patient Protection and Affordable Care Act; and

WHEREAS, The Department of Healthcare and Family Services has not requested a waiver to formally ask for the implementation of these reforms despite requests from members of the General Assembly to request such a waiver; and

WHEREAS, One of the reasons provided by the Department of Healthcare and Family Services for not submitting a waiver for the income and residency requirements contained in the Medicaid reforms is a lack of agency manpower to submit such waivers; and

WHEREAS, In an effort to work with the Department of Healthcare and Family Services to address staffing issues, Senate Bill 1762 was passed in November of 2011 and signed into law as Public Act 97-649 to provide flexibility outside of the Personnel Code to allow the Department to hire employees with experience in administration, information technology, and healthcare financing to facilitate implementation of Medicaid reforms; and

WHEREAS, Also included in the landmark Medicaid reforms was a provision to place a 2-year moratorium on the expansion of Medicaid eligibility, thus enacting a 2-year moratorium through January 25, 2013; and

WHEREAS, Despite this moratorium, the Department of Healthcare and Family Services officially submitted a waiver request to the federal government in January of 2012 to expand Medicaid eligibility in Cook County to individuals currently not eligible for Medicaid coverage; and

WHEREAS, The implementation of all of the landmark bipartisan Medicaid reforms remains a key to addressing the ever expanding backlog of unpaid Medicaid bills, which according to the Department of Healthcare and Family Services could reach \$21 billion by the end of FY 2017; and

WHEREAS, numerous other reforms also remain to be implemented, including coordination of care for high risks moms and babies, creation of a Medicaid transparency portal, payment recapture audits, use of durable medical cards, civil remedies for fraud, copayment requirements for unauthorized use of emergency rooms, enhanced third-party liability provisions, and the creation of a specialty drug program for high cost medications; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we recommend that the Department of Healthcare and Family Services formally file a Medicaid waiver to implement the income and residency requirements and all other provisions of Public Act 96-1501 that may require a waiver; and be it further

RESOLVED, That the Department of Healthcare and Family Services should timely submit to the Centers for Medicare and Medicaid Services any and all State Plan amendments necessary to implement all reform provisions included in Public Act 96-1501; and be it further

RESOLVED, That we urge the Department of Healthcare and Family Services to fully implement all previously enacted reforms to address the unsustainable growth in the Medicaid program and to improve the quality of care provided to program participants; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Governor, the Director of the Department of Healthcare and Family Services, and to the members of the Illinois Congressional delegation.
