Executive Summary

The following report outlines waivers of School Code mandates that school districts, regional offices of education, or special education or vocational education cooperatives have requested since the last report, which was transmitted in March 2012. Pursuant to Section 2-3.25g of the School Code (105 ILCS 5/2-3.25g), these requests must be sent to the General Assembly for its consideration before October 1, 2012.

The report is organized by subject area and by school district, regional office, or special education or vocational education cooperative. The General Assembly may disapprove the report in whole or in part within 60 calendar days after each chamber next convenes once the report is filed. This is done by a joint resolution. If either chamber fails to reject a waiver request, then that request is deemed granted.

Section I summarizes the 44 requests received for waivers of School Code mandates for consideration by the General Assembly, which are presented alphabetically by topic area. The largest number of applications received (16 requests) seeks waivers from the requirement for daily physical education. There are 15 requests for non-resident tuition; seven requests for limitation of administrative costs, four requests for school inservice training; and two requests for the use of other practice driving methods in lieu of the required six hours of behind-the-wheel instruction in a dual control car on public roadways.

Public Act 95-223, passed early in 2008, limited the number of waivers of daily physical education that could be requested by school districts and other eligible applicants to an initial, 2-year request, with the possibility of no more than two additional, 2-year renewal requests. Of the 16 waiver request renewals for physical education contained in this report, five districts are requesting their second and final renewal.

This document also contains one other section beyond what is required under Section 2-3.25g of the School Code. Section II is a database with listings of modifications or waivers of State Board of Education rules and modifications of School Code mandates upon which the State Superintendent of Education has acted in accordance with Section 1A-4 of the School Code (105 ILCS 5/1A-4). The database also includes listings of requests that have been returned to or withdrawn by the petitioning entities. In addition, the database includes the 44 waiver requests for the General Assembly's consideration and is organized by Senate and House districts.

Complete copies of the waiver requests for the General Assembly's consideration have been made available to legislative staff.

This is the thirty-fifth report submitted pursuant to Section 2-3.25g of the School Code, which requires that the State Board of Education through agency staff compile and submit requests for waivers of School Code mandates to the General Assembly before March 1 and October 1 of each year.

Driver Education

Behind-the-Wheel Instruction

New Trier THSD 203 – Cook (SD 9/HD 17) / Expiration: 2017-18 school year

WM100-5640 (renewal) – Waiver of School Code (Section 27-24.3) request to allow the district to use computerized simulators for 12 hours of practice driving in lieu of three hours of behind-the-wheel instruction in a car with dual operating controls operated on public roadways. The district states that its simulators are able to create a progressive learning experience that is less stressful since it allows students to learn from early mistakes in a risk-free environment. If approved, this waiver would take effect in the 2013-14 school year.

Glenbard SD 87 – DuPage (SD 21/HD 42) / Expiration: 2017-18 school year

WM100-5665 (renewal) – **Waiver of School Code** (Section 27-24.3) request to allow the district to use computerized simulators for 12 hours of practice driving in lieu of three hours of behind-the-wheel instruction in a car with dual operating controls operated on public roadways. The district states that its simulators are able to create unusual and dangerous conditions from which students can learn without their safety being threatened, and that students develop skills through practice/review/repetition procedures available to them through the program. If approved, this waiver would take effect in the 2013-2014 school year.

Limitation of Administrative Costs

Irvington CCSD 11 – Washington (SD 58/HD 115) / Expiration: 2011-12 school year

WM100-5648 – **Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. During FY 2012, the costs of the health benefits provided to the superintendent increased by 12.5 percent. In lieu of a raise in salary, the superintendent had requested the year previous to this cost change that his family's health insurance be paid. The increased premiums caused the district's administrative costs for FY 2012 to exceed the 5 percent limitation.

Wood River – Hartford SD 15 – Madison (SD 56/HD 111) / Expiration: 2012-13 school year

WM100-5652 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. For the FY 2012 school year, the district employed an interim superintendent. The hiring of a full-time superintendent with paid benefits for the 2012-2013 school year caused the district's administrative costs to exceed the 5 percent limitation

A-C Central CUSD 262 – Cass (SD 47/HD 93) / Expiration: 2011-12 school year

WM100-5653 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district added an inhouse prekindergarten program through a state grant during the FY 2012 school year, with grant management provided by the elementary school principal. The compensation received by the principal to handle the increased duties contingent on the grant caused the district's administrative costs to exceed the 5 percent limitation.

Laraway CCSD 70C – Will (SD 43/HD 86) / Expiration: 2011-12 school year

WM100-5658 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. In the summer of 2011 the superintendent was reassigned as a principal in a new building, retaining his previous salary and benefits. The district hired an interim (retired) superintendent to fill the vacant position. At the conclusion of his 100-day contract, an additional interim superintendent had to be hired. A new vacancy in an existing principal position was filled by one interim superintendent; the other suspended his retirement status and worked full-time as superintendent for the remainder of the year. The combined effect of these personnel changes caused administrative expenses for the district to exceed the 5 percent limitation

Posen – Robbins SD 143.5 – Cook (SD 15/HD 30) / Expiration: 2011-12 school year

WM100-5679 – **Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district needed to improve its tracking system for special education funds to ensure that students were efficiently served. It made the necessary improvement by moving the position of secretary to the director of special education into the district's administrative cost calculations. This accounting adjustment caused administrative expenses for the district to exceed the 5 percent limitation.

Sandoval CUSD 501 - Marion, Clinton (SD 54/HD 107) / Expiration: 2011-12 school year

WM100-5680 – **Waiver of School Code** (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. The district received a federal School Improvement Grant to improve student achievement in language arts and mathematics. The district chose one of the models mandated for this grant, which required the housing and administration of a lead partner, and the purchase of necessary office equipment and supplies. The expenses associated with the new grant caused the district's administrative costs to exceed the 5 percent limitation.

Chaney – Monge SD 88 – Will (SD 43/HD 85) / Expiration: 2012-13 school year

WM100-5683 – Waiver of School Code (Section 17-1.5) request to allow the district to waive the limitation of administrative costs due to circumstances beyond its control. For the 2011-2012 school year, the district employed two interim superintendents. The hiring of a full-time superintendent with paid benefits for the 2012-2013 school year caused the district's administrative costs to exceed the 5 percent limitation.

Nonresident Tuition

Dodds CCSD 7 – Jefferson (SD 54/HD 107) / Expiration: 2016-17 school year

WM100-5625 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow nonresident students whose parents are full-time employees of the district to attend its schools free of charge.

Herrin CUSD 4 – Williamson (SD 59/HD 117) / Expiration: 2016-17 school year

WM100-5631 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow nonresident students whose parents are full-time employees of the district to attend its schools free of charge.

La Harpe CSD 347 – Hancock (SD 47/HD 94) / Expiration: 2016-17 school year

WM100-5645 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow nonresident students whose parents are certified employees of the district to attend its schools free of charge.

ROWVA CUSD 208 – Knox (SD 37/HD 74) / Expiration: 2016-17 school year

WM100-5647 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are employees of the district to attend its schools free of charge.

Lena Winslow CUSD 202 - Stephenson (SD 45/HD 89) / Expiration: 2017-18 school year

WM100-5649 – **Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If approved, this waiver would take effect in the 2013-14 school year.

Avon CUSD 176 – Warren, Fulton, Knox (SD 47/HD 94) / Expiration: 2016-17 school year

WM100-5654 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time certified employees of the district to attend its schools free of charge.

Bureau Valley CUSD 340 – Bureau, Lee, Whiteside (SD 37/HD 74) / Expiration: 2017-18 school year WM100-5656 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools at a rate set annually by the board of education, with a range from \$250 to \$1,500. In addition, the district would claim the average daily attendance of such students on the State Aid Claim. If approved, this waiver would take effect in the 2013-14 school year.

Anna-Jonesboro CHSD 81 – Union (SD 59/HD 118) / Expiration: 2016-17 school year

WM100-5657 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Waltham CCSD 185 – LaSalle (SD 38/HD 76) / Expiration: 2013-14 school year

WM100-5664 – **Waiver of School Code** (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time certified employees of the district to attend its schools at a yearly rate of \$1,500.

Summersville SD 79 – Jefferson (SD 54/HD 107) / Expiration: 2017-18 school year

WM100-5668 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge. If approved, this waiver would take effect in the 2013-14 school year.

Marshall CUSD C-2 - Clark (SD 55/HD 109) / Expiration: 2016-17 school year

WM100-5671 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools at a reduced tuition rate of \$3,000, representing the difference between the General State Aid per student rate and the district's per capita tuition charge. The district would claim the average daily attendance of such students on the State Aid Claim.

Johnston City CUSD 1 – Williamson (SD 59/HD 117) / Expiration: 2016-17 school year

WM100-5673 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Odell CCSD 435 - Livingston (SD 53/HD 105) / Expiration: 2016-17 school year

WM100-5675 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Hamilton County CUSD 10 - Hamilton (SD 59/HD 117) / Expiration: 2016-17 school year

WM100-5681 – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Marion CUSD 2 – Williamson, Johnson (SD 59/HD 117) / Expiration: 2016-17 school year

WM100-5682 (renewal) – Waiver of School Code (Section 10-20.12a) request to enable the district to allow non-resident students whose parents are full-time employees of the district to attend its schools free of charge.

Physical Education

Indian Prairie SD 204 – DuPage (SD 48/HD 96) / Expiration: 2014-15 school year

WM100-5624 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education three times a week for 25 minutes each session due to inadequate facilities. The district states that students receive more daily physical activity under this schedule than what is mandated. In addition to formal classes, students have daily supervised recess sessions with activities such as football, kickball, races, softball, and soccer. If approved, this waiver would take effect in the 2013-14 school year.

Plainfield CCSD 202 – Will (SD 42/HD 84) / Expiration: 2013-14 school year

WM100-5629 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education two times a week for 35 minutes each session due to inadequate facilities. Students also will receive supplemental instruction one day a week covering a health and wellness curriculum.

El Paso-Gridley CUSD 11 – Woodford (SD 53/HD 106) / Expiration: 2014-15 school year

WM100-5630 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 3 to participate in physical education three times a week for one semester and two times a week for the other semester, with each session lasting 30 minutes. This schedule would allow for music instruction on the days in which the students are not in physical education classes. Students also have two, 15-minute activity sessions each day. The district plans to use this part of the waiver only if enrollments increase, as has happened in the past. The district also requests to be allowed to exempt students in grades 11 and 12 from daily physical education while they participate in show choir. Such students will receive daily dance practices before school. If approved, this waiver would take effect in the 2013-14 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

Wilmington SD 209-U – Will (SD 38/HD 75) / Expiration: 2014-15 school year

WM100-5636 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 6 through 12 from the physical education requirement for a variety of reasons: those who have failed an academic course needed for promotion or graduation; and those who elect to take a course other than physical education and have permission from their principals to do so. In addition, the district asks to excuse students in grades 9 through 12 from daily physical education if they participate in two or more interscholastic athletic programs. The waiver, if approved, will allow the district to use the instructional day in the "most beneficial manner to students." If approved, this waiver would take effect in the 2013-14 school year.

East Aurora SD 131 – Kane (SD 42/HD 83) / Expiration: 2013-14 school year

WM100-5637 – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 6 through 8 from the physical education requirement if they are in need of intense reading interventions and not able to participate in an elective academic class after school or during the summer. Such students will be given additional reading instruction to better prepare them for high school reading. The district states that it is important to give each student an enriching educational experience that builds skills for reading, writing, and math, through an exploratory academic class offered either after school or during the summer.

Morton CUSD 709 – Tazewell (SD 53/HD 106) / Expiration: 2014-15 school year

WM100-5639 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 6 to participate in physical education for a minimum of twice a week for 25 minutes each session rather than daily. Classroom teachers will determine whether additional physical education activities will be offered, based on balancing students' physical and intellectual needs. The request is being made due to inadequate facilities. If approved, this waiver would take effect in the 2013-14 school year.

Collinsville CUSD 10 - Madison (SD 56/HD 112) / Expiration: 2013-14 school year

WM100-5643 (renewal) – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grades 11 and 12 from the daily physical education requirement to enable those students to enroll in additional academic classes, including a variety of AP courses and a vocational program offered in conjunction with the local community college. Over 500 students participate in interscholastic athletic programs or band in the district, and many others also join non-school–sponsored athletic programs.

Montmorency CCSD 145 - Whiteside (SD 45/HD 90) / Expiration: 2014-15 school year

WM100-5644 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 8 to participate in physical education twice a week for 40 minutes each session due to inadequate facilities. Students receive recess periods totaling 225 minutes per week of physical activity, in addition to physical education classes, and students in grades 5 through 8 have the opportunity to participate in after-school sports programs. If approved, this waiver would take effect in the 2013-14 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

Morris CHSD 101 - Grundy (SD 38/HD 75) / Expiration: 2013-14 school year

WM100-5646 – **Waiver of School Code** (Section 27-6) request to allow the district to excuse students in grade 10 from nine weeks of daily physical education in order to be enrolled in driver's education. The 200 students affected by this waiver, if approved, will be able to enroll in a foreign language, fine arts, or a second math or science class, thereby completing all necessary college entrance requirements.

 $\textit{Sterling CUSD 5-Whiteside, Lee} \ (SD\ 45/HD\ 90) \ / \ \textbf{Expiration:} \ \ \textbf{2014-15 school year}$

WM100-5651 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 5 to participate in physical education twice a week for 25 minutes each session due to inadequate facilities. Students will also have 20 minutes of recess each day, structured physical activities in the classroom and opportunities to participate in the park district's athletic programs after school. If approved, this waiver would take effect in the 2013-14 school year.

Lake Villa CCSD 41 – Lake (SD 31/HD 62) / Expiration: 2013-14 school year

WM100-5660 – Waiver of School Code (Section 27-6) request to allow the district to permit students in kindergarten through grade 6 to participate in physical education once a week for 35 minutes. Students will also have daily recess, and teachers will provide structured classroom activities requiring movement and fitness. The district states that the waiver will allow additional classroom time to implement the Common Core Standards.

Wauconda CUSD 118 – Lake (SD 26/HD 52) / Expiration: 2014-15 school year

WM100-5667 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 9 through 12 from the daily physical education requirement for ongoing participation in cheerleading, pom-pons, dance programs, or swing choir (if credit is provided). In addition, the district requests that students in grades 9 and 10 be excused for ongoing participation in an interscholastic athletic program. The district's goal is to complement the exercise such students are

receiving with coursework in core academic areas, career preparation and the fine arts. If approved, this waiver would take effect in the 2013-14 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

Ridgeview CUSD 19 – McLean (SD 53/HD 105) / Expiration: 2014-15 school year

WM100-5670 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 6 through 10 from the daily physical education requirement for ongoing participation in an interscholastic athletic program, and students in grades 9 through 12 from the daily physical education requirement for ongoing participation in cheerleading, pom-pons *or* marching band. If granted, the waiver will enable high school students to take additional academic classes and for those in middle school, to schedule a supervised study session if they are also enrolled in band or music. If approved, this waiver would take effect in the 2013-14 school year.

Crete – Monee CUSD 201U – Will (SD 40/HD 80) / Expiration: 2014-15 school year

WM100-5449 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 9 through 12 from the daily physical education requirement for ongoing participation in show choir or for participation in academic intervention courses designed to assist students in passing content-area courses. The waiver, if granted, will enable students to take additional academic and elective courses. If approved, this waiver would take effect in the 2013-14 school year.

Mundelein CHSD 120 – Lake (SD 26/HD 51) / Expiration: 2014-15 school year

WM100-5676 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to excuse students in grades 11 and 12 from the daily physical education requirement for ongoing participation in cheerleading, pom-pons, or show choir. The district states that students eligible for this waiver have rigorous daily practice sessions and that the waiver, if approved, would allow these students to schedule a study hall or enroll in other academic courses. If approved, this waiver would take effect in the 2013-14 school year.

Warren THSD 121 – Lake (SD 31/HD 62) / Expiration: 2014-15 school year

WM100-5678 (renewal) – Waiver of School Code (Section 27-6) request to allow the district to permit students in grades 9 through 12 to take physical education as a summer school course in order to schedule additional academic courses during the regular school year. The district hopes the summer school option will spur students to enroll in more English and math classes, a goal articulated in its plan for "corrective action." In addition, the district wants to excuse students in grades 11 and 12 from physical education for ongoing participation in varsity hockey and varsity lacrosse. If approved, this waiver would take effect in the 2013-14 school year. If granted, this is the last physical education waiver the district will be permitted to request under the law.

Carthage ESD 317 – Hancock (SD 47/HD 94) / Expiration: 2016-17 school year

WM100-5544 – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold five full-day teacher inservice sessions instead of ten half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

City of Chicago SD 299 – Cook (SD 3/HD 5) / Expiration: 2016-17 school year

WM100-5662 (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold four full-day teacher inservice sessions instead of eight half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

Prairie Hill CCSD 133 – Winnebago (SD 35/HD 69) / Expiration: 2016-17 school year

WM100-5669 (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day teacher inservice sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days.

Blue Ridge CUSD 18-DeWitt, McLean, Livingston (SD 44/HD 87)/Expiration: 2017-18 school year

WM100-5677 (renewal) – Waiver of School Code (Section 18-8.05(F)(2)(d)(2)) request to allow the district to hold two full-day teacher inservice sessions instead of four half days, and to count the days among the 176 days of actual pupil attendance required by Section 10-19. The district will accumulate sufficient time beyond the five-clock-hour requirement to apply towards these days. If approved, this waiver would take effect in the 2013-14 school year.

WHEREAS, The current fly quiet program needs to be re-evaluated for the purposes of instilling and sharing the primary purpose of flight and community partnership at O'Hare International Airport with all

of the collar communities; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Federal Aeronautics Administration and O'Hare International Airport authorities to decrease jet noise over the communities of Northwest Chicago by establishing a full-time fly quiet program and urge the creation and passage of a federal homeowner's aviation fly quiet act; and be it further

WHEREAS, The community services agreement between DHS and CRA authorizes payments of up to \$1,350,000 to the vendor for the development of a clinical transition plan, as well as the performance of resident assessments costing \$5,300 per resident; and

WHEREAS, The assessment of residents to facilitate community transitions has been a function historically performed by facility staff as an ongoing process requiring substantial interaction with the client, medical providers, and family members; and

WHEREAS, Concerns have been raised that current client reviews performed by CRA include only a minimal amount of observation and interaction with clients prior to individual transition plans being determined; and

WHEREAS, Concerns have also been raised that assessments of clients have been hindered because families of clients currently residing at the Jacksonville and Murray Developmental Centers have voiced support for the continuation of the current care provided and have declined to give permission to new, out-of-state review teams brought in by CRA to be involved in the transition of their loved ones; and

WHEREAS, Adequate accountability and oversight of the assessment process is key to ensuring the safety of and proper care for residents currently being considered for community placements; and

WHEREAS, The use of a competitively bid procurement utilizing the State procurement process provides safeguards to ensure the efficient expenditure of State funds; and

WHEREAS, The current community services agreement between DHS and CRA expires on October 31, 2012, and a full review of the services provided under the existing grant should be provided prior to an extension of the grant being considered; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct an audit of the DHS grant to CRA; and be it further

RESOLVED, That the audit shall address, but need not be limited to addressing:
(1) whether CRA has provided the deliverables required under the grant agreement with

DHS:

- (2) whether the other requirements of the grant are being met;
- (3) whether DHS has assessed the performance of CRA in meeting the grant requirements;
- (4) whether prior business relationships have existed between the principals of CRA and staff within the Governor's office and DHS;
- (5) whether the principals of CRA have any business interests in the community group homes to which affected residents are being transferred; and
- (6) whether the prerequisites for competitive bid procurement had been triggered, thus

RESOLVED, That DHS and any other entity having relevant information to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act.

SC0079

RESOLVED, BY THE SENATE OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article IV of the Illinois Constitution by changing Section 6 as follows:

ARTICLE IV THE LEGISLATURE

SECTION 6. ORGANIZATION

- (a) A majority of the members elected to each house constitutes a quorum.
- (b) On the first day of the January session of the General Assembly in odd-numbered years, the Secretary of State shall convene the House of Representatives to elect from its membership a Speaker of the House of Representatives as presiding officer, and the Governor shall convene the Senate to elect from its membership a President of the Senate as presiding officer.
- (c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be. A person who has served 2 consecutive 2-year terms as Speaker of the House of Representatives, President of the Senate, Minority Leader of the House of Representatives, or Minority Leader of the Senate may not be re-elected to the same office for a period of 4 years after his or her second term expires. Service before the second Wednesday in January of 2013 shall not be considered in the calculation of a person's service.
- (d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior.

To the Honorable Members of the Illinois Senate 97th General Assembly:

In accordance with Article IV, Section 9(b) of the Illinois Constitution, I hereby veto Senate Bill 1849

from the 97th General Assembly.

It is critically important that any expansion of gaming in Illinois be undertaken thoughtfully and carefully. We have one opportunity to get it right. If we do, we can create jobs and foster economic development in areas that need it across Illinois.

Over the past several years, I have repeatedly made clear that any expansion of gaming in our state must include strong ethical standards, proper balance, and support for education.

While Senate Bill 1849 addresses some of the shortcomings of Senate Bill 744, such as a reduction in the number of gaming locations, it continues to fall well short of the standards of the people of Illinois.

The most glaring deficiency of Senate Bill 1849 is the absence of strict ethical standards and comprehensive regulatory oversight. Illinois should never settle for a gaming bill that includes loopholes for mobsters.

Notably, this legislation lacks a ban on campaign money from gaming licensees and casino managers. We must prevent campaign contributions by gaming operators from infecting our political process.

To protect the public interest, other states have enacted such bans, including Massachusetts, New Jersey, Pennsylvania, and Louisiana, and our neighboring states such as Iowa, Michigan, and Indiana. The people of Illinois deserve no less.

Senate Bill 1849 also does not ensure clear regulatory oversight over the proposed Chicago casino. This bill does not provide the Illinois Gaming Board with the same regulatory authority over the Chicago casino that it maintains over all other gaming operations in Illinois. Permitting the Chicago casino to operate without the appropriate oversight of the Gaming Board is not good for Illinois.

In addition, this bill does not subject Chicago casino contracts to the Illinois Procurement Code. The bill contains a weak procurement process with many loopholes. Such a complete lack of oversight will leave the Chicago casino's numerous procurements vulnerable to organized crime, unsavory influence and potentially overpriced vendors.

This bill also does not provide the Illinois Gaming Board with sufficient time to make critical licensing and regulatory decisions. The Gaming Board has a solid track record of keeping corruption out of an industry that is susceptible to nefarious activity.

Furthermore, we cannot forget that Illinois' economic future relies on the education of our children. This bill does not provide adequate support for education. The budget for pre-school to 12th grade education was reduced by \$210 million by the General Assembly this fiscal year and faces more challenges in the immediate future. Any expansion of gaming must prioritize the needs of our students.

I call on the members of the General Assembly to work with my staff, the Illinois Gaming Board, the Illinois Racing Board, the City of Chicago, and all other interested parties to ensure that the final version of any gaming legislation includes strong ethical standards, clear oversight and adequate support for education. Anything short of that is unacceptable and would be a disservice to the people of Illinois.

Finally, Illinois cannot gamble its way out of our fiscal challenges. Even a casino on every street corner cannot repair the State's \$83 billion unfunded pension liability. I urge the members of the Illinois House and Senate to address the most pressing issue of our time – comprehensive public pension reform.

Accordingly, I must return this bill without my approval. Therefore, pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I hereby return Senate Bill 1849, entitled "AN ACT concerning gaming," with the foregoing objections, vetoed in its entirety.

To the Honorable Members of the Illinois Senate, 97th General Assembly:

I would like to commend the sponsors for their hard work on Senate Bill 2945. This legislation amends the Right to Privacy in the Workplace Act to allow for-profit employers who provide medical or hospital treatment to those with cancer to refuse to hire, discharge, discipline and alter the pay, benefits and working conditions of any employee who uses tobacco products when not at work. As Governor, I am committed to working together to decrease the number of smokers and to make sure Illinois residents have fresh air to breathe while they are at work and in public places. Although this bill has been narrowly drawn to primarily apply to employees of a cancer treatment center, there are more extensive consequences which could have an impact on a citizen's right to privacy.

The issue of employees' rights to engage in certain off-duty activities and the competing authority of their employers to prohibit them from doing so has received significant attention from lawmakers and other policymakers around the country. In total, twenty-nine states and the District of Columbia have statutes that protect employees from adverse employment actions based on their off-duty activities. These statutes provide three different levels of protection: (1) use of tobacco only, (2) use of lawful products; and (3) any and all lawful activities. Since this bill has been transmitted to me, concerns have been raised that this legislation has far-reaching consequences beyond an employer's desire to keep employees healthy.

In addition, I am concerned about how this bill will be implemented in order to make sure it protects our health care employees. According to the sponsors of the bill, the provision will only apply to new employees hired after the effective date of the bill. This important stipulation was not written into the bill and cannot be enacted through regulation. In addition, the legislation does not address whether employees will have the right to appeal adverse employment decisions.

Finally, the bill does not address how employees will be tested for tobacco use. According to proponents, new employees may be tested for tobacco use by undergoing blood tests. Although proponents claim the blood test threshold cannot be reached through second-hand smoke, I remain concerned about how the tests will be administered

For these reasons, I cannot affix my signature to Senate Bill 2945. I look forward to working with sponsors in the coming months to continue to encourage individuals to stop smoking and to make sure cancer treatment centers have the tools they need to treat patients.

Therefore pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I return Senate Bill 2945 with the foregoing objections, vetoed in its entirety.

I would like to commend the General Assembly for their important work on Senate Bill 3442. I pledge to continue working with lawmakers on this issue in the coming months.

Senate Bill 3442 creates a statewide plastic bag and film recycling program to reduce the number of bags and films that end up in our landfills each year. Specifically, the bill requires manufacturers to register with the Environmental Protection Agency and develop a recycling plan. Units of government nationwide have realized the growing problem of plastic film, which accounts for approximately 4% of waste in landfills. Only 3% of the 500,000 tons of plastic waste produced every year is currently recycled. Plastic bags are too often found tangled in trees, littering waterways, and harming wildlife. We must enact policies that prevent pollution and safeguard our communities and natural resources. As Governor, I am committed to preserving our environment for future generations.

Since this legislation was sent to me, many interested parties have raised important concerns regarding its potential effects. While I agree with the intent of the legislation, I share concerns that this program would not increase the rate of recycling beyond the natural growth. Local authorities and the environmental community strongly oppose this program because the metrics are simply not aggressive enough and home rule preemption prevents more stringent local regulation. This bill is more restrictive on municipalities than any other plastic bag regulation in the country, which creates a roadblock for locals to choose the policies that fit the needs of the area. Communities throughout the country experienced great success with different types of policies, as can be seen in the numerous municipalities in California that enacted an outright ban on plastic bags.

Local governments deserve the ability to enact environmental health laws that best respond to their communities. This bill hinders further opportunities to realize even greater benefits from other types of municipal plastic film regulation. I look forward to reviewing future policies that will bring Illinois to the forefront of sustainability.

Therefore, pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I return Senate Bill 3442, entitled "AN ACT concerning safety.", with the foregoing objections, vetoed in its entirety.

To the Honorable Members of the Illinois Senate, 97th General Assembly:

Today, I return Senate Bill 3766 vetoed in its entirety.

Last year, I signed Public Act 97-0096, which provided a framework for the construction of a coal gasification project on the south side of Chicago. The plant, built by Chicago Clean Energy, LLC, would turn Illinois coal and petroleum coke into synthetic natural gas. Additionally, the Act allowed our State's four largest utilities to purchase the synthetic natural gas through 30-year sourcing agreements.

At that time, the proportion of gas purchased by the utilities, and ultimately their ratepayers, was fairly apportioned to protect consumers against rate shock. Even more, the law required the developers to create a consumer protection account designed to lower the cost of the synthetic gas in times of low market prices. With these provisions in place, the project was designed to create jobs, support Illinois' coal resources, and, most importantly, protect businesses and consumers.

However, since that time, circumstances have changed. In September of 2011, two of the gas utilities opted out of procuring the synthetic gas, leaving the remaining two utilities with far greater purchase obligations. In response, the developers argued before the Illinois Commerce Commission that Ameren and Nicor customers should be paying for 95% of the costs of the facility, while only receiving 84% of its output. That is not a fair deal for ratepayers. We can do better.

In addition, our country is in the midst of a natural gas boom, which is coupled with dramatically

decreasing demand. As a result, current natural gas prices are at historic lows, and many indicators suggest prices will remain low for years to come. These new facts require further scrutiny, and a revisiting of the economics of this 30-year project. I support the Chicago Clean Energy project, but it must be implemented in a way that protects the consumers of Illinois.

Therefore, pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I hereby return Senate Bill 3766, entitled "AN ACT concerning public utilities," with this statement of objections, vetoed in its entirety.

I urge the General Assembly to send me a better bill to enable this project to move forward.

Pursuant to my constitutional powers as Governor of the State of Illinois, I hereby return Senate Bill 681 with specific recommendations for change. In doing so, I propose to ban assault weapons and high-capacity ammunition magazines in our state.

As Governor, it is my foremost duty to protect the citizens of Illinois, especially our children, from deadly violence.

I am a strong supporter of the Second Amendment of the United States Constitution- the right to bear arms

However, the proliferation of military-style assault weapons and high-capacity ammunition magazines undermines public safety and the right of personal security of every citizen.

Right now, anyone with a FOID card in Illinois is permitted by law to purchase an assault weapon. Illinois also does not impose any restrictions on the purchase or possession of high-capacity ammunition magazines, which automatically feed ammunition into a firearm chamber to allow the user to fire

repeatedly without reloading.

Banning assault weapons and high-capacity ammunition magazines will make Illinois a safer place to live.

Other states including California, Connecticut, Massachusetts, New Jersey and New York all have such bans in place. The ban would not pertain to law enforcement officials or members of the military.

There is no place in the State of Illinois for weapons designed to rapidly fire at human targets at close range.

My action today gives the members of the General Assembly an immediate opportunity to protect the people of Illinois by banning assault weapons and high-capacity ammunition magazines.

Therefore, pursuant to Article IV, Section 9(e) of the Illinois Constitution of 1970, I hereby return Senate Bill 681, entitled "AN ACT concerning regulation.", with the following specific recommendations for change:

By replacing everything after the enacting clause with the following:

"Section 5. The Criminal Code of 1961 is amended by adding Sections 24-1.9 and 24-1.10 as follows:

(720 ILCS 5/24-1.9 new)

Sec. 24-1.9. Manufacture, possession, delivery, sale and purchase of semi-automatic assault weapons, assault weapon attachments, .50 caliber rifles, and .50 caliber cartridges.

- (a) Definitions. In this Section:
 - (1) "Semi-automatic assault weapon" means:
 - A. Any of the firearms or types, replicas, or duplicates in any caliber of the firearms, known as:
 - i. Norinco, Mitchell, and Poly Technologies Avtomat Kalashnikovs (all models);
 - ii. Action Arms Israeli Military Industries UZI and Galil;
 - iii. Beretta AR-70 (SC-70);
 - iv. Colt AR-15;
 - v. Fabrique Nationale FN/FAL, FN/LAR, and FNC;
 - vi. SWD M-10, M-11, M-11/9, and M-12;
 - vii. Steyr AUG;
 - viii. INTRATEC TEC-9, TEC-DC9, and TEC-22; and
 - ix. Any shotgun which contains its ammunition in a revolving cylinder, such as (but not limited to) the Street Sweeper and Striker 12;
 - B. A semi-automatic rifle that has an ability to accept a detachable magazine and has any of the following:

- i. A folding or telescoping stock;
- ii. A pistol grip or thumbhole stock;
- iii. A shroud that is attached to, or partially or completely encircles the barrel, and that permits the shooter to hold the firearm with the non-trigger hand without being burned; or
- iv. A fixed magazine that has the capacity to accept more than 10 rounds of ammunition;
- C. A semi-automatic pistol that has an ability to accept a detachable magazine and has any of the following:
 - i. A folding, telescoping, or thumbhole stock;
 - A shroud that is attached to or partially or completely encircles the barrel, and that permits the shooter to hold the firearm with the non-trigger hand without being burned;
 - iii. An ammunition magazine that attaches to the pistol outside the pistol grip;
 - iv. A fixed magazine that has the capacity to accept more than 10 rounds of ammunition;
 - v. A manufactured weight of 50 ounces or more when the pistol is unloaded; or
 - vi. A semi-automatic version of an automatic firearm;
- D. A semi-automatic shotgun that has any of the following:
 - i. A folding or telescoping stock;
 - ii. A pistol grip or thumbhole stock;
 - iii. A fixed magazine capacity in excess of 5 rounds; or
 - iv. An ability to accept a detachable magazine.

"Semi-automatic assault weapon" does not include:

A. Any firearm that:

- i. Is manually operated by bolt, pump, lever, or slide action;
- ii. Is an "unserviceable firearm" or has been made permanently inoperable; or
- iii. Is an antique firearm;
- B. Any air rifle as defined in Section 1 of the Air

Rifle Act.

- (2) "Assault weapon attachment" means any device capable of being attached to a firearm that is specifically designed for making or converting a firearm into any of the firearms listed in paragraph (1) of subsection (a) of this Section.
- (3) "Antique firearm" has the meaning ascribed to it in 18 U.S.C. Section 921 (a)(16).
- (4) ".50 caliber rifle" means a centerfire rifle capable of firing a .50 caliber cartridge. The term does not include any antique firearm as defined in 18 U.S.C. Section 921 (a)(16), any shotgun including a shotgun that has a rifle barrel, or a muzzle-loader used for "black powder" hunting or battle re-enactments.
- (5) ".50 caliber cartridge" means a cartridge in .50 BMG caliber, either by designation or actual measurement, that is capable of being fired from a centerfire rifle. The term ".50 caliber cartridge" does not include any memorabilia or display item that is filled with a permanent inert substance or that is otherwise permanently altered in a manner that prevents ready modification for use as live ammunition or shotgun ammunition with a caliber measurement that is equal to or greater than .50 caliber.
- (b) Except as provided in subsections (c) and (d), 90 days after the effective date of this amendatory. Act of the 97th General Assembly, it is unlawful for any person within this State to knowingly manufacture, deliver, sell, purchase, or possess or cause to be manufactured, delivered, sold, purchased, or possessed, a semi-automatic assault weapon, an assault weapon attachment, any .50 caliber rifle, or .50 caliber cartridge.
- (c) This Section does not apply to a person who possessed a weapon or attachment prohibited by subsection (b) before the effective date of this amendatory Act of the 97th General Assembly, provided that the person has provided proof of ownership to the Department of State Police within 90 days after the effective date of this amendatory At of the 97th General Assembly as required by law. On or after the effective date of this amendatory Act of the 97th General Assembly, such person may transfer such weapon or attachment only to an heir, an individual residing in another state maintaining that weapon in another state, or a dealer licensed as a federal firearms dealer under Section 923 of the federal Gun Control Act of 1968.
 - (d) This Section does not apply to or affect any of the following:
 - (1) Peace officers as defined in Section 2-13 of this Code and retired peace officers not otherwise prohibited from receiving a firearm, in possession of a semi-automatic assault weapon, assault weapon attachment, or .50 caliber rifle transferred to the retired peace officer by his or her law enforcement agency upon retirement.
 - (2) Wardens, superintendents, and keepers of prisons, penitentiaries, jails, and other institutions for the detention of persons accused or convicted of an offense.
 - (3) Members of the Armed Services or Reserve Forces of the United State or the Illinois National Guard, while in the performance of their official duties or while traveling to or from their place of duty.
 - (4) Manufacture, transportation, or sale of weapons, attachments, or ammunition to persons authorized under subdivisions (1) through (3) of this subsection to possess those items.
 - (5) <u>Possession of a semi-automatic assault weapon, an assault weapon attachment, a .50 caliber rifle, or a .50 caliber cartridge at events taking place at the World Shooting and Recreational Complex at Sparta, only while engaged in the legal use of the firearm or attachment, or while traveling to or from this location if the items are broken down</u>

in a non-functioning state, or are not immediately accessible, or are unloaded and enclosed in a care, firearm carrying box, shipping box, or other container.

- (6) Possession of any firearm if that firearm is sanctioned by the International Olympic Committee and by USA Shooting, the national governing body for international shooting competition in the United States, but only when the firearm is in the actual possession of an Olympic target shooting competitor or target shooting coach for the purpose of storage, transporting to and from Olympic target shooting practice or events if the firearm is broken down in a non-functioning state, is not immediately accessible, or is unloaded and enclosed in a case, firearm carrying box, shipping box, or other container, and when the Olympic target shooting competitor or target shooting coach is engaging in those practices or events. For the purposes of the paragraph (6), "firearm" is defined in Section 1.1 of the Firearm Owners Identification Card Act.
- (7) <u>Possession of a semi-automatic assault weapon, an assault weapon attachment, a .50 caliber rifle, or a .50 caliber cartridge only for a hunting use expressly permitted under the Wildlife Code, or while traveling to or from a location authorized for such hunting use under the Wildlife Code if the items are broken down in a non-functioning state, or are not immediately accessible, or are unloaded and enclosed in a case, firearm carrying box, shipping box, or other container.</u>
- (8) Manufacture, transportation, possession, sale, or rental of blank-firing semiautomatic assault weapons and .50 caliber rifles or the weapons respective attachments to persons authorized or permitted, or both authorized and permitted to acquire and possess such weapons for the purposes of rental for use solely as props for a motion picture, television, or video production or entertainment event.

(e) Sentence.

- (1) A person who knowingly manufactures, delivers, sells, purchases, or possesses or causes to be manufactured, delivered, sold, purchased, or possessed a semi-automatic assault weapon in violation of this Section commits a Class 3 felony for a first violation and a Class 2 felony for a second or subsequent violation or for the possession or delivery of 2 or more of these weapons at the same time.
- (2) A person who knowingly manufactures, delivers, sells, purchases, or possesses or causes to be manufactured, delivered, sold, purchased, or possessed in violation of this Section an assault weapon attachment commits a Class 4 felony for a first violation and a Class 3 felony for a second or subsequent violation.
- (3) A person who knowingly manufactures, delivers, sells, purchases, or possesses or causes to be manufactured, delivered, sold, purchased, or possessed in violation of this Section a .50 caliber rifle commits a Class 3 felony for a first violation and a Class 3 felony for a second or subsequent violation or for the possession or delivery of 2 or more of these weapons at the same time.
- (4) A person who knowingly manufactures, delivers, sells, purchases, or possesses or causes to be manufactured, delivered, sold, purchased, or possessed in violation of this Section a .50 caliber cartridge commits a Class A misdemeanor.

(720 ILCS 5/24-1.10 new)

Section 24-1.10. Manufacture, possession, delivery, sale, and purchase of large capacity ammunition feeding devices.

i. As used in this Section:

"Large capacity ammunition feeding device" means:

- 1) A magazine, belt, drum, feed strip, or similar device that has a capacity of, or that can be readily restored or converted to accept, more than 10 rounds of ammunition; or
- 2) Any combination of parts from which a device described in paragraph (1) can be assembled.

"Large capacity ammunition feeding device" does not include an attached tubular device designed to accept, and capable of operating only with, .22 caliber rimfire ammunition or any device that has been made permanently inoperable.

- (b) Except as provided in subsections (c) and (d), it is unlawful for any person within this State, beginning 90 days after the effective date of this amendatory Act of the 97th General Assembly, to knowingly manufacture, deliver, sell, purchase, or possess or cause to be manufactured, delivered, sold, purchased, or possessed, a large capacity ammunition feeding device.
- (c) This Section does not apply to a person who possessed a device prohibited by subsection (b) before the effective date of this amendatory Act of the 97th General Assembly, provided that the person has provided proof of ownership to the Department of State Police within 90 days after the effective date of this amendatory Act of the 97th General Assembly as required by law. On or after the effective date of this amendatory Act of the 97th General Assembly, such person may transfer such device only to an heir, an individual residing in another state maintaining that device in another state, or a dealer licensed as a federal firearms dealer under Section 923 of the federal Gun Control Act of 1968.
- (d) This Section does not apply to or affect any of the following:
 - 1) Peace officers as defined in Section 2-13 of this Code and retired peace officers not otherwise prohibited from receiving a firearm, in possession of a large capacity ammunition feeding device transferred to the retired peace officer by his or her law enforcement agency upon retirement.
 - 2) <u>Wardens, superintendents, and keepers of prisons,</u> penitentiaries, jails, and other institutions for the detention of persons accused or convicted of an offense.
 - 3) Members of the Armed Services or Reserve Forces of the United States or the Illinois National Guard, while in the performance of their official duties or while traveling to or from their place of duty.
 - 4) <u>Manufacture, transportation, or sale of large capacity ammunition feeding devices to persons authorized under subdivisions (1) through (3) of this subsection to possess those items.</u>
 - 5) Possession of a large capacity ammunition feeding device at events taking place at the World Shooting and Recreational Complex at Sparta, only while engaged in the legal use of the device, or while traveling to or from this location if the items are broken down in a non-functioning state, or are not immediately accessible, or are unloaded and enclosed in a case, firearm carrying box, shipping box, or other container.
 - 6) Possession of any large capacity ammunition feeding device if that large capacity ammunition feeding device is sanctioned by the International Olympic Committee and by USA Shooting, the national governing body for international shooting competition in the United Sates, but only when the large capacity ammunition feeding device is in the actual possession of an Olympic target shooting competitor or target shooting coach for the purpose of storage, transporting to and from Olympic target shooting practice or events if the device is broken down in a non-functioning state, is not immediately accessible, or is unloaded and enclosed in a case, firearm carrying box, shipping box, or other container, and when the Olympic target shooting competitor or target shooting coach is engaging in those practices or events.

- 7) Possession of a large capacity ammunition feeding device only for a hunting use expressly permitted under the Wildlife Code, or while traveling to or from a location authorized for such hunting use under the Wildlife Code if the items are broken down in a non-functioning state, or are not immediately accessible, or are unloaded and enclosed in a case, firearm carrying box, shipping box, or other container.
- (e) Sentence. A person who knowingly manufactures, delivers, sells, purchases, or possesses or causes to be manufactured, delivered, sold, purchased, or possessed in violation of this Section a large capacity ammunition feeding device capable of holding more than 17 rounds of ammunition commits a Class 3 felony for a first violation and a Class 2 felony for a second or subsequent violation or for possession or delivery of 2 or more of these devices at the same time. A person who knowingly manufactures, delivers, sells, purchases, possesses or causes to be manufactured, delivered, sold, purchased, or possessed in violation of this Section a large capacity ammunition feeding device capable of holding more than 10 rounds but not more than 17 rounds of ammunition commits a Class 4 felony for a first violation and a Class 3 felony for a second or subsequent violation or for possession or delivery of more than one of these devices at the same time.

Section 97. Severability. The provisions of this Act are severable under Section 1.31 of the Statute on Statutes."

With these changes, Senate Bill 681 will have my approval. I respectfully request your concurrence.

Today I return Senate Bill 2474 with item and reduction vetoes in the amount of \$56,110,400.

These appropriation reductions reinforce our intention and need to close a number of facilities across Illinois.

These are difficult fiscal times and it is clear that we must employ a variety of methods to manage those who violate the laws of our State -- not just for the purpose of reducing the annual cost of operating State government, but because the policies that these facilities reinforce do not adequately reduce recidivism.

The Fiscal Year 2013 budget as passed by the General Assembly provides resources to maintain operations for a full fiscal year for the Murphysboro and Joliet Youth Centers. It is my intention to move forward with the Illinois Department of Juvenile Justice closures. We are in a time of scarce resources and cannot afford to staff empty facilities. The limited resources that we have are better spent providing services to these troubled youths in their [November 14, 2012]

communities, at a lower cost, with performance-based goals, so that these youths do not once again fall into our custody upon reaching adulthood.

The budget as passed by the General Assembly also funds the operations of North Lawndale Adult Transition Center, Peoria Adult Transition Center, Fox Valley Adult Transition Center, Crossroads Adult Transition Center, Westside Adult Transition Center, Decatur Adult Transition Center, and Southern Adult Transition Center. It is my intention to maintain operations at the North Lawndale, Crossroads, Peoria and Fox Valley Adult Transition Centers for the purpose of continuing to provide job training and programmatic support to those individuals that will soon be returning to our communities.

This budget also provides funding for the Tamms and Dwight Correctional Centers. The appropriation that is in the budget for Tamms provides for its operation, but for a different purpose than it is serving today. However, the General Assembly has not provided the necessary resources to repurpose Tamms so that it can be operated in a different capacity. The cost of operating this facility is \$62,000 per inmate per fiscal year, about three times the statewide cost for other facilities within the Department of Corrections. This cost can simply no longer be afforded. The Dwight Correctional Center is in need of substantial repairs and can no longer be operated efficiently. The Department of Corrections has also seen a 41% decrease in the number of female admissions, reducing the Department's need to maintain existing female capacity.

Therefore, pursuant to Article IV, Section 9(d) of the Illinois Constitution of 1970, I hereby return Senate Bill 2474, entitled "AN ACT concerning appropriations" with item and reduction vetoes in appropriations totaling \$56,110,400.
