House Bill 2877.

(Secretary reads title of bill)

2nd Reading of the bill. No committee or Floor amendments reported.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Aquino. 3rd Reading. Senate Bills 3rd Reading, final action, page 6. Senate Bill 170. Senator Koehler. Mr. Secretary, read the bill.

Senate Bill 170.

(Secretary reads title of bill) 3rd Reading of the bill. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

Thank you, Mr. President, and Members of the Senate. This bill creates the Vegetable Garden Protection Act which establishes, that notwithstanding in any other State or local government law, that any person may cultivate a vegetable garden on their private property or another private property with the owner's permission. State and local government may adopt general regulations, provided that the regulations do not preclude or specifically regulate vegetable gardens. This is -- a -- a bill that I think will help all of the folks especially during this

time of the pandemic where they want fresh fruits and vegetables and I'm happy to answer any questions. PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Senator McClure, for what purpose do you seek recognition?

SENATOR McCLURE:

Mr. President, will the sponsor yield? PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield. SENATOR McCLURE:

Senator, I did vote for this in committee, but I just want clarification so that everyone voting on this is aware of what this does. This does limit some home rule power. Is that correct? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler. SENATOR KOEHLER:

Yes. Thank you, for your question. Yes it does. But it does not limit a city's ability to be able to provide, you know, zoning setbacks or -- or other things that they would use to regulate, you know, their community. It just says that you cannot specifically discriminate against gardens. So thank you for your question.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator McClure.

SENATOR McCLURE:

And also, as far as the limitation of vegetable gardens, can it be any size garden? Or what -- what ability is there to limit the size of a garden in these -- in these cities? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler. SENATOR KOEHLER:

Well, a community can still regulate setbacks, and, you know, structure ordinances, whatever, so they -- they -- they limit it by that. But if -- if it's allowed in terms of other reasonable setbacks and things then you can have a vegetable garden, yes. And -- and they can also regulate the height of it.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator McClure.

SENATOR McCLURE:

So -- so the height can be regulated, but the size overall, for example, the, you know, the length of it? Can that be regulated?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

It can be regulated as -- yes, it can be regulated as long as it's not regulated because it's a vegetable garden. So, in other words, if there are setbacks and things like that, yes that -that does apply. But if you say, we're not going to allow vegetable gardens, well then that's not permitted.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator McClure. SENATOR McCLURE:

Thank you, Senator. One final question. And then is IML still opposed to this legislation? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler. SENATOR KOEHLER:

Thank you again for your question. Yes, IML opposes anything that preempts the home rule.

Sponsor indicated he will yield.

And, I'm sorry, Senator Koehler. You know I dearly love you. This is an issue that we have seen in many committees for several years prior to this. Is this a single incident that this bill has resulted from?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

I don't think the bill is a result of a single incident, but, yes, there is a single incident in which kind of garnered a lot of publicity. But again this -- this does not limit a community's ability to be able to regulate zoning setbacks, height restrictions, structures, whatever. It just says that you cannot discriminate by calling something a garden. So the height of the garden, all those things that pertain to anything else in -- in city codes is still enforceable.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Holmes.

SENATOR HOLMES:

It's my understanding that where this issue really came from was a structure that they called a hoop house, where they were

trying to grow vegetables underneath it - that actually was the reason this whole incident came up is because the city was trying to limit this hoop house being erected on the property. Is that true or not still?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

Well, again, that was what kind of galvanized the publicity initially on this, but I don't -- I don't think this law was written just with that in mind. This is written just to protect the rights of anyone in the State to be able to have a vegetable garden. And I'm not even going to opine on -- on whether or not this would protect or relate to that incident you're talking about. Because again, this is very clear, that communities can still regulate based on zoning, based on structures, based on all the other things in their code. They just can't say that because it's a garden, it's, therefore, illegal.

SENATOR HOLMES:

Thank you, Senator. And this does -- you did say, this does preempt home rule, true?

Senator Holmes was referring to a hoop house. A hoop house. H-O-O-P house. Okay.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose.

SENATOR ROSE:

So, I'm very excited to support vegetable gardening, you know, a huge proponent, I enjoy it immensely. But my question is, how or is there a difference between home rule communities and nonhome rule communities? Because, right now, as I understand, this deals with zoning, but if you're home rule, you can do some things, if you're not home rule, you can do some other things. I represent mostly home rule communities, where I would think we wouldn't have any zoning of vegetable gardens to begin with. So, I don't want to suddenly be letting my people -- my people suddenly regulate vegetable gardening. So, is there a huge difference between -- is there any difference between home rule and non-home rule communities with respect to this bill?

Senator Koehler.

SENATOR KOEHLER:

No, it treats all communities the same. And, I just, again, says that you can -- you can still regulate on the basis of everything else that's in your ordinances. You just can't say that you can't have vegetable gardens. It's pure and simple. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Rose.

SENATOR ROSE:

Then I do look forward to voting for this bill and later this fall coming over to Senator Bennett's house to enjoy some squash and beets that he's planted. Thank you.

Senator Cullerton, for what purpose you seek recognition? SENATOR CULLERTON:

To the bill.

First I'd like to thank Senator Koehler to -- to usher this through. This is a -- this is actually an issue that should be very easy to handle for everybody, it shouldn't have taken this long, and I do appreciate his leadership and his desire to get this through, and I can't thank you enough. And I look forward to voting Aye.

Senator Wilcox, seeking recognition. SENATOR WILCOX:

So, I carried this bill last year and have come to the conclusion that this should be no different from municipalities than the ordinance on temporary signage that had to go to the Supreme Court where we had to be told you can regulate temporary signage but you can't regulate temporary signage based on the message or the aspect. And what Senator Koehler's bill does, is says municipalities you can regulate things under zoning, you just can't regulate them differently for different reasons. So, in that regard, I will be supporting this bill. Thank you. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Tracy, for what purpose do you seek recognition? SENATOR TRACY:

Thank you, Mr. President. A question of the sponsor, please. PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield. SENATOR TRACY:

Senator Koehler, I likewise support this concept of -- of allowing people to grow vegetables. It's a wonderful trend that's taken off. But, I -- back to the hoop house, I just was wondering - and I'm looking at all the language and I -- I'm thinking it's accurate but in the instance of that -- of the garden problem that got all the attention in the media - does your bill allow the vegetable garden to have a hoop house? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

No, this bill is -- is silent to that. What it says is and -- and whether you can have a hoop house or not depends on the local ordinances and how it's constructed. So this bill doesn't -- doesn't speak to that issue per -- per -- per se, it -- what -- what Senator Wilcox just said is exactly what this bill does. It just says you can do all kinds of things in terms of your ordinances. You just can't do it to say that it -- that you're not going to allow vegetable gardens. So -- so it -- it -- it's really agnostic in terms of that particular story that we're talking about.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Tracy.

SENATOR TRACY:

Thank you for that clarification. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Martwick, for what purpose do you seek recognition? SENATOR MARTWICK:

Thank you, Mr. President. Question of the sponsor. PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield. SENATOR MARTWICK:

Thank you, Senator Koehler, for bringing this legislation forward. So this is the Vegetable Garden Protection Act and my question to you is -- are there -- are there any criminal penalties that are -- are added in this bill? Is there any language that -- creates any criminal penalties? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

I was just wondering if there was anything in there that specifically addressed this problem I'm having with these pesky squirrels? They like to eat just one bite out of a tomato and then they move on to the next one. And I was wondering if there's any penalties that might help address that situation for them.

Senator Koehler. SENATOR KOEHLER:

For fear of running afoul of Senator Holmes, we did not include anything about squirrels in this bill. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Martwick.

SENATOR MARTWICK:

Thank you, Mr. President. And thank you, Senator Koehler for bringing this bill. I hope you'll consider some trailer legislation to help that. I -- I'd encourage an Aye vote. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Glowiak, for what purpose you seek recognition? SENATOR GLOWIAK:

To the bill. PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

So the hoop house structure that was on my constituent's lawn, back lawn, there are many other similar structures in this same town that were not required to be removed. And so, this just simply standardizes what can be put in someone's yard as opposed to cherry-picking what could be and what could not be allowed in someone's yard. Very similar structures were all over in other -- other people's yards. So, this merely standardizes it. The ordinances could be enforced on what could be put on people's property. And I really do want support of this bill. Thank you. PRESIDING OFFICER: (SENATOR MUÑOZ)

Further discussion? Senator Koehler, to close. SENATOR KOEHLER:

This is not my first bill, but I appreciate all the discussion about this. My tomatoes go in the ground right after Mother's Day. I appreciate an Aye vote.

Senate Bill 170, having received the required constitutional majority, is declared passed. Keep in mind Ladies and Gentlemen, we still have a long day ahead of us. Senate Bill 208. Senator Martwick. Mr. Secretary, read the bill.

SECRETARY ANDERSON:

Senate Bill 208.

(Secretary reads title of bill) 3rd Reading of the bill. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Martwick.

SENATOR MARTWICK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 208 is the initiative of the Treasurer's Office. It expands the Secure Choice Savings Program Act to include employers with five or more employees, allows the Secure Choice Savings Board to establish automatic contribution increases of up to ten percent of the employees' wage as part of the default savings option, and clarifies that penalties are applicable for full years of noncompliance instead of partial years. For the employers who become

subject to this Act pursuant to SB 208, enrollment deadlines for those between twenty-five and fifteen employees shall be no sooner than September 1, 2022. And the enrollment deadline for employers with five to fifteen employers {sic} shall be no sooner than September 1, 2023. So, Ladies and Gentlemen, this bill is an expansion of what the Treasurer did a few years ago when he established Secure Choice and -- and what that is to create good retirement savings options for people whose employers do not offer that. A few years ago that was established at twenty-five or more employees. We're seeking to expand that to make sure that -- that the vast majority of our employees that are out there who are working for employers that do not have in-house retirement savings have that same access that we need. This is best practices. This is the right thing to do for the people who are working, to give them those options. It is the right thing to do for our State and for our economy, as we ensure that people have retirement savings as they reach their golden years and do not have to rely on -- on future budgets to get through in their golden years. Now, I -- I would just note that with the amendment and with -- we did an amendment on this bill and we negotiated very -- in very good faith with the business community and such the vast majority of the business community has been removed as opposition to this bill including - so, the Illinois Chamber of Commerce is no longer an opponent to this bill. The Illinois Manufacturers' Association, the Illinois Retail Merchants Association are no longer opponents to this bill. That -- that does not mean that there is no opposition, but I would suggest that it is a very small percentage of the business community because this is the right thing to do. And -- and -- and I think the vast majority of the business

community acknowledges that. I ask for a -- a favorable vote and I'll be happy to answer any questions. PRESIDING OFFICER: (SENATOR MUÑOZ)

Any discussion? Senator Stoller, what purpose do you seek recognition?

SENATOR STOLLER:

Thank you, Mr. President. To the bill. PRESIDING OFFICER: (SENATOR MUÑOZ)

...bill, Senator. SENATOR STOLLER:

Yeah. Thank you. I really like the concept of the Secure Choice Program. I think it's a good program. And I like the idea of encouraging people to save for retirement. I also appreciate this sponsor's willingness to negotiate and exempt the smallest of businesses. That was a great change and I -- it's appreciated. It did remove some opposition, but not all. NFIB is still opposed. And my concern is that it imposes a mandate on the small businesses. It's not optional for the businesses to participate. The employee can opt out but the business cannot. And it imposes penalties for non-compliance. For that reason, I'll be a No vote and I encourage a No vote.

PRESIDING OFFICER: (SENATOR MUÑOZ)

There being no further discussion, the question is, shall Senate Bill 208 pass. All those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Senator --Senator Harris. Senator Harris. Senator Lightford. SENATOR LIGHTFORD:

Senate Bill 208, having received the required constitutional majority, is declared passed. Senate Bill 251. Senator Koehler. Mr. Secretary, read the bill. SECRETARY ANDERSON:

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

Thank you, Mr. President and Members of the Senate. I'm going to read just right from the bill, itself, because I think it makes it very clear what this bill does. It says, "No managed care contract shall provide for a level of reimbursement lower than the fee-for-service rate in effect for the facility at the time service

is rendered." That's the actual language of the bill. What this does is it prohibits any managed care contracts from providing a level of reimbursements for nursing home lower than that fee-forservice level. I'd like to think this is a kind of a peace of mind bill for people who run nursing homes. This is brought to me by HCCI. And I'll just give you some of the rational, the State is seeking to double the nursing home bed tax. Without a rate floor in place, there's no guarantee that facilities will benefit from the increased tax. The latest federal regulations governing Medicare -- Medicaid managed care indicate that States are permitted to establish rate floors, and eighteen other States have adopted such measures. We ask that Illinois join those eighteen other states across the nation to establish a rate of -- a rate floor at the fee-for-service rate at the time the service is rendered. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Any discussion? Senator Syverson, for what purpose do you seek recognition?

SENATOR SYVERSON:

To the bill, Mr. President. PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator. SENATOR SYVERSON:

Thank you. I -- I appreciate the leadership that Senator Koehler has brought to this issue and certainly there's no group that has suffered more over the last year as results of COVID than long term care. And I understand what he is trying to achieve by giving them that assurance during these very difficult financial times - that they be assured that there's a floor there. Having

said that, the Department has committed to making sure that that floor stays there. And so, it kind of puts us into a quandary with this -- with this issue. That being said, again, I understand what the -- what the sponsor is trying to do, and I think the Members on our side it -- it probably makes sense as a way to get some assurance for those long-term care facilities that -- that they will be paid at that floor rate. It is something though that the Department does oppose and they have concerns that it sets a precedent that could affect other contracts throughout the State. So, I just wanted to share some of those thoughts. And, again, Senator, thank you for the time you took to work through this and explain it through committee where there was an open process for everyone to discuss the issue. Thank you, Mr. President. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Gillespie, for what purpose do you seek recognition? SENATOR GILLESPIE:

To the -- question for the sponsor. PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates he will yield. SENATOR GILLESPIE:

Senator Koehler, this bill is only for the nursing home industry, right? It does not apply to any other Medicaid vendor? Doesn't offer the same protection to anybody else? PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler.

SENATOR KOEHLER:

Yes, that is correct. PRESIDING OFFICER: (SENATOR MUÑOZ) Senator Gillespie.

SENATOR GILLESPIE:

Thank you. And then secondly, does the provision impact the ability to do incentive-type arrangements that could result in a rate dipping below fee-for-service while overall compensation would still be above fee-for-service?

Yes. Thank you for that question. My opinion is, no, it doesn't.

To the bill, please. PRESIDING OFFICER: (SENATOR MUÑOZ)

SENATOR GILLESPIE:

This is, you know, this is an, definitely a topic that's worthy of discussion whether the Medicaid program should include that kind of a protection for the overall program. But picking it

apart industry by industry is going to result in a -- a lot of ad hoc legislation that could impact the overall Medicaid program. So, while I appreciate what the sponsor is doing in trying to ensure that we have a stabilized industry under Medicaid, I do think it's important to look at it from a programmatic perspective rather than doing it on an industry-by-industry basis. And would ask everybody to consider that in their vote. Thank you. PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Koehler, to close. SENATOR KOEHLER:

Thank you, Mr. President. I think this is an important piece of legislation. I think it's a necessary piece of legislation. So I'd appreciate a support on this. Thank you. PRESIDING OFFICER: (SENATOR MUÑOZ)

It would be a cost to DHS, because they're doing the grant program.

And according to the Pancreatic Cancer Action Network, Pancreatic Cancer is one of the deadliest cancers with the lowest -- lowest five rates -- survival rate at

Currently, no federal permit exists. So, under this bill - I'm sorry, I'm being distracted by these voices behind me - under -- under this bill, it would eliminate that potential loophole that would allow coal

It's a chronic problem in my community and I'm sure in many of your communities as well. This bill basically does three things: it helps municipalities intervene and save these

abandoned properties earlier, allows municipalities and counties to partner with land banks to maintain and manage these properties so they can be saved, and the third major provision reduces the cap on interest rates on unpaid property taxes to twelve percent which is aligned with other government penalties. It includes offenses included in Article 9 of the Criminal Code as those eligible for license suspensions including homicide. Requires school boards to notify TRS when an employee has been convicted of crimes defined in Section 16-106 of the Pension Code. Requires additional information to be submitted to the State Superintendent for violations of contractual continued service. This legislation passed out of committee unanimously.
