Yes, this -- with our amendment, we also are asking that when a child victim is under eighteen years of age at the time of the offense, that the court can exclude -- witnesses from the proceedings while the child victim is testifying, regardless of the alleged victims age at the time of the victim's courtroom testimony. All persons, who in the opinion of the court, do not have a direct interest in the case, of course, except the media. This comes to us on behalf of the McClean County States Attorney's Office where they had a couple of cases in which the minor had to testify, and in some cases, the minor did not want to testify because they were afraid to do it in front of people that were inside the courtroom.

To have the ability to clear the courtroom, except for media, which I understand the bill allows, as it should. Gives a little bit of peace of mind to these brave witnesses. And so, I just wanted -- I wanted to ask my side of the aisle to make sure that we support this bill. This is very important to make sure that these juvenile witnesses get a chance

I assume, probably, you get airports using it as well, but for ag we always use it, it's always delivered to the farm and then they -- they put it out on the farm. So, I want to make sure we're not cutting out that entire supply chain that delivers the fuel to the farm. I'm not trying to be opposed to the bill here. I just want to make sure I'm not making a huge mistake for my constituents.

Senator Villivalam.

SENATOR VILLIVALAM:

We're not cutting them out at all. We just want them to be licensed, as well.

I -- okay, so -- so, I get back to the first question. If they're not licensed, how are they selling it already?

Senator, we -- we believe they should be licensed and regulated like the -- like the other distributors that are doing it properly and that's the intent of this legislation. It's not

To the bill and I appreciate the sponsor. I think there's just too much confusion. If they're delivering the fuel today and there hasn't been an issue, then I don't know what we're solving. On the other hand, if they're required to be licensed anyway, then what are we doing here? And I need to know more before I vote for this. I would encourage anybody on both sides, who represents downstate, to -- to take a second look at this before they vote Yes. Thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any discussion? Seeing none, the question... Ope, I'm sorry, Senator Plummer, I did not see your light on. Did you.... For what purpose do you seek recognition?

SENATOR PLUMMER:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR HOLMES)

Sponsor indicates he'll yield.

SENATOR PLUMMER:

Senator, just a -- a quick question for clarification. When I was reviewing this, I may have misunderstood you. But I thought you said that this requires the Department to collect this data. And on my summary here, it -- it says it repeals the provision that requires the Department to collect the data. So, I'm just -- I'm just clarifying whether it's mandating they collect the data or it's repealing that they collect the data.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Belt.

SENATOR BELT:

Senator, great -- great question. What this does, it repeals the current version which requires them to only collect racial and ethnic data in lieu of the latest, that requires them to collect much more, much broad, much more comprehensive than the racial and ethnic demographic. So, it replaces an outdated version with the latest version and puts it in line with the rest of the State agencies in terms of data collection.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Plummer.

SENATOR PLUMMER:

Thank you for the clarification.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any further discussion? Senator Belt, would you like to close?

SENATOR BELT:

Madam President, as stated before, I just would like a favorable roll call, thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

The question is, shall Senate Bill 4001 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 Ayes, 0 voting Nay, and 0 voting Present. Senate Bill 4001, having received the required constitutional majority, is declared passed. Senate Bill 4020, Senator Hunter. She indicates she'd like to proceed. Mr. Secretary, read the bill, please.

SECRETARY ANDERSON:

Senate Bill 4020.

Thank you very much, Madam President. Senate Bill 4020 requires the Department of Lottery to offer special -- a special instant scratch off lottery game for the United Negro College Fund to support educational scholarships for college students. And that revenue from the scratch off game will be deposited into the United Negro College Fund -- Scholarship Fund and will be overseen by the United Negro College Fund -- Scholarship Fund Advisory Board. This -- this bill passed unanimously in Executive Committee and it also passed this Chamber last year. I -- I know of no opposition and I would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any discussion? Seeing none, the question is, shall Senate Bill 4020 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 50 Ayes, 0 Nays, 0 voting Present. Senate Bill 4020, having received the required constitutional majority, is declared passed. Senate Bill 4024, Senator Villa. Would you like to proceed? She indicates she would. Mr. Secretary, read the bill, please.

SECRETARY ANDERSON:

Senate Bill 4024 -- 4024.

(Secretary reads title of bill)

SENATOR VILLA:

Thank you, Madam President. Senate Bill 4024 which is an initiative of the Illinois Department of Aging and the long — the State Long Term Care Ombudsmen, is to help older adults and adults with disabilities more easily access the long-term care services that they need. The goal of this initiative is to clarify language on the Department's website in order to help residents and their caregivers more easily identify the Consumer Choice search tool. I know of no opposition and I urge an Aye vote.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any discussion? Seeing none, the question is, shall Senate Bill 4024 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 Ayes, 0 Nays, and 0 voting Present. Senate Bill 4024, having received the required constitutional majority, is declared passed. Mr. -- Mr. Secretary, Resolutions.

SECRETARY ANDERSON:

Senate Joint Resolution 48, offered by President Harmon. It is substantive, Madam President.

PRESIDING OFFICER: (SENATOR HOLMES)

With leave of the Body, we're going to go to Senate Bill 4025. Senator Crowe. Indicates she'd like to proceed. Mr. Secretary, read the bill.

SECRETARY ANDERSON:

Senate Bill 4025.

(Secretary reads title of bill)

SENATOR CROWE:

Thank you, Madam President. Senate Bill 4025 is an initiative of the Department of Human Services. It amends the reporting process for the Illinois Department of Human Service's Managed Healthcare Worker Registry by allowing the Inspector General to request a stipulated disposition of the investigative report. This will allow more discretion in reporting individuals who've been found to engaged in misconduct into the Registry. I know of no opposition and I ask for an Aye vote.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any discussion? Seeing none, the question is, shall Senate Bill 4025 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 Ayes, 0 Nays, and 0 voting Present. Senate Bill 4025, having received the required constitutional majority, is declared passed. Senator Belt, would you like Senate Bill 4056? He indicates he would like to proceed. Mr. Secretary, read the bill.

SECRETARY ANDERSON:

Senate Bill 4056.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Belt.

SENATOR BELT:

Thank you, Madam President. Senate Bill 4056 is an initiative of ISBE, it's technical cleanup language. As amended, makes multiple changes to the School Code, other provisions concerning school and school district operations by making technical changes and deleting outdated and obsolete language. Madam President, I know of no opposition and I would ask for all favorable votes.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Rezin, for what reason do you seek recognition? SENATOR REZIN:

Thank you, Madam President. Question for the sponsor, please. PRESIDING OFFICER: (SENATOR HOLMES)

Sponsor indicates he'll yield.

SENATOR REZIN:

Thank you, Madam President. Senator, could you tell us - it is a cleanup bill, we just want to make sure that in your cleanup bill, is there any change to the Evidence-Based Funding formula? PRESIDING OFFICER: (SENATOR HOLMES)

Senator Belt.

SENATOR BELT:

No -- no, not at all.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Rezin did you have...

SENATOR REZIN:

For an Aye vote on this bill. Thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Belt.

SENATOR BELT:

Ask for all Aye votes.

PRESIDING OFFICER: (SENATOR HOLMES)

PRESIDING OFFICER: (SENATOR HOLMES)

On Supplemental Calendar No. 1 is the Order of Resolutions. This is final action. Senate Joint Resolution 48. President Harmon, do you wish to proceed? He indicates he does. Mr. Secretary, read the resolution.

SECRETARY ANDERSON:

Senate Joint Resolution 48, offered by President Harmon. PRESIDING OFFICER: (SENATOR HOLMES)

SENATOR HARMON:

Thank you, Madam President, Ladies and Gentlemen of the Senate. Senate Joint Resolution 48 represents the conclusion of a process that began more than seven months ago with the resignation of the Legislative Inspector General, Carol Pope. Her -- through her graciousness she extended the retirement date several times, but the Office has now been vacant for two weeks and we've learned from past experience that the -- a vacancy in that office should be filled very quickly. The Legislative Ethics Commission has been deadlocked for four months now. So, today I filed this resolution appointing former federal Judge McCuskey to serve as the Legislative Inspector General. He has a stellar resume - an incredibly well qualified candidate - having served on both the federal and State court benches, having served - appointed by a Democratic President, confirmed by a Republican Senate. I know that the Members of our caucus who know the Judge think incredibly highly of him, and I stand behind his credentials. I'm happy to answer any questions you may have to the best of my ability.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there any discussion? Senator -- ope! Senator Tracy, for what reason do you seek recognition?

SENATOR TRACY:

Questions of the sponsor, please, Madam Chairman -- President.

PRESIDING OFFICER: (SENATOR HOLMES)

Sponsor indicates he'll yield.

SENATOR TRACY:

President Harmon, can you point me to the statutory authority for this resolution?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Would you bear with me for one moment while I consult counsel? Thank you -- thank you, Madam President. Thank you, Senator, for your indulgence. If you refer to 5 ILCS (430) Section 25-10 paragraph b, "The Legislative Inspector General shall be appointed by a joint resolution of the Senate and the House of Representatives". Continues from there.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

Thank you, and going above that, does it have a process for how we get to a recommendation or a resolution being made?

PRESIDING OFFICER: (SENATOR HOLMES)

President Harmon.

SENATOR HARMON:

Thank you, Madam President. I -- I believe you're referring to the process in the first full paragraph of Section B. I -- I recognize that, but I do not think it places a limitation on the operative sentence that I read.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

And what does that Section say that you're referring to?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

"The Legislative Inspector General shall be appointed without regard to political affiliation and solely on the basis of integrity and demonstrated ability." I'd argue that our appointment clearly satisfies that. "The Legislative Ethics Commission shall diligently search out qualified candidates for the Legislative Inspector General and shall make recommendations to the General Assembly." The Legislative Ethics Commission, despite the fine work of some of its members, has failed for four months to advance candidates to the General Assembly for consideration. And so, we are moving forward today with our resolution.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

Has the candidate that you're proposing in your resolution gone before a search committee as pro -- as -- as provided for in this statute under 25-10 (b-5)?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

-- Thank you, Senator. The -- I believe you are referring to the -- the search committee provisions where four members appointed by the four legislative leaders who then advance recommendations to the Legislative Ethics Commission. I do not believe Judge McCuskey has, but again, I don't think that impedes our ability, by resolution, to name him the next Inspector General.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

But taken as a whole, this legislation that we put into law, I believe it was in 2017 in Veto Session, I -- the legislative intent, do you believe, was that we follow the process outlined by having a search committee seek applications, the search of committee be convened, take applications, interview and then recommend up to two -- three candidates for the Legislative Ethics Commission to interview and proceed.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Thank you, Senator, for that. I -- I would point out that -- that process, however well-intentioned, has failed with four members of the Legislative Ethics Commission consistently refusing to advance candidates to the Floor. And in a note of irony, that law was adopted to prevent a long-standing vacancy in the Office of Inspector General. The defect we are seeking to cure here today, before the two-week vacancy becomes a two-month vacancy.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

But do you agree that we're ignoring the legislative intent of what this legislation was done? In fact, I would ask further, have you ever known that we have not observed the legislative intent of this law since it was put in place?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Senator, there's only been one appointment since it's been put in place, and I would say that the deadlock at the Ethics Commission flies in the face of the intent of this. The Ethics Commission could have advanced multiple candidates. The search committee could have advanced three candidates at the front end. There have been many deviations in this process, well before this resolution was filed in the Senate. We're seeking to remedy those and move forward with a very well qualified Legislative Inspector General.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

Are you aware that the candidate that -- that there was only one candidate recommended by the search committee that was put forth as highly recommended to be placed in this candidate position?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

I'm aware that the search committee is authorized to advance three candidates for the consideration of the Ethics Commission and perhaps put its thumb on the scale in tilting the -- the recommendation in one direction and not giving the Ethics Commission the full authority that it has to consider multiple candidates from the search committee.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

Are you aware that the scenario you just gave me isn't

following this procedure that set out as what the search committee shall do?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

I'm sorry, Senator, I didn't understand the question.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

I'll repeat it. I believe as I heard from you, that the search committee can recommend up to three names, in this instance, they recommended up to two, and are you aware that -- now you've made me forget -- sorry, President. If we were in court, I could have the reporter read it back. What I'm asking is, is are you aware that the candidates that were vetted, one of them was not recommended by the search committee. When I say vetted, I mean, vetted within the Legislative Ethics Commission because, there again, we did interview one candidate, highly qualified, but not recommended by the search committee. Were you aware that one was recommended, and one was not, and that's what's led to this impasse?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, I'm not aware of all of the ins and outs and hiccups that occurred in the Legislative Ethics Commission, and I want to refrain from doing much of a postmortem for the sake of the reputation of the members who were considered. I think that they had a -- alarmingly bad experience

going through that process, and some of the things they were subjected to. I know that the search committee could have, under the statute, advanced three candidates, but chose not to for whatever reason. I understand that there were -- I'm going to refrain from -- suggesting any motives on behalf of the committee. I'm aware that the Legislative Ethics Commission had to ask for the third candidate because they weren't satisfied with the -- the two candidates presented. But there have been far too many hiccups. Again, the irony is this process is intended to avoid the very situation we have. A protracted vacancy in the Office, the important Office, of the Legislative Inspector General. We seek to remedy that with an incredibly well qualified candidate and one I hope will get unanimous support from the Senate.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Tracy.

SENATOR TRACY:

Thank you, Madam President, may I speak to the bill please?
PRESIDING OFFICER: (SENATOR HOLMES)

To the bill.

SENATOR TRACY:

The Legislative Ethics Commission was established back in 2003, and since then, we've had Legislative Inspector General Tom Homer, who I worked with. We've had an interim acting one that was - came about after it was discovered that we had a -- a gap and that we had no Legislative Inspector General, and that all efforts to replace that person were thwarted and we learned that we had complaints, sexual harassment complaints, and the like, that were sitting without redress. And it was a horrible blight on the reputation of the General Assembly, as it should be. So we

did this reform legislation. We tried to make things more apparent -- transparent to the public because the Legislative Ethics Commission meets in confidentiality. The confidentiality is what we -- we meet about as far as reports and complaints, because we recognize it's a very sensitive nature that -- complaints can be made and very often they're unfounded and it could tarnish a person's reputation. And we, as legislators, of course, are sensitive to that, and that is confidential. However, we report how many reports are -- are reported, how many the Attorney General took under consideration. If you go the website, which we created after all of this in 2017, we tried to be transparent to the public. We enacted the statute. We had an acting Legislative Inspector General, that was Julie Porter. I worked with her too. Then we went through the search application process and Legislative Inspector General Carol Pope joined us by unanimous consent of the General Assembly. And that process worked, and we were more transparent. However, it became all too apparent that ethics wasn't -- reform wasn't finished. All of these Inspector Generals, three of them, pointed out severe flaws in our process. We enacted another legislative ethics reform, last session. Again, when it didn't go far enough, Legislator Inspector Pope resigned with a letter, July 15th, that was going to be effective December 15th. Now, I have given it a lot of reflection, and no one likes to air dirty laundry in public, especially the General Assembly, we have enough dirty laundry that's private and then made public. But in full transparency, we are not required under statute to be confidential about the process of how we select the Legislative Inspector General. And we have a search committee and we take applications, and let me run through how this application process

worked. July 15th, we found out that Legislative Inspector Pope was done with us. She said ethics aren't -- you all aren't -what did she call us - a paper tiger, we aren't really sincere about our efforts to address ethics reform under this Dome. So she gave us till December 15th, and knowing that the next time we would be in Session would be Veto Session, I and the Commission set forth to -- to ask the leaders to get a search committee in place. I felt it was utmost importance because to me this is one of the highest priorities is making sure that the public is reassured that we are trying to be better at ethics and we don't want to police ourselves. We want to have an independent Legislative Inspector General. So, I asked the leaders to make the appointments for the search committee, and I really had to remind and remind certain leaders under this Dome to get me names for a search committee, so that we could proceed in Veto Session. And we were past the thirty-day deadline and I still was reminding certain leaders, and finally, I got the names of the search committee, and I got to tell you, I -- I highly recommend -commend them for their efforts. They're busy, busy, very busy individuals who set about diligently and promptly interviewing candidates and then they made two recommendations of highly qualified individuals. And then the LEC met during Veto Session. However, we could not come to a consensus. We interviewed a candidate that was not recommended by the search committee. They interviewed that person, but did not think this person could be elevated to the extent that they would be recommended. And again, all highly qualified, and the search committee is in place because, to me, I call them a citizen advisory group. They're the eyes of the public on this process. We're not hiring and vetting our own

Legislative Inspector General. We're putting four citizens out there to vet and look at certain qualifications. And -- and so yes, we were at an impasse because the republicans of the Commission, and this is one of the few bipartisan commissions under this Dome, it's equal, 4-4 members. The republicans wanted to value and observe the process, the legal technical statute, the way it's always proceeded, and we wanted to go with the -- the search committee. Because why have a search committee? What purpose is it that we put the search committee in this statute if it's not to be the one that make the recommendation? Not us, the legislative Body. So, this didn't happen in Veto. We were still at an impasse in December. Yes, it's very unfortunate that all this has been aired but -- the truth has to be told. If we value ethics, we've got to follow statutes and procedures. interviewed today, a highly qualified individual that I believe is -- Judge Michael McCluskey {sic} (McCuskey) and it was very interesting in interviewing Judge -- McCuskey, a -- a wonderful engaging individual with a very esteemed career. He said, "You should name me as Acting Inspector General because I haven't been vetted by the search committee." And I said, "Well would you be" -- I mean he was open to being vetted by the search committee. And he said, "No, no you'd have to do the application process for everybody. That's what's in the statute." This Judge, that you're wanting to recommend, knows the statute. I think he's highly qualified but he knows you've got to follow the process! The law! To the nth degree, because he said, the -- the -- "You have to go back and open the application process to be proper under consideration of this statute." He'd read the statutes. He had them in front of him, as I do now. And so, if we want to keep

making attempts at being ethical, this gentleman should be Acting Inspector General until, as he said, "I'm vetted." Has an FBI check, he's gone through those before obviously, but they are current but that's what we usually do. This gentleman has them but name him Acting Inspector General and then you've got to open the search or the application process. I have to be vetted by the search committee, maybe they'll choose me, maybe they won't and that's how the process is supposed to be in law. So, I don't know why the majority party continually wants to review process and procedure, but apparently, they do. So I'm asking that you be -we be a No vote. You be a No vote if you value ethics under this Dome and that we get transparent about being ethical, about letting the public have a say and not the legislative -- Body choosing their own Inspector General to police them. Then vote Yes. But I believe we should vote No and go about the process as this gentleman knows, as we know, it should be. And with that, I will conclude my remarks, thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

Mark Maxwell with WCIA requests permission to record the proceedings. Seeing no objection, leave is granted, and also Andrew Adams with SJR requests permission to photograph the proceedings. President Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. I know that speech was not in the form of a question, but for the record I want to correct two things. First of all, the search committee advanced three qualified candidates, recommended by the search committee. Two initially, the third under the statute in response to the request of the Legislative Ethics Commission. Since Senator Tracy was so

candid about sharing the back and forth within the Ethics Commission, it is my belief that democrats offered to vote and did vote in favor of sending two candidates to the General Assembly for our consideration. Nothing that we are doing today, nothing that the Commission has done so far, contravenes the statute. A deadlock at the Ethics Commission leads to a protracted vacancy in an important office. We're seeking to remedy that today. I hope you will vote Aye. That is not my closing, Madam President, but I wanted to make sure the record corrected those misstatements.

PRESIDING OFFICER: (SENATOR HOLMES)

Is there further discussion? Senator Barickman, for what reason do you seek recognition?

SENATOR BARICKMAN:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR HOLMES)

Sponsor indicates he'll yield.

SENATOR BARICKMAN:

Thank you, Madam President. Mr. President, I -- I listened to the exchange that you had with Senator Tracy, and a lot of the exchange was about the process. And I -- I guess just to start off our exchange, I want to lay a framework for why we think the process is important. This Chamber, like the Chamber across the hall in the House, has seen numerous instances where our Members, and former Members, have been subjected to public scrutiny, embarrassed, brought in for criminal activity and otherwise, that has led to a cloud of suspicion in the public about whether or not we, the Members of this Body, can in fact, police ourselves adequately. And the public has concluded, with no uncertain terms, that we are ineligible to police ourselves and therefore should

have an independent authority who helps guard the hen house. This Body put this -- the statute together that sets forth a process, not for our benefit, but for the public's benefit. I think the irony of the candidate that's before us, Mr. -- McCuskey, is that I know him. I know Judge McCuskey. But this isn't about Jason Barickman, it's about my constituents and their need to know that we're selecting an individual who adheres to the utmost in ethical considerations and can be that independent Inspector General that the public needs him to be. And so, this Body put forth a law that said the manner in which we're going to scrutinize these candidates includes a number of steps. And my colleague, Senator Tracy, I think, has very appropriately raised questions about why that process is being circumvented here. And what it tells to the public when the process is avoided. And so, I want to -- I want to ask I -- I suspect, Mr. President, I hope that you share with this side of the aisle the desire to prove to the people of this State that we truly want an independent Inspector General. And if you share with us that view, I would question why we don't put Mr. McCuskey through the process designed to show the public that he is, in fact, independent and worthy of this position. So, let me ask of you Mr. President, did Mr. McCuskey go through the search committee process and was he interviewed in person?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you -- thank you, Madam President. Thank you, Senator. I -- I would go so far as to say the entirety of this conversation today is about process, because there is no substance for you to debate. There is no doubt that the candidate is extraordinarily

well qualified and will do an excellent job as an independent Legislative Inspector General. Your question, I think, is whether or not he appeared before the four-member search committee with one member appointed by each of the four Legislative Leaders, that independent process. He did not. He was interviewed by the Legislative Ethics Commission, I think, under the circumstances as the other candidates were interviewed. I don't -- I think they all were interviewed via a remote process. I'm looking at what the Member of the Commission on our caucus -- so, he was interview by the Ethics Commission in the same way. But I would also point out there is nothing in the statute that says the Legislative Ethics Commission is limited to advancing a name that was advanced by the search committee. Similarly, there's nothing in the statute that says the General Assembly is limited to appointments referred by the Legislative Ethics Commission. are dealing with a fundamental breakdown in that process. want to focus on process. The process has resulted in deadlock vote after deadlock vote, and no Inspector General. So, if you were serious about ethics, you would vote with us to confirm Judge McCuskey.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Okay, so as I understand it, Mr. President, there was a search committee process for which Mr. McCuskey did not go through, but your response is that Mr. McCuskey did in -- appear before the Legislative Ethics Commission. Would you please share for this Body the questions that were asked of that Commission of Mr. McCuskey, regarding his background and qualifications or questions

maybe that the Commissioners had?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. Senator, as you may know, I'm not a member of the Legislative Ethics Commission. I do not know what questions were asked. I didn't ask what questions were asked. Because I really have no business asking those questions if we're to maintain the independence of this process to the best of our ability.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

I'm told that members of the Commission did not ask Mr. McCuskey any questions. Is that true?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Senator, as I mentioned, I'm not a member of the Ethics Commission. I was not there. I didn't ask if any questions were asked or answered. Again, I'm maintaining a -- a -- an appropriate distance from that process.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

The irony of -- of this, of course, Mr. President, is that while you testified to the -- while you -- while you explained to this Body your belief that Mr. McCuskey is all the things that you said about him, when he actually appeared before the Commission

that may have an opportunity to scrutinize those credentials, it appears that there were actually no questions asked of him. Which again, to the public, will likely appear as though it were a fait accompli. That there was no scrutiny of this individual and may lead the public to ask why not. Why not scrutinize the candidate? I mean, what's your answer to that?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Senator, I'm not sure I understand your hypothetical question.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman, did you have a question?

SENATOR BARICKMAN:

Many of the candidates who went through this search process completed federal background checks. Did Mr. McCuskey complete a federal background check, FBI criminal check, or otherwise?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon, do you have a response?

SENATOR HARMON:

Thank you. I -- I -- I presume Judge McCuskey incurred, not just an FBI background check, but a much more thorough vetting when he appeared before the United States Senate to be confirmed as a federal judge. I don't know if any of the candidates had an FBI background check. I don't know what criteria the search committee or the Legislative Ethics Commission used.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

The numerous candidates who went through this process, in fact, Mr. President, were subjected to federal background checks. Again, the question here would be, why is Mr. McCuskey not treated in such a manner?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Senator, I -- I have to ask how you know so much about what happened at the Legislative Ethics Commission and in the search committee. I don't know. I don't think any of our Members know. I don't think we've received any FBI background checks. So, maybe you can help me answer your question by telling me how it is you know so much.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Sure, I'd be glad to, by the way, I believe I'm asking the questions here, but to your question, Mr. President, given that this is an appointment of the -- what should be an independent Legislative Inspector General, I questioned my colleague, Senator Tracy, as to what diligence was done by the Ethics Commission in the candidates that appeared before them. I have learned that many of those candidates, in fact, had a criminal background check done in order for the Commission to determine whether or not there was something in their background that might be telling to the Commission in making the recommendation to us. I then learned that Mr. McCuskey did not have such a background check and I'm asking you, Mr. President, because it's your resolution, why in fact that breach of practice occurred. So, my question again would

be, why are you treating this candidate different from the other candidates who applied for this position?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, I've consulted through counsel with a Member of our Caucus appointed to the Legislative Ethics Commission, who tells me that she is not aware of any FBI background checks having been performed. I -- I don't know if the Republican caucus authorized these background checks, or someone else. I really don't know how to answer your question. You -- you seem to have insight and information to which I have not been made privy.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

You, Mr. President, are the one who have presented that you believe this candidate has the utmost credentials. The Legislative Ethics Commission performed the background checks on the other candidates. Yet, did not do so in this instance. And so, my question again is, which you've not yet answered, why are you treating this candidate different from those other ones.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. Thank you for your patience. Senator, I -- I'm not entirely sure what background checks you're talking about. I don't think our Members are privy to that. The qualifications for a Legislative Inspector General

are -- could probably be greater than they are. They shall not have been convicted of any felonies, they shall have a BA Degree, and have five or more years of experience in certain agencies, including as a State or federal judge. I think Judge McCuskey clears those by leaps and bounds, and his repetition and his work on behalf of the Supreme Court, and the other commitments he has made, including having been before the Senate before for confirmation as the Chair of the Illinois State University Board. I don't know what more you're looking for.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Does the candidate have to be a lawyer?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Again, the five or more years of experience with federal, State, or local law enforcement agency, as a federal, State or local prosecutor, as a senior manager or executive of federal, State or local agency, as a member, an officer, or State or federal judge or representing any combination of the above. My counsel does not report an absolute requirement that one would be a lawyer. Although many of those previous roles would require one to be a lawyer.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Is -- Mr. McCuskey a lawyer? Is he licensed? Is he...? PRESIDING OFFICER: (SENATOR HOLMES)

SENATOR HARMON:

Senator Barickman, he's a former federal judge and State judge. He is a lawyer. Whether he's licensed or in retirement is unrelated to his ability to serve as Legislative Inspector General. PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Is he licensed or not though?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

We'll confirm that and get back to you, Senator.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

It appears that Mr. McCuskey's law license is in fact, inactive, that he's no longer licensed. I find it interesting that that revelation is being made on the Floor of the Senate in the time before the vote. I think this is an example, Mr. President, contrary to your repeated remarks that, you know, the due diligence has been done. But this is an easy one that you could not answer on the Floor, that one could find out simply by looking on the internet. It's troubling because it begs the question that the public will have of what else did this Body not know before they took a vote and why did this Body not follow the process that it used with other candidates to find out information about those candidates before they took a vote. Mr. President, what have you or your staff done to inquire into the professional

or personal background of Mr. McCuskey?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, I don't know what color Judge McCuskey's eyes are either. But it's not germane to his qualifications for appointment, as is his status as a current or retired lawyer. He's a retired federal judge. He is the ideal candidate and he meets all of the qualifications. We're not going to be looking into things that are unrelated to his qualifications for this office.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

Has there been any inquiry as to whether Mr. McCuskey has -if there's evidence in the public records about things the public
may care about? Right? Citations, bankruptcies, traffic
violations, has -- have you or your staff, Mr. President, looked
into the public records of Mr. McCuskey, to in fact, see what's
there?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Thank you, Senator. We have looked into his judicial record. If you have something that you wish to share with us, I'd be happy to hear it, but I believe his judicial record is exemplary and one that merits his consideration as the Legislative Inspector General.

PRESIDING OFFICER: (SENATOR HOLMES)

SENATOR BARICKMAN:

There is a State board which handles complaints made against members of -- of the judicial branch -- the Judicial Inquiry Board. Did you inquire to the Judicial Inquiry Board as to what records they have regarding Mr. McCuskey?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you -- thank you, Senator. He was appointed by Judge -- Justice Thomas to the Professional Standards Board. I'm -- I'm going to consult with counsel to make sure I have the title correctly and served in that role for many years until just recently. I don't think there's any concern there.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

The Judicial Inquiry Board, again, is a judicial disciplinary system, Mr. President. My question was whether you inquired there as to whether they have any records concerning Mr. McCuskey.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. Senator, do you have something you're eager to share?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

I do, Mr. President. I think this Body would be well served

to do its due diligence on any candidate who it aspires to serve in a role that should be independent of this Body. And I do not understand, Mr. President, why you were unwilling to make those inquiries. As I opened here, I know Mr. McCuskey. This isn't about me, it's about the people of this State who deserve, from this office, confidence that the individual appointed by this Body can do its job to hold us accountable to upholding the utmost ethical standards for the people of this State who elect us to represent them. Why, Mr. President, do you want to avoid that process? I understand the gamesmanship that occurs on this Floor, and the unwillingness to answer questions from time to time. But, you, yourself, put into this Body, this is a retired judge, one appointed to the federal bench, one who served at the State level. So, it makes sense to me that an inquiry should be made to the Judicial Inquiry Board. So that we can find out what, if any records exists regarding his service. Why, Mr. President, don't you want that inquiry to be made before we cast a vote?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, I believe his qualifications speak for themselves. Again, if there's something you think we should know, happy to hear it, but I stand by this resolution and again, the process, the much-wanted process that you are referring to, has failed. It has broken down. It has resulted in a -- a -- a vacancy in the Office of Legislative Inspector General and potentially a protracted one. So, I think everyone, maybe, should look at each other and see where the -- the cause of that breakdown is. We're trying to remedy that.

We're trying to fill this vacancy with a well-qualified candidate and I hope that you'll join us in voting Aye.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Barickman.

SENATOR BARICKMAN:

I just want to take you up on your offer, Mr. President, regarding -- is there anything I would like to share with this Body. Yes. Mr. President, I think this Body would be well served to inquire into the background of this candidate. That's what I have to offer, Mr. President. You seem to be on a path for which you're unwilling to find out the answers to the questions that we're asking. The questions that the process would help to answer. I don't know why you don't want to get those answers, but I think it's telling that you're unwilling to inquire there and find out those answers we have -- before we have a vote. I think, and to the bill, Madam President, or to the resolution, Madam President. PRESIDING OFFICER: (SENATOR HOLMES)

To the resolution.

SENATOR BARICKMAN:

I think it is highly unfortunate that this Body, on this issue, is taking such a callus approach to demonstrating to the public our desire to put forward an independent Inspector General who can hold -- the -- who can hold us accountable to the people we represent. That's all we ask for, Mr. President. We ask to put the candidate through a process that proves to the public that the individual is of the utmost integrity. That it -- that the person has an -- a -- a tremendous ethical record, and that the public can be confident in the job that they're going to do. Possibly, Mr. McCuskey, is the answer to the problem before us,

but the public won't know because you won't allow them to find out. And while that's highly disappointing to this side of the aisle, I think it's just another one of a long list of examples that the public will point to and say that they are doggone fed up with the corruption that exists in this State and the unwillingness of the Illinois General Assembly to do anything about it. I'd urge a No vote, thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McConchie, for what purpose do you seek recognition? SENATOR McCONCHIE:

To the resolution.

PRESIDING OFFICER: (SENATOR HOLMES)

To the resolution.

SENATOR McCONCHIE:

Thank you, Madam President. Thank you, President Harmon for bringing this. We have a public trust problem in this State as it is, and here we're about to have the legislature pick its own watchdog without any citizen oversight. The person responsible for investigating lawmaker misconduct and corruption is about to be hand chosen by the very people that he's supposed to be watching over. It's no wonder that the people of Illinois have lost faith in government, because of the lack of accountability that exists, even in this process, is just solidifies their belief. We have a process in place, in statute, that calls for an independent citizen search committee to review, vet, investigate, and interview candidates and given their informed recommendation to the Legislative Ethics Commission. That statutory process is being completely skirted. A process, I should note, that the candidate himself says is required by law. That a candidate who has been a

federal and State judge says his reading of the law would require It is dumbfounding to me that this Chamber would fast forward through that process, putting their very candidate in a circumstance that he insists he shouldn't be involved in. Republicans have continuously advocated on following the recommendations of the citizen search committee, throughout this process. We have even offered to bring the search committee back, so that they could do their due diligence on Mr. McCuskey, vote to ensure independent oversight and citizen oversight of this process and of him. Do you have that public trust that's necessary? Our simple and reasonable request has been denied. Doing it this way was clearly not in the legislative intent behind the originally. Clearly, the law was designed so we don't have politicians choosing their own Inspector General. With all these scandal, corruption charges, indictments that we have witnessed in recent years, we have a responsibility to the people of Illinois to restore trust in their government. And that begins with accepting a qualified Legislative Inspector General candidate that's gone through the appropriate citizen oversight process. To completely ignore that process set forth in statute, is not simply a disappointment, it's just plain wrong. We can do better than this. Let's do what the candidate, himself, says we must do. We made an offer to make him an Acting Inspector General, and while he goes through that process. That's what he said, he would prefer to do. Until Mr. McCuskey's request is honored, I encourage us all to vote No. Thank you.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Cunningham, for what purpose do you seek recognition? SENATOR CUNNINGHAM:

Thank you, Madam President, I move the previous question. PRESIDING OFFICER: (SENATOR HOLMES)

The previous question has been moved. We have two additional speakers, Senator McClure and Senator Koehler. Go to you Senator McClure, for what purpose do you seek recognition? SENATOR McCLURE:

Questions -- questions, Madam President.

PRESIDING OFFICER: (SENATOR HOLMES)

Sponsor indicates he'll yield.

SENATOR McCLURE:

Thank you, Madam President. President Harmon, do we know what political contributions that this potential Legislative Inspector General has made in the last ten years?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Thank you, Senator. Yes, we do. PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

Has Judge McCuskey donated to any current Members of the General Assembly?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. He has contributed to a few democrats and republicans. One, two, three -- three, I believe.

PRESIDING OFFICER: (SENATOR HOLMES)

SENATOR McCLURE:

Mr. President, can you please name the people he has donated to?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, this is all public record, so I'm happy to share, at least according to our research. In 2019, he contributed to "Friends of Jehan Gordon" and "Friends of Ryan Spain", and in 2020 to "Friends of LaPointe". I do not recognize any others as Members of the General Assembly.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

Thank you, President Harmon. So, in a situation where any of those Members would have an allegation against them that the Legislative Inspector General is to look into, I wouldn't think any of those would ever come up with those people that you just named, what would the Legislative Inspector do? How would they - how would -- how would Judge McCuskey handle the case?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. Senator, maybe you can clarify your question. I think your conflict-of-interest point is in reverse. He did not receive any funds from any of these people. PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

Mr. President, number one, sometimes people make political contributions and they get benefits from those contributions. My question to you is, do we know what benefits that Judge McCuskey may have received and, if so, what is he going to do if anyone of those names appears before him with allegations of misconduct.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Madam President, I would call the prior speaker to Order.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Our rules do suggest we refrain from personalities on the Floor. And Senator, I reject your -- your allegation that anyone receives a benefit for a campaign contribution.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

Thank you, Madam President. I didn't make any allegation, but I can tell you this, President Harmon, we have just seen Members of the General Assembly be convicted of bribery. I'm not making any allegation. I'm simply trying to make sure that we have done everything that we can, so that the people of this State can rest assured that we have an independent Inspector General. And your responses are making it seem as though I'm making allegations. I am not. I'm simply trying to inform the public, and I think these are -- these are valid questions that anybody would have, given what has happened in this Capitol over the last

couple of years.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Senator, what benefits do contributors to your campaign contribution -- your campaign receive?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

You know, President Harmon, I do what I think is right in this building. I represent my constituents. And sometimes people support me afterwards and sometimes they don't. So, you know, and I think that's true for almost all of us, but we have -- a couple Members that have had issues with bribery. I'm -- I'm not making any -- any allegations against anyone. I'm simply pointing out questions that I think the public asks and wants to know.

PRESIDING OFFICER: (SENATOR HOLMES)

President Harmon.

SENATOR HARMON:

Thank you, Madam President. Perhaps we can get Judge McCuskey the same benefit of the doubt and not characterize campaign contributions as bribes.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

Well -- let me get to another point, another subject here. You -- you stated that Judge McCuskey has not had a background check, but you also said that he has no felonies on his record. I guess the question, obvious question is, if there's been no

background check, how do you know that he has no felonies on his record?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator Harmon.

SENATOR HARMON:

Thank -- thank you, Madam President. Are you aware of any felonies on Judge McCuskey's record, Senator?

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

No, and that's why a background check would be in order here. Particularly, since individuals - I'm not - I and I want to be clear when I respond, Mr. -- President Harmon. I'm not making any allegations at all. I'm just trying to make sure we're doing the process that we're supposed to be doing. But anybody who does - has worked in law enforcement or as a prosecutor, knows that the only way to actually know is by doing a deep dive with the help of FBI or with leads. And people have aliases sometimes, people type in things in different states. So, that's just, I mean, that's just common practice. So I -- so the...

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure, was that a question?

SENATOR McCLURE:

Now I have a question, so the question again is how do you know he has no felonies on his record.

PRESIDING OFFICER: (SENATOR HOLMES)

President Harmon.

SENATOR HARMON:

Thank you, Madam President. Senator, apparently the

Republican caucus is aware of background checks that the Democratic caucus is not aware of for any of the candidates. We have searched all of the requisite public databases and have found no indication that Judge McCuskey has any felonies on his record. I don't know that it requires an FBI background check to reach that conclusion. But again, your caucus seems to have much more information than ours does about the process and what was applied to other candidates. I don't know why you have that information, I don't know how you have that information, but you seem to have more than we do.

PRESIDING OFFICER: (SENATOR HOLMES)

Senator McClure.

SENATOR McCLURE:

To -- to the bill, Madam President.

PRESIDING OFFICER: (SENATOR HOLMES)

To the resolution.

SENATOR McCLURE:

Thank -- thank you, to the resolution. And thank you, President Harmon, for answering my questions. You know, this is just troubling. I mean this is really troubling. And, I've got to say that to not follow the process that was laid out by this very Body, is troubling. I -- I don't know how anyone could say anything other than that. I mean, we have people in this Chamber that have been found guilty of federal crimes. Just since I've been here, that has happened. And the fact that this Body does not have a case before it with the due diligence that was necessary to properly vet the candidate. And the fact...

SENATOR McCLURE:

To the resolution, Madam President, thank you. I think anybody that's listening to this debate can see why any reasonable person in this State would have doubts about the process and about the resolution, itself. And for that, Madam President, I do urge a No vote. Thank you.

The final speaker. Leader Koehler. For what reason do you seek recognition?

SENATOR KOEHLER:

I'm not going to speak about process. I'm going to speak about Judge McCuskey. I think I'm correct in stating that I probably know him better than anyone in this room. He's from Central Illinois. I've known him for many, many years. And I trust he's probably listening, and after this kind of a discussion you wonder why good, qualified, honest, decent people like this would even want to subject themselves to this kind of a thing. There is no more ethical or more moral person that I can think of that — for this job than Judge McCuskey. He was ratified by the United States Senate under Republican control back in the 90's when Bill Clinton was President. He received unanimous support out of committee, a unanimous vote on the Senate Floor. He was vetted by more than one FBI agent during that process. He has served well on the federal bench, on the State bench. He is well respected by people of all kinds of political persuasions. You

know, this is a good, decent, honest man, you know. And I will say this as a friend, if I, and I don't intend to do this, but if I were to ever go astray and have - do things that are ethically not consistent with this Body, Judge McCuskey would not hesitate but to hold me accountable for that. I say that as a friend. And so, all the discussions we've heard about what if and what if and that, we are so darn lucky in this Chamber and in -- in this State to have people like him that are willing to step forward. And again, all of us be warned, this is not somebody that's going to look the other way. He is going to look and tell you exactly what he sees. Just like he told the committee, you know, this is a good, and decent, and honest man and I think we should vote Yes. PRESIDING OFFICER: (SENATOR HOLMES)

Senate -- Senate President Harmon, would you like to close? SENATOR HARMON:

Thank -- thank you, Madam President, Ladies and Gentlemen of the Senate. First, one of the prior speakers raised this sinister possibility that Judge McCuskey had something on his record at the Judicial Inquiry Board. We've updated our review of those materials and there is no founded complaint against him. I would point out also, anything shy of that is constitutionally sealed. So, Senator, you can rest assured that we have checked him with the JIB and there is nothing to be concerned about. So, we'll take that stain off his record. This -- this -- this debate took an unfortunate turn. So, I'm not going to bite my tongue. You know what I find offensive? The Republican Members of the Legislative Ethics Commission saying, if we don't get to pick our handpicked Inspector General, then nobody gets to pick an Inspector General. If we don't get to advance on the veteran of the Rauner

Administration with a deep partisan streak, then you can't have an Inspector General. The reason we passed these laws, is to make sure there is no gap in the Office of the Inspector General. I have lived through that. We don't want to do that we want a well-qualified Legislative Inspector General. Judge McCuskey fills the bill. I dare you to vote No.

PRESIDING OFFICER: (SENATOR HOLMES)

Order. Order. Pursuant to the provisions of the Senate Officials and Employees Ethics Act, a resolution appointing a Legislative Inspector General requires a three-fifths vote of each Chamber. The question is, shall Senate Joint Resolution 48 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 37 Ayes, 17 Nays, and 1 voting Present. Senate Joint Resolution 48, having received the required statutory majority, is declared adopted. Mr. Secretary, Resolutions.

SECRETARY ANDERSON:

Senate Joint Resolution 49, -- offered by Senator Villanueva. It is substantive, Madam President.
