- 13. more...more qualifying examinations in order to remain in
- 14. employment of the board. Also it repeals a requirement that
- 15. the Department of Personnel exams designed to qualify persons
- 16. for work in the areas of public disclosure and elections
- 17. administration be germane to such areas. The purpose of this
- 18. amendment then, Senator, was that these people have already
- 19. taking two or three examinations, depending on the person,
- 20. already for this position and now again they are being asked,
- 21. again, to take examinations to qualify him. So it's the grand-
- 22. father clause and it does state that those who have already been
- 23. certified under a merit plan adopted by the board be allowed to
- 24. continue work.
