

- 9. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 10. Is...is it Senator Bloom's amendment? Senator Bloom,
- 11. is this you amendment?
- 12. SENATOR BLOOM:
- 13. Yes.
- 14. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 15. Senator Bloom moves to adopt...to Table Amendment No.
- 16. 2 and Senator Vadalabene moves to...that that lie up on the Table,
- 17. Senator Davidson.
- 18. SENATOR DAVIDSON:
- 19. Well, in...in committee, the amendment was offered by
- 20. Senator Vadalabene. It was moved by Senator Bloom, was it not
- 21. or was it offered by Senator Bloom? I'm...I'm hazy from the
- 22. meeting last week, but I'd like to know where we're coming
- 23. from.
- 24. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 25. Senator Vadalabene.
- 26. SENATOR VADALABENE:
- 27. Yes, so to clear up the...the cloud in regard to this,
- 28. Senator Davidson. I'm not a member of that committee so we
- 29. had Senator Bloom offer the...the amendment and I explained

- 29. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 30. Senator...Senator Bloom. Senator Davidson, for what
- 31. purpose do you arise?
- 32. SENATOR DAVIDSON:
- 33. Parliamentarian inquiry, please. On a committee...

- 3. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- The negative roll call has been verified. On that

- 7. Is there any motion from the Body? Senator Savickas.
- 8. SENATOR SAVICKAS:

- 32. Senator Davidson, for what purpose do you arise?
- 33. SENATOR DAVIDSON:

- 30. 27.
- 31. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 32. All in favor say Aye. Opposed Nay. The resolution
- 33. is Tabled. Senator Hickey, for what purpose do you arise?

- SENATOR HICKEY:
- Mr. President, I want...wish to make an announcement.
- 3. The Senate Committee on Higher Education will not meet at
- seven-thirty this evening in Room 400 as scheduled, but
- 5. will meet at 5:00 p.m. this afternoon in Room 400.
- 6. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 7. Senator Graham, for what purpose do you arise?
- 8. SENATOR GRAHAM:
- 9. I was checking to see if your left eye was any good.
- 10. I'd like to have the attention of the Body in particularly
- 11. ... Senator Netsch. I talked to her this morning regarding
- 12. House Bill 1685, which is scheduled in her committee
- 13. tomorrow. It's Representative Ewell's bill, which is...
- 14. is identical to our Senate Bill 30, which we've already
- 15. passed. Only that we'll put on an amendment tomorrow
- 16. ...department amendment for clarification and it'd be
- 17. identical and I'd like to have her committee discharged
- 18. and have 1685 placed on the Order of 2nd reading. It's
- 19. ...identical bill to the one that's on...
- 20. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 21. Senator Netsch. Senator Netsch.
- 22. SENATOR NETSCH:
- 23. On Senator Graham's representation that as of...it
- 24. will be amended. It will be identical to a bill which

- 11. Senator Graham moves to discharge House Bill 1685
- 12. from Judiciary II. All those in favor say Aye. Those
- 13. opposed Nay. The bill is discharged and placed on the Order
- 14. of 2nd reading. ... Senator Glass, for what purpose do
- 15. you arise?
- 16. SENATOR GLASS:
- 17. Mr. President. I move that House Bill 2000 be
- 18. discharged from further consideration by the assignment
- 19. of bills committee. I've spoken to Senator Donnewald
- 20. and I'm going to move that the Six Day Notice be waived
- 21. so that that bill may be heard by Executive. So I move
- 22. that a...a Committee on Assignment of Bills be discharged
- 23. and that that bill be assigned to the Committee on Executive.
- 24. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 25. Senator...Senator Glass moves to discharge the Committee
- 26. on Assignment of the Bills for further consideration of
- 27. House Bill 2000 and to commit the bill to Senator...to Senate
- 28. Executive Committee and to waive the Six Day Notice. Is...
- 29. All those in favor say Aye. Those opposed Nay...Senator
- 30. Hynes.
- 31. SENATOR HYNES:
- 32. Mr. President, I would like to amend that motion to
- 33. include House Bill 2313, which is in the same situation, so

- 1. that you could make the motion as to both bills...
- 2. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- Well, it'll...House Bill 2000 and yours is 2313. All
- 4. in favor say Aye. Those opposed Nay. The motion carries.
- 5. Senator Demuzio, for what purpose do you arise?
- 6. SENATOR DEMUZIO:
- 7. Mr. President. On 3rd reading there's a House Bill
- 8. 2086. I think I gave...incorrectly gave the Secretary
- 9. the wrong number yesterday. That is...it is an easement
- 10. bill. I have an amendment on the Secretary's Desk I'd
- 11. like to, with leave of the Body go to 3rd reading,
- 12. bring it back 2nd reading, and put the technical amend-
- 13. ment on this easement bill and, hopefully, get it on the
- 14. Agreed Bill list, if I...if I have leave of the Senate.
- 15. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 16. Is leave granted? Leave...is there objection? Is
- 17. thereobjections? No objections. What's the bill number,
- 18. Senator? Is it 2086? Turn Senator Demuzio on.
- 19. SENATOR DEMUZIO:
- 20. House Bill 2086.
- 21. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 22. 2086. Are you moving that from 3rd back to 2nd, Senator?
- 23. SENATOR DEMUZIO:
- 24. Yes. Mr. President.
- 25. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 26. If...with leave of the Body House Bill 2086 is returned
- 27. to Order of 2nd reading.
- 28. SENATOR DEMUZIO:
- 29. If you were only younger.
- 30. SECRETARY:
- 31. Amendment No. 1 offered by Senator Demuzio.
- 32. PRESIDING OFFICER: (SENATOR KENNETH HALL)
- 33. Senator Demuzio.

- 1. SENATOR DEMUZIO:
- Yes, Mr. President. It's a technical amendment to
- 3. an easement bill and it's for the elementary school property
- 4. in Collinsville, Illinois. I move for the adoption of the
- 5. amendment.
- 6. PRESIDING OFFICER: (SENATOR KENNETH HALL)
