14. Mr. President, I move that the Journals just read by the

17. PRESIDING OFFICER: (SENATOR BRUCE)

18. You've heard the motion. Is there discussion? All in favor
19. say Aye. Opposed Nay. The Ayes have it. The motion
20. prevails. Committee Reports.

22. Senator Berman, Chairman of Elementary and Secondary
23. Education, reports out Senate Bill 1892 with the recommendation

7. Thank you, Mr. President, Ladies and Gentlemen of the
8. Senate. For purpose of announcement, I've heard from Senator
9. Merlo who is unable to be with us today because of an illness
10. in the family. It's nothing serious. He expects to be with us
11. tomorrow, but we would like the Journal and the record to reflect
12. his absence due to an illness in the family.

16. SENATOR DALEY:

17. Mr. President and fellow Senators. I'd like to discharge the
18. Judiciary Committee I on further hearing of Senate Bill
19. 1886 and 1887. I've talked to Senator Shapiro and Senator Hynes.
20. These are bills on the Legislative Reference Bureau dealing with
21. some technical changes in the law. Yes, then move them to 2nd
22. reading.

23. PRESIDING OFFICER: (SENATOR BRUCE)

24. The motion is to discharge the Judiciary I Committee
25. from further consideration of Senate Bills 1886 and 1887,
26. and have them placed on the Order of 2nd reading on the Calendar.
27. For what purpose does Senator Hynes arise?

28. SENATOR HYNES:

29. Mr. President, just so there is no confusion, these bills were
30. among several that were introduced and sent to...to committee
31. last...in our last meeting. The...pursuant to motion of...by
32. Senator Rock, the rules were waived so that they could be introduced
33. ...the rules were suspended, rather, so that they could be
introduced, read a first time, considered by the committee and in

1. effect, go through the entire legislative process during this
2. Session. So, these are not bills that have been around
3. for a long time. They are merely revisory bills, as Senator
4. Daley indicated, and the rules were suspended to allow them to be
5. considered.

6. PRESIDING OFFICER: (SENATOR BRUCE)

7. Is there further discussion on the motion to discharge?
8. All in favor say Aye. Opposed Nay. The Ayes have it. The
9. Committee on Judiciary is discharged from further consideration
10. of the bills mentioned and they will be placed on the Order of
11. 2nd reading. For what purpose does Senator Hynes arise?
12. May we have order, please? Senator Hynes.

13. SENATOR HYNES:

14. Mr. President, members of the Senate. Since no member has
15. indicated a readiness to call a motion at this time and since
16. the Committees on Appropriations I and II have work to do,
17. supplemental appropriations to consider, have not completed their
18. work, I would move that the Senate stand in recess until...
19. well, let's...and...subject to the call of the Chair so that the
20. Appropriations I and II Committees can complete their
21. work and I would also say that we will not consider any
22. substantive matter such as those motions. We will simply come
23. back into Session for purpose...for the purpose of receiving
24. those reports.
