- 20. offers one amendment.

- 23. SENATOR ROCK:
- 24. Thank you, Mr. Chairman and Ladies and Gentlemen of the
- 25. Senate. Senate Bill 160, as introduced, calls for a supple-
- 26. mental appropriation in the amount of four million plus dollars
- 27. to the Judicial system of our State to, in fact, pay the...
- 28. purported FY...FY'79 deficiency for the pay increases, which
- 29. we allowed back in November and additionally, you will recall
- 30. that we overrode the bill at Senator Weaver's request, which
- 31. called for the State to pick up the previous counties share
- 32. of the Judicial salary. This amount of money is necessary.
- 33. Amendment No. 1, as offered in the committee also provides

- 1. for an additional supplemental in the amount of five hundred
- 2. thousand dollars to cover the pay increase for FY '79 for the
- 3. members of the General Assembly and the members of the Executive
- 4. Branch and I would move its adoption.
- 5. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 6. You've heard the motion. Those in favor indicate by
- 7. saying Aye. Those...those opposed. The Ayes have it. The
- 8. Committee Amendment is adopted. Are there any further amend-
- 9. ments?
- 10. SECRETARY:
- No further committee amendments.
- 12. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 13. Any amendments from the Floor?
- 14. SECRETARY:
- No Floor amendments.
- 16. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 17. 3rd reading. Senate Bills, 3rd reading. Senate Bill 59,
- 18. Senator Grotberg. Senate Bill 74, Senator Sangmeister. Senate
- 19. Bill 113, Senator Berning. Mr. Secretary, read the bill.
- 20. SECRETARY:
- 21. Senate Bill 113.
- 22. (Secretary reads title of bill)
- 23. 3rd reading of the bill.
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. Senator Berning.
- 26. SENATOR BERNING:
- Thank you, Mr. President and members of the Senate. I hope
- 28. we have enough members on the Floor to really give this bill
- the consideration it deserves. Perhaps many of you have been
- 30. as surprised as I was when I learned that an amendment to the
- 31. Statutes some little while back precluded any of our charitable
- 32. organizations such as the Veteran's organizations, the Lions,
- 33. the Kiwanis and others from carrying on their normal procedure

- 1. of fund raising by soliciting for funds at street corners.
- 2. But that is the fact. Raising money by these charitable
- 3. groups is the only way they...they can fulfill their
- 4. commitments to aid the needy and worthwhile groups and
- 5. individuals that they want to serve. A major fund generating
- 6. activity is offering candy or peanuts on the street corners
- 7. while requesting donations. To really make it pay, workers
- 8. must go out into the street and contact auto drivers and
- 9. passengers. My own Lion's Club in Deerfield raises much of
- 10. its funds for its charitable activities in this fashion. So
- 11. Senate Bill 13 allows municipalities to authorize these fund
- 12. raising activities by duly registered organizations...registered
- 13. charitable organizations with the Secretary...the Attorney
- 14. General's Office providing that they have made provisions for
- 15. adequate public liability coverage and are garbed in an easily
- 16. identifiable suit, coat, vest or whatever. Mr. President and
- 17. members of the Senate, I would try to answer questions.
- 18. Senator Vadalabene and I are most anxious that this bill pass.
- 19. It has an immediate effective date or upon becoming law so that
- 20. our charitable activities can continue during the summer months.
- 21. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 22. Is there any further discussion? Senator Vadalabene.
- 23. SENATOR VADALABENE:
- 24. Yes...yes, Mr. President and members of the Senate. As
- 25. joint sponsor of Senate Bill 113, Senator Berning has relayed
- 26. the message exactly and I would appreciate a favorable vote
- 27. though along with the rest of the members on this very important
- 28. piece of legislation.
- 29. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 30. Is there any further discussion? Senator Berning may
- 31. close the debate.
- 32. SENATOR BERNING:
- 33. A roll call, Mr. President.

 - 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
 - 2. The question is, shall Senate Bill 113 pass. Those in
 - favor vote Aye. Those opposed Nay. The voting is open.
 - 4. Have all voted who wish? Have all voted who wish? Take
 - 5. the record. On that question, the Ayes are 48, the Nays
 - 6. are 1. Those voting present, None and ten members are
 - 7. recorded absent. Senate Bill 113 having received a
 - 8. constitutional majority is declared passed. House Bills,
 - 9. 2nd reading. House Bill 242. Senator Wooten, we have
 - 10. a request for a fiscal note on this bill. No. House Bill
 - 11. 242...Mr. Secretary, will you read the bill?
 - 12. SECRETARY:
 - 13. House Bill 242.
 - 14. (Secretary reads title of bill)
 - 15. 2nd reading of the bill. The Committee on... Elementary and
 - 16. Secondary Education offers one amendment.
 - 17. PRESIDING OFFICER: (SENATOR SAVICKAS)
 - 18. Senator Wooten.
 - 19. SENATOR WOOTEN:
 - 20. Yes, the Senator...Senator Davidson and I each had
 - 21. amendments and I think we've agreed on one which Senator
 - 22. Davidson will offer. This amendment says that there will be
 - 23. eight days permitted in addition to the five snow days, but
 - 24. it must clearly be stated that they are die to adverse!
 - 25. weather. Senator Davidson is at his desk now. Perhaps
 - 26. he would like to explain the amendment.
 - 27. PRESIDING OFFICER: (SENATOR SAVICKAS)
 - 28. Senator Davidson.
 - 29. SENATOR DAVIDSON:
 - 30. Yes. In support of the amendment, which was adopted
 - 31. in committee unanimous was a worked out compromise between
 - 32. all parties concerned so that if adverse weather conditions
 - 33. after they had been certified by the local school district

- 1. superintendent and regional superintendent up to eight school
- days can be used for the adverse weather conditions so they
- 3. will not be penalized and lose money. I would...move the
- 4. adoption of the amendment.
- 5. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 6. Is there further discussion? Senator Berman.
- 7. SENATOR BERMAN:
- 8. A parlimentary inquiry, Mr. President. Mr. Secretary...
- 9. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 10. State your inquiry.
- 11. SENATOR BERMAN:
- 12. ... How many amendments do you have on the bill? Just
- 13. one?
- 14. SECRETARY:
- 15. , One.
- 16. SENATOR BERMAN:
- 17. Just one. All right. Then, apparently, the...the
- 18. other two just didn't get shown. So this is the only one,
- 19. I guess. I have no objection.
- 20. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 21. Senator Shapiro.
- 22. SENATOR SHAPIRO:
- 23. Will the sponsor yield for a question...
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. He indicates he will.
- 26. SENATOR SHAPIRO:
- 27. ...on the amendment. Senator, will this allow now a
- 28. school to have thirteen total days...snow days?
- 29. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 30. Senator Wooten.
- 31. SENATOR WOOTEN:
- 32. Yes. Thirteen, but they...it has to be certified.
- 33. They're due to adverse weather. We already have several

- 1. school districts who are at thirteen days right now.
- 2. SENATOR SHAPIRO:
- 3. All right. Now, is this in perpetuity or is it just
- 4. for this one year?
- 5. SENATOR WOOTEN:
- 6. One year. Just for the one year.
- 7. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 8. Senator Shapiro.
- 9. SENATOR SHAPIRO:
- 10. Another guestion. Would the school district have to
- 11. use up any vacation time that has been scheduled prior to
- 12. being eligible for the additional eight days?
- 13. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 14. Senator Wooten.
- 15. SENATOR WOOTEN:
- 16. No. I don't think so.
- 17. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 18. Senator Shapiro.
- 19. SENATOR SHAPIRO:
- 20. Then, as I understand the bill...if the amendment is
- 21. successful, then they would be allowed thirteen snow days
- 22. but they would also be allowed to use vacation time that
- 23. they had scheduled?
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. Senator Wooten.
- 26. SENATOR WOOTEN:
- 27. Yes. The situation is that we have schools prior to
- 28. the Spring vacation, which have already lost thirteen days
- 29. and are anticipating the loss of additional days for which
- 30. they must use their Spring vacation because of the flooding
- 31. situation. The reason we worked out this compromise is
- 32. that the...in order to receive these eight additional days,
- 33. it must be certified by the superintendent of the district

- and the regional superintendent that these additional days
- are due to adverse weather. This is to prevent anyone from
- taking advantage of this one year exception.
- 4. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 5. Senator Shapiro.
- 6. SENATOR SHAPIRO:
- I think it's probably proper I address my future remarks
- 8. to the bill on 3rd reading.
- 9. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 10. Is there further discussion? Senator Demuzio.
- 11. SENATOR DEMUZIO:
- 12. Yes. Thank you, Mr. President. I'd like to ask the
- 13. sponsor of the bill, Senator Davidson, a question if I may?
- 14. Although it doesn't...it doesn't pertain to this amendment,
- 15. it is my understanding that this bill was submitted in the
- 16. House to include all of the counties in Illinois, not just
- 17. those ones that were under the President's Declaration. Is
- 18. that...is that not true?
- 19. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 20. Senator Demuzio, Senator Davidson indicates that
- 21. Senator Wooten is the sponsor and that he will answer the
- 22. question.
- 23. SENATOR DEMUZIO:
- 24. Sorry, I...
- 25. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 26. Senator Wooten.
- 27. SENATOR WOOTEN:
- 28. I didn't hear the question. I was talking.
- 29. SENATOR DEMUZIO:
- 30. Well, my question is...it's...my understanding that
- 31. this bill was amended in the House to include all of the
- 32. counties in Illinois and not just those that were declared
- 33. disaster areas under the Presidential Declaration.

- 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 2. Senator Wooten.
- 3. SENATOR WOOTEN:
- 4. No, but the...this amendment will have that effect.
- 5. The analysis you have on the amendment, I believe, is in
- 6. error because it deletes all of that language that has to
- do with disaster areas.
- 8. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 9. Senator Demuzio.
- 10. SENATOR DEMUZIO:
- 11. Well then, it's applicable to all of the counties in
- 12. Illinois and not just those that have been under the
- 13. President's order. Thank you.
- 14. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 15. Is there any further discussion? The motion is, shall
- 16. the Committee Amendment No. 1 be adopted. Those in favor
- 17. indicate by saying Aye. Those opposed. The Ayes have it.
- 18. The amendment is adopted. Are there any further amendments?
- 19. SECRETARY:
- 20. No further committee amendments.
- 21. PRESIDING OFFICER: (SENATOR SAVICKAS)

- 5. SENATOR SOMMER:
- 6. Mr. President, I would move that the revelant
- 7. committees be discharged and this bill be advanced to the
- 8. Order of 2nd reading. The Chairman of the Committee has
- 9. expressed his consent along with the minority spokesman.
