- 25. Executive appointments. Ladies and Gentlemen, before
- 26. we begin the introduction of bills and we will, in fact, be
- 27. open all day and unfortunately most of the night for the
- 28. purpose of introduction. On Page 9 of the Calendar on the
- 29. Secretary's Desk there are some resolutions. HJR...on the...
- 30. on the Order of the Secretary's Desk on resolutions is HJR 9.
- 31. Senator Netsch.
- 32. SENATOR NETSCH:
- 33. Thank you, Mr. President. I thought we could take this

- 1. and get it removed from the Calendar today. It is a resolution
- 2. which has already passed the House which extends the life of
- 3. the Long Term Debt Study Committee just until June 1 of this
- 4. year. This...the purpose was to allow the committee to stay
- 5. in existence long enough to review the bills that resulted
- 6. from our deliberations and to have an opportunity to respond
- 7. to any proposed amendments or adjustments that might be
- g. proposed during the course of the legislative deliberations.
- So that the...the committee unanimously agreed that we should 9.
- stay in existence only until June 1 of this year. I would
- seek approval of this resolution so that we could have a 11.
- meeting and, in fact, go over the bills that have now been 12.
- introduced, with bipartisan sponsorship. 13.
- PRESIDENT: 14.

- Is there any discussion? There is an expenditure of 15.
- State funds involved, it will require a roll call. Is there 16.
- any discussion? If not, Senator Netsch has moved the adoption 17.
- of House Joint Resolution 9. Those in favor will vote Aye. 18.
- Those opposed will vote Nay. The voting is open. Have all 19.
- 20. voted who wish? Have all voted who wish? Take the record.
- On that question the Ayes are 51, the Nays are none, none
- 22. Voting Present. House Joint Resolution No. 9 is declared
- 23. passed.
- SENATOR NETSCH: 24.
- Thank you, Mr. President. 25.
- PRESIDENT: 26.
- Senator Netsch. Oh. On the Order of the Secretary's 27.
- Desk, resolutions. Senate Resolution 71, Senator Mitchler. 28.
- SENATOR MITCHLER: 29.
- Mr. President and members of the Senate. Senate Resolution 30.
- 71 was heard in the Senate Executive Committee where it received 31.
- a unanimous vote. This resolution that requests Congress to 32.
- allow states to determine the speed limits on State highways 33.
- 34. and on the interstate highways without the loss of Federal

- 1. highway funds. I know of no objection to this, there is
- 2. nothing mandatory about changing the speed limit at this
- 3. time. I ask for a favorable roll call.
- 4. PRESIDENT:
- 5. Senator Mitchler has moved the adoption of Senate
- 6. Resolution 71. Is there any discussion? If not, all those
- 7. in favor signify by saying Aye. All those opposed. The Ayes
- 8. have it, the resolution is adopted. Senate Resolution 101,
- 9. Senator Joyce. Senator Joyce.
- 10. SENATOR JEROME JOYCE:
- 11. Thank you, Mr. President. This resolution would create
- 12. a Senate committee to investigate and look into and whatever
- 13. else they decide to do about the nuclear power in the State
- 14. of Illinois and the transportation of hazardous waste as
- 15. well as the storage of hazardous waste. It would be seven
- 16. members, four appointed by the Senate President, three appointed
- 17. by the Minority Leader.
- 18. PRESIDENT:
- 19. Senator Joyce has moved the adoption of Senate Resolution
- 20. 101. Is there any discussion? Senator Mitchler.
- 21. SENATOR MITCHLER:
- 22. Mr. President and Senator Joyce. There has been some
- 23. question on this. I think I would ask that it be taken out
- 24. of the record at this time...until we can have some discussion
- 25. on it. I think you'll get into a discussion on the...resolution.
- 26. PRESIDENT:
- 27. Is there any further discussion? Senator Mitchler.
- 28. SENATOR MITCHLER:
- 29. The...the question was asked of the Senator if he would
- 30. take it out of the...record.
- 31. PRESIDENT:
- 32. Senator Joyce.
- 33. SENATOR JEROME JOYCE:

- Yes, what is the question? What is the problem with it
- Senator?
- 3. PRESIDENT:
- Senator Mitchler.
- 5. SENATOR MITCHLER:
- 6. Well, some of the Senators have come up to me and asked
- 7. me if this did not overlap some of the work that is being
- 8. done by the Illinois Commission on Atomic Energy with their...
- g, their work in monitoring the nuclear plants and I have to
- 10. agree with them that it does. Now, we can create commissions
- 11. for this and study commissions for that and everything, but
- 12. You're duplicating what is already being accomplished. The
- 13. Governor has appointed a special ad hoc committee, Representative
- 14. George Ray Hudson, the Chairman of the Illinois Commission on
- 15. Atomic Energy is chairman of that ad hoc committee. The...
- 16. we/re up to, I believe it was Zion yesterday and went all
- 17. the way through the plant. They have on that ad hoc committee
- 18. representatives from the University of Illinois, knowledgeable
- 19. people in the area of nuclear plant operation and I...I think
- 20. that that is one example of a committee that is already functioning
- and of course I know the genesis of this, had we not had that
- 22. incident in Harrisburg, I don't think there would be very
- 23. many members of the Senate that would have been concerned about
- 24. this. There are those of us who have been serving on the
- 25. Illinois Commission on Atomic Energy. We have been visiting
- 26. these plants. I personally have visited four or five of them
- 27. on different occasions. Revisited them as a member of the
- 28. Illinois Water Resources Commission, we have visited them
- 29. because much of this material is stored in...in water
- 30. containers and there is discharge from the plants. I see
- 31. no need in duplicating that. If you felt that a special
- 32. report should come out of one of the existing commissions
- 33. that we already now have functioning, I'd be glad to go

- along with that and give a report. But with the Governor's
- 2. ad hoc committee of knowledgeable people that are geared to
- 3. this, I think that that is suffice and I see no need for this,
- 4. Senator Joyce, and I understand that you're interested in having
- 5. some type of plan adopted or that down in Grundy County where
- 6. the nuclear facility is located as well as the General Electric
- 7. storage, but we have extended invitations time after time. I
- 8. think three trips have been sponsored by the Illinois Energy
- 9. Resources Commission already this year. I have announced them on
- 10. the Floor of this Senate and invited you up to visit that. And
- 11. the response that we had was nil. Senator...rather Represen-
- 12. tative Schoeberlein, Representative Murphy were the only two
- 13. that attended the first. I think there was a group of some
- 14. sixteen at the...
- 15. PRESIDENT:
- 16. Senator, will you conclude your remarks.
- 17. SENATOR MITCHLER:
- 18. Thank you. Well, I just don't see any need for it and
- 19. if you want to have these things fly up just to get a lot
- 20. of publicity and react to something that happened in another
- 21. state, why you can have committees and commissions every day,
- 22. so I'd ask for the holding up of this rather that the defeat of
- 23. it until we can talk it over and resolve your problem.
- 24. PRESIDENT:
- 25. Further discussion? Senator Rhoads.
- 26. SENATOR RHOADS:
- 27. Briefly, Mr. President, to rise in favor of the resolution.
- 28. More than a third of Illinois Power comes from nuclear sources
- 29. in the northern part of the State. It is a kind of energy which
- 30. is distinct, unique, requires a unique kind of study, separate
- 31. and apart from the other types of issues that the other energy
- 32.
- 33.

- committees address itself to and I think it's a good resolution.
- 2. PRESIDENT:
- Further discussion? Senator Geo-Karis.
- 4. SENATOR GEO-KARIS:
- 5. Mr. President and Ladies and Gentlemen of the Senate.
- 6. I happen to live seven blocks west of the nuclear plant in
- 7. Zion and my office is four blocks west of it. I think too
- 8. that this is a good resolution. I'm not against nuclear
- 9. energy. I think nuclear energy is here to stay and I think
- 10. it's necessary. But I do think we owe it to the public
- 11. to take every safeguard we can in looking into it and
- 12. looking into it as thoroughly as possible and the fact
- 13. that the Atomic Energy Commission will be looking into it,
- 14. I think they will be taking care of one facet of it, I
- 15. think we'll be taking care of another and I certainly know
- 16. this, that the constituency where I live have been urging
- 17. me to do something fast and I'm in favor of this resolution.
- 18. PRESIDENT:
- 19. Any further discussion? Senator Joyce may close the
- 20. debate.
- 21. SENATOR JEROME JOYCE:
- 22. Yeah, yes, Mr. President, thank you. I think that the
- 23. Atomic Energy Commission, I've read the report. I think it
- 24. tends to be somewhat biassed in its views toward nuclear
- 25. energy. I think that people, you know, in some places in
- 26. here it says of the...it quotes...to quote the report, it
- 27. says, "The Atomic Energy Commission...the NRC uses dilatory
- 28. actions to stop the storage and reprocessing of...of nuclear
- 29. waste." So I think that the people who live in the shadow
- 30. of these nuclear plants are concerned and they want some
- 31. action taken right now, they want their fears to be put
- 32. to rest. I think that we owe our constituency...this
- 33. committee. Thank you.

- Senator Joyce has moved the adoption of Senate Resolution
- 3. 101. Those in favor will vote Aye. Those opposed will vote
- 4. Nay. The voting is open. Have all voted who wish? Have

- 14. to capture Federal money and some...we want to look at both
- 15. some structural and some funding processes in the department
- 16. and I would request the adoption of the resolution.

- 18. Senator Wooten has moved the adoption of Senate Resolu-
- 19, tion 86. Is there any discussion? If not, all those in
- 20. favor signify by saying Aye. All those opposed. The Ayes
- 21. have it, the resolution is adopted. Resolutions.
