

Thank you, Mr. President. My motion will be that the Senate 13. not disapprove Executive Reorganization Order No. 1. That 14. is to take account of the fact that in the Constitution, the 15. Executive Orders become effective unless either House of the 16. General Assembly disapproves and so our decision is to put the 17. motion in the negative. All of these 27. are basically the residential or service oriented activities of 28. DCSF which relate to people who are handicapped. It was agreed 29. that the Division of Vocational Rehabilitation, which 30. has become a very different and a much more effective agency, is 31. the appropriate agency to handle those activities. There was no 32. negative testimony at all before the Reorganization Committee 33.

۱. to the proposed reorganization and to the best of my knowledge, 2. not a dissenting word was to be heard from any source. If 3. so, it did not come to my attention. The committee, therefore, 4. unanimously recommended that the Governor's Reorganization 5. Order be in effect, approved and that has lead to the proposal 6. of the motion. 3. Senator Martin.

4. SENATOR MARTIN:

Senator Netsch, you stated that there was no objection. 5. I find myself in a bit of a quandry. Virtually every organization 6. connected with the visually handicapped...and even those who 7. work for the State that help the visually handicapped, have 8. talked to me in Rockford and they are all opposed to the reorganization. 9. They strongly felt and they may well be incorrect, that they would 10. be put in a very subservient role in the department to which the 11. Governor wished them to go, that the emphasis in that department 12. was toward a different kind of...of disabled and they were... 13. they were...they liked where they were, in effect. Now, they 14. may be in error, but I find that interesting that...that there 15. seems to be this consensus when back in my home district, without 16. ...without exception, they, at minimum, voiced strong fears and 17. really kind of the hope that this wouldn't go through. It 18. obviously is going to and it may work out for them. But I think 19. probably that should be on the record because at least in one 20. area of the State, they're not as pleased about it as...as 21. seems to be here. 22.

23. PRESIDING OFFICER: (SENATOR BRUCE)

24. Senator Netsch, and I have the following Senators
25. who have sought recognition; Senators Mitchler, Wooten and Daley.
26. Senator Netsch to answer the guestion.

27. SENATOR NETSCH:

Yes, I guess I would answer in part with a question. Did that
occur during this current period, Senator Martin? The reason
why...your answer is in the affirmative. Well, it does come as
a surprise then. That was not conveyed to any of us on the committee.
The only sort of quasi-negative that was conveyed to us on behalf
of the National Federation for the Blind, was that they would still

like to have the...or the now Division of Vocational Rehabilitation, 1. with a special division statutorily created that dealt with blind 2. 3. services. But they went on to say that this year, as opposed to their position last year, by the way, last Session, that 4. they did not object and agreed that it was a good idea except 5. that they would still much prefer to have their own separate 6. division. Now, it is true that when the same issue was before 7. the General Assembly in bill form, last Session, there was a 8. great deal of dissention about it and I think several things 9. have happened in the interim. For one thing, DCFS has now 10. agreed with the proposal and I think that there has also been 11. a recognition that the Division of Vocational Rehabilitation 12. has, indeed, become quite different from its initial impetus, 13. that is that it is more than just a vocationally oriented 14. responsibility and that is what we have assumed was responsible for 15. the elimination of that strong outburst of opposition that did 16. in fact, occur last Session. 17.

18. PRESIDING OFFICER: (SENATOR BRUCE)

19. Senator Martin.

20. SENATOR MARTIN:

Well, I will follow the committee's lead, but I... I guess 21. my underlying fear is where the heads of people down here are 22. saying one thing. The people who are actually out in the field and 23. the blind who have been in to see me, who aren't the powerful one's, 24. who aren't the spokesmen, they're just out on a day to day living 25. their life and working...working to help each other, don't have 26. those same feelings and let us hope, as I say, that they are 27. proved wrong and this works out very well. 28.

29. PRESIDING OFFICER: (SENATOR BRUCE)

30. Further discussion? Senator Mitchler.
