- 16. saw fit to not vote it out favorably and I think it should
- 17. repose in the committee for further study and I would urge
- 18. opposition to Amendment No. 1 and would request a roll call.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Is there further discussion? Senator Wooten may close.

- 22. Thank you, Mr. President. With all due respect to Senator

- 6. Senator Jerome Joyce.
- 7. SENATOR JEROME JOYCE:
- Yes, Mr. President. Thank you. Amendment No. 2
- 9. try...it makes this Act reciprocal with other states that
- 10. would accept spent nuclear fuel rods, then we would...would
- 11. accept theirs. So, it tries to put this bill in the form that
- 12. would be constitutional.
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. Is there discussion? The question is shall Amendment
- 15. No. 2 to Senate Bill 262 be adopted. Those in favor indicate
- 16. by saying Aye. Those opposed. The Ayes have it. Amendment
- 17. No. 2 is adopted. Are there further amendments?

- 19. No further amendments.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. 3rd reading. Senate Bill 263, Senator Maragos. Read the bill,
- 22. Mr. Secretary.
- 23. SECRETARY:
- 24. Senate Bill 263.
- 25. (Secretary reads title of bill)
- 26. 2nd reading of the bill. The Committee on Judiciary I offers
- 27. one amendment.
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Senator Maragos.
- 30. SENATOR MARAGOS:
- Mr. President and members of the Senate. There's three
- amendments, as I recall.
- SECRETARY:

One amendment is all I have, Senator Maragos.

- 1. SENATOR MARAGOS:
- Is it...how many pages is it?
- 3. SECRETARY:
- Two pages.
- 5. SENATOR MARAGOS:
- 6. All right. Then it's combined. Okay. I move for its
- 7. adoption. What that amendment does, Mr. President and members
- 8. of the Senate, is to change the wording of the particular
- 9. bill to show that for future amendments...for future adoptions
- 10. the information will be given if the parents consent ahead of time.
- 11. It still prevents any obtaining of any information from
- 12. ... regarding the natural parent without court order. We delineate
- 13. that and it also states that they could get their medical
- 14. or genealogical information. I told many other people who may
- 15. have any additional suggestions, that I'll...if they...we agree,
- 16. we'll bring it back to 2nd, but I wish to move this on and have
- 17. the amendment adopted at this time.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Senator Rhoads.
- 20. SENATOR RHOADS:
- 21. Question on the amendment, Senator Maragos.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Indicates he will yield.
- 24. SENATOR RHOADS:
- 25. It is prospective only. That...is that correct?
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Maragos.
- 28. SENATOR MARAGOS:
- 29. It is prospective only for information of finding out
- 30. who the natural parent is but right now it is still presently...
- 31. you still need a court order. It doesn't change the facts as to
- 32. the...giving the name of the natural parent without the natural
- 33: parent's consent. You still need a court order on that. And this was adopted at the time.

PRESIDING OFFICER: (SENATOR DONNEWALD) 1. 2. Senate... Senator D'Arco. Senator D'Arco. SENATOR D'ARCO: 3. When you say it's prosective...will the sponsor yield 4 . for a question? 5. PRESIDING OFFICER: (SENATOR DONNEWALD) 6. He indicates he will. 7. SENATOR D'ARCO: 8. Now, when you say the amendment makes it prospective for 9. the adopted child to get the names of his natural parents, is 10. that what you're saying? 11. PRESIDING OFFICER: (SENATOR DONNEWALD) 12. Senator Maragos. 13. SENATOR MARAGOS: 14. Only if the natural parent has already stated in its 15. adoption proceedings that it does not mind that information 16. being given. 17. PRESIDING OFFICER: (SENATOR DONNEWALD) 18. Senator D'Arco. 19. SENATOR D'ARCO: 20. Now, let me get this straight so I understand it. In the 21. adoption proceedings, if the natural parent says that the 22. child, his child, he will, when he reaches the age of 21, be 23. allowed to reveal the name of the natural parent, then, even 24. though the adopted parent does not agree that that name of the 25. natural parent should be revealed, the name will be revealed 26. anyway, is that correct? 27. PRESIDING OFFICER: (SENATOR DONNEWALD) 28. Senator Maragos. 29. SENATOR MARAGOS: 30. Not necessarily and that's why I'm still asking from 31. Senator Sangmeister if he wants additional language, I will bring 32. it back from 3rd reading. We could not, in any way, find out the 33:

...agree with anybody to say...yes, in answer to your question

- 1. as of now is yes. But we are...and I said if anything comes up
- 2. wherein the...I talked to Sangmeister and he said he hasn't

- 11. parent will be revealed to the natural child when the child reaches
- 12. majority, you're saying that if Sangmeister comes up with that
- 13. language, you will put that in the bill?
- 14. PRESIDING OFFICER: (SENATOR DONNÉWALD)
- Senator Maragos.
- 16. SENATOR MARAGOS:
- 17. If it does not scuttle any other parts of this bill, we agreed
- 18. to that. I mean, the only thing we said is that if he can
- 19. give us language because I asked George the last two...I've
- 20. held it up now over ten days on 2nd reading with the understanding
- 21. that he gave me...in fact, I asked him a few minutes ago if he
- 22. has language that could be suitable with the subcommittee participants
- 23. be...Senator Bowers, Senator Daley, and myself, then we would
- 24. put it on and he agreed to...to that language. But I cannot
- 25. foresee what language he could put on that will scuttle the bill
- 26. if he...
- 27. PRESIDIN G OFFICER: (SENATOR DONNEWALD)
- 28. Senator D'Arco.
- 29. SENATOR D'ARCO:
- Then...then, what you're saying is that if he comes up
- 31. with langauge that you and Senator Bowers and Senator Daley
- find acceptable, then you will put it on, but if you don't
- find it acceptable, then you will not put it on?

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Maragos.
- 3. SENATOR MARAGOS:
- 4. I will bring it back for debate in any case. I mean,
- 5. I'll give the consideration so the House...the whole...the whole
- 6. Senate can deal on it. I can't do anymore than that, Senator
- 7. D'Arco.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Sangmeister.
- 10. SENATOR SANGMEISTER:
- 11. Yes, Mr. President and members of the Senate. I...so we'll
- 12. get clear, I just happened to be in committee when that bill came
- 13. up and I want everybody to understand, my amendment, if I propose
- 14. what...and I'm planning on doing so, would only be prospective.
- 15. I think the way to solve the problem from here on forward, you
- 16. know, you can't do anything about the present situation but
- 17. from here on forward, is to have a form perhaps by the Bureau of
- 18. Vital Statistics which must be made a part of the adoption
- 19. proceeding or the decree is just not entered. That particular
- 20. form would have all of the health information of the child.
- 21. It would have all of his ancestry, blood type, whatever you may
- 22. want in there and the bill would then provide, or the amendment
- 23. would provide that either the adopted parent or the adopted
- 24. child could just go into court and ask for that information.
- 25. There would be no notice to anyone else. He's entitled to know
- 26. his past history. But that's only going to work if we put that
- 27. on from here on forward. That's not going to solve the problem
- of the present adopted child who wants to know who his natural
- 29. parents are. It won't even get into that area. That's not
- 30. what I'm proposing. So, it won't change that part of the bill.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 32. Senator D'Arco
- SENATOR D'ARCO:

All right. Then, the as the amendment now stands, the adopted

- child will be able to know who his natural parents were when 1. 2. he reaches the age of majority and your amendment will not even address that situation. You're just talking about his genealogy ٦. in his...the history. 4. PRESIDING OFFICER: (SENATOR DONNEWALD) 5. Senator Maragos. 6. SENATOR MARAGOS: 7. No, that's the wrong conclusion, Senator D'Arco. I'll have 8. Senator Bowers, 'cause he's...subcommittee. I'll have him 9. speak on the point as well. 10. PRESIDING OFFICER: (SENATOR DONNEWALD) 11. Senator Bowers. 12. SENATOR BOWERS: 13. Mr. President, the only suggestion I wanted to make, number 14. one, the amendment makes the bill more restrictive than the bill 15. is in its original form and more to Senator D'Arco's liking. 16. My only suggestion is we go in and put the amendment on. 17. He's agreed to move it back to 3rd...back to 2nd at any time 18. for someone else's amendment and once the amendment goes on, 19. everybody looks at it and if they have further amendments, 20. he'll bring it back and...and I don't know any reason to debate 21. the amendment now other than to say to Senator D'Arco that the 22. amendment makes the bill more restrictive and it's a subcommittee 23. agreement, but the amendment makes the bill more restrictive 24. than the bill in its original form. 25. PRESIDING OFFICER: (SENATOR DONNEWALD) 26. The Chair is in favor of that also. Senator D'Arco. 27. SENATOR D'ARCO: 28. Find out what it does. 29. PRESIDING OFFICER: (SENATOR DONNEWALD)

- 2. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Well, just a moment. Senator Maragos.
- 4. SENATOR MARAGOS:
- 5. I thought I explained it. You were in the committee, too,
- John. We passed this amendment in committee. I thought you
- 7. understood what the amendment did and that's why I repeat.
- 8. again to you that it does, at this time that you cannot get the
- 9. natural parent's information without a court order. You just
- 10. can't go...and all you can say now is to get the medical
- 11. information, whatever is available. You still not..cannot go and
- 12. get the name of the birth parents without a court order and
- 13. therefore, there has to be a full petition and if the natural
- 14. parent doesn't want his information given, the court will not
- 15. give it. Secondly, we say for the future that they still can't
- 16. even get it then, the birth parents names, unless the birth
- 17. parent has consented. The only thing that you have brought up
- 18. in committee the other day, which Senator Sangmeister happened
- 19. to be sitting in, was the question...the rights of the adopting
- 20. parent and at that time, I said if we worked those things out,
- 21. we'll be glad to help...to work along with you...more restrictive
- 22. than it was.
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Senator D'Arco.
- 25. SENATOR D'ARCO:
- 26. The amendment is...is the essence of the bill. And you know,
- 27. for you to say that we should sent it to 3rd reading and then we
- 28. can talk about it and if there's any problem, someone can offer
- 29. an amendment to bring it back or something, I think that's
- 30. absurd because this amendment is the essence of the bill.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 32. Well, Senator, that practice has been observed in this Chamber
- 33: as long as I have been here.

- 1. SENATOR D'ARCO:
- But, no, I'm not...I'm not quarreling with the practice
- of bringing a bill back to 2nd reading. But I think that
- 4. the amendment, since it is the essence of the bill, should be
- 5. debated and should be understood by the membership as to what
- 6. it does and voted on because if you're going to vote for the
- amendment, you're going to vote for the bill.
- 8. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 9. Senator Maragos.
- 10. SENATOR MARAGOS:
- 11. I'm not arguing with Senator D'Arco's right to oppose
- 12. the amendment, but I'm trying to tell him that this amendment
- 13. makes it better than what his original objections were because
- 14. it takes out two-thirds of the area which he...he objected.
- 15. The only third area that he still has some questions with
- 16. ...questions about has to do with the adopting parent's right
- 17. and I told him that if he wants to bring that back at that time,
- 18. fine. But it's more restrictive than it was in its original form
- 19. and if you...this bill is going to be better now than it was
- 20. when it first was introduced. And I...because you had raised
- 21. some objections. We took them into consideration at that time.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Senator D'Arco.
- 24. SENATOR D'ARCO:
- 25. I want to speak on the amendment. What the amendment does
- is to say that from henceforth if this bill becomes law,
- 27. the adopted child will have the right, when he reaches majority
- 28. to know the name and address and telephone number of his natural
- 29. parents. And what they're saying is that when there is a court
- 30. proceeding, and the natural parent consents to having his name
- revealed to the natural child, then, when that child reaches
- majority, the identity of the natural parent can be known
- by the adopted child. That's the essence of the bill and that's the essence of the amendment and what I'm saying to you is that

- ignores the rights of the adopted parent who raised this kid from
- day one until he became...reached the age of majority. And I
- 3. know many adopted parents, including Senator Sangmeister, who
- 4. opposes this amendment because the child, sometimes, does not know
- 5. what is in his own best interest and the fact of the matter is
- 6. that he may...he may go back to the natural parent and if the
- 7. natural parent is eighteen years later in a better position
- 8. financially, and however else, than he was when he decided that
- 9. he should rid himself of this child eighteen years before...
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Just a moment. For what purpose do you arise, Senator
- 12. Maragos.
- 13. SENATOR MARAGOS:
- 14. I will pull this out of the record. I get...copies of the
- 15. amendment...
- 16. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 17. Take it out of the record. Take it out of the record.
- 18. Senator Rock, for what purpose do you arise?
- 19. SENATOR ROCK:
- 20. It appears, Mr. President and Ladies and Gentlemen of the
- 21. Senate, we are at this point, at the point of diminishing returns
- 22. and I would, before putting a motion to adjourn, remind the
- 23. membership that we will come into Session at 9:00 a.m. tomorrow
- 24. morning to afford the Appropriations Committee the afternoon to
- 25. finish up their business. They have assured me, both Senators
- 26. Carroll and Regner have assured me that they can, in fact, complete
- 27. their business so that there will be a modification of the
- 28. schedule this week, that is on Friday, May 11, as opposed to coming
- 29. in at noon, we will come into Session at 9:00 o'clock in the
- 30. morning and attempt to go home at noon, if that's agreeable to
- 31. the membership. But I would urge that everyone try to be here at
- 32. 9:00 tomorrow. We will commence with 3rd reading bills tomorrow
- 33: and attempt on Friday to handle 3rd reading bills, readings on 3rd reading. Right. Bills on 3rd reading. So that we will attempt

- 1. to try to pass some of the lessor controversial bills at least.
- 2. But I would urge everyone to try to be here at 9:00 o'clock
- 3. tomorrow morning. There are a number of things scheduled for
- 4. this evening. Senator Hall asked me to remind everybody about
- 5. the soul food soiree that's going to be held at the Holiday
- 6. East commencing at 6:30. And I know we've all put in a long
- 7. hard day and unless there are no further announcements or
- 8. other business, I would put a motion to adjourn until 9:00
- o'clock tomorrow morning.
- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Are there announcements? Senator Rock moves we adjourn
