- 17. Yes, Mr. President and members of the Body. I think that
- 18. there are several matters that have to be taken care of this
- 19. morning. One of which is Senator Kenneth Hall has a House
- 20. Joint Resolution that we could consider after which in a few
- 21. moments we have two emergency measures... House Bills that
- 22. should be passed today. We would then go to the Order of 2nd
- 23. reading and after that, if we have the time, we would go to
- 24. the Order of 3rd reading on noncontroversial bills and we
- 25. would go through the files to determine if there was a great
- 26. deal of discussion on the committee end of it and then if there
- 27. is, objection on the Floor, why we would pull it from the record
- 28. if that has the consent of the Body.
- 29. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 30. You've heard the motion. Senator Hall.
- 31. SENATOR KENNETH HALL:
- 32. Thank you, Mr. President and Ladies and Gentlemen of the
- 33. Senate. This is House Joint Resolution...

- 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator Hall, just a moment. Senator Hall moves...asks
- 3. leave to go to the Order of the Secretary's Desk for the
- 4. purpose of considering House Joint Resolution 31. Is leave
- 5. granted? Leave is granted. Senator Hall.
- 6. SENATOR KENNETH HALL:
- 7. Thank you, Mr. President and Ladies and Gentlemen of the
- 8. Senate. The reason the necessity of this going out right now
- 9. is that I've been informed by Representative Steele that the
- 10. Governor is flying out to talk to the Flying Tigers to encourage
- 11. them to locate here in Illinois their air freight terminal and
- 12. he would like to be able to say that the General Assembly has
- 13. passed this resolution in support of attracting agencies and
- 14. for locating major air freight carriers in Illinois so I would
- 15. urge that this is passed out here at this time.
- 16. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 17. You've heard the motion. Senator Hall moves for the
- 18. adoption of House...Senator Berning.
- 19. SENATOR BERNING:
- 20. A question of the sponsor, Mr. President.
- 21. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 22. He indicates he will yield.
- 23. SENATOR BERNING:
- 24. My understanding, Senator, is that the proposed Waterloo-
- 25. Columbia Airport has been now termed strictly the proposal of
- 26. this airport has been to...designated strictly as a cargo
- 27. airport and from the volumes of mail that I have received from
- 28. citizens all over the State, even up in my district, which is
- 29. as far removed from the Columbia-Waterloo proposed site, I guess,
- 30. as one can get in this State. There is vast citizen opposition
- 31. to that proposed airport. Now, my question then is, by adopting
- 32. such a resolution as you are now proposing, are we not, if not
- 33. directly, indirectly endorsing the proposal to construct the

- 1. Columbia-Waterloo Airport in Illinois?
- 2. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator Hall.
- 4. SENATOR KENNETH HALL:
- 5. Senator, that what has happened, if you're referring to
- 6. the Waterloo, Illinois' location, there is a move on to locate
- 7. what we call, an International Airport in that area. So far,
- 8. that...there's been studies, restudies and that if we're ever
- 9. going to get a major airport in that area, so while that is
- 10. still in the process...in the working, there is an opportunity
- 11. for my information is, that a number of major air freight, like
- 12. the...the Flying Tigers are trying to find someplace that they
- 13. can relocate. I understand that they have been notified by
- 14. the Chicago airports that they need their part that they're
- 15. using there for expansion. Hopefully, that somewhere in this
- 16. State, that they will locate and I understand that the Governor
- 17. is going to be talking with them and want to show that the
- 18. legislature is interested and in support of attracting major
- 19. air freight carriers in Illinois and that's the answer to the
- 20. question.
- 21. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 22. Senator Berning.
- 23. SENATOR BERNING:
- 24. Well, Mr. President and members of the Senate. This may
- 25. have a laudable objective, as it's proposed, however, the
- 26. inference, in my opinion, is directly tied to the ill-advised
- 27. efforts to build that airport down in the Columbia-Waterloo
- 28. area and I would...would hesitate. In fact, I would just like
- 29. to see this Body take action that could, in any way, be
- 30. interpreted as an endorsement and, therefore, I...I would
- 31. respectfully suggest that it be appropriate for this Body
- 32. to reject this resolution, as now drawn or to suggest that the
- 33. sponsor withdraw it and amend it so as to specifically preclude

- 1. an endorsement of any particular site.
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- 3. Is there any further discussion? Senator Moore.
- 4. SENATOR MOORE:
- 5. In deference to my colleague, Senator Berning, and it's
- 6. not often that I agree with Senator Hall, particularly on
- 7. matters down South, but the...having a...a major air freight
- 8. airport in the Waterloo area down there is going to have a
- 9. tremendous impact upon the overall economy of the State of
- 10. Illinois. As Senator Hall has stated, there is an opportunity
- 11. for us to get some very large freight airplane companies that
- 12. have to relocate. We do have the jump on them at this point.
- 13. I have heard a rumor that, perhaps, the Flying Tigers would
- 14. use this and there is just a tremendous opportunity for the
- 15. creation of jobs and for the...the helping of the economy of the
- 16. State of Illinois. I think this is a good resolution and I
- 17. would its adoption.
- 18. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 19. Senator Bruce.
- 20. SENATOR BRUCE:
- 21. Well, I, at first, had some problems with this resolution
- 22. and Senator Berning, I think, has confused the issue, perhaps,
- 23. on the Waterloo Airport. The resolution explicitly states that
- 24. it is of assistance to all communities in the State of Illinois
- 25. that are trying to attract major air carriers, which in my own
- 26. district we are trying to attract the Emery Air Freight and the
- 27. Flying Tigers to come to Lawrenceville, Illinois where we have
- 28. a World War II in place, in sight facility. We've contacted
- 29. the Federal Aviation Administration. They are cooperating and
- 30. building additional site facilities there. All this resolution
- 31. says, is we ought to attract more business to Illinois in the
- 32. way of air freight. I wouldn't support it if it said Waterloo
- 33. because, frankly, the Governor came down to our area and said

- 1. he thinks it ought to be at Lawrenceville and I would like
- 2. to hold him and his representatives to that idea that it
- 3. ought to be in Lawrenceville, but it doesn't say Lawrenceville
- 4. and doesn't say Waterloo and it doesn't say Kankakee or any-
- 5. place else. It just says that we endorse the idea that we
- 6. ought to have more air freight...business located in Illinois
- 7. and I think on that basis all of us could support additional
- 8. jobs being located in this State. For example, Emery Air
- 9. Freight located in...in Memphis is thinking about locating
- 10. in Lawrenceville, that's fifty-four million dollars of
- 11. additional construction at that one airport alone. Not only
- 12. construction jobs, but about six hundred new employees in...in
- 13. Lawrence County so I would be very much in support of saying
- 14. to the Governor and to Flying Tigers, come to Illinois and we
- 15. will support your efforts to expand in this State.
- 16. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 17. Is there any further discussion? Senator Vadalabene.
- 18. SENATOR VADALABENE:
- 19. Yes, I too, also want to go on record as supporting this
- 20. House Joint Resolution 31. As you well know, I am...have been
- 21. for years the sponsor of the St. Louis Metropolitan Airport
- 22. Authority funding and I think that we have a good base and I
- 23. think we have made some extremely important studies, as
- 24. Senator Don Moore has said, and as Senator Kenny Hall has
- 25. indicated. This resolution is needed and I think we ought to
- 26. get the show on the road and vote it out.
- 27. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 28. Is there any further discussion? Senator Hall moves for
- 29. the adoption of House Joint Resolution 31. Those in favor
- 30. indicate by saying Aye. Those opposed. The Ayes have it.
- 31. House Joint Resolution 31 is adopted. For what purpose does
- 32. Senator Donnewald arise?
- 33. SENATOR DONNEWALD:

- 1. Well, would we...would we now have leave to go to the
- 2. Order of 3rd reading concerning...concerning House Bill 510
- 3. and 367. They are emergency matters.
- 4. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 5. You've heard the motion. Is leave granted? Leave is
- 6. granted. House Bills, 3rd reading. House Bill 367, Senator
- 7. Egan. Read the bill, Mr. Secretary.
- 8. SECRETARY:
- 9. House Bill 367.
- 10. (Secretary reads title of bill)
- 11. 3rd reading of the bill.
- 12. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 13. Senator Egan.
- 14. SENATOR EGAN:
- 15. Thank you, Mr. President and members of the Senate. This
- 16. bill was passed out of the Senate in the form of Senate Bill
- 17. 138 without any opposition. It...it restructures the language
- 18. to conform with the...the taxing on real estate transfer
- 19. because of case law that struck down the twenty-five cent tax
- 20. that a county levies on or...or assesses against...through the
- 21. stamps on land transfers, but it...what it does is conform the
- 22. law...the statutory law to the case law and I move...or I
- 23. commend it to your favorable consideration.
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. Is there any further discussion? Senator McMillan.
- 26. SENATOR McMILLAN:
- 27. Mr. President and members of the Senate. I would just
- 28. merely rise in support of the motion and I had had extensive
- 29. hearing in the Revenue Committee in the form of the parallel
- 30. Senate Bill and I would...would urge a favorable vote.
- 31. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 32. Senator Rhoads.
- 33. SENATOR RHOADS:

- 1. Thank you, Mr. President and a question of the sponsor.
- 2. Senator Egan, I recall the bill very well, but I... I don't
- 3. understand what the emergency nature of this action on a
- 4. House Bill on 3rd reading is this morning.
- 5. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 6. Senator Egan.
- 7. SENATOR EGAN:
- 8. Well, it...it's strictly fiscal. The county is presently in
- 9. a bind on...on their ability to collect this tax and all
- 10. counties and so they...they need it today and it becomes
- 11. effective upon the signing it.
- 12. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 13. Is there any further discussion? The question is, shall
- 14. House Bill 367 pass. Those in favor vote Aye. Those opposed
- 15. vote Nay. The voting is open. Have all voted who wish? Have
- 16. all voted who wish? Take the record. On that question, the
- 17. Ayes are 39, the Nays are 0, none Voting Present. House Bill
- 18. 367 having received the constitutional majority is declared
- 19. passed. For what purpose does Senator Vadalabene arise?
- 20. SENATOR VADALABENE:
- 21. Yes, Mr. President, I would like to have leave to waive
- 22. the Six Day Rule so that the easement bills can be heard in
- 23. Executive and Appointments on next Tuesday.
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. You've heard the motion. Is leave granted? Leave is
- 26. granted. House Bill 510. Read the bill, Mr. Secretary.
- 27. SECRETARY:
- 28. House Bill 510.
- 29. (Secretary reads title of bill)
- 30. 3rd reading of the bill.
- 31. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 32. Senator Merlo.
- 33. SENATOR MERLO:

- 1. Thank you, Mr. President and members of the Senate. The
- 2. Illinois Young Adult Conservation Corps Program is a Federally
- 3. subsidized employment program for those sixteen to twenty-
- 4. three. The enrollees in this program are paid by the Federal
- 5. Administration Service. Unfortunately, the Department of
- 6. Conservation has had to continue with difficulties with the
- 7. payments made by this office and they wish to exercise an
- 8. option and that is to transfer this payroll over to the
- 9. State of Illinois so that they can process these checks to the
- 10. enrollees and I ask your favorable consideration of the...
- 11. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 12. Is there any further discussion? Senator Demuzio.
- 13. SENATOR DEMUZIO:
- 14. Thank you, Mr. President. I have no quarrel with what
- 15. Senator Merlo is attempting to do here. I...I'd just like
- 16. to ask a question, if I may?
- 17. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 18. He indicates he will yield.
- 19. SENATOR DEMUZIO:
- 20. The question being, that on the exemption of these
- 21. individuals from the Pension Code and Personnel Code, are they,
- 22. in fact, deemed employees of the Department of Conservation
- 23. as determined by the Federal Government?
- 24. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 25. Senator Merlo.
- 26. SENATOR MERLO:
- 27. They would not, Senator. These...the period of time is
- 28. normally about twelve months of employment and, of course,
- 29. under the exemption they would not be considered employees
- 30. of the State and they are not at the present time.
- 31. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 32. Senator Demuzio.
- 33. SENATOR DEMUZIO:

- 1. Then, if they're not considered as employees of the State
- 2. of Illinois, do they...are they covered under the usual
- 3. ordinary and customary Workmen's Compensation and Unemployment
- 4. Compensation Laws in Illinois, if they carry this exemption...
- 5. terminology?
- 6. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator Merlo.
- 8. SENATOR MERLO:
- 9. I really don't know the answer to that, as far as Unemployment
- 10. Compensation or Workmen's Compensation is concerned, but I know
- 11. as far as the other fringe benefits, hospitalization, retirement
- 12. funds, et cetera, they are not considered under that program.
- 13. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 14. Senator Demuzio.
- 15. SENATOR DEMUZIO:
- 16. Well, as I say, I have no guarrel with what you're
- 17. attempting to do here, but I am curious as to if...if these
- 18. exemptions only are applicable to the...the Pension Code and,
- 19. quite frankly, I would like to know why we're exempting them
- 20. from the...from the Personnel Code.
- 21. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 22. Senator Merlo. Senator Merlo.
- 23. SENATOR MERLO:
- 24. As I mentioned before, they are not State employees and,
- 25. therefore, would not come under the Act, the Personnel Act.
- 26. This is a Federal Program. It's a temporary employment
- 27. program. The maximum number of months is twelve months. No,
- 28. these are not the CETA employers, no.
- 29. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 30. Senator...Senator Demuzio.
- 31. SENATOR DEMUZIO:
- 32. Well, my question is then, I...I don't, frankly, understand
- 33. why Senator Merlo, we're exempting them if they, in fact, aren't

- 1. State employees anyway.
- 2. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator Merlo.
- 4. SENATOR MERLO:
- 5. That, the reason being, that they are now going to transfer
- 6. the process of the paychecksover to the State of Illinois.
- 7. Presently, the checks to the enrollees are made through the
- 8. Federal agency. Assuming now that this is done by the State
- 9. of Illinois, then the question, of course, arises as to
- 10. whether or not they become State employees and the answer to
- 11. that would be no because under the Act they would be exempted.
- 12. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 13. Senator Demuzio.
- 14. SENATOR DEMUZIO:
- 15. I'm not convinced of that, frankly, the...I...are they...
- 16. are they...will they be classified now as beneficiaries of the
- 17. Federal Program rather than as an employee? What would be
- 18. their classification now?
- 19. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 20. Senator Merlo.
- 21. SENATOR MERLO:
- 22. Vince, I'm sure if you will look at the Act, there are
- 23. a number that are exempt. I think there's something like
- 24. ten or twelve classifications of employees that are exempt
- 25. as far as the Department of Personnel and the various agencies
- 26. of Government are concerned. This would be just included in
- 27. the Act. I don't...this was a Department of Conservation's
- 28. bill. I...I'm sure that there's every protective measure
- 29. taken that it will be not a cost to the State of Illinois.
- 30. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 31. Senator Demuzio.
- 32. SENATOR DEMUZIO:
- 33. Well, I notice that Senator Lemke has a bill on the

- 1. Calendar that...as I recall correctly exempts or...or
- reclassifies so...so-called employees or removes employees
- from the definition at various colleges and universities in
- 4. Illinois and I would have the same questions on that bill as
- 5. I'm relating to this one. It would appear to me that under the
- 6. exemption of...of these individuals no longer being...not
- 7. being classified as employees that, if we're going to...exempt
- 8. them from just the Personnel and Pension Code that this would
- 9. automatically have some effect on their status in terms of
- 10. Workmen's Compensation, for example, and State liability.
- 11. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 12. Senator Knuppel.
- 13. SENATOR KNUPPEL:
- 14. Well, this is my question. Does this exempt these young
- 15. people from being entitled, if they're injured, to Workmen's
- 16. Compensation benefits?
- 17. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 18. Senator Merlo.
- 19. SENATOR MERLO:
- 20. Senator, as far as Workmen's Compensation and Unemployment
- 21. Compensation...John, did you find the answer in the bill? Well,
- 22. John's looking...looking the answer up.
- 23. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 24. Senator D'Arco, do you wish to...Senator D'Arco.
- 25. SENATOR D'ARCO:
- 26. Yeah, to answer Vince's question. It says in this letter
- 27. from the Employees Retirement System of Illinois that because
- 28. they receive State payroll checks they must be included in
- 29. the definition of employee in the State system for retirement
- 30. purposes. Just like the CETA employees were included in...and
- 31. that's the reason for the bill to exempt them from the Pension
- 32. Fund
- 33. PRESIDING OFFICER: (SENATOR SAVICKAS)

- Senator Knuppel.
- 2. SENATOR KNUPPEL:
- 3. Well, I don't think that has...answers the question that
- 4. I asked. It...it goes over to something else entirely. These
- 5. young people, as I understand it, work for the State of
- 6. Illinois. In other words, they get paid by someone else but
- 7. they work at, for instance, Marseilles State Park. They work
- 8. other places. They do work that's beneficial to the State of
- 9. Illinois and right at the present time, unfortunately, I have
- 10. to say this, that the State of Illinois is being somewhat less
- 11. than candid with people who are injured in work. All of a
- 12. sudden they come to the realization, the people that are
- 13. running the State of Illinois Workmen's Compensation Program...
- 14. they've come to the realization that it...that the new program
- 15. that was passed in 1975 is costing one hell of a lot of money.
- 16. They're cutting off people that are permanently disabled, even
- 17. though the commission finds that they're not permanently disabled
- 18. and...and they're cutting them off temporarly total arbitrarily.
- 19. I think this is a very controversial subject and it was my
- 20. understanding that we weren't going to take up controversial
- 21. subjects this morning. I, personally, think that...that before
- 22. I could vote for this bill I would have to be assured that these
- 23. young people perform no worthwhile service for the State of
- 24. Illinois and/or if they do that they're entitled, if they're
- 25. injured on the job, to the same kind of coverage that anybody
- 26. else that's doing something beneficial for the State of Illinois
- 27. receives, particularly our young people. These people generally
- 28. are youngsters between fifteen and seventeen years of age and I
- 29. think it will be atrocious to have some youngster that was injured
- 30. down at Marseilles State Park or some place else, you know, be
- 31. cut off.
- 32. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 33. Senator Merlo requests that the bill be taken out of the

- 1. record. For what purpose does Senator Donnewald arise?
- 2. SENATOR DONNEWALD:
- 3. Well, while we have a lull and in between noncontroversial
- 4. bills, I...I would suggest that any member that might have a
- 5. bill on the Order of 3rd reading and wishes to amend it would...
- 6. would give a list or the numbers of those bills to the Secretary.
- 7. We might consider that at a later time this morning.
- 8. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 9. For what...for what purpose does Senator Graham arise?

- 11. I'd like to arise on a point of personal privilege, Mr.
- 12. President, for the purpose of making an observation.
- 13. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 14. Make your observation.
- 15. SENATOR GRAHAM:
- 16. Some few years ago, the Senate had adopted a policy,
- 17. generally considered by all that in order to perpetuate some
- 18. sense of dignity and decor on the Floor of the Senate...
- 19. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 20. Could we have a little attention for Senator Graham.
- 21. SENATOR GRAHAM:
- 22. ...that when we referred to fellow Senators in debate,
- 23. usually it was the practice that to say to the Gentleman from
- 24. whatever county or whatever town or Senator so and so...whatever
- 25. his name would be. I think we have fallen into a trap now where
- 26. we're using so much informality that we're abusing the dignity
- 27. of the Senate to a great degree as we are doing with an extra-
- 28. ordinary amount of movement in...and the conversation on the
- 29. Floor of the Senate, which may make it appear to the people
- 30. in the gallery that this is some kind of picnic we're running
- 31. down here while we're doing the business of the State. I
- 32. would...I would plead with my colleagues to address each other
- 33. on the Floor of this Senate as Senator whatever their last name

- 1. is or the Gentleman from somewhere. If you want to call them
- 2. by their first names in your...in your social activities, that's
- 3. fine or off the Floor of the Senate. I just think, Ladies and
- 4. Gentlemen, if we would adhere to this, I think we would present
- 5. a better picture to the people that are observing the action

- 21. SENATOR GITZ:
- 22. There are a lot of bills here and I know that time is getting
- 23. short, but there are some of us that would like to know what
- 24. we're voting on. Now, the fact remains that a lot of these amendments
- 25. have not been distributed. There was a vote taken just a few
- 26. minutes ago, there were about thirty-five people that were absent.
- 27. I submit that most of the people didn't even know what we were
- 28. doing up or down. I believe we should abolish these commissions,
- 29. but I am very, very disgusted at the fact that a lot of these
- 30. amendments are not distributed to the membership because I want to
- 31. know what I am voting on and accountable for.
- 32. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 33. Would you distribute amendments to Senator Gitz, get the Page to distribute them. Senator Hall.

- 1. SENATOR HALL:
- 2. I would wonder, Senator Pate Philip, this is quite a
- 3. controverisal matter. I think that we should hold that bill right
- 4. where it is on 2nd reading until many of us know just exactly what
- 5. is going on. I would...Senator Philip, you asked me yesterday
- 6. about when a boat was going to be launched. Let's not...let's not

- 21. I...I think that the Gentleman ought to leave this bill on
- 22. 2nd reading with so many amendments that haven't even been digested
- 23. today, that we can come back Monday and perhaps do a little more
- 24. work on this bad bill.
- 25. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator Coffey.
- 27. SENATOR COFFEY:
- 28. Well, Mr. Chairman, I'd also like to ask the sponsor of this bill
- 29. to hold on 2nd reading. I've got two amendments that they haven't
- 30. got down to me yet that I was going to offer and I would appreciate
- 31. it if he would hold it on 2nd reading.
- 32. PRESIDING OFFICER: (SENATOR SAVICKAS)

- 18. The two that deal with agriculture cost the State no money whatsoever.
- 19. And I say be...when we get to 3rd reading with the amendments,
- 20. I will produce a list of the commissions we are abolishing so
- 21. everybody knows exactly what we are attempting to do.

- 23. Senator Mitchler.
- 24. SENATOR MITCHLER:
- Thank you, Senator Philip, for telling me that. Now, who...
- 26. who decided to put those back in?
- 27. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 28. Senator Philip.
- 29. SENATOR PHILIP:
- The sponsor decided in his great wisdom.
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- 32. Senator Mitchler.
- SENATOR MITCHLER:
 - Well, that answered my question. Thank you. Then in my opinion,

- 1. in the wisdom of the other fifty-eight members, you should respect
- their wisdom, also.
- 3. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 4. Senator D'Arco.
- 5. SENATOR D'ARCO:
- 6. I move the previous question.
- 7. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Would you hold that for a moment. Senator Graham, for what
- 9. purpose do you arise?
- 10. SENATOR GRAHAM:
- 11. I rise on two points, Mr. President. First is to announce
- 12. that Senator Ozinga is absent today due to the fact that there is
- 13. a death in the family and to make an observation with regard to
- 14. Senator Philip's dilemma. You know, we had a young man one time
- 15. that had kind of a tough time and was a young fellow and his
- 16. parents were on relief and he went to the public schools and
- 17. graduated and he got a legislator's scholarship to go to college and
- 18. got through college, he got a...some kind of a grant to
- 19. finish his master's degree, he got out and he opened his business,
- 20. he got a small business loan to open his business and was doing
- 21. pretty well, he got a loan from the Federal Land Bank to buy a farm
- 22. to keep mom and dad on and then he got his income tax one day and
- 23. he sat down and wrote his congressman and he said what the hell are
- 24. we going to do about this excessive spending in government? This
- 25. kind of relates to this bill. You know, everybody thinks their own
- 26. is the best and nobody wants to be tramped upon, but just remember
- 27. about all the things we get and how we scream about it when we pay
- 28. the bills.
- 29. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 30. We had two Senators who sought recognition before Senator D'Arco
- 31. made his motion. They are Senator Gitz and Senator Hall.
- 32. Senator Gitz.
- 33. SENATOR GITZ:

- 1. I would merely reiterate my request of the sponsor to hold this
- 2. bill on 2nd reading. I think he has a fine bill. I like the intent
- 3. of it. I think it should be done. But I am very much afraid that
- 4. many of us are not clear on what these amendments are doing, what
- 5. commissions are staying in and which are not. If this bill is held
- 6. on 2nd reading, we can see what we are doing and then we can
