3. Senators please be in their seats. Will our guests in the

6. REVEREND ANDREW MCCOY:

7. ( Prayer given by Reverend McCoy )

8. PRESIDING OFFICER: (SENATOR HALL)

9. Reading of the Journal. Senator Nedza.

10. SENATOR NEDZA:

11. Yes, thank you...thank you, Mr. President. Mr. President,  
12. I move that the reading and approval of the Journals of Tuesday,  
13. June the 17th, Wednesday, June the 18th, and Thursday, June  
14. the 19th in the year 1980 be postponed pending arrival of the  
15. printed Journals.

16. PRESIDING OFFICER: (SENATOR HALL)

17. You've heard the motion. All in favor say Aye. Opposed Nay.  
18. The motion carries. Committee Reports. Mr. President.

19. SENATOR ROCK:

20. Thank you, Mr. President, and Ladies and Gentlemen of  
21. the Senate. I would like the Senate to recognize, we have a  
22. group of distinguished visitors from Nigeria, each of whom is  
23. a elected official of that great nation. They are here visiting  
24. with us, and have been touring the State Capitol. They spent  
25. some time yesterday in the House of Representatives and they  
26. have graced our Chamber, and I would like the Senate to recognize

30. SENATOR ROCK:

31. Thank you, Mr. President. The Committee on Appropriations  
32. II is still, at this moment, meeting. And they have suggested that  
33. they need, at least, an additional forty-five minutes or so. So,

4. and all Senators, it is congratulatory.

5. Senate Resolution 574, offered by Senators Shapiro, Rock,  
6. and all Senators, and it is congratulatory.

7. Senate Resolution 575, offered by Senators Mitchler,  
8. Vadalabene, Bloom, and others, and it is congratulatory.

23. PRESIDENT:

24. Is there leave to add the foregoing congratulatorys to  
25. the Consent Calendar? Leave is granted. Senator Wooten, for  
26. what purpose do you arise?

27. SENATOR WOOTEN:

28. Well, Mr. President. I would like to move that House  
29. Joint Resolution 104, which is in Executive Committee, be dis-  
30. charged and placed on the Secretary's Desk. This relates to  
31. the need to prepare arguments for and against a proposed Con-  
32. stitutional Amendment. It's still the subject of some study,  
33. but we have to be prepared, and have to have the committee organized

1. to get this done. So, I would move that the Executive Committee  
2. be discharged.

3. PRESIDENT:

4. All right, Senator Wooten has moved that the Executive  
5. Committee be discharged from further consideration of House  
6. Joint Resolution 104, and that it be placed on the Order of  
7. the Secretary's Desk, Resolutions. All in favor signify by  
8. saying Aye. All opposed. The Ayes have it. So ordered.

9. Senator Nimrod, for what purpose do you arise?

10. SENATOR NIMROD:

11. Yes, thank you, Mr. President. I would move on Senate  
12. Joint Resolution that's on the Secretary's Desk, I would move  
13. to suspend Rule 6 and the other appropriate rules to have an  
14. immediate consideration of the resolution.

15. PRESIDENT:

16. What...what's the number? Senate Joint Resolution 121.  
17. Read the...all right. Resolutions.

18. SECRETARY:

19. Senate Joint Resolution 121, offered by Senators Nimrod,  
20. Berman, Newhouse, and Davidson.

21. PRESIDENT:

22. Senator Nimrod.

23. SENATOR NIMROD:

24. Yes, Mr. President, and Ladies and Gentlemen of the Senate.  
25. This resolution...provides for the members of the Elementary and  
26. Secondary and Higher Education Chairman and Minority Spokesman,  
27. and the School Problems Commission to accept and review the  
28. materials that are being furnished by the State Board of Ed-  
29. ucation, which are due June 30th as a result of a bill we passed  
30. out of this Senate eighteen months ago. And it provides for us  
31. to then return, for the nextnext Session, and consider any leg-  
32. islation they're recommending. I would move for the immediate  
33. adoption of the resolution.

1. PRESIDENT:

2. All right, Senator Nimrod has moved to suspend the rules  
3. for the immediate consideration and adoption of Senate Joint  
4. Resolution 121. Any discussion? If not, all in favor signify  
5. by saying Aye. All opposed. The Ayes have it. The rules are  
6. suspended. Senator Nimrod now moves the adoption of Senate  
7. Joint Resolution 121. All in favor signify by saying Aye.  
8. All opposed. The Ayes have it. The resolution is adopted.  
9. Resolutions.

10. SECRETARY:

11. Senate Resolution 583, offered by Senators Mitchler,  
12. Vadalabene, and others.

13. PRESIDENT:

14. Consent Calendar. Senator Nimrod, for what purpose do you  
15. arise?

16. SENATOR NIMROD:

17. Mr. President, I would ask leave to have the reporting of  
18. the Senate Resolution 205, which had to do with a...study  
19. on sex education, to extend that reporting date until November  
20. the 15th. I would seek leave to have that reporting date.

21. PRESIDENT:

22. I think that has to be done by Resolution in Writing. We  
23. can get to it Monday. Resolutions. Messages from the House.

24. SECRETARY:

25. A Message from the House by Mr. O'Brien, Clerk.

26. Mr. President - I am directed to inform the Senate  
27. the House of Representatives has adopted the following joint  
28. resolution, in the adoption of which I am instructed to ask  
29. concurrence of the Senate, to-wit:

30. House Joint Resolution 106.

31. ( Secretary reads HJR 106 )

32. PRESIDENT:

33. Senator Savickas.

1. SENATOR SAVICKAS:

2. Yes, Mr. President, I would move the adoption of House  
3. Joint Resolution 106.

4. PRESIDENT:

5. Yes, this is the adjournment resolution. Is there any dis-  
6. cussion? Senator Wooten.

7. SENATOR WOOTEN:

8. No, not on this.

9. PRESIDENT:

10. All right. All right, Senator Savickas has moved to suspend  
11. the rules for the immediate consideration and adoption of  
12. House Joint Resolution 106, the adjournment resolution which  
13. calls for both Houses at the close of business today to return  
14. to Springfield next Monday at the hour of noon. Is there any  
15. discussion? If not, all in favor signify by saying Aye. All  
16. opposed. The Ayes have it. The rules are suspended. Senator  
17. Savickas now moves the adoption of House Joint Resolution 106.  
18. All in favor signify by saying Aye. All opposed. The Ayes  
19. have it. The resolution is adopted. On the Resolutions Consent  
20. Calendar, Mr. Secretary have any objections been filed?

21. SECRETARY:

22. No objections have been filed, Mr. President.

23. PRESIDENT:

24. All right, if not, Senate...copies have been distributed,  
25. I'm informed. There's Senate Resolution 559, 560, 561, 62,  
26. 563, 564, 567, 568, 569, 570, 71, 72, Senate Joint Resolution  
27. 120, Senate Resolution 573, 74, 75, 76, 77, 78, 79, 580, 581,  
28. 582, and 583. No objections having been filed, is there any  
29. discussion? Senator Savickas moves the adoption of the  
30. foregoing Consent Calendar, and in the resolutions there-  
31. on. All in favor signify by saying Aye. All opposed. The  
32. Ayes have it. The resolutions are adopted. If I can have  
33. your attention, if you'll turn to page 18. Pursuant to the

1. agreement reached earlier in the week, we will proceed on the  
2. Order of Motions in Writing. Senator Wooten, for what purpose  
3. do you arise?

4. SENATOR WOOTEN:

5. Mr. President, I want to make an inquiry. Yesterday, I  
6. filed a motion, which was signed by Senator Sommer on Amend-  
7. ment No. 3 to House Bill 3474, which quite frankly got past  
8. me, I was talking to another member, and that's a subject that  
9. several of us want to consider again, but I don't see that  
10. Motion in Writing in our list today. Is that in order to be  
11. considered today, or when will that come before us?

12. PRESIDENT:

13. Yes. No, those motions, of course, do not...not of course,  
14. but in the ordinary course of events do not show up on this order  
15. of business. This is a motion with respect to a committee amend-  
16. ment, which had been adopted. It is a motion to reconsider, and  
17. when we get to that order of business, when we get House Bill  
18. 3474, that will be dealt with.

19. SENATOR WOOTEN:

20. Okay, it was...the motion was Tabled, the committee amend-  
21. ment was Tabled, and I was really not aware that was happening.  
22. So...all right, so that is in order today, then. Thank you very  
23. much.

24. PRESIDENT:

25. It is in order. Senator Shapiro, for what purpose do you  
26. arise?

27. SENATOR SHAPIRO:

28. Mr. President, and Ladies and Gentlemen of the Senate.  
29. On the Secretary's Desk is a Motion in Writing, which I have  
30. filed, and I'd like the Secretary to read the motion, please.

31. PRESIDENT:

32. Mr. Secretary.

33. SECRETARY:

A Motion in Writing. I move to suspend the Senate Rule 5C,

1. and all appropriation...and all appropriate rules for the  
2. purpose of Tabling all Motions appearing on the Senate Calendar  
3. on the Order of Motions in Writing. Dated 6/20/80. Signed,  
4. Senator David Shapiro.

5. PRESIDENT:

6. All right, you've heard the motion. Senator Shapiro.

7. SENATOR SHAPIRO:

8. Well, Mr...Mr. President, and Ladies and Gentlemen of the  
9. Senate. I think the Rules Committee has done an excellent  
10. job and if we want to get out of here by June 30th, this is  
11. the motion to consider, and I would appreciate affirmative vote  
12. on the motion.

13. PRESIDENT:

14. All right, Senator Shapiro has placed that Motion in  
15. Writing, it has been read. Is there any discussion? Senator  
16. Kenneth Hall.

17. SENATOR HALL:

18. Parliamentary inquiry, Mr. President.

19. PRESIDENT:

20. Yes.

21. SENATOR HALL:

22. If we move to adjourn right now, what would be the position  
23. of...of these things...of these...

24. PRESIDENT:

25. That...that motion would probably prevail. No question  
26. about it, everybody want to go home.

27. SENATOR HALL:

28. I mean what about...are we going back to this same order  
29. of business Monday when we come back?

30. PRESIDENT:

31. I think not. We are going to be pretty busy on Monday.  
32. And I hope everybody will be here at the hour of noon, sharp  
33. as Senator Rhoads and I say.



1. SENATOR HALL:

2. Well, I hope everybody votes against this motion then.

3. PRESIDENT:

4. Further discussion? Senator Knuppel.

5. SENATOR KNUPPTEL:

6. Well, I...well, I appreciate how hard the Rules Committee  
7. worked, and I appreciate everything that Senator Shapiro has  
8. said. My mother used to tell me, you know, self...self-brag...  
9. what is that. Self-brag, is self-scandal or something to that  
10. effect. Anyway, I know they hold themselves in high esteem,  
11. but I...I feel that they did this on a piecemeal basis, where  
12. they give each of us a crumb and hope that would satisfy us.  
13. It may satisfy some, it doesn't satisfy me with...with respect  
14. to some of them. There's some of the bills, and I have probably  
15. more motions here than anyone else, there's some I don't intend  
16. to call, there's others I do. But I...I would like to see them  
17. have an opportunity at least.

18. PRESIDENT:

19. Further discussion? Senator Netsch.

20. SENATOR NETSCH:

21. Thank you, Mr. President. I would rise in opposition  
22. to the motion, also. It seems to me that a number of people  
23. have...who have been less than happy with the uneven course  
24. of the Rules Committee have been relying on their capacity to  
25. offer a motion to discharge and at least have a chance at it.  
26. Whether or not they're going to be successful, we all know  
27. given the fact that many members have already left the...it's  
28. not a very high degree of probability, but at least there is  
29. an opportunity, and for some of us that is quite important.  
30. I, for one, am the sponsor of...Senator Martin and I, in fact,  
31. are the sponsors of some bills that were sponsored by all of  
32. the women Legislators, on dealing with a very important subject,  
33. and although I kept counting enough votes in the Rules Committee  
to get them out, for some reason the bills never came out, and

1. I think at least, I would like a chance to...Senator Martin  
2. and I would like a chance to discharge one. It seems to me  
3. that the...the pattern is sufficiently uneven, that it is not  
4. fair to those of us who have been relying on this to just simply  
5. out of hand Table all of the motions. And I would resist it.  
6. PRESIDENT:  
7. Further discussion? Senator Wooten.  
8. SENATOR WOOTEN:  
9. Mr. President, just an inquiry. The motion about which  
10. I inquired, I did not mean to lead it to a mass-execution. Is it...  
11. PRESIDENT:  
12. It is not involved in this.  
13. SENATOR WOOTEN:  
14. So, Senator Shapiro's motion only relates to those which  
15. are printed?  
16. PRESIDENT:  
17. That is correct.  
18. SENATOR WOOTEN:  
19. Oh, thank God, we're not on that list. Thank you, Sir.  
20. PRESIDENT:  
21. Further discussion? Senator Ozinga.  
22. SENATOR OZINGA:  
23. Mr...Mr. President, I would say that I think this is a  
24. good motion after all the hard work that's been done by the  
25. Rules Committee, and this is one way of expressing our feelings  
26. to them by voting for this motion. And I would move the  
27. previous question.  
28. PRESIDENT:  
29. Well, as...in accord... with our rules, there are three or  
30. four members who have indicated prior to that motion. So, if  
31. you'll just withhold that, I will recognize you at the appropriate  
32. time. Senator Newhouse.  
33. SENATOR NEWHOUSE:

1. Thank you, Mr. President. Mr. President, it seems to  
2. me that the only recourse that's available to those who have  
3. met the fate worse than death in the Rules Committee, is for  
4. a general discussion on the Floor and a vote by the members of  
5. this Body, and to cut off that kind of vote, it would seem to  
6. me would violate all the rules of either democracy or republicanism.  
7. And I would suggest that we wouldn't want to be in that position  
8. and...might want to consider, seriatim, even though it...take a bit more  
9. time, those motions that Legislators felt seriously enough  
10. about to file a written request with the Secretary's Desk. And  
11. I would be opposed to the motion, and would hope that my  
12. colleagues would join in and let us get on with the business  
PRESIDENT:

13.  
14. Senator Philip.  
15. SENATOR PHILIP:

16. Thank you, Mr. President, and Ladies and Gentlemen of  
17. the Senate. I might remind our fellow Senators that the Rules  
18. Committee did leave out two hundred and thirty-two bills. Now,  
19. if I remember correctly, this Session is supposed to be limited  
20. to budgetary matters and emergency matters. If you take a  
21. close look at those two hundred and thirty-two bills, I'll bet  
22. you ten percent of them are not emergency matters. You know  
23. we've worked long and hard, I think the Rules Committee did  
24. a good job, and we ought to support this motion.

25. PRESIDENT:  
26. Further discussion? Senator Lemke.  
27. SENATOR LEMKE:

28. ...today, I want to vote on adjournment.  
29. PRESIDENT:

30. Yeah, well that motion...  
31. SENATOR LEMKE:

32. It's always in order.  
33. PRESIDENT:

1. That motion is always in order, and it will be so re-  
2. cognized. Senator Donnewald.

3. SENATOR DONNEWALD:

4. Well, thank you, Mr. President, and members of the Body.  
5. I think that a vote on this particular motion, if it receives  
6. thirty votes will save all of the members a lot of time, be-  
7. cause very frankly, if you have thirty votes to sustain this  
8. particular motion it will also show that none of the motions  
9. on the Calendar as set forth will succeed. So, I would be in  
10. favor of the motion to...

11. PRESIDENT:

12. Any further discussion? Senator Ozinga has moved the previous  
13. questions. Senator Shapiro may close.

14. SENATOR SHAPIRO:

15. ...call

16. PRESIDENT:

17. Oh, I...Senator Bruce.

18. SENATOR BRUCE:

19. Thank you, Mr. President, and members of the Senate. I  
20. rise in opposition to this motion, and let me tell you why.  
21. This is a deliberative Body, lead by leadership, which happens  
22. to sit on Rules. And we came here Monday with our word to  
23. every member who had not gotten a fair shake out of Rules,  
24. and I think there's...justifiable reasons why people would feel that  
25. they have not gotten adequate consideration in the Rules Committee,  
26. that they would have a shot at these motions on Friday. And,  
27. by God, I gave my word I would be here to vote on those motions.  
28. I have one motion, which I plan to Table when it comes up in the  
29. order. But the Rules Committee is not the only opinion and  
30. judgment which exists in this Body. There...this Body decides  
31. whether any of these bills will be heard and only this Body  
32. and I'm not ready to abdicate my responsibility of...of a State  
33. Senator to the Rules Committee to have them decide each and

1. every bill, that's going to come before this Body for debate.  
2. I don't know how many of these I'm going to vote for myself,  
3. but I think every Senator who is elected who was told we would  
4. get to this Order of Motions, that they would have their shot,  
5. their day in court, ought not to be denied that right. The  
6. final thing is that if we allow this to happen, by leader-  
7. ship, each and every member of this Body will suffer because  
8. on June 27th or 28th or 29th another list may be prepared  
9. containing my bill or your bill or someone else's bill and  
10. they'll Table my bill on a motion of thirty votes. I don't  
11. want to be a party to that. Every guy here, he wants to take  
12. a shot at it, wonderful, but the Rules Committee did not...they  
13. were not invested with the right to decide by fiat what's going  
14. to happen in this Body, and I oppose strongly this motion.

15. PRESIDENT:

16. Further discussion? Senator Rhoads.

17. SENATOR RHOADS:

18. Mr. President, for the same reasons just stated by Senator  
19. Bruce, I think it's obvious that there aren't enough people here  
20. today to give adequate consideration to these motions. If they  
21. were left on the Calendar, and we came back next week and some-  
22. thing was very important that we had to go to that order of  
23. business we can do so by thirty votes at that time. But I think  
24. Senator Lemke's motion for adjournment would be the preferable  
25. motion at this time.

26. PRESIDENT:

27. Senator Buzbee.

28. SENATOR BUZBEE:

29. Thank you, Mr. President. I resent the implication by another  
30. Senator that we ought to not be able to do any business this  
31. afternoon because some folks have gone home. Now, I was caught  
32. in a box a few weeks ago where I was trying to pass a bill that  
33. wasn't all that controversial, and some folks had gone home on

1. Thursday afternoon and I lost my damn bill. Now, if they don't  
2. want to stay here and serve the way they were elected to serve  
3. that's not my problem. I'm here, they ought to be here. I  
4. think that we ought to go ahead and deal with this motion up  
5. or down, I happen to agree with Senator Shapiro in this case.  
6. But up or down, let's move on this motion. But let's don't  
7. use the excuse, let's put it off till Monday, because there's  
8. some folks that have gone home. That's their problem, hopefully  
9. their constituents will take care of them the next time.

10. PRESIDENT:

11. Senator Washington.

12. SENATOR WASHINGTON:

13. On a parliamentary inquiry. Am I correct, a motion to  
14. Table was lodged by Senator Shapiro?

15. PRESIDENT:

16. Yes, it's a motion to suspend and...and then Table the  
17. Motions in Writing.

18. SENATOR WASHINGTON:

19. Suspend...

20. PRESIDENT:

21. It will...it will require thirty affirmative votes, yes Sir.

22. SENATOR WASHINGTON:

23. It's lumped together as one motion?

24. PRESIDENT:

25. That is correct. Senator Shapiro. All right, Senator  
26. Shapiro...Senator Shapiro has moved to suspend Senate Rule  
27. 5C and all appropriate rules for the purpose of Tabling all  
28. motions appearing on the Senate Calendar on the Order of  
29. Motions in Writing. Those in favor with that...of that motion  
30. will vote Aye. Those opposed will vote Nay. The voting is open.  
31. Have all voted who wish? Have all voted who wish? Have all  
32. voted who wish? Take the record. On that question, the Ayes  
33. are 24, the Nays are 27. The motion fails. Senator Shapiro.

1. SENATOR SHAPIRO:  
2. Mr. President, I'd like to call a Republican caucus immediately  
3. in Room 309.  
4. PRESIDENT:  
5. That request is in order. The Senate will stand in recess.  
6. RECESS  
7. AFTER RECESS  
8. PRESIDENT:  
9. The Senate will come to order. If you'll turn to page  
10. 18 on the Calendar. On the Order of Motions in Writing, there's  
11. a motion filed with respect to House Bill 447. Mr. Secretary.  
12. Senator Knuppel.  
13. SENATOR KNUPPTEL:  
14. I'm told by my hyphenated sponsor on this bill, that...that  
15. he doesn't want to call it. I personally think this is something  
16. that requires more discussion, and would impede us next week.  
17. It should have been let out of Rules in the first place, but I'm  
18. going to Table it.  
19. PRESIDENT:  
20. That motion has been Tabled...that motion is in order. All  
21. in favor signify by saying Aye. All opposed. The Ayes have it.  
22. Tabled. How about 554?  
23. SENATOR KNUPPTEL:  
24. I don't feel exactly the same way about 554. 554 is a...  
25. PRESIDENT:  
26. All right, read...read the motion, Mr. Secretary.  
27. SECRETARY:  
28. I move to discharge the Committee on Rules from further  
29. consideration of House Bill 554, and that the bill be placed  
30. on the Calendar on the Order of 2nd reading. Signed, Senator Knuppel.  
31. PRESIDENT:  
32. Senator Knuppel.  
33. SENATOR KNUPPTEL:

1. It's a simple single issue and it's whether you want to  
2. take out of the...out of the consideration of the court and de-  
3. termine as non-marital property pension plans that individuals  
4. have paid into which have not yet vested. It's a simple issue,  
5. and I would like to have the...the...I would like for the Body  
6. to adopt the motion to discharge.

7. PRESIDENT:

8. Senator Knuppel has moved to discharge the Committee on  
9. Rules from further consideration of House Bill 554. Is there  
10. any discussion? If not, those in favor of the motion will vote  
11. Aye. Those opposed will vote Nay. The voting is open. Have  
12. all voted who wish? Have all voted who wish? Take the record.

3. the Senate. This is a much needed bill, as Senator Bloom has

5. employees in Belleville, and a thousand in Peoria. Now, this  
6. means that the...the brewery alone in Peoria contributes over

27. SENATOR NETSCH:

28. Thank you, Mr. President. This motion filed jointly by

30. pregnancy bills which were the work product of all of the women  
31. Legislators in the House. This is the only motion that we will  
32. be filing, or...or that we will be calling with respect to these  
33. bills. This is the most important of the bills in the package, and



1. the primary focus of the long period of hearings and work  
2. product of that group. It designates the Illinois Department  
3. of Public Health as a single State agency for planning and  
4. co-ordinating adolescent parent support services and establishes  
5. a fifteen member State-wide task force to carry out a...all of  
6. the co-ordination activities that are authorized and mandated  
7. in the bill. It is supported by every single one of the State  
8. agencies that is involved in any aspect of teenage pregnancy.  
9. It is supported by all of the private agencies and others who  
10. are concerned and interested in this. It was the one bill that  
11. had unanimous support from everyone who has been concerned  
12. about the extremely serious problem of teenage pregnancy. I  
13. yield to Senator Martin for additional comments.

14. PRESIDENT:

15. All right, Senator Netsch has moved to discharge the  
16. Committee on Rules from further consideration of House Bill  
17. 3214. Any discussion? Senator Martin.

18. SENATOR MARTIN:

19. Thank you, Mr. President. I do hate to file a motion on  
20. this and I will be Tabling all others. I'm still not sure how

Rules let it out?

1. PRESIDENT:

2. Senator Netsch.

3. SENATOR NETSCH:

4. You just opened a can of worms, Senator Rhoads. I do  
5. not know. I was under the impression that there were ample  
6. votes in the Rules Committee, having talked to a very sub-  
7. stantial number of the Rules Committee, myself directly as  
8. did Senator Martin, that the bill would be, in fact, let out  
9. of the Rules Committee. But for mysterious reasons, which  
10. none of us has been able to understand, it nevertheless  
11. did not make it out. That's the second part of your question.  
12. The first part is it genuine emergency, and I think there is

14. I let one go, I'd like to have a shot at this one. This is  
15. not a bill that came over with any sponsor from the House,  
16. this is a House Committee on Environment, Energy, and Natural  
17. Resources, very simple bill, which encourages us to preserve  
18. the natural preserves of the State of Illinois which are going  
19. to be going...and the emergency being, they're going by the  
20. waysides if we don't do something. The bill simply allows  
21. the State and the local taxing bodies to exempt from real  
22. estate taxation those parcels that farmers are otherwise are  
23. willing to dedicate for preserves throughout the State of  
24. Illinois. The fiscal implication, as I've been given, is  
25. somewhere around eight thousand dollars. It's not going to  
26. cost local governments a lot of money. We're going to preserve  
27. our natures...areas for the State of Illinois, and I think that's  
28. important, I think we ought to consider it now. And I would

5. fails. 3469, Senator Lemke. Senator Newhouse, for what purpose  
6. do you arise?

7. SENATOR NEWHOUSE:

8. Parliamentary inquiry, Mr. President.

9. PRESIDENT:

10. Yes.

11. SENATOR NEWHOUSE:

12. House Bill 3259, was, I believe a hyphenated sponsorship  
13. between me and Senator Daley. If it is in order, I...I'd  
14. like leave to go back to that order of business and give it  
15. a run. It's a simple bill, I'd like to explain it and get a  
16. call on it.

17. PRESIDENT:

18. You've heard the request. Is leave granted? Leave is  
19. granted. On the Order...on the bottom of page 20 on the Calendar  
20. on the Order of Motions in Writing, there is a motion filed with  
21. respect to House Bill 3259. Read the motion, Mr. Secretary.

22. SECRETARY:

23. We move to discharge the Committee on Rules from further  
24. consideration of House Bill 3259, and that the bill be placed  
25. on the Calendar on the Order of 2nd reading. Signed, Senators  
26. Daley and Newhouse.

27. PRESIDENT:

28. Senator Newhouse.

29. SENATOR NEWHOUSE:

30. Thank you, Mr. President. This is a Legislative Advisory  
31. Committee bill, and it's a bill that requires a posting in  
32. hospitals of three placards that state that emergency medical  
33. services will be provided in their...in their emergency rooms.

1. There's no serious cost effect of this. It's a well considered

21. with the Workmen's Comp. injury of a State employee, we cannot  
22. get one of the State departments to talk to the other department.  
23. And this came about because we couldn't get any rehabilitation  
24. services for a State employee, which is 33...3493, and this  
25. creates a State Safety Package and they all have to talk to  
26. one another and do something about promoting occupational health  
27. and safety of State employees. And 94 says if there is  
28. going to be...really is creates risk management within the  
29. Department of Administrative Services, which is responsible for  
30. this, we have found that if an employee is injured on the  
31. job and it is an unsafe situation they do nothing about correcting  
32. that unsafe situation, and all I'm trying to do is get the depart-  
33. ment to do what we require private industry to do. And I'd appreciate

1. a vote to get this up to 2nd reading and we can do something to  
2. protect and retrain injured...first protect the worker in the  
3. beginning, keep from being injured and second, if he is injured  
4. we retrain him,make him useful.

27. Senator Nimrod.

28. SENATOR NIMROD:

29. Thank you, Mr. President. The necessity for this bill  
30. has to do with the fact of the abortion bill, which has been  
31. struck down...parts have been struck down by the Supreme Court,  
32. and I have an amendment that's been sent to me, that's been  
33. endorsed by all the pro-life groups that want to be sure it

1. gets on there. Their attorneys, in fact, have prepared the  
2. amendment in order to make it effective. Without that, we  
3. have the whole bill...the abortion bill that we pass is all  
4. in jeopardy, and has to do with the viable fetus; and the  
5. amendment..we have been unable to get it on the other bills.  
6. If we could do that, we would have done it. So, I would ask  
7. if we...vote to discharge this bill, so we can amend  
8. the bill and properly be in conformity with the Constitutional  
9. requirements.

10. PRESIDENT:

11. All right. Senator Nimrod has moved to discharge the  
12. Committee on Rules from further consideration of House Bill  
13. 3595. Is there any discussion? If not, those in favor of  
14. the motion will vote Aye. Those opposed will vote Nay. The

27. All right. With leave of the Body we will go back to  
28. the top of page nineteen, House...there's a motion filed

33. consideration of House Bill 1387 and that the bill be placed

4. Senator Nimrod.

5. SENATOR NIMROD:

6. Thank you, Mr. President and Ladies and Gentlemen of the  
7. Senate. This is probably one of the most important bills...  
8. issues to come before us. We were very fortunate the House  
9. was able to pass it by an overwhelming vote of 114 votes;  
10. and it deals with the repeal of the Inheritance Tax. I've talked  
11. to a number of you about it, and given you information and  
12. literature about this bill; and this is the one opportunity,  
13. I think, to do something not only from keeping millions of  
14. dollars from leaving the State of Illinois, but, I think,  
15. that the tax loss will be very negligent...very minimal, I mean.  
16. And I think one thing, if you're concerned about the loss to  
17. the counties, what we're...what we're proposing is that we  
18. amend the bill so that the counties will, in fact, receive as  
19. much money; maybe give them ten percent of the holding tax,  
20. so that...those that are doing the collecting, now, that the  
21. counties will have no loss of revenue. But I do think that  
22. what it does, it removes this onerous bill which really  
23. gives the problem to both those who have no money to pay, it  
24. locks up the lock boxes and holds the cash away when the  
25. widows need the money the most. At the same time, we have a  
26. max...mass exodus of those wealthy people, who are forced to  
27. leave, take their estate out of the State of Illinois after  
28. they retire, become senior citizens, so that they can avoid  
29. the taxes. I think the State is the loser in this area, both  
30. in the families and the money; and I...I would think that if  
31. we were able to do this that the net loss in this whole bill  
32. would almost be minimal. I think it's very important to those  
33. in...both in low income and high income, to do away with this

1. tax...is probably the highest tax of any State in the union.  
2. I would ask for your favorable consideration.

3. PRESIDENT:

4. Senator Nimrod has moved to discharge the Committee on  
5. Rules from further consideration of House Bill 1387. Any  
6. discussion? If not, those in favor of the motion will vote  
7. Aye. Those opposed will vote Nay. The voting is open. Have  
8. all voted who wish? Have all voted who wish? Take the  
9. record. On that question, the Ayes are 25, the Nays are 12,  
10. none Voting Present. The motion fails. Further Motions  
11. in Writing, Mr. Secretary? I understand a motion has just  
12. been filed. Read the motion.

13. SECRETARY:

14. I move to suspend Senate Rules and to discharge House  
15. Bill 3220, from Senate...from the Senate Rules Committee,  
16. and that the bill be placed on the Calendar on the Order of  
17. 2nd reading. Signed, Senator Newhouse.

18. PRESIDENT:

19. Senator Newhouse.

20. SENATOR NEWHOUSE:

21. Mr. President, I inadvertently filed that motion. It's  
22. Senator Sam Vadalabene's bill. I withdraw the motion.

23. PRESIDENT:

24. The motion has been withdrawn. Any other members have  
25. Motions in Writing with respect to House Bills? Senator  
26. Donnewald.

27. SENATOR DONNEWALD:

28. Yes, Mr. President and members of the Senate, if there  
29. be no further motions concerning Motions in Writing on page
