29. To be members of the Board of Aeronautical Advisors
30. for a term expiring January 1983, Gene Seibert of Carbon-
31. dale, and Barbara Jenison of Paris.

32. To be members of the Illinois Board of Natural Resources
33. and Conservation for a term expiring January 17, 1983, Dr.
34. Lorin I. Nevling, Jr. of Downers Grove.

1. To be members of the Industrial Development Authority
2. for a term expiring January 17, 1983, Peter Gidwitz of Chicago, and
3. N. Clyde Oberlin of Effingham.

4. To be a member of the Health Finance Authority for a
5. term expiring January 20, 1986, Gregory A. Hasty of Peoria.

6. To be a member of the Advisory Board to the Department
7. of Insurance for a term expiring January 17, 1983, David
8. Merritt of Springfield.

9. So, Mr. President and members of the Senate, having
10. read the unsalaried appointments, I now seek leave to

28. Voting Present. A majority of Senators elected concurring

3. On the motion, all in favor say Aye. Opposed Nay. The Ayes
4. have it. The Senate does arise from Executive Session.

6. SENATOR ROCK:

7. Thank you, Mr. President and Ladies and Gentlemen of
8. the Senate. I know some are in a hurry. The Judiciary II
9. Committee, I understand, will, again, meet...pursuant...
10. right after adjournment. I would move that we will stand
11. adjourned until Monday at the hour of noon. I understand,
12. further, from the Reference Bureau that there are a lot of
13. bills that are due to be hatched...they just had trouble
14. with their machine this morning. So in order to accommodate
15. the members who wish to introduce those bills today, perhaps
16. we could stand in recess at this point until the hour of
17. two o'clock for the purpose of introduction of bills and
18. then when we leave here, we will come back...at noon on
19. Monday.

32. and most of the members of the committee will be there, so,
