29. Thank you, Mr. President, Ladies and Gentlemen of the Senate.

30. Senate Joint Resolution 40 is the adjournment resolution, it calls

31. for us to return to Springfield next Tuesday, April 28th, at the

32. hour of noon. And I would move for the suspension of the rules

33. and the immediate...consideration and adoption of this resolution.

1. PRESIDING OFFICER: (SENATOR BRUCE)

2. You've heard the motion. Discussion? All in favor say Aye.  
3. Opposed Nay. The Ayes have it. The resolution is adopted. Senator  
4. Rock, any word on Session next Friday, as tentatively scheduled?  
5. Senator Rock.

6. SENATOR ROCK:

7. Given the...we're now up near a thousand bills, and I have...  
8. if I heard correctly, I have additionally passed out a schedule  
9. for the week of May 4, which, as you know, is the week of the dead-  
10. line, which is May 8. And between next week and this week of  
11. May 4, every committee should have the opportunity to meet three  
12. times. Now, I'm sure everyone's painfully aware that we have a great  
13. number of bills that we have to consider. So, I would urge the  
14. committee chairmen and the minority spokesmen to try to handle  
15. these with some...some degree of alacrity because that week of  
16. May 4 is just...it's fierce, it's a bear, and we're all going  
17. to get overworked, I'm afraid. I do not think we will be able  
18. to avoid next Friday, unfortunately, we just simply have too  
19. much work to do.

20. PRESIDING OFFICER: (SENATOR BRUCE)

21. For what purpose does Senator Egan arise?

22. SEANTOR EGAN:

23. Yes, I would like to announce, Mr. President, and members  
24. of the Senate, in behalf of Senator D'Arco, that the Committee  
25. on Insurance will not meet on April 30th, but instead thereof  
26. will meet on May 5th at 7:00 p.m., and again on May 6th at  
27. 1:00 p.m. here in the Senate Chamber. Thank you.

28. PRESIDING OFFICER: (SENATOR BRUCE)

29. Thank you, Senator Egan. Senator Rock.

30. SENATOR ROCK:

31. Thank you, Mr. President. I have ten bills that were in-  
32. advertently assigned to the wrong committee, and we have checked  
33. with the sponsor and the leadership on both sides, and with the

1. Minority Spokesman on the Committee on Assignment, and I would,  
2. therefore, like to make an omnibus motion with respect to these  
3. ten bills, Senate Bill 631 to be discharged from Public Health,  
4. Welfare and Corrections and be reassigned to the Insurance, Pension,  
5. and Licensed Activities Committee. Senate Bill 642, to be dis-  
6. charged from Elementary and Secondary and reassigned to the  
7. Committee on Higher Education. Senate Bill 758, to be discharged  
8. from the Committee on Revenue and reassigned to Transportation.  
9. Senate Bill 126, to be discharged from Executive and rereferred  
10. to Transportation. Senate Bill 793, to be discharged from Executive  
11. and reassigned to Elections. 794, from Judiciary II to Elections.  
12. Senate Bill 844, from the Committee on Higher Ed to the Committee  
13. on Finance. Senate Bill 845, from Executive to Finance. Senate  
14. Bill 850, from Executive to Finance. And finally, Senate Bill 761,  
15. to be discharged from the Committee on Judiciary I and reassigned  
16. to the Committee on Finance. And I would so move.

17. PRESIDING OFFICER: (SENATOR BRUCE)

18. You've heard the motion. Discussion? All in favor say Aye.  
19. Opposed Nay. The Ayes have it. And the bills listed will be  
20. discharged from the committee as denominated by Senator Rock and  
21. reassigned to the committee as mentioned. All those in favor say  
22. Aye. Opposed Nay. Senator Rock.

23. SENATOR ROCK:

24. While we're on the business of announcements before everyone  
25. gets out, the Legislative Correspondence Association has asked  
26. me to remind you that the Tenth Annual Gridiron Dinner, sponsored  
27. by the Correspondents will be held Tuesday, May 5 at the Springfield  
28. Hilton. The event begins at 6:30 p.m., and tickets are now available  
29. from the Illinois Legislative Correspondence Association, each of  
30. their members.

31. PRESIDING OFFICER: (SENATOR BRUCE)

32. Senator Newhouse.

33. SENATOR NEWHOUSE:

1. Mr. President, I'd...I'd like to...Senate Bill 687 and 688  
2. have been assigned to Executive and they should be in Labor. I've  
3. talked to the chairs of both committees, and they have no objection  
4. to making that transfer. So, I move to discharge Executive from  
5. consideration of 687 and 688, and rerefer those to the Committee  
6. on Labor.

7. PRESIDING OFFICER: (SENATOR BRUCE)

8. You've heard the motion. Discussion? All in favor say Aye.  
9. Senator Walsh.

10. SENATOR WALSH:

11. Mr. President, we went to great pains to...with Mr. O'Keefe  
12. to go through a long list of bills, ten, I think, that the President  
13. just mentioned that there was no objection from the sponsor or  
14. the...this side of the aisle as to rereferring bills. Now, these  
15. two...

16. PRESIDING OFFICER: (SENATOR BRUCE)

17. All right, why don't we...Senator Newhouse...

18. SENATOR WALSH:

19. ...I'm not familiar with...

20. PRESIDING OFFICER: (SENATOR BRUCE)

21. ...and you confer and let's see if we can resolve it.

22. SENATOR WALSH:

23. ...and...well let me just state further. In the future  
24. I think we can save a lot of time if there are these requests, if  
25. they would come to this side of the aisle so that when the motion  
26. is made from that side of the aisle the statement can be made that  
27. there is no objection from the minority, then it won't be necessary  
28. for someone to jump up and wonder what's going on.

29. PRESIDING OFFICER: (SENATOR BRUCE)

30. All right, Senator Newhouse, would you withdraw your motion?

31. SENATOR NEWHOUSE:

32. I withdraw the motion, but give me a chance to confer with...

33. PRESIDING OFFICER: (SENATOR BRUCE)

1. Sure, we...we have a great deal more business to do. Senator  
2. Nimrod.

3. SENATOR NIMROD:

4. I thought we were on announcements. I can wait...

5. PRESIDING OFFICER: (SENATOR BRUCE)

6. No, we're...we're...we'd like to get some resolutions handled
