Amendment No. 3 offered by Senator Coffey.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Coffey.

SENATOR COFFEY:

Amendment No. 3 adds an additional parcel of land in Bond County to Senate Bill 1658, which is the easement bill. This release is for an access rights. It is not to the whole parcel but merely an entrance of approximately one hundred lineal square feet. It'll...the State will receive...the department will receive two thousand eight hundred dollars for that which will make a total of the...at the completion of all these easements of fifty thousand eight hundred and eighty-one dollars total to the Road Fund.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt Amendment No...2...

ACTING SECRETARY: (MR. FERNANDES)

3...3, I'm sorry.

PRESIDING OFFICER: (SENATOR BRUCE)

...3. On the motion to adopt, all in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 3 is adopted. Further Floor amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further Floor amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

1670, Senator Schaffer. 3rd reading on Senate Bill 1658.

1671, Senator Simms. 1681, Senator Philip. The Chair would like to recognize the presence of the Governor of the State of Illinois with us today. Welcome to our Chambers, Governor. For what purpose does Senator Philip...he's the guy right down to the left, Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Just like to welcome His Excellency, the Governor, to the Senate and remind everybody today is his birthday, and I think we all ought to wish him well, good luck and long life, more babies and, of course, his reelection. SENATOR BUZBEE:

Well, Mr. President, I don't know what the Governor is preparing for, but this morning when I was at the YMCA to workout, he was in there pumping iron, and I don't know if he's preparing for something, an event that's coming this fall or what, but, anyhow, welcome once again, Governor.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Maitland, your amendment has arrived and we've gotten the paper work corrected. Do you wish to...is there leave to return to Senate Bill 1656? Senator Maitland had Tabled Committee Amendment No. 1 when the bill was taken from the record. Is there leave to return to that bill? Leave is granted. The bill is on the Order of 2nd Reading. Are there amendments, Mr. Secretary?

ACTING SECRETARY: (MR. FERNANDES)

...amendment No. 2 offered by Senator Maitland.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Maitland.

SENATOR MATILAND:

Thank you, Mr. President. When this bill was heard

in...in Judiciary II last week there was some concern, some confusion over the amendments. The amendment has been redrafted. The Democratic Staff, Senator Sangmeister have viewed it and are in agreement that it does meet the...the requests of the committee, and I would seek its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt Amendment No. 2. On the motion to adopt, all in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further Floor amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further amendments from the Floor.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Is there leave to go to the Order of Resolutions? Leave is granted. Resolutions, Mr. Secretary.

ACTING SECRETARY: (MR. FERNANDES)

Senate Joint Resolution No. 90 offered by Senator Rock.

(Secretary reads SJR No. 90)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock moves for the suspension of the rules and the immediate consideration and adoption of the adjournment resolution. On the motion to suspend, all in favor say Aye. Opposed Nay. The Ayes have it and the rules are suspended. On the motion to adopt this...adjournment resolution, discussion? Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The resolution is adopted. For what purpose does Senator Grothberg arise? Oh, Senator Ozinga, I'm sorry, I...I'm trying to get some last minute...

SENATOR OZINGA:

Just to call the attention, I'm hopeful that that...that resolution that was just adopted will be forthcoming within a few seconds. So in order to clarify, there will be a Republican caucus in the...in the Minority Leader's office, Senator Philip's office, immediately following adjournment. Hopefully a very short caucus.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President. I'd like to have the Journal show that Senator Becker is still convalescing from an illness.

PRESIDING OFFICER: (SENATOR BRUCE)

The Journal will so reflect. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. We are apparently engaged in a game of petulance. I have filed with the Secretary an amendment to House Bill 2211, which calls for a supplemental appropriation of some nineteen million dollars so that the one hundred thousand people receiving general assistance can, in fact, be paid on time. I would like to move to that order of business with the sponsor's consent and offer that amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to go to the Order of House Bills 2nd Reading? Leave is granted. House Bills 2nd reading, House Bill 2211, Senator Schaffer. All right. Senator Rock, Senator Schaffer indicates that...
