PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Gitz arise?

SENATOR GITZ:

For the purposes of a motion, Mr. President. I would like House Bill 2335, the Senate sponsor to be changed from Gitz to Rock. And on House Bill 2485 with the new sponsorship to read Senator Jeremiah Joyce-McMillan-Gitz.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Gitz has moved that principle sponsor of House...House Bill 2335 be changed to Senator Rock. Is there leave? Leave is granted. On House Bill 2485 that the sponsor be shown as Senator Jeremiah Joyce-Senator McMillan-Senator Gitz. Is there leave? Leave is granted.

For what purpose does Senator Carroll arise?

SENATOR CARROLL:

Thank you, Mr. President. With leave of the Body, I had just picked up a bill in the bipartisan spirit for the Attorney General since no one seemed to want to be the sponsor of their appropriation bill. I've now heard significant comment from the other side that they would not like the bipartisan approach, and Senator Bloom would like to be the sponsor on House Bill 2393, and with leave of the Body, I would like to relinquish sponsorship to him.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to change the sponsorship of House Bill 2393 from Senator Carroll to Senator Bloom? Leave is granted. For what purpose does Senator Rock arise?

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I have just discussed with Senator Philip the proposed schedule for tomorrow. If I can have your attention so that everybody's on the same wavelength. The Committee on Executive will meet at 9:00 a.m., the Rules Committee will meet at 10:00 a.m. in Room 400, and we will commence the

Session at eleven. And it does not appear that we will have an extraordinary amount of work to do, so, I would suggest for those of you who have some matters of interest in the City of Chicago tomorrow night, that we will be out of here by noon, most certainly, and then when we...leave tomorrow, we will return Monday at the hour of one o'clock.

PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Taylor arise?

SENATOR TAYLOR:

Mr. President, I rise on a point of personal privilege.

PRESIDING OFFICER: (SENATOR BRUCE)

State your point, Senator.

SENATOR TAYLOR:

Mr. President, as you see in the gallery today, we have an awful lot of people that are here interested in the subject of the ratification of the equal rights amendment. And due to the fact that we are going to have a big rally here in Springfield on Sunday and all around the country where there is a possibility of the ratification being made before the deadline, I have decided that I will not call for the ratification vote today on the rules change. Therefore, it would be no need for our...the people in the gallery to stay around, they can leave and be all invited to the big rally this coming Sunday at...here in Springfield. Eleven o'clock in the morning be a big march here on June the 6th, so come to Springfield all of you and help us in the rally so that we can go on and ratify the equal rights amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Thank you, Senator Taylor. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. I am causing to be distributed a schedule...the Senate schedule for the week of June 7 to June 11. It indicates that on Monday, June 7, it says Session at noon, that will be Session at 1:00 p.m., 1:00

o'clock p.m. And that, as you know, is the final week...the deadline for Senate committees to report out House Bills except appropriation bills. So, that, I suggest, will be a...given the action of the Rules Committee in the last couple of meetings, that will be a rather busy week, so I would suggest that people pay attention to the Senate schedule for the week of June 7th. We have all the committees scheduled according, we hope, to their workload, and we have deliberately left open both Thursday afternoon and Friday morning in the event that some of the committees cannot quite finish. But as I indicated, when we leave here tomorrow, which will be before noon, we will return on Monday, June 7 at the hour of one o'clock. One other change I might note from the schedule which was passed out some weeks ago, that on the week of the 14th, we will commence Session at one o'clock on Monday, on the 14th and hopefully, be in a position to take that Friday off. The prior schedule had us off on Monday and working on Friday. It was felt by some that it would be better to have a longer weekend and I readily concurred. Alright, there is objection from some quarter which is quickly overruled. Thank you, very much.
