The hour of twelve-thirty and past have arrived. The Senate will please come to order. Will the guests in our galleries please rise. Prayer by Reverend Dennis Kollross of St. Agnus' Church, Springfield.

SENATOR JOHNS:

Thank you. Request permission to waive the Six-day Notice Rule and have House Bill 2439 heard today in the Insurance Committee.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the request. Is there leave? Leave is granted. For what purpose does Senator Totten arise?

SENATOR TOTTON:

Thank you, Mr. President, to ask leave of the Body to have myself removed as the chief sponsor of House Bill 2578, and have the name of Senator Art Berman added as the chief sponsor of House Bill 2578, which is in the Revenue Committee.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the request. Is there leave? Leave is granted. Leave to go to the Order of Resolutions? Resolutions.

PRESIDING OFFICER: (SENATOR BRUCE)

Executive Committee. Consent Calendar. For what purpose

does Senator Collins arise?

SENATOR COLLINS:

Thank you, Mr. President. I would request leave from the Body to waive the six-day posting requirement so that House Bill 958 may be heard in the Labor and Commerce Committee Friday at nine o'clock.

PRESIDING OFFICER: (SENATOR BRUCE)

And that...that rule, the Six-day Posting Notice has been waived as to all House Bills, so...but you should notify members, I think, appropriately if the bill has not been posted that it will, in fact, be heard. So...your motion is appropriate that you've notified the Body. Is there leave that it be heard? Leave is granted. For what purpose does Senator Rock arise?

SENATOR ROCK:

Thank you, Mr. President. Before I put the motion to adjourn until noon tomorrow, the schedule has been passed out, Judiciary, Transportation and Higher Ed will meet in the morning, and in the afternoon, Revenue will reconvene and Finance will meet. We have a heavy committee schedule this afternoon. I am reluctant to say, Mr. Chairman and members, that the Rules Committee made a mistake. House Bill 2381 is an amendment to the Revenue Act which should have been gotten out, it did not, by oversight, and I would move that the Rules Committee be discharged and that that bill be immediately assigned to the Committee on Revenue for hearing tomorrow afternoon.

PRESIDING OFFICER: (SENATOR BRUCE)

SENATOR D'ARCO:

Just to announce, Mr. President, that the Insurance Committee will meet sharply at one-thirty, so I would request that all Senators be present at the meeting at one-thirty.
