And I think that we should be appreciative of their 13. willingness to shoulder a portion of the pain, so to speak, in 14. these rather dark days, financially. And I'd like to rise in 15. support of the motion and to thank the Hospital Association and 16. the agencies of the Government, that it worked out, what appears 17. to be a reasonable compromise, under the circumstances. 18. PRESIDING OFFICER: (SENATOR BRUCE) 19. Further discussion? Senator Grotberg. 20. SENATOR GROTBERG: 21. Thank you, Mr. President, fellow members. If you'll recall 22. the debate on the Public Aid and Medicaid portion of the budget 23. and the companion bill which we're now accepting the Amendatory 24. I asked those who had some questions not 6. to take up a lot of time asking them, because I think I can 7. briefly answer in closing. This was the program that allowed 8. the hospitals to maintain their emergency rooms, to maintain 9. their outpatient clinics, to maintain their canes and crutches 10. and other necessities, and to maintain those at a reasonable 11. cost figure, so that they would be funded. This also allowed the 12. State to continue the pharmaceutical, the optometric, the 13. podiatric, the dentistry, the chiropractic and the other 14. auxiliary services that had been provided before at a lower 15. cost than hospitalization. In lieu of that, we trimmed, in effect, 16. one day off the length of stay of each patient who's a long-term 17. stay patient, we cut, approximately, fourteen percent from 18. the in-bed costs in order to achieve the savings. It was the 19. hospital's opinion and those who received the services, that 20. emergency rooms, clinics, et cetera are essential to providing 21. health care and are cost effective, and that they can afford, if 22. necessary, to reduce it in length rather than reduce it in service. 23. And we think that one of the mistakes they may have made was 24. Grotberg, but with that aside, we would urge that this finally 25. become the law of the State of Illinois. 26.
