PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to go to the adoption of the Resolution Consent Calendar? Leave is granted. Mr. Secretary, have any Senators filed objection to any of the resolutions contained upon the Resolution Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

No objections being filed, Senator Welch moves the adoption of the Resolution Consent Calendar. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and the resolutions are deemed adopted. Any further business to come before the Senate? Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President. I'd like to move to Table Senate Bill 914 that resides in the Senate Executive Com-

tee.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. The motion is to discharge Senate Bill 914 from the Senate Executive Committee for the purpose of Tabling. On the motion to discharge, those in favor say Aye. Opposed Nay. The Ayes have it. The bill is discharged. On the motion to Table, those in favor say Aye. Opposed Nay. The Ayes have it and Senate Bill...914 is Tabled. Any further business? (Machine cutoff)...Senator Netsch arise?

SENATOR NETSCH:

Thank you, Mr. President. I realize that we have suspended the Six Day Rule but there are several bills that did not get heard in Revenue, and I want to make clear that they are going to be heard Monday night at our meeting that deals with property tax related issues, and so if I might just get this on the record. There will be a supplemental notice which will show that. They are Senate Bills 156, Senator Lemke's bill; Senate Bill 667, Senator Egan; Senate Bills 868 to 870, Senator Marovitz; Senate Bill 79...I'm sorry, Senate Bill 922, Marovitz; 824, Jeremiah Joyce; 835, Degnan. They will all be heard Monday night and a supplemental notice will so indicate.

PRESIDING OFFICER: (SENATOR BRUCE)

Thank you, Senator Netsch. For what purpose does Senator Grotberg rise?

SENATOR GROTBEBG:

A parliamentary inquiry. Mr. President, Senator Netsch's remarks made me stop and think. Are all bills in all committees posted for next week without benefit of what you just went through, Senator Netsch? That was my understanding.

PRESIDING OFFICER: (SENATOR BRUCE)

No, that...that was not the...the motion. The motion was to waive the Six Day Posting Notice for bills that were posted as late as today and they would be heard in committee

next week.

SENATOR GROTEBERG:

It's still up to each of us to have our own bills posted, then...under the waive...waiving of the rule?

PRESIDING OFFICER: (SENATOR BRUCE)

That's right.

SENATOR GROTEBERG:

Thank you.

PRESIDING OFFICER: (SENATOR BRUCE)

You still have to have the bill posted.

SENATOR GROTEBERG:

And we can do that yet, after this meeting?

PRESIDING OFFICER: (SENATOR BRUCE)

That's correct. For what purpose does Senator Schaffer arise?

SENATOR SCHAFFER:

Mr. President and members of the Senate, we, in the Appropriations II Committee yesterday heard, or I guess we can't say we heard because the bill had technically not been assigned to the committee, House Bill 1296, which is a supplemental for the Department of Public Aid. I believe that that bill has been referred to the Appropriations II Committee. Due to the emergency nature, it was the conclusion of the chairman and myself and the members of the committee present that we would discuss the bill, which we did do, with Director Miller, but then today make a motion to have the bill, I guess, the technical motion is discharged from the Appropriations II Committee and referred to the Calendar on the Order of 2nd Reading, so that we can act on it on a timely fashion so that the general assistance checks can be mailed on the...on time by the Comptroller. If I have the technical motion correctly, I would like to make it at this time.

PRESIDING OFFICER: (SENATOR BRUCE)

Fine. Senator Schaffer has moved to discharge the Committee on Appropriations from further consider of House Bill 1296. Is that right, Senator Schaffer, 1296? The bill was heard already in committee.

SENATOR SCHAFFER:

...technically in the committee, it couldn't have been heard by the committee, but it was discussed.

PRESIDING OFFICER: (SENATOR BRUCE)

The subject matter was discussed by committee and has leave of the leadership. Is there leave to discharge the bill and have it placed on the Order of the Calendar on 2nd Reading? Leave is granted. It's Appropriation II would be discharged...and the bill will be placed on the Order of 2nd Reading on the Calendar. Other business to come before the Senate? No further business to come before the Senate, Senator Rock moves the Senate stands adjourned until May the 2nd at the hour of noon. On the motion to adjourn. Discussion? Those in favor say Aye.
