Senator Collins, I am told there's an amendment for this resolution, is that correct?

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Collins.

SENATOR COLLINS:

Yes, thank you, Mr. President and members...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Can we have some order, please? Senator Collins.

SENATOR COLLINS:

Yes, Amendment No. 1 to Senate Resolution 691 was suggested by the...by the committee and...and what it does, it simply adds...rather than a cochair, two cochairmens in a efforts to make this...this whole committee review process of the status of...of health in the State of Illinois a nonpartisan issue. And also the amendment includes to the bill HMO's in general and not just those in relationship to indigent health care in the State of Illinois, and I would ask for the adoption of this amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Collins has moved the adoption of Amendment No. 1 to Senate...Resolution 691. Any discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Secretary's...all right. Senator Collins, you wish to proceed on Senate Resolution 691 now? Senator Collins. All right. Senate Resolution 695, Senator Dawson. Page 3...page 3 on your Calendar, Senate Resolution 736, Senator Lechowicz. House Joint Resolution 40, Senator Darrow. All right. Top of page 3 is House Joint Resolution 40. Senator Darrow.

#### SENATOR DARROW:

Thank you, Mr. President. House Joint Resolution 40 urges Congress to revise the Hill-Burton formula to allow Illinois to receive its fair share of funding for services to the disabled. I'd move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, Senator Darrow has moved the adoption of House Joint Resolution 40. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 40 is adopted. House Joint Resolution 65, Senator Lechowicz. Senator Lechowicz on House Joint Resolution 65, top of page 3. Senator Lechowicz.

### SENATOR LECHOWICZ:

Thank you, Mr. President. I ask leave to bring that bill...the resolution back for an amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz, the Secretary does not have the...all right, do you...I'm sorry. All right. Senator Lechowicz requests leave of the Body to return House Joint Resolution 65 to the Order...all right, to have it...to have an amendment considered. Is leave granted? Leave is granted. Mr. Secretary, Amendment No. 1, House Joint Resolution 65.

Amendment No. 1 offered by Senator Lechowicz.

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz.

#### SENATOR LECHOWICZ:

Thank you, Mr. President. Amendment No. 1 changes the reporting date from April of 1986 to November of 1986, and I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Lechowicz has moved the adoption of Amendment No. 1 to House Joint Resolution 65. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Lechowicz, do you wish to proceed?

SENATOR LECHOWICZ:

No.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. House Joint Resolution 79, Senator Rock.

House Joint Resolution 80...no, wait a minute...79? House

Joint Resolution 79. Senator Rock.

### SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Joint Resolution 79 sent over by Representatives LeFlore, Madigan and Daniels memorializes Congress to extend the Emergency Veterans, Job Training Act. I know of no opposition, I would solicit a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? Can we have some order, please? Senator Vadalabene.

SENATOR VADALABENE:

Yes, at the proper time, I would like to go with Senate Resolution 435.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Oh,...we'll get...we'll get back to it. Further discussion? Senator Rock has moved the adoption of House Joint Resolution 79. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 79 is adopted. House Joint Resolution 80, Senator Rock.

### SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Joint Resolution 80 also sent over by Representatives LeFlore, Madigan and Daniels, again memorializes the 99th Congress to vote favorably and pass House Resolution 1458, an amendment to the Internal Revenue Code to extend again the...the deduction allowance for expenses incurred in removing architectural and transportation barriers for the handicapped and the elderly. Again, I know of no opposition, I would solicit a favorable vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, Senator Rock has moved the adoption of House Joint Resolution 80. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 80 is adopted. House Joint Resolution 104, Senator Luft. House Joint Resolution 128, Senator Berman. Senator Berman, House Joint Resolution 1-2-8.

### SENATOR BERMAN:

Thank you, Mr. President. House Joint Resolution 128 calls on the Chicago Board of Education to provide transportation service for children involved in the Permissive Transfer Program to be picked up and dropped off at their homes. The preamble and whereas clauses states the problems as far as the safety that is not presently accorded to these children. They're passed out without dissent out of the committee, I move the adoption of House Joint Resolution 128. PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, Senator Berman has moved the adop-

tion of House Joint Resolution 128. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 128 is adopted. Senate Joint Resolution 74, Senator Topinka. Senator Topinka.

#### SENATOR TOPINKA:

Yes, Mr. President and Ladies and Gentlemen of the Senate, Senate joint resolution urges Congress to oppose the closing of Great Lakes Naval Base as well as the O'Hara Air Force Base. It basically reads just exactly that way. I don't know of any opposition, would encourage its passage.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, Senator Topinka has moved the adoption of Senate Joint Resolution 74. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 74 is adopted. Senator Vadalabene, when we get finished through here, we'll come right back to you. Okay, Senate Joint Resolution 101, Senator...Senator Rock. Senate Joint Resolution 103, Senator Davidson. All right. Senate Joint Resolution 103, the bottom of page 3, Senator Davidson.

#### SENATOR DAVIDSON:

Mr. President and members of the Senate, this is the resolution we passed every year for a number of years, appreciate a favorable vote.

### PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, Senator Davidson moves the adoption of Senate Joint Resolution 103. Those in favor will indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 103 is adopted. 117, Senator Rock. Page 4...page 4 on your Calendar, Senate Joint Resolution 1164, Senator Jerome Joyce. Oh, I beg your pardon...all right. All right. With leave of the Body, we'll return to pick up Senator Vadalabene's resolution. Senator, that's Senate Resolution 435? Page 2, Senate Resolution 435. Senator

tor Vadalabene.

### SENATOR VADALABENE:

Yes, Senate Resolution 435 calls on the director of Conservation to officially change the name of Horseshoe Lake in Madison County to Karandjeff Lake. This is not the Horseshoe Lake in Southern Illinois. It passed out of the committee unanimously and I would move for its adoption.

#### PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? If not, Senator Vadalabene moves the adoption of Senate Resolution 435. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. House...or Senate Resolution 435 is adopted. Senator Collins indicates that she is prepared to go on Senate Resolution 695, Mr. Secretary, if you can find that one...691, 6-9-1. Page 2...bottom of page 2 is Senate Resolution 691. Senator Collins.

### SENATOR COLLINS:

Yes, thank you, Mr. President and members of the Senate. Senate Resolution 691 creates a special task force to study and to take a look at the quality and accessibility of health care in the State of...Illinois as a result of the Federal cutback and our efforts in the Legislature to reduce hospital cost in the State of Illinois. And it also includes under the amendment we put on today HMO's and prefer provider...service organization. So I would ask for favorable adoption of this amendment. It is a statewide problem and we would like to make it a...bipartisan issue.

#### PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? This will, in fact, Senator Collins, require a roll call. Senator Collins moves the adoption of Senate Resolution 691. Those in favor will indicate...will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish?

Take the record. On that question, the Ayes are 47, the Nays are none, none voting Present. Senate Joint...Senate Resolution 691 is adopted. Senator Netsch, while we're on this order of business, do you wish to proceed with an amendment on 624? Senator Netsch, for what purpose do you arise?

Yes, I didn't want to call the resolution today, Mr. President, but there is an amendment. Why don't I get that on and we'll get it cleaned up.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well. Senator Netsch. there is a committee amendment as well as a Floor amendment.

SENATOR NETSCH:

I am advised by staff that it is the same amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. With leave of the Body, we'll go to Senate Resolution 624 to accommodate Senator Netsch who was obviously late arriving. Senate Resolution 624, at the bottom of page 2, Senator Netsch on Amendment No...1.

SECRETARY:

Executive Committee offers Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Netsch.

SENATOR NETSCH:

Thank you. This is a purely technical amendment. It corrects misspellings, it corrects capitalization and matters of that sort. It has no substantive effect at all and I would move the adoption of Amendment No. 1 to Senate Resolution 624.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, Senator Netsch moves the adoption of Committee Amendment No. 1 to Senate Resolution 624. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Committee...Committee

Amendment No. 1 is adopted. Further committee amendments?
SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Amendments from the Floor? SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Secretary's Desk, it will repose there. Any other member wish at this time to proceed with their resolution? Senator Rock.

#### SENATOR ROCK:

Thank you, Mr. President. If no other member wishes to...to proceed on that order of business. I'd like leave of the Body to move to the Order of Senate Bills 2nd Reading. There was a lengthy amendment that was offered and adopted at my request in committee. A number of people interested in this legislation wish to have access to the amendment. The only way we can get it printed is to get it adopted and then we'll work off the amendment. I agreed in committee to hold the bill and I will do so for the next week or ten days while everybody has an opportunity to get the printed copy of the amendment and any refinements that are needed, I'd be happy to call it back for that purpose. So...if we could have leave to go to that order, I'd like to get that amendment on. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. With leave of the Body, we will go to top of page 2, Senate bills 2nd reading. Is...leave granted? Leave is granted. Page 2 is Senate Bill 1491, Mr. Secretary. SECRETARY:

Senate Bill 1491.

(Secretary reads title of bill)

2nd reading of the bill. The Committee on Public Health,
Welfare and Corrections offers one amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Committee Amendment No. 1 which I offer for adoption does four or five things. This...this bill and this amendment are...attempted to address the difficulty that we incurred with respect to school and day-care employees and their obligation under the Child Abuse, Neglect and Reporting Act. The Department of Children and Family Services and the Illinois Education Association are in favor of this amendment. and I agreed with all members of the committee that I would hold the bill and I intend to do that, but I want to get printed so that everybody has got access to it. This addresses the problem of the obligation of school and day-care employees to be part of the class that are required to report instances of child abuse and neglect, and it...it forecloses. I think, the discussion about the necessity or desirability of any fingerprinting or any other background checks. It puts some additional obligations on the department which they are willing to accept. I know of no serious opposition and I would urge the adoption of Committee Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Discussion? If not, Senator rock has moved the adoption of Committee Amendment No. 1 to Senate Bill 1491. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Bill 1600 is discharged from Rules. Senator Marovitz now moves to Table Senate...Senate Bill 1600. Discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Bill 1600 is Tabled. Senator Hall, for what purpose do you arise?

### SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Three things, I would like to be shown as...sponsor, I've talked to the lead sponsors of both of these bills. Senate Bill 2162 and Senate Bill 2163...

PRESIDING OFFICER: (SENATOR DEMUZIO)
