Is there any discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The Committee on Higher Education is discharged from Senate Bill 1852 and it is rereferred to the Committee on Elementary and Secondary Education. Senator Luft, for what purpose do you arise?

Thank you, Mr. President. I would like to add Senator O'Daniel as a hyphenated sponsor of Senate Bill 1-5-9-6.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the request of Senator Luft to add Senator O'Daniel as a hyphenated cosponsor to Senate Bill 1596. Is leave granted? Leave is granted. Senator Macdonald, for what purpose do you arise?
