Thank you, Mr. President. Might I suggest...I've just conferred with Senator Philip, there...there will be a request again renewed for a Republican Caucus and I presume we'll also have one. So that not to delay and...and inconvenience too many who are...will be attending the Appropriation's Committee meeting this afternoon, perhaps this is a logical place to stop. We will continue tomorrow where we left off on 2nd reading and just keep going in an attempt to accommodate Enrolling and Engrossing and the members who wish to move the bills. In the meantime, we have special guest and a House joint resolution has been sent over and....was placed on the Consent Calendar. I'd move at this time to suspend the rules for the immediate consideration and adoption of House Joint Resolution 192 which deals with the spectacular, I guess, Hands Across America project. And I'd ask the Secretary to read that resolution, then I'd move for the suspension of the rules and its immediate consideration and adoption while you...then introduce our guest. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the motion as posed by Senator Rock. Senator Rock has moved to...to suspend the rules for the immediate consideration and adoption of House Joint Resolution 192. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The rules are suspended. House Resolution 192, Mr. Secretary, would you read the resolution. Can we have some order, please. Just a moment. Mr. Secretary. Can we have some order, please. All right. House Joint Resolution 192.

If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 869 is adopted.

Senate Joint Resolution 146 is a congratulatory resolution offered by Senator Hudson. PRESIDING OFFICER: (SENATOR DEMUZIO)

Tomorrow morning at 11:00 a.m. at the Old State Capitol there will be a ceremony commemorating the days of remembrance so that we do not forget the Holocaust that engulfed Europe during the Second World War. Everyone is invited, 11:00 a.m., at the Old State Capitol tomorrow morning. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Hall, for what purpose do you arise? SENATOR HALL:

I'd like to make the announcement to...to...so that

everyone who serves on Appropriation II that we're meeting twice. The first meeting is 9:00 a.m. tomorrow morning in Room 212, so I'd like to have...we can get started on time and then we'll come to Session, then we'll go back in the afternoon at 2:00 p.m. So that's tomorrow. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further announcements? Senator Watson. SENATOR WATSON:
