SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. With leave of the Senate, I would like to add to House Bill 815 Senator Arthur Berman as a cosponsor.

PRESIDENT:

All right. The gentleman seeks leave to show Senator Berman as a cosponsor of House Bill 815. Without objection, leave is granted. Senator Kelly, for what purpose do you arise?

SENATOR KELLY:

Mr. President, I'd like to request leave to be added as a hyphenated sponsor on House Bill 800. I've discussed this with Senator Marovitz...it meets with his approval.

PRESIDENT:

All right. Senator Kelly seeks leave to be added as a hyphenated cosponsor of House Bill 800. Without objection, leave is granted. If I can have your attention, there are two announcements, the Chicago Tribune, Mr. Greer who is their photographer and Mr. Egler is seeking leave to take

PRESIDENT:

Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, this is the annual appropriation for the Metropolitan Fair and Exposition Authority and I would appreciate its...your support.

PRESIDENT:

Any discussion? Senator Sommer.

SENATOR SOMMER:

Mr. President and members, just for the record, traditionally the monies appropriated from this portion of the cigarette tax have gone into the reconstruction of both McCormick Place and I believe Donnley Hall. This will be the first time that this is...money has been ticketed for Operations, that is, salaries and whatnot of the Exposition

Authority, and I'd like to enter that into the record. It's our intent at this point in time to...to not favor that unless there's statutory authority which at the present time does not exist.

PRESIDENT:

Further discussion? Any further discussion? If not, the question is, shall Senate Bill 226 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 25 Ayes, 22 Nays, 4 voting Present. Senate Bill 226 having failed to receive the required constitutional majority is declared lost. Top of page 3, on the Order of Senate Bills 3rd Reading, Senate Bill 306. Read the bill, Mr. Secretary.

PRESIDENT:

Senator Demuzio.

SENATOR DEMUZIO:

Well, in order to avoid the confusion from the last bill, perhaps, I'll read this little paragraph. "The Auditor General's...fiscal 1986 budget request of nine million five hundred and thirty-three thousand five hundred dollars has been reduced by forty-six thousand three hundred dollars to the amended level of nine million four hundred eighty-seven thousand two hundred," and I would ask for your support.

PRESIDENT:

Any discussion? Any discussion? If not, the question is, shall Senate Bill 306 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all

voted who wish? Take the record. On that question, the Ayes are 54, the Nays are none, 1 voting Present. Senate Bill 306 having received the required constitutional majority is declared passed.

PRESIDING OFFICER: (SENATOR SAVICKAS)

On the Order of Senate Bills 3rd Reading, Senate Bill 308, Senator Schaffer. Read the bill, Mr. Secretary.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Schaffer.

SENATOR SCHAFFER:

This is an appropriation for seventy-five thousand dollars from the Recreational Boating Fund for the Chain-o-lakes-Fox River Water Management Agency which was created by the people in that area by referendum. That agency will be primarily funded by boat fees but since it just got created, it does need some money to get it started. I should point out that some forty thousand recreational boaters use that chain and by the Department of Conservation's figures, that generates about 3.6 million dollars into that fund, and we are asking for seventy-five thousand dollars.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. I presume, if the sponsor will yield, that this also is for Operations. Is that correct?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Schaffer. Senator Schaffer.

SENATOR SCHAFFER:

Yes, as a matter of fact, it is particularly needed

because since this agency will be funded by boat funds, they need to get some start-up money to get tags and get going. They'll be dead in the water without our help. I would respectfully remind everyone that the forty thousand boaters come from all parts of northern Illinois, a significant number from that fine city on the lake and...and the agency, I believe, has enjoyed a great deal of support from all parts of northern Illinois; and since we're asking for a seventy-five thousand dollar return from a fund we generate 3.6 million for...I understand what the Senator has in mind, I think I have the message rather clearly.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rock.

SENATOR ROCK:

Well, I would just point out that probably those same boaters attend the annual boat show at McCormick Place,...which generates an inordinate amount of income for our State, and I would hope that Senate Bill 308 would meet with the same twenty-five vote fate.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, the question is, shall Senate Bill 308 pass. Those in favor vote Aye. Those opposed...Senator Schaffer, what purpose do you arise?

SENATOR SCHAFFER:

No, I am...Senator Rock, I don't know...I think I'm obviously...I have a...the...the best of timing here, I would only respectfully point out that I think the confusion on this side comes...rather major change in State policy using that fund amounting to serve a million dollars. I'd hate to see that particular discussion which we know will be ongoing and will eventually be resolved tied to this particular issue, and I would respectfully and sincerely request the two issues be separated...and a favorable roll call.

SENATOR DEMUZIO:

Thank you, Mr. President. The Office of the Comptroller...this bill as introduced was twenty-nine million six hundred and sixty-four thousand twenty-nine...over twenty-nine million dollars of GRF, five hundred and ninety-two thousand of other. Excluding the State officer's salaries and other expenditures, the Comptroller's operating budget is fifteen million one hundred and thirty-three thousand. Senate Amendment No. 1 reduced two hundred and twenty-two thousand GRF, one percent from the adjusted operating budget, making it fourteen million nine hundred thousand as amended. I would ask for your support.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 342 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 54, the Nays are none, 1 voting Present. Senate Bill 360 having received the constitutional majority is declared passed.

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. Senate Bill 364 amended appropriates one hundred and ninety million sixty-six thousand three hundred dollars for Fiscal '86 Operations and Grants to Southern Illinois University, and I would appreciate a favorable vote.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there discussion? If not, the question is, shall Senate Bill 364 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 54, the Nays are none, none voting Present...1 voting Present. Senate Bill 364 having received the constitutional majority is declared passed. Senate Bill 383, Senator Poshard. Read the bill, Mr. Secretary.

SECRETARY:

(Machine cutoff)...Bill 383.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Poshard.

SENATOR POSHARD:

Thank you, Mr. President. This is a bill which simply reappropriates funds for Fiscal Year '86 which have already been approved and appropriated of both the Legislature and the Governor on an earlier supplemental appropriation bill, House Bill 1370. I ask for your favorable vote and passage of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Senator Schaffer.

SENATOR SCHAFFER:

Well, I just wanted to request my friends on this side of the aisle not to confuse this bill with any other bill or any other issue which we may have previously voted on. This bill doesn't have anything to do with the Chain-o-lakes area and I hope we'll all support it, and this is for southern Illinois, that other bill was for northern Illinois. I think Senator Rock thought the Chain-o-lakes was located in Tazewell County, but I hope we'll all vote for this good bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Rock.

SENATOR ROCK:

A point of order. I know very well where the Chain-o-lakes is having visited many times with former Representative Murphy. The point in fact was that a game was being played, that appropriation to the Metropolitan Fair and Exposition Authority was exactly the same as was FY '85, exactly, to the nickel, for the same purposes.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR POSHARD:

Just ask for your favorable consideration of the bill.

I would just like to ask a question of the sponsor. Are we not back on that bill now?

SENATOR KEATS:

Those of us who were being loyal soldiers and voted No would like to ask a question to now figure out why we're supposed to vote Yes. Is this...there are two or three questions here, I'll ask the first one. This now will allow the McCormick Place Board to spend this money for personnel, right? Operations.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Savickas, will you give the loyal opposi-

tion...Senator Savickas.

SENATOR SAVICKAS:

Well, I'm...I don't know loyal opposition, I read in today's paper how Governor Thompson is supporting not only the expansion but the whole operation of McCormick Place. This is their annual budget. I'm sure that he could not support their operation without an annual budget and this is not the first time that the money has been used this way. This is the second time. For any more detailed explanation and more...just to put it more eloquently, Senator Carroll indicates that he has a personal interest in it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Savickas, do you wish to yield to Senator Carroll? Senator Carroll yields...Senator Savickas...Senator Carroll. Senator Carroll.

SENATOR CARROLL:

Yes, my...thank you, my personal interest is that I carried the spears the year we made the change and...advised Senator Sommer, which is why he so graciously made the motion because apparently the Digest on their side was in error, a few years ago, I don't remember if it was last year or the year before, we changed the manner in which we appropriate for the Metropolitan Fair and Exposition Authority. This is a statutory amount of 4.8 million, that was set back several years ago when McCormick Place was rebuilt, call it fifteen years ago, I don't recall exactly how long. After paying off part of that debt, only 1.7 was needed for continuing that service although the Statute still called for us to award them 4.8 as it does today. So, a few years ago we then publicly proclaimed that having only needed 1.7 for debt service, the Statute was changed to allow any surplus to be used for "corporate purposes." That would mean that this year, 3.1 million is being used for those other corporate purposes as has been done for the last couple of years and

having taken the questions and jaunt, the first time, that's why I recall the incidents so well.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further...further discussion? Your...Senator Keats, your time is about up. Senator Keats.

SENATOR KEATS:

Thanks, Vince. You mean now we have 3.1 million dollars to boondoggle and hire more precinct captains for Chicago...now we can get them off the city and county payroll and put them on the McCormick Place payroll. I don't remember when we okayed that to begin with, but we ought to be looking a little more careful. I mean, McCormick Place's national reputation is, let's merely say, poor, allowing this sort of thing...these changes. I mean, I wouldn't want to be partisan. I'm...I'm glad for the McCormick Place. I voted to expand it. I'm just wondering whether we aren't giving largess to a board who is noted for incompetence.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well,...Senator Keats, I assume that's a rhetorical question. Further discussion? Senator Keats.

SENATOR KEATS:

...are we not giving more largess to a board that is questionable? I don't think Howard wants to answer that one.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator Geo-Karis' light is on. Senator Geo-Karis.

Mr...Mr. President and Ladies and Gentlemen of the Senate, I didn't vote on it the first time it came up today 'cause I thought it was for the World's Fair, but I...I think the bill is justified in spite of what my colleague says and I'm going to vote for it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, further discussion? Senator Savickas may close.

SENATOR SAVICKAS:

Well, the questionable board, I may point out to Senator Keats if he doesn't know already, as a loyal Republican, that half of it is appointed by his leader, Governor Thompson, and I am sure that his loyalty for a questionable board can be answered with his Yes vote on this bill, and I solicit your support.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Question is, shall Senate Bill 226 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 45, the Nays are 9, 3 voting Present. Senate Bill 226 having received the required constitutional majority is declared passed. On the Order of Motions, Mr. Secretary, read the motion.

SECRETARY:

Having voted on the prevailing side, I move to reconsider the vote...by which Senate Bill 308 failed. Signed, Senator Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator...Senator Carroll moves...having voted on the prevailing side to reconsider the vote on Senate Bill 308 and the manner in which it failed. Is...those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The vote is reconsidered. Senate Bill 308. The question is, shall Senate Bill 308 pass. Those in favor will vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 51, the Nays are 5, 2 voting Present. Senate Bill 308 having received the required constitutional majority is declared passed. Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

Thank you, very much, Mr. President. Having checked with the principal sponsor, I'd ask leave to have my name added as a hyphenated principal cosponsor on Senate Bill 300...House Bill 300, House Bill 853, 856 and 857.

PRESIDING OFFICER: (SENATOR DEMUZIO)

As a hyphenated cosponsor? You've heard the request, is leave granted? Leave is granted. Senator Marovitz, you want to give the list to the Secretary. On the...on the Order of Motions...Senator Rock on the Floor? Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

If we're on that order of business, with respect to House Bill 1847, will you remove Senator Luft as the principal sponsor and substitute Senator Netsch?

PRESIDING OFFICER: (SENATOR DEMUZIO)

We'll be delighted. Senator Netsch requests...that Senator Luft be removed as the sponsor of Senate Bill 1847 and that...Senator Netsch be added. Is leave granted? Leave is granted. It's so ordered. All right, is there leave to go to the Order of Resolutions? Well, wait a minute, Kenny. Resolutions.

SECRETARY:

I move that at 4:30 p.m. on May 29th, 1985, all Senate bills then residing on the...on the Orders of 2nd Reading, 3rd Reading and Consideration Postponed be recommitted to the Senate committees from which they were last reported or discharged. Signed, Senators Rock and Weaver.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. This is the annual motion to send those bills that were not considered in a timely fashion back to the committees from whence they came so that the committees can further deliberate and so that we can reduce

our printing costs so we don't have to keep printing them every day. I don't know of anybody...any objection. I would move adoption of this motion.

All right, you've heard the motion. Is there discussion?
Senator Geo-Karis.

SENATOR GEO-KARIS:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator, I think that is the...we are recommitting all the bills back to...back to their respective committees from which they came. Senator Geo-Karis.

SENATOR GEO-KARIS:

Well, how do I get it on...in a subcommittee?

PRESIDING OFFICER: (SENATOR DEMUZIO)

I would suggest that you...talk to the committee chairman.

SENATOR GEO-KARIS:

Okay.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the motion of Senator Rock. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. The motion is carried. Motion is adopted. Resolutions.

SECRETARY:

Senate Resolution 269 offered by Senator Maitland and all Senators, and it's congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar.

SECRETARY:

Senate Resolution 270 offered by Senator Jones.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Executive.

SECRETARY:

Senate Resolution...Senator Resolution 271 offered by Senator Donahue and it's congratulatory.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Consent Calendar. All right, with leave of the Body, we're going to continue on the Order of...of Resolutions. Page 19, Secretary's Desk, on the Order of Resolutions, there are several on that page. If the sponsors wish to have their resolution called, now is the...the time. Senate Resolution 40, Senator Kelly. Senate Resolution 45, Senator DeAngelis. All right, on the Order of Senate...Secretary's Desk Resolutions, Senate Resolution 45, Mr. Secretary. Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Senate Resolution 45 asks Congress and the President not to abolish the SBA. It does not preclude it from modifying it but simply recommends that in the interest of all the small business people in the State of Illinois that the SBA be retained.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, any discussion? All right, if not, Senator DeAngelis moves the adoption of Senate Resolution 45. Those in favor signify by saying Aye...opposed Nay. The Ayes have it. SENATOR VADALABENE:

promote peace and...and eliminate the threat of war and endorses a concept of mutual assured survival, and I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Senator Vadalabene moves the adoption of Senate Resolution 104. Senator Hudson. All right. Senator Vadalabene moves the adoption of Senate Resolution 104. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Senate Resolution 104 is adopted. House Joint Resolution 1, Senator Sangmeister. Mr. Secretary, House Joint Resolution 1, Senator Sangmeister. This is a...

SECRETARY:

No, we have an amendment on this that we should adopt. Amendment No. 1 offered by the Executive Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sangmeister.

SENATOR SANGMEISTER:

Yes, Amendment No. 1 places the University of Illinois at Chicago Circle as the center for research in law and justice as directed to commence the evaluation of the intensive probation study program in lieu of the Criminal Justice Information Authority, and I move for the adoption of the amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any...any discussion? Senator...Sangmeister moves the adoption of Amendment No. 1 to Senate...Senate...House Joint Resolution 1. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sangmeister.

SENATOR SANGMEISTER:

All right, the...the resolution does exactly as the Calendar says. It directs the Criminal Justice Information Authority to cease its evaluation of the intensive probation study program. They, in the end result, had no objection to that; however, they figured the court should not be supervising their own...or conducting their own probation studies, so they agreed that the University of Illinois at Chicago Circle should conduct the evaluation instead, and the resolution is in order to do that, and I move its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Senator Sangmeister moves the adoption of House Joint Resolution 1 as amended. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. Senate Joint Resolution 23 urges the United States Congress to reestablish May 30th as the official Memorial Day holiday, and I move for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? If not, Senator Vadalabene moves the adoption of Senate Joint Resolution 23. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Senate Joint Resolution 23 is adopted. Senate Joint Resolution 25, Senator Davidson...Mr. Secretary. Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, this...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson, just one moment. I think we have an amendment. Mr. Secretary, Senate Joint Resolution 25.

SECRETARY:

Amendment No. 1 offered by the Executive Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Davidson.

SENATOR DAVIDSON:

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any discussion? Senator Davidson has moved the adoption of Amendment No. 1 to...Senate Joint Resolution 25. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

No further amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator...Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, I urge the adoption of this resolution. This is...this one and two other resolutions were part of the package that did with the commission that you people authorized to study the improvement of elementary and secondary education and this is part of the package.
