PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Thank you, Mr. President. I would at this time move to Table the committee amendment for purposes of putting on a Ploor amendment that was agreed to in committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...Senator Welch, would you...there's been some inquiry, would you explain the committee amendment? Senator Welch.

SENATOR WELCH:

During the committee hearing there was some...there was a

request that an amendment be put on concerning private colleges. And this amendment that I m putting on incorporates that provision as well as the request of Senator Davidson that...that the tuition and fees for students at private colleges and university not exceed the average tuition and fees for students at the four-year public colleges and universities, and also a request by Senator Etheredge that instead of the top one-third of the schools graduating students be eligible that it be a tightened-up figure and we came up with the figure of twenty-five percent, which I believe was agreed to with Senator Etheredge. So, in effect, this does include the amendment offered in committee by the private colleges plus it takes care of the two...stipulations requested by the two Republican Senators.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator...Senator Luft has moved to Table Committee Amendment No. 1 to House Bill 1034. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is Tabled. Further committee amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further committee amendments.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Any amendments from the Floor?

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 2 offered by Senator Welch.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

This is the amendment of which I just spoke. What it does is...provide that...among the provisions that are to be considered as factors for awarding a scholarship to be included are the applicant's family income, the size of the family in determining financial need. The scholarships are

good for up to four years while the recipient is enrolled in college and the limitation on the amount available is equal to...rather shall not exceed the average tuition and fees for students at four-year public colleges and universities. And the...and that is basically it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Welch has moved the adoption of Amendment No. 2 to House Bill 1034. There are a couple of lights on. If we can have some...break up the caucuses on the Republican side. Senator Davidson.

SENATOR DAVIDSON:

Will the sponsor yield for a question?

PRESIDING OPPICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Davidson.
SENATOR DAVIDSON:

Senator Welch, what you stated was true, what's in this amendment we will work out, but there's been a...a point raised with me which I think we need to clear up right now and if necessary you can bring it back from 3rd and correct the language. But there's some...the way that it reads on the first page, "Five hundred new scholarships shall be provided each year." People interpreting that that there'll be five hundred this year, that number, then next year another five hundred that actually we're compounding the number of scholarships. And as I remember yesterday from the committee, it's a total of five hundred per year no compounding. We're not adding onto this and I think we need to clarify that language so everyone understands it's not compounding the number.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further...Senator Welch.

SENATOR WELCH:

I've got no problem pulling it back from 3rd to 2nd for that sole purpose. This was the language in the original

bill though, Senator Davidson, we just repeated that.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Davidson.

SENATOR DAVIDSON:

I understand that, Senator Welch, and it was just brought to my attention. I did not catch that yesterday and so there's no doubt, I think we need to clear that that we're not compounding this number each year. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator DeAngelis.

SENATOR DeangeLIS:

Yeah, a question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator DeAngelis.

SENATOR DEANGELIS:

Senator Welch, in this amendment...there is to be considered the family's income et cetera, et cetera. What happens if someone is eligible under the regular State's Scholarship Commission Grant Program?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Well, a person can apply for as many scholarships as they are able to apply for. These are some of the factors that can be taken into consideration. This isn't the sole factor, there are several other factors. As I...I think I said in committee was that there are many decisions that have to be made by the State board, that you can't be so rigid that the computer selects who gets the scholarships and that's what we were trying to avoid. When you have a subjective test such as this, that's what happens.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator DeAngelis.

SENATOR DEANGELIS:

Well,...you can be, Senator Welch, because if someone is eligible for this and gets it, this is going to count against what they're eligible for under the Illinois State Scholarship Commission Grant. And those grants do not allow the payment of anything more than tuition. If you're going to, in fact, give scholarships for people to be teachers, it should be beyond what they would normally receive; and if that's the case, then you would disregard family income, because family income would be taken care of through the Illinois State Scholarship Commission. So what you're doing is, here you got it, now you don't. You either have it or you don't. In this case, you don't know whether you do or you don't. What good does it do to give somebody a scholarship under this and then the money is taken away by the Scholarship Commission?

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Welch.

SENATOR WELCH:

Well, Senator DeAngelis, there...there is many scholarships that are restricted as to receipt of...of outside income. The scholarships we give is the General Assembly, of course; if you get that, you can't accept the sheriff's scholarships and there are other exclusive requirements.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeanGELIS:

Well, that's precisely my point. I think you ought to omit the...the examining of family income, because then...if you...the minute you put that in, you're in fact allowing the taking away of the very scholarship you've given.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Welch may close. SENATOR WELCH:

I would just urge adoption of the amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch has moved the adoption of Amendment No. 2 to House Bill 1034. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further amendments?

And these bills have been discussed with both sides of the aisle and the sponsors.
