PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Vadalabene. Reading of the Journal.

SENATOR VADALABENE:

Yes, thank you, Mr. President. I move that reading and approval of the Journals of Wednesday, June 18th; Thursday, June 19th, and Friday, June 20th; Monday, June 23rd, and Tuesday,...June 24th, and Wednesday, June 25th, and Thursday, June 26th, and Friday, June 27th, in the year 1986, be postponed pending arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the motion as posed by Senator Vadalabene. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries. So ordered. Messages from the House.

SECRETARY:

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Luft moves that the Senate accede to the request of the House...and Conference Committee be appointed. It's...it's my understanding that Secretary's Desk Nonconcurrence...leave, we'll go to that order of business, page 8, handle just the appropriation bills for the moment. We will begin on page 8, House Bill 2688, Senator Carroll. 2688.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I move that we nonconcur...I'm sorry, that we do not recede from Senate Amendment No. 1 and ask the House for a conference.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Mr. Secretary,...2688, let's read it in,

ACTING SECRETARY: (MR. FERNANDES)

House Bill 2688 with Senate Amendment No. 1.

PRESIDING DEFICER: (SENATOR DEMUZIO)

All right. Senator Carroll moves that the Senate refuse to recede from the adoption of Senate Amendment 1, and that House Bill 2688...to House Bill 2688 and that a Conference Committee be appointed. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. 2986, Senator Sommer. Senator Sommer.

SENATOR SOMMER:

Mr. President, could I have leave to move that in absence of Senator Leitch?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Yes. Senator Sommer requests leave of the Body to handle House Bill 2986. Is leave granted? Leave is granted. Mr. Secretary, House Bill 2986.

ACTING SECRETARY: (MR. FERNANDES)

House Bill 2986 with Senate Amendments Noed. 1 and 3.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer.

SENATOR SOMMER:

Mr. President, I move that the Senate refuse to recede from Senate Amendments 1 and 3 and request a Conference Committee of the House.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Sommer moves that the Senate refuse to recede from the adoption of Senate Amendments 1 and 3 to House Bill 2986 and that a Conference Committee be appointed. All those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. 2988, Senator Donahue. Senate...all right. House Bill 2988, Hr. Secretary.

ACTING SECRETARY: (MR. FERNANDES)

House Bill 2988 with Senate Amendments 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

Thank you, Mr. President. I would move... I would move to...refuse to recede from Amendment No. 10.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well...Senator Donahue.

SENATOR DONAHUE:

Yeah, I°m still...I refuse to recede. I may have the wrong amendment, but I refuse to recede from any of them.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sommer.

SENATOR SOMMER:

All right. SENATOR ETHEREDGE:

Thank you, Mr. President. I would seek leave to handle this bill in the absence of Senator Davidson.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge seeks leave to handle House Bill 2991.

Leave is granted. House Bill 2991, Mr. Secretary.

SECRETARY:

House Bill 2991 with Senate Amendments 1, 2 and 4.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Etheredge.

SENATOR ETHEREDGE:

Mr. President, I move that the Senate refuse to recede and...from Senate Amendments 1, 2 and 4 and request a Conference Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. You've heard the motion. Senator Etheredge has moved that the Senate refuse to recede from the adoption of Senate Amendments 1, 2 and 4 to House Bill 2991. Is there discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. House Bill 2998, Mr. Secretary.

SECRETARY:

House Bill 2998 with Senate Amendments 1, 3, 6, 7, 8, 11, 13, 14, 15, 16, 17 and 18.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rigney.

SENATOR RIGNEY:

Mr...Mr. President, I move that we do not recede and ask for a Conference Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rigney...moves that the Senate refuse to recede

from the adoption of Senate Amendments 1, 3, 6, 7, 8, 11, 13, 14, 15, 16, 17 and 18 to House Bill 2998 and that a Conference Committee be appointed. Those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries and the Secretary shall so inform the House. Page 9...page 9, House Bill 3165, Senator Carroll. House 3ill 3165, Mr. Secretary.

SECRETARY:

House Bill 3165 with Senate Amendments 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20.

Senator Carroll.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR CARROLL:

Well, thank you, Mr. President. The House apparently didn't like our amendments, but we did. We will refuse to recede from Senate Amendments 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20 and ask them to sit down.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Carroll moves that the Senate refuse to recede from the adoption of the...amendment...Senate Amendments 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20 to House Bill 3165 and that a Conference Committee be adopted...appointed. All those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries. The Secretary shall so inform the House. Senator Hall, 3191. House Bill 3-1-9-1, Mr. Secretary.

House Bill 3191 with Senate Amendments 1 and 2.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall.

SENATOR HALL:

What...just hold that for a moment and come back...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall. (Machine cutoff)...Hall.
SENATOR HALL:

I would refuse to recede and ask that a Conference
Committee be appointed.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall moves that the Senate refuse to recede from the adoption of Senate Amendments 1 and 2 to House Bill 3191 and that a Conference Committee be appointed. All those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries. The Secretary shall so inform the House. House Bill 3257, Mr. Secretary.

SECRETARY:

House Bill 3257 with Senate Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I move that we refuse to recede from Senate Amend-ment No. 1 and ask the House to confer.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Carroll moves that the Senate refuse to recede from the adoption of Senate Amendment 1 to House Bill 3257 and that the...a Conference Committee be appointed. All those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. The motion carries. The Secretary shall so inform the House.

PRESIDENT:

All right, the Chair's understanding is that there are no bills on the Concurrence Calendar that anybody wishes to call today. On the Order of Nonconcurrence, we will go through the Order of Nonconcurrence. Senator Smith on 1446. On the Order of Secretary's Desk Nonconcurrence, House Bill 1446.

SECRETARY:

House Bill 1446 with Senate Amendment No. 1.

PRESIDENT:

Senator Smith.

SENATOR SHITH:

Thank you, Mr. President and members of the Senate. I will recede from Senate Amendment No. 1.

PRESIDENT:

All right. Senator Smith has moved to recede from Senate
Amendment No. 1 to House Bill 1446. Senator Smith.
SENATOR SMITH:

I merely ask...I'll explain the amendment. Amendment No. I to Senate Bill 1446 was that it made three changes. Number one was that children would only have to wait five months instead of ten months to receive one month of support due them. Number two orders withholding would be in dollars amount instead of percentages for the conveniences of the employees. And number three, parents can obtain a cartified copy of their order withholdings from the circuit clerk to send to a new employer, and they would not concur so I...recede to Senate Amendment No. 1.

PRESIDENT:

Senator Smith has moved that the Senate recede from Senate Amendment No. 1 to House Bill 1446. Any discussion? If not, the question is, shall the Senate recede from Senate Amendment No. 1 to House Bill 1446. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 48 Ayes, no Nays, none voting Present. The Senate recedes from Senate Amendment No. 1 to House Bill 1446 and the bill having received the required constitutional majority is declared passed. Senator Weaver on 2839. We're on the top of page 8. Top of page 8, on the Order of Secretary.

SECRETARY:

House Bill 2839 with Senate Amendment No. 1.

PRESIDENT:

Senator Weaver on Senate Amendment No. 1.
SENATOR WEAVER:

Thank you, Mr. President. I would move that the Senate refuse to recede from Senate Amendment No. 1 and request a Committee of Conference.

PRESIDENT:

All right. Senator Weaver has moved that the Senate refuse to recede from the adoption of Senate Amendment No. 1 to House Bill 2839 and that a Conference Committee be appointed. All in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and the Secretary shall so inform the House. 3036, Senator Welch. 3162, Senator Vadalabene. Top of page 9. Hold. 3266, Senator Demuzio. On the Order of Secretary's Desk Nonconcurrence is House Bill 3266. Mr. Secretary.

SECRETARY:

House Bill 3266 with Senate Amendment No. 1.

PRESIDENT:

Senator Demuzio on Senate Amendment No. 1.
SENATOR DEMUZIO:

Thank you, Mr. President. I...I move that the Senate refuse to recede from the adoption of Senate Amendment No. I and that we request a Conference Committee.

PRESIDENT:

All right. Senator Demuzio has moved that the Senate refuse to recede from Senate Amendment No. 1 to House Bill 3266 and that a Conference Committee be appointed. All in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and the Secretary shall so inform the House. 3351. Senator Demuzio. 3475. Senator Leitch. On the Order of Secretary's Desk Nonconcurrence is House Bill 3475.

Mr. Secretary.

SECRETARY:

House Bill 3475 with Senate Amendment No. 1.

PRESIDENT:

Senator Leitch on Senate Amendment No. 1.

SENATOR LEITCH:

Thank you, Mr. President. I would move that we not recede from this amendment and ask a Conference Committee be appointed, please.

PRESIDENT:

All right. Senator Leitch has moved that the Senate refuse to recede from Senate Amendment No. 1 to House Bill 3475 and that a Conference Committee be appointed. All in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and the Secretary shall so inform the House. Resolutions, Mr. Secretary.

SECRETARY:

Senate Resolution 1139 offered by Senators Sommer, Jeremiah Joyce, Leitch and all Senators.

PRESIDENT:

Senator Sommer.

SENATOR SOMMER:

Mr. President and members, this resolution suggested by Senator Jeremiah Joyce and others requests the President of the Senate to recommend...or to appoint a committee to recommend...an appropriate memorial to our departed colleague, Senator Bloom.

PRESIDENT:

All right. Senator Sommer has moved to suspend the rules for the immediate consideration and adoption of Senate Resolution 1139. All in favor of the motion to suspend indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Senator Sommer now moves the adoption of Senate Resolution 1139. All in favor of the resolution indi-

cate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. All right. The Secretary informs me that the Resolutions Consent Calendar has been distributed. In accordance with our rules, we are to do this weekly, and whether we realize it or not, it is the end of the week. Mr. Secretary, have there been any objections filed to the Resolutions Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDENT:
