This particular piece of legislation amends the Higher Education Student Assistance Act to increase the maximum full-time grant award for those people in the MAP program, the Monetary Award Program, from thirty-five hundred to thirty-eight hundred dollars a year. It also increases the part-time enrollment -those -- those involved in part-time enrollment, from seventeen hundred and fifty dollars to nineteen hundred dollars. We heard in the committee concerning this issue. Ιt was Assistance Commission, the Illinois Student supported by Northwestern University, the Federation of Independent Colleges and Universities. This MAP award has not been increased for about five years, and I think it -- time is overdue.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

SENATOR DEMUZIO:

Thank you very much, Madam President and Ladies and Gentlemen of the Senate. I, too, would rise in support of Senate Bill 1322. I would only ask the sponsor that we pay close attention to the appropriation bill, in making sure that once these monetary award

increases have been put into effect, that the money does, in fact, stay in the appropriation bill. And if there aren't any objections from the sponsor, I'd like to be added as a cosponsor.
