Senate Resolution 999, offered by Senator Geo-Karis. There are no committee or Floor amendments, Mr. President. PRESIDENT PHILIP:

Senator Geo-Karis, to explain the resolution. SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, Senate Resolution 999 is the result of the U.N. Convention on the Elimination of all Forms of Discrimination Against Women, and it's an important international human rights item. Over a hundred and twenty-two countries have ratified this treaty, and this is important, to show that violence and discrimination against women -- don't just victimize the individuals; they hold back whole societies by confining the human potential of half the population. And I urge the favorable passage of this resolution. PRESIDENT PHILIP:

SENATOR GEO-KARIS:

I urge a favorable vote. Thank you. PRESIDENT PHILIP:

Senator O'Malley, to explain the resolution. SENATOR O'MALLEY:

Thank you, Mr. President and Members of the Senate. Senate Resolution 1012 resolves that any person or entity affected by a law relating to the acquisition, continued availability or disbursement of public monies is placed on notice that reliance upon the continued or unamended presence or existence of the law is unwarranted. The need for clarification in this General Assembly grew out of our Senate Revenue Committee hearings on tax reform, especially with respect to our discussions concerning sunset laws and -- and potentially imposing sunsets on -- on certain exemptions. Additionally, the resolution is in keeping with the following concepts: that the General Assembly has authority to make laws consistent with the Constitution, and may alter or repeal those laws, and no General Assembly may bind a subsequent General Assembly. I'd be happy to answer any questions there may be.

PRESIDENT PHILIP:

Any further discussion? Any further discussion? If not, Senator O'Malley, to close. SENATOR O'MALLEY:

I'd request the support of the Senate. Thank you.

Senator Woodyard. SENATOR WOODYARD:

Thank you, Madam President and Members of the Senate. Senate Resolution 1112 is very similar to two resolutions that we passed in the Veto Session last fall - one by Senator Topinka; the other by Senator Dunn - the first encouraging the federal Congress to designate Fort Sheridan as a national cemetery; the second to use part of the land at Joliet Arsenal as a cemetery. I did not know at that time that part of the process that we should use to proceed in encouraging Congress dealt with the need to pass a resolution. A community in my district, Cissna Park, has a two-hundred-and-fifty-acre site that quite a number of people in that community have worked on for a number of years to seek designation as a national cemetery. There is a need for this in We certainly have an awful lot of veterans and not the State. nearly enough space in cemeteries for their burial between now and the year 2030. What this resolution does is to encourage Congress to at least consider and look at that site at Cissna Park as а national cemetery, and I would urge adoption of this resolution. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Any further discussion? Hearing none, Senator Woodyard, to close. On this resolution, Senator Woodyard moves the adoption of Senate Resolution 1112. Those in favor will say Aye. Those opposed will say Nay. Those in favor will say Aye. No opposed? The Ayes have it, and the resolution's adopted. Senate Resolution 1164. I'm sorry, 1113. Senator Lauzen. Mr. Clerk -- Mr. Secretary, will you please read the resolution.

SENATOR LAUZEN:

Thank you, Madam President. Senate Resolution 1113 requests the Governor to proclaim the week of October 2nd through 9th, 1994, as Respect Life Week in Illinois. This resolution in nearly identical form has been adopted every year since 1973. The preamble states that the Respect for Life Program originated as a national week of prayer and study, focusing on the sanctity of all human life and recognizing that each human being after being called into existence, has a right to life, liberty and the pursuit of happiness. It is desired that the week of October 2nd through 9th, '94, be designated as Respect Life Week for the purpose of assuring a collective appreciation and mobilization of the efforts of social forces to support -- in support of human life and dignity.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any discussion? Any discussion? Hearing none, Senator Lauzen, to close.

SENATOR LAUZEN:

I would just ask for an Aye vote. PRESIDING OFFICER: (SENATOR GEO-KARIS)

On -- on this question, Senator Lauzen moves the adoption of Senate Resolution 1113. Those in favor, say Aye. Those opposed. The Ayes have it, and this resolution's adopted. Senate Resolution 1164. Senator Shadid. Mr. Secretary, will you please read Senate Resolution 1164.

SECRETARY HARRY:

Senate Resolution 1164, offered by Senator Shadid, Hawkinson and Demuzio.

Senator Shadid.

SENATOR SHADID:

Yes, Mrs. -- Madam Chairman. This resolution calls for the Illinois Congressional Delegation to work for the adoption of the recommendation of Justice Powell's committee in 1988 that examined issues related to death penalty appeals. Basically what it does is we're urging them to adopt these -- to adopt these -- the -the rules of Justice Powell that speeds up the appeals system in the death penalty, instead of people sitting on death row for fifteen to twenty years. And I would urge you to adopt this. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Senator Hawkinson.

Senate Thank you, Madam President, I rise in support of Resolution 1164, and I think this is an important resolution. Several years ago, we passed legislation in Illinois which reduced the post-conviction appeal period from ten years to three years, an attempt to do something about the outrageous delays in the in carrying out of executions in this State, as well as nationally. The Supreme Court, through former Justice Powell, studied this issue and has proposed a solution to the problem of delaying appeals at the federal level by making sure that the states provide adequate counsel at trial, provide adequate counsel on appeal, but then saying that when you provide adequate counsel, that there are going to be limits on the number and the length of the federal habeas corpus appeals. No single provision could do more to make punishment occur at a time more reasonably attuned to the crime than this provision. It is not currently in the federal crime bill in conference. It was originally discussed and voted on as part of the original crime bill. It's important that it be

included in a crime bill passed by Congress, and I think it's imperative that we in the states let Congress know that we, and certainly the public, are no longer going to tolerate fourteen-year delays between the imposition of sentence and the carrying out of the sentence. And I would urge your Aye vote. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Senator Klemm. Senator Klemm.

Thank you, Madam President. I stand in support of the resolution. I think it's a long time in coming. And I think the recommendations of -- of Supreme Court Justice Powell were certainly overlooked, I think, at the proper time years ago. I think with what's happened today in the current and recent cases that have come before the public's attention, certainly calls again attention to the desperate need I think the citizenry needs for Congress to address this issue, and I do ask for its support. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Any further discussion? Senator Shadid, to close.

SENATOR SHADID:

I'd just like to urge the adoption of this resolution. PRESIDING OFFICER: (SENATOR GEO-KARIS)

On this resolution, we'll have a roll call vote. And Senator Shadid moves the adoption of Senate Resolution 1164. Those in favor will vote Aye. Those opposed will vote Nay. And the voting is now open. Have all voted who wish? Have all voted who wished? Have all voted who wish? Mr. Secretary, take the roll. On this question, there are 57 Ayes, none voting No, none voting Present. And this resolution is -- is hereby adopted. Senate Resolution 1262. Senator Hawkinson. Mr. Secretary, would you please read this resolution. SECRETARY HARRY:

We don't need to tell this General Assembly how important the MEG enforcement groups are throughout the State of Illinois, and while we recognize the importance of adding additional police officers in our cities and states to combat crime, we don't feel that the funding for those officers ought to be taken from the important funding that helps to run our MEG programs. And I would urge an Aye vote.

House Joint Resolution 94, offered by Senators Shadid and Demuzio.

Senator Shadid. Senator Shadid.

SENATOR SHADID:

Yes. This resolution urges the U.S. EPA to adopt rules

Mr. Secretary, will you read the resolution.

SECRETARY HARRY:

House Joint Resolution 108, offered by Senators Topinka and Philip.

There are no committee or Floor amendments, Madam President. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Topinka. SENATOR TOPINKA:

Yes. Madam President and Ladies and Gentlemen of the Senate, Resolution, which comes to us from this House Joint Representatives Martinez and Parke, would resolve that the Republic of China on Taiwan deserve appropriate recognition and credit as a participant in the -- in the international community, and should be accorded full membership in the United Nations. It is something I think we should seek, because it is already ---Taiwan is already Illinois' twelfth largest trading partner. We do have a sister state relationship with it. And just in -in the last year alone, we had over four hundred and thirty-one million dollars worth of exports that Illinois sent to the Republic of -- of Taiwan. So on that basis, I would hope that we could agree and encourage our federal government to push in that

I think that probably applies to the Willard Ice Building, think that just naming these buildings after Ι as well. individuals who worked there may work well on college campuses, where they like to name the buildings after people who are on the board of trustees, but I think State buildings should be named after individuals who were either elected officials, served as leaders in the community or leaders nationwide. Instead of just picking out somebody's name and naming a State building after them, I think we should have some policy. Unlike Senator Madigan's proposal, which was a conservation area in his district, that makes some sense to name it after some local individual. But to me, this doesn't make any sense. To start naming buildings after people who were bureaucrats, who worked in the office, just

While you mention that the other resolution made sense because it was in Senator Madigan's district, this is in my district, and while we banter about bureaucrats a lot, I would have to say that there are thousands of them who do work for State government and do an excellent job. I'm told that there are a couple of other vehicles in place to use that, should the Senate decide that changes are needed to be made to make Illinois in compliance with federal law. But on the digitization, I believe that this guarantees voter security better than in some cases today. It eliminates precinct registration binder, eliminates a number of cost savings and moves Illinois forward, if the local election authority deems it to be -- to keep up with today's technology. And above all, it -- it is a good way to verify that people actually live where they're going to vote, and I would solicit an Aye vote. Thank you. PRESIDING OFFICER: (SENATOR DUDYCZ)

The question is, shall House Bill 3779 pass. Those in favor
