PRESIDING OFFICER: (SENATOR WEAVER)

Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Senate Resolution 1 informs the House of Representatives that the Senate is assembled and is ready to transact business. Therefore, I move to suspend the rules for the immediate consideration and adoption of Senate Resolution 1.

PRESIDING OFFICER: (SENATOR WEAVER)

Senator Demuzio.

SENATOR DEMUZIO:

Well, thank you, Mr. President. I'd like to ask a question, if I might, of Senator DeAngelis. Senator, you are now moving to the -- adopt Senate Resolution 1, and the President of the Senate is -- or the -- Presiding Officer has indicated that since we are in a continuation of the regular Session and that we don't have to adopt temporary rules, I'd like to know under what authority do we not have to adopt temporary rules. And if, in fact, this is a legitimate resolution - Senate Joint -- Senate Resolution 1 - and we are, in fact, here for the purpose of -- of doing business in the regular Session, why is it Senate Resolution 1, and why it is -- why a new number? Why isn't it a continuation of the old number in the old Session?

PRESIDING OFFICER: (SENATOR WEAVER)

Senator Demuzio, the Chair recognizes that under the administration of former Senate President Rock, the Senate would typically reorganize itself at the commencement of each Special Session by readopting the then existing rules, and reelecting and reappointing and then -- the then existing committees. this administration, the Chair intends to utilize the procedures outlined in the 1972 Attorney General's opinion, No. S548, which procedure was followed during the administration of Senate President Harris. For the benefit of the Members, I would -could quote that Attorney General's opinion, if you'd like. The Constitution encourages an orderly and efficient legislative process by permitting the distribution of legislative work over the entire two-year existence of the General Assembly. Within this framework, it would appear illogical to require complete reorganization of the General Assembly for any Special Session called during its existence. Subsection (b) and (d), Section Article IV of the Illinois Constitution of 1970 prescribes the basic rule for the organization and internal government of It would be contrary to the provisions to Assembly. require the General Assembly to require for a Special Session -to reorganize for a Special Session. A requirement of Special Session reorganization, election and rules adoption would impede the General Assembly's ability to resolve problems under the conditions of crisis of emergency which normally compel such Sessions, imposes on the General Assembly burdens not imposed on it upon reconvening in Regular Session during the second year of its existence. I didn't know you had a copy. Any further questions? Senator Demuzio.

SENATOR DEMUZIO:

I am not quarreling with the -- the '72 opinion by the Attorney General. I have a copy of it in my hand. If -- if, in

fact, we are -- are not obligated to adopt new rules for the Special Session, that we, in fact -- according to their -- his opinion, we, in fact, can proceed with the orderly business as was conducted in the general -- general Session -- regular Session, by what virtue now are -- are we illogically going to Senate Resolution No. 1, and No. 2, and No. 3 in succession, when we have already done that in the regular Session? As a consequence, I don't know why we don't go with a Senate resolution that is the next number and why we are having to go through this dilatory process, apparently, as you have indicated, to adopt these three housekeeping resolutions, when they've already been adopted in the regular Session?
