And I would think that that is a severe enough issue, and is becoming more important everyday, that whether it's you, ma'am, as the presiding officer, or anyone else who's in that chair, would be -- want to be very careful in cutting Members off who want to raise this issue. So, perhaps if you can provide us with some general guidelines, that would be extraordinarily helpful.
