### SENATOR DeLEO:

Thank you very much, Madam President. That's exactly the situation we have here. And I think one of the most important things that we have for a parent and for young sports is the accessibility of press at these events. And I think if we start at this level blocking the championship or the playoff games it moves on to -- I don't think we'll ever see a child's picture in the back page of the Norridge or -- or Rosemont or Peoria Journal of them catching that famous pass. And I think that if everything was put on dollars and cents and -- and we got off on the wrong -- in the Executive Committee, we got off on the wrong -- it was about dollars and cents and how much the High School Association's going to lose in their contract to this company for seventy-five thousand dollars, and I think that -- that's not the issue. The issue is, what is a public place? And, is a school board meeting a public place? Should we ban the media from going to a school board meeting? Is a high school -public high school sporting field -- athletic field, football field, is that a public place? Well, it's been deemed a public place. And the IS -- IHSA is not the Illinois Toll Highway Authority; it's not McPier Authority. It's an organization. And I think an organization's going to dictate that -- that media cannot come into a public event, is wrong. And that's

what -- why we have this bill coming through the General Assembly, to define -- to define. Not about money. It's about getting that child's picture in a neighborhood newspaper.

Thank you... To the bill: I agree with the eloquent words of the distinguished Senator from Chicago. This is an issue involving parents and the public athletic events that their children are a part of. And they are -- want to be part of the community record. And they want the community to vicariously be -- be a part of them. This is -- this is an attempt by the High School Association to grab hold, for a -- a narrow profit interest, the -- the public endeavors of its citizens and its students. And I would encourage an Aye vote. Thank you.

Senator Jacobs.

## SENATOR JACOBS:

Question of the esteemed sponsor.

PRESIDING OFFICER: (SENATOR HALVORSON)

#### SENATOR JACOBS:

Senator, so I understand, the dispute is between the schools who want to be able to sell the rights to shoot the pictures and then the news media who wants to sell the pictures.

Is that -- am I accurately describing that?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator DeLeo.

### SENATOR JACOBS:

So, the question I have then is, where are the students? Are the students part of this payment? I mean, we're using the sweat off the backs of these kids who are playing basketball and both groups want to sell the photos. It just seems to me that maybe we ought to find a way to make sure the schools or the kids who are actually helping produce these photos are compensated.

PRESIDING OFFICER: (SENATOR HALVORSON)

Further discussion? Senator Burzynski.

## SENATOR BURZYNSKI:

Thank you, Madam President. To the bill: I really wasn't going to speak on this. I was the only No vote in committee. But the sponsor made a comment or two and Senator Haine made a comment or two. This is about money. There is nothing currently -- under current statute, under current law, under current rule of the Illinois High School Association that prohibits a newspaper or any other news entity from taking a photo at a high school basketball game or football game, playoff game, championship game, or anything else, and from using it in their paper. Not one thing. And I think we were led to believe just now that there was something that precluded that from being

a part of the normal record in the local newspaper. That is not The issue is, who has the rights to sell those the issue. photos then for a profit. And that's what the newspapers want. They want the right to sell those photos for a profit while the IHSA, which is the high schools by the way, all of the high schools pay or are a part of the Illinois High School Authority That's who sponsors football. -- Association. sponsors the baseball playoffs. Track. You name it. Music. Anything you want to. Drama. IHSA - that -- that is the high schools. So, what I'm trying to suggest to you here is that it is profit-oriented, profit-driven. It is not an issue of accessibility. It is not an issue of a newspaper being able to go and take photos of a sporting event or any other event to run in their publication. That is not the issue. And I believe that they still can sell those photos to recover their costs. They simply can't make a profit on them. That's what the issue is. Folks, all of our high schools are going to end up paying for this regardless. If this bill does become a law, then the high schools are going to have to charge entry fees for all of their schools in order to make up for that and then to be able to run these tournaments. So, I just want to clarify it is profit-driven.

Senator Garrett.

### SENATOR GARRETT:

Thank you very much, Madam President. I stand up in support of this bill, and while we're talking about who is able to sell the photos, who makes the money, I think what we're really talking about is the notion that if this bill doesn't

pass, the ISHA {sic} will be able to monopolize the entire photography business when it comes to schools. They should not have the right to own that monopoly and actually say to newspapers and others that this is not for you to participate in. This is something that should be open to anybody, whether it be newspapers or other organizations. So, I -- I say think a little bit more before we vote on -- on this, the -- those that are opposed to it, because what we're establishing, if we don't vote Yes, is that we are allowing the ISHA {sic} to have a monopoly on these types of things, and I -- I personally think that's a very bad idea.

agreement with this company from out-of-State to -- to photograph the championship games, barring the local media from having access to these events and saying that they have to...

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

#### SENATOR SYVERSON:

I mean, that's -- I guess that's where I'm confused. The local papers are barred from taking photos at the event? You just said that they are barred from taking photos. Is that -- are they barred from taking photos, or are they barred from selling photos for a profit?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator DeLeo.

## SENATOR DeLEO:

Let me explain this to you one more time. Last fall, the IHSA banned -- banned photographers from five Illinois newspapers from the sidelines of the State football championship game because those papers maintain online galleries of their photos and they refused to sign waivers.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

## SENATOR SYVERSON:

Was that -- was that because they refused to sign the waivers because they were going to sell those at a profit, or -- 'cause -- how come the other newspapers weren't banned from coming and taking photos? I guess I'm still confused. Can't anyone take photos? Is the issue just about who can sell 'em for profits?

PRESIDING OFFICER: (SENATOR HALVORSON)

### SENATOR DeLEO:

They put them on -- their photographers put them on their website after they're used and people can purchase them.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

### SENATOR SYVERSON:

Is that what they -- but they can currently do that now, correct? So what is this legislation then doing? If they can do it now, they just can't make a profit. Anyone can take the photos. You can buy them. You just can't make a profit. I guess I'm -- I'm confused. How does this preclude families or newspapers from covering games and taking pictures?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator DeLeo.

## SENATOR DeLEO:

I don't -- maybe I wasn't clear enough. They were banned from the sidelines. They did not get media credentials to go on courtside, on the sidelines of these games to take these photographs. Now, they could buy a bleacher pass and go sit up in the bleachers and take these shots, but they were banned from sidelines - media access to a public event, which all -- at a presidential campaign, at a sports -- you have -- media have credentials that allows them access to certain areas. They would not let them have access to these areas.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

#### SENATOR SYVERSON:

Is -- then, is this any different? You said at a sporting

event or a professional event. Is this any different than in the NCAA or in professional sports? If a reporter is on the sidelines and they take pictures at the NCCA {sic} or the -- or the professional tournaments, or they're taking pictures of players, are they allowed to sell those, then, as a profit, or do they also have to get a waiver that says that they won't sell those at a profit? Or are they not -- or are they not allowed to sell those at all at the NCAA tournaments?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator DeLeo.

#### SENATOR DeLEO:

It's -- it's very different. I am told by legal staff that the NCAA has interstate agreements and contracts and it's totally different than a -- than a local high school event.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

### SENATOR SYVERSON:

The argument was being in a public place for the press. If -- these are public universities, and so I guess I'm confused as why -- I guess the issue is, what it sounds like you're saying on one hand, we don't want -- it's going to be a problem for parents or newspapers to take pictures, but it turns out it's really just anyone can take pictures, they just can't sell 'em at a profit, which is the same that happens in the professionals or at the college level, that they're not allowed to do it. We're just -- aren't they just really doing what -- the same thing that the colleges are doing and that the professional level is doing? Anyone can take photos, you just can't make a profit off of the students, and that's why the IHA {sic} says if

you're going to make a profit, let the high schools make the profit to help reduce the cost to the children. No one's keeping them from taking the pictures. So, I guess that's where I was confused when you started talking from what seems to have come out. So, I appreciate the -- the debate on this.

PRESIDING OFFICER: (SENATOR HALVORSON)

Further discussion? Senator Hendon.

### SENATOR HENDON:

Thank -- thank you, Madam President. I'll be very brief. I hope -- and I'm certainly not a shield for the media, because they don't treat me that nicely, but if -- I hope the media takes a -- really look at this, at who's voting to say the media -- should not have access. I mean, we are -- we're -we're saying the media should have access, period. I mean -and -- and the difference between professional ball and high school, some of those professionals, they're going to get in the paper anyway. Some of these young people, if they're not in the local paper, Senator, they're not going to be in the paper. to ban local papers from being on the sidelines, getting good shots -- what good is it taking a shot from the balcony where you can't even see the young person's face or -- or the play they made to give them an opportunity to go to the next level? Everybody should be an Aye on this. Senator DeLeo is right on point, and it's amazing to me the length of this discussion. So, if you're against access to the media, vote No. If you're for open access to the media, vote Yes. And I hope the media takes into consideration who's for open access to the media.

PRESIDING OFFICER: (SENATOR HALVORSON)

Further discussion? Senator Luechtefeld.

#### SENATOR LUECHTEFELD:

I -- I apologize for speaking twice, but I think some things were just said that are not necessarily true. Before -you can go on the floor and you can take pictures, and you can go to the finals and take pictures. It's not that they're not going give you access without this law. You can -- you can still go on the floor. It's not a freedom of the press thing; it's about who's going to make the money. And -- and -- and that's -- that's what it's all about. And -- and my -- my question to you is, why wouldn't we want to let this be settled in the court? I would think this is a -- this -- you know, there -- there is a case right now in the court at who's right and who's wrong as far as the First Amendment is concerned. I -- and I guess I had hoped that this could be dealt with there and we wouldn't have to deal with it, because I really don't believe it's our place to deal with it. And -- and -- and again, you know, I know that people mean well and they're trying to do the right thing here, but this is probably not something we really should deal with.

## PRESIDING OFFICER: (SENATOR HALVORSON)

Since Senator Luechtefeld spoke for a second time, I'll allow Senator Maloney to speak for a second time, and then we'll have Senator DeLeo to close.

## SENATOR MALONEY:

Thank you, Madam President. It occurred to me that this, if I could use the analogy -- you remember several years ago, the Chicago Cubs, in the adjacent neighborhood, many people put up these rooftop stands and -- charging people admission to come up to their roof, a private building, and watch the Cub game.

And the Cubs -- they went to court. The Cubs went to court and the court's conclusion was, yes, you were stealing the product. So, now these people, who are these rooftop vendors, have to pay the Cubs for this. And this is the same situation. The IHSA wants the publicity to generate the excitement about IHSA sports. But the fact of the matter is, they're simply saying, that the photos that are being used should not be used for profit and that that -- that -- that particular privilege belongs to them. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator DeLeo, to close.

### SENATOR DeLEO:

Thank you very much, Madam President. I told the Tribune recently these organizations -- the news organizations have a legitimate and constitutional right to cover and photograph these games. I said, how are these tournaments ever going to get attention if... I think the IHSA is really wrong on this issue. To cut a deal with an out-of-state photograph company, I don't think they should be able to do this. This is a sweet deal for a company that holds a monopoly, who gets free use of the competition photos, free photos in their contract to the members -- staff members. I think this is what Senator Jacobs referred to: This is a disservice to the athletes, to the parents, who are your fans of New Trier, Glenbard -- Glenbard South, Marshall, every other school in this State. If they want a photo of a championship game, there's only one place to go to a company in Wisconsin? There's no historic record of -- in their local newspaper. They have to go to a Wisconsin company and pay a fee. This is a right. This is a constitutional

right. This is a open meeting. This is an open sporting event. This is an open -- just like I mentioned, at a school board meeting. So, I'd ask a Aye vote on this very important...

PRESIDING OFFICER: (SENATOR HALVORSON)

## SENATOR HAINE:

Thank you, Madam President, Ladies and Gentlemen of the Senate. This bill amends the State Employees Group Insurance Act to allow units of local government, school district employees, child advocacy centers, rehabilitation facilities, to have an option to buy their insurance as part of the State group health insurance coverage. This is to meet the rising cost of insurance premiums to these local units, many of -- of which have contracts with the State. CMS does not oppose this. There is a number of labor organizations, represent these employees, who are in favor of this. And I would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR HALVORSON)

Thank you. Senator, we had -- there was a few discussions during committee on that and I guess I -- I want to make sure we're -- we have a clarification on this. The -- one of the concerns was raised, the issue about cherry-picking, where the current rule is that eighty-five percent of the -- of that group has to go into the State's pool. And so, by eliminating that eighty-five percent, then what would preclude a small agency that just had one or two people that had significant health problems from those one or two people just joining into the State's plan, thereby creating significantly higher costs to all those who currently have State coverage? - which is one of the reasons why we had that at eighty-five percent before, so we would not have the cherry-picking issue.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Haine.

### SENATOR HAINE:

Senator, that's a -- that was a good question. We -- they can join the pool now. The rule now is eighty-five percent. So, they -- they can do that now and that hasn't occurred. CMS has looked at this. I waited for their response. They don't have a problem with this. Because of the -- the workings of the -- the marketplace, there will be enough people joining because of the cost or not joining because of the cost. If they get a better deal locally, it'll moot out. So, there doesn't seem to be a concern that'll happen.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Syverson.

#### SENATOR SYVERSON:

The reason why carriers, whether it's auto or home or health carriers, require a larger pool is to -- is to keep them -- employers from just saying "I'm going to take all my sick people and put with this group and I'm going to put all my healthy people with this group." And that's why they said, okay, let's make sure eighty-five percent of your people have to be on there. So that means, basically, your whole group has to go in there. So, either as a group you decide to go into the State's plan, both the healthy ones and the unhealthy ones - you all go in together so we share the risk - or nobody goes in it. What we're doing now is, you're saying, potentially -- for organizations, let's put all of our sick people into the State's plan because we don't have to meet eighty-five percent anymore let's put our sick people into the State's plan; let's put our healthy people with a private plan that's much less. And then up getting significantly adverse State ends health the conditions that they wouldn't get if they were required to take eighty-five percent, because that means the healthy ones and the unhealthy ones would both be going into the group. So, I guess that's where my concern is, if we eliminate the eighty-five percent, employers then will -- will cherry-pick the sick ones and keep the healthy ones for their own private carriers.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Haine.

### SENATOR HAINE:

Senator, thank you for that very good question. I understand completely what you're saying. And again, I waited for CMS to come up with a figure or to express opposition.

There have been several similar bills broader in scope in which they did oppose for that very reason in the past and they didn't go anywhere in committee, but they didn't seem to think this would be a problem. ## SENATOR HAINE:

I -- I will pull this from the record and -- and bring it back at a later time.

PRESIDING OFFICER: (SENATOR HALVORSON)

### SENATOR HAINE:

Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senate Bill 2002, out of the record. Senator Link, on 2005. Mr. Secretary, read the bill.

### ACTING SECRETARY KAISER:

Senate Bill 2005.

And it will only affect non-home rule counties of two hundred and fifty thousand and above. And excludes Cook County. So, it will only affect Kane, Will, Lake and DuPage counties. I'll be more than happy to answer any questions.

PRESIDING OFFICER: (SENATOR HALVORSON)

Any questions? Senator Althoff.

SENATOR ALTHOFF:

Madam President, will the sponsor yield?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Link, can you explain to me specifically how we've changed that definition?

### SENATOR LINK:

In -- in the population -- and I misread that, it was five hundred thousand and above. So, it's that. But to change that to where it would have -- it would have to have a current license plate on it or a tag to be declared inoperable. A lot

of your local municipalities have that already in their ordinances, but counties don't have it. And this is what they want to do so if a vehicle is along a county road, inoperable, they can tag it and have it towed away. That's what we're changing.

And it's my understanding, this is permissive. The counties would have to enact an ordinance to follow this statute and -- and change the definition?

Yes.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Althoff.

### SENATOR ALTHOFF:

I would just like to take a moment and thank you for working with us on this bill and limiting it to those particular counties and making it permissive. Thank you.

Is there any further discussion? Seeing none, Senator Link, to close.

The way I understand it - I'm not an attorney - is that it's really a -- a hearing. It's a hearing process.

### SENATOR CLAYBORNE:

Thank you -- thank you, Madam President, Members of the Senate. This is called the Illinois New Market Tax Credit Development Program. Basically, what this bill does is, this program provides that taxpayers that make a qualified equity investment earn a vested right to certain tax credits against income, franchise and insurance premium taxes. The tax credits are not transferable and total credits cannot exceed forty million dollars in one physical {sic} (fiscal) year. Investments must be made solely in Illinois or the purchase price shall be reduced by the same ratio. DCEO will recapture the tax from -- from the taxpayer that claimed the credit on the return if necessary, subject to specific conditions. And DCEO may promulgate the rules. I ask for your favorable vote.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any discussion? Senator Lauzen.

### SENATOR LAUZEN:

Thank you, Madam President. I just would like to share with the Senate that this received unanimous support in the Revenue Committee, and congratulate the sponsor for a good initiative and innovative plan. Thank you.

Any further discussion? Seeing none, Senator Clayborne, do you wish to close?

### SENATOR HAINE:

Thank you, Madam President, Ladies and Gentlemen of the Senate. This is an initiative of EPA and it allows a five-hundred-dollar annual fee for an NPDES on-site construction discharge permit. It's a one-time permit initial fee of seven hundred and fifty dollars, rather than the annual fee of five hundred dollars, which can add up depending upon the construction over a one-, two-, three-year period. So, it saves the Department bookkeeping and recordkeeping and monitoring. It saves the construction -- the -- the owner and the manager of the construction company an expense too. So, it seems to be win-win. There's no opposition.

Senator Haine, in light of various fee increases that have taken place and the administration sweeping them and the like - and I was in the committee hearing when this took place - the -- ultimately this, though -- is this is going to be a cost savings or better from a financial standpoint for the enterprise that's applying for this one-time fee as opposed to an ongoing. Is that correct?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Haine.

#### SENATOR HAINE:

Yes. Yes, Senator, that is correct. That's what's -that's what I'm getting out of the business groups and the EPA.
They tell me that the average construction period - they being

they would save a considerable amount of money by just paying
the seven hundred and fifty dollars.

Senate Bill 2021.

Senator Frerichs.

SENATOR FRERICHS:

Senate Bill 2021 amends the Bingo License and Tax Act to allow senior citizens organizations that conduct bingo games to

charge up to fifty cents for a single bingo card and to offer prizes with an aggregate retail value of up to five dollars. This was brought to me by some constituents of mine in Georgetown, Illinois. They currently comply with State law even though they know that other senior centers are not complying. Basically it's been very difficult for them to find prizes worth anything under a dollar to give out at these events. They're looking to raise it to five dollars. This is not something that's going to expand gambling or turn seniors out of their homes through -- through gambling. But I -- I do believe that as our eight-year-olds and our ten-year-olds are on these buses without safety belts, our four- and five-year-olds can be on those same buses and be perfectly safe.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Lauzen.

### SENATOR LAUZEN:

I'm sorry. The question that I was asking wasn't so much about the seat belts, and I've heard, over the years, the controversy on both sides of that. My question was about the car seat that's required in regular vehicles. Not -- not the seat belt, but the car seat - because the weight of the child and the danger and the wiggling around that our younger children do.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Wilhelmi.

### SENATOR WILHELMI:

Senator, there is no provision for -- you may be referring to booster seats. We have one in both of our vehicles for our - our younger child. There are no provisions in this bill for booster seats or car seats. And again, a first grader might very well need to be in a booster seat. And as we have it right now, there are no such booster seats on our buses for our first graders.
