It asserts that the individual is allowed to remain enrolled in the Medicaid program as long as all other eligibility criteria are satisfied; that the Department of Healthcare and Family Services is not responsible for reimbursement of services that the individual received during detention or incarceration; and finally, that following the release of the individual, the Department of Healthcare and Family Services is responsible for providing Medicaid to the person provided that the individual is enrolled in the Medicaid program at the time of release, that neither a county, the Department of Juvenile Justice, or Department of Corrections continues to have jurisdiction over the person's medical care, or that the county, the Department of Juvenile Justice, or the Department of Corrections makes provisions for timely notice of date of released of the person in a fashion

I do, Mr. President. To the bill: I urge your Aye vote on This came out of the Public Health Committee unanimously. I don't know if you've had the situation in your district, but I have had it in mine, where a prisoner is released and they have to wait two or three months to be able to qualify for Medicaid to get the medications that they really need at the very first day they leave. A percentage of our population in the prisons have mental health problems. And so to be without their medications for one, two, three months, whatever it takes for them to get back on the Medicaid rolls, is a difficulty. This bill will allow them to keep their eligibility during the time that they are in prison, but no services will be delivered during that time that will be collected under their -- under the Medicaid bill. This was a question that we asked over and over in -- in committee and were assured by the Department and everybody involved that there will be no services provided, no expense to the taxpayers. But it will allow them to have whatever medications they need and whatever services they'd need immediately upon getting out of prison. I urge your Aye vote.

It stipulates that firefighters wishing to purchase this time must apply in writing to the fund within three months after the effective date of the bill. So it's a very narrow opportunity. The cost, if any -and there shouldn't be one dime of a cost to the municipalities or the local governments. This requires the member contribution to fund this benefit. And that -- that contribution shall be equal to the employer contribution that would have been required had the service been rendered, plus an amount determined by the fund to equal the employer's normal cost of the benefits accrued for that military service, plus six-percent interest per year. So, I know we're all sensitive to the issue of pensions and imposing any further obligations on local governments. a bill that does not do that, and yet it recognizes people that

have served their country and give them an opportunity to buy out of -- you know, out of their own pocket, pension benefits or credits toward their pension.
