And the task force is comprised of top leaders from around the State of Illinois in -- in the areas of education, mental health, public safety and law enforcement, along with the input and the leadership of the Illinois Emergency Management Association {sic}, the Department of Human Services, the Division of Mental Health, and the Attorney General's Office. The task force made recommendations as to how -- what we can -what steps can be taken to address security and safety issues on our higher education campuses in the State of Illinois. those recommendations are included in the legislation that we'll be addressing here today. Specifically, it -- the legislation creates the Campus Security Enhancement Act of 2008. Under this Act, all institutions of higher education in Illinois, both public and private, including community colleges, are required to work with their associated municipalities or counties and their emergency management associations to establish emergency plans for the campuses. The bill also requires institutions to establish violence prevention protocols and committees. This is to be done in cooperation with the local mental health departments and first responder agencies. IEMA will be required to provide any assistance to the institutions to establish those policies. I'll be more than happy to answer any questions.
