I also want all the young Members to take a real good look at -- at Todd Sieben, because in the days of partisanship, Todd Sieben was someone who understood you had to work on both sides of the aisle and that Illinois had a place that we needed to go to that didn't -- that wasn't about one side being here and on the other side being here; it was about us finding middle ground and making this a better State. I also, you know, will note that Senator Sieben is from Geneseo and that he is a Republican. But I can tell you there's been countless times when Senator Sieben has reached out and helped my community and I want to thank you from the bottom of my heart for that. And I also want to close by saying that the thing that I'm most impressed with, Senator, is that you

The Division of Insurance has to have this bill to keep its accreditation with the National Association of Insurance Commissioners.
