The bill is a product of a lot of negotiations with insurance providers to clarify the scope of this new law and how it would interact with other existing insurance laws. And over the last weeks, we've worked on the language that we believe was fair to the insurance companies and businesses and also to ensure our kids get the therapy that they need to fully develop to their potential. I would like to just take this opportunity to thank everybody who has come together to work on this legislation. I think we've come to a real good and fair bill and I would be willing to answer any questions.
