SENATOR WILHELMI:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. On Senate Bill 2718, I move to accept the specific recommendations of the Governor. And it's very simple. The amendatory veto of the Governor makes this bill effective immediately. And that is the only change. As you may recall, this is the limited hearsay exception, known as forfeiture by wrongdoing. I ask my colleagues to please vote Aye and --accepting the specific recommendations of the Governor.

PRESIDENT JONES:

Senator Wilhelmi moves to accept the specific recommendation of the Governor as regard to Senate Bill 2718. Is there any discussion? Any discussion? Seeing none, the question is... Senator Righter. Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield, please? PRESIDENT JONES:

He indicates he will.

SENATOR RIGHTER:

Thank you, Mr. President. Senator Wilhelmi, for those of us who are growing older by the day and our memories are fading a little bit, can you just walk through very briefly what the legislation does? Just kind of remind the Body. Thank you. PRESIDENT JONES:

SENATOR WILHELMI:

Thank you, Mr. President. Senator, as you may recall, under the forfeiture by wrongdoing doctrine, what this bill does specifically is allows for an exception to the hearsay rule if a

statement is offered against the party that has murdered a witness for the purpose of preventing that witness from testifying in a civil or criminal proceeding. Originally, this was expanded somewhat more to deal with kidnapping or bribery. We limited this to murder only. And we also have a very specific test to ensure the reliability and a court would have to rule that that reliability test has been met before the statement would be offered, and that would happen through a separate hearing on the admissibility of the out-of-court statement.

PRESIDENT JONES:

Any further discussion? Any further discussion? Seeing none, the question is, shall the Senate accept the specific recommendation of the Governor as it relate to Senate Bill 2718. All those -- all those in favor will vote Aye. Opposed, Nay. With this immediate effective date amendment, it takes thirty-six votes. The -- the voting is open. Have all voted who wish? The specific recommendations to the Governor as relate to Senate Bill 2718, having received the constitutional majority of votes, is -- is declared passed. The underlying Senate Bill 2636 regulates the behavior of companies who, for a fee, will reunite Illinois citizens with their lost property. The Governor amendatorily vetoed it to add certain reporting requirements for those companies. It is -- it is my view and -- and I believe the view of the House that the -- the Governor's amendatory veto exceeded his constitutional authority. And in order to ensure that the underlying bill becomes law, I move to override the Governor's amendatory veto.

PRESIDENT JONES:

Senator Harmon moves that Senate Bill 2636 do pass, notwithstanding the specific recommendations of the Governor. Is there any discussion? Any discussion? Senator Murphy.

SENATOR MURPHY:

Thank you, Mr. President. To the motion: I rise in strong support of the motion. Urge an Aye vote on this side of the aisle to all my colleagues hanging on every word.

And I understand, Mr. President, that you are going to pay the bill. So we want to have plenty of good food and wine at this bill. And we appreciate your offer to pay very, very much. Thank you, sir.
