## SECRETARY SHIPLEY:

I move to concur with the House in the adoption of their Amendment No. 2 to Senate Bill 1415.

Filed by Senator James Clayborne.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Madam Secretary. Senator Clayborne, to explain your motion, sir.

### SENATOR CLAYBORNE:

Thank you. I -- I wish to concur with the House amendment, House Amendment No. 2. Basically, this amendment becomes the bill and clarifies the law that prevents this mistake from hurting tens of thousands of families. The bill simply clarifies existing law. Family Care has been established for years and funded to cover families up to -- one hundred and eighty-five percent of the federal poverty level. And it basically just clarifies that and makes sure that families up to

a hundred and eighty-five percent are covered. That's basically it.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Is there any discussion? Senator Cullerton, you seeking recognition, sir? No. Senator Righter, are you seeking recognition on this motion, sir? Senator Righter.

### SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield, please? PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

### SENATOR RIGHTER:

And I wonder, Mr. President, if we might, at the start -- I know there's a lot of -- there's a lot of hubbub and people saying "It's good to see you and happy new year", but since we're moving on concurrences... You just gaveled us down and I appreciate that very much. Senator Clayborne, first, I want to make sure that I am understanding what this motion would do. First, with regards to the Family Care program, it would increase the statutory percentage of what a family can make as a percentage of the federal poverty level and still be eligible. Is that correct?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

### SENATOR CLAYBORNE:

No, it's actually clarifying what's already in the rule, up to one hundred and eighty-five percent.

Okay, is there -- is it -- is there a percentage set forth in statute now? And I'm not talking about administrative rule; I'm talking about statute.

It's currently ninety.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

### SENATOR RIGHTER:

So, as a matter of Illinois law, this would increase that percentage of federal poverty level from ninety to one eighty-five. Is that correct?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

That's correct.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

## SENATOR RIGHTER:

Thank you, Mr. President. Is there any other changes with regards to TANF cash grants?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

### SENATOR CLAYBORNE:

It -- it increases it to fifteen percent, subject to appropriation. By fifteen percent.

Now -- and you said subject to appropriation. Is -- is there language in there that says subject to appropriation or is the TANF -- TANF cash grant process an entitlement, which means we're going to pay it whether we appropriate it or not?

### SENATOR CLAYBORNE:

There -- there is language that says subject to appropriation.

## SENATOR RIGHTER:

Is there an appropriations bill that you expect to be passed if this becomes law that will fund this cash grant? Or is this just something we're going to tell the families we're going to increase their cash grant by fifteen percent and then not appropriate it?

Senator Clayborne.

### SENATOR CLAYBORNE:

We -- we've already increased it by nine effectively, but it has been -- it was appropriated in FY`09.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

## SENATOR RIGHTER:

It was appropriated. The nine percent was appropriated or the full fifteen that you've got in this bill?

The nine percent was appropriated in FY`09.

Okay, then, Senator, I wonder if you can help the Body understand then - how much extra money are we talking about? Not just for the nine percent that was appropriated in this current fiscal year, but for the addition -- the addition, all the way up to fifteen. What is that outlay going to have to be for a State that's running seven months, eight months behind on its bills?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

### SENATOR CLAYBORNE:

Up to fifteen percent, the total amount is about twelve and a half million. From -- from nine to fifteen is five million dollars.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

### SENATOR RIGHTER:

Is the -- am I correct, Senator, the -- the language would actually give the Governor the authority to increase the cash grant up to fifteen? In other words, the Governor can go -- leave it where it's at, or go to ten, or go to twelve, or -- or what not.

I guess to answer your question, yes and no. I guess yes in the sense that the Governor is the executive. And -- and no in the sense that DHS actually makes that determination.

## SENATOR RIGHTER:

To the bill if I'm -- to the motion, excuse me, Mr. President.

PRESIDING OFFICER: (SENATOR DeLEO)

To the motion, sir.

### SENATOR RIGHTER:

Thank you. Ladies and Gentlemen of the Senate, here we are at the -- the dawn of 2009 in a State that is cash -- cash strapped, to say the least. Our unpaid backlog of bills is larger than it's ever been. Our deficits are larger than it's ever been. And here we have before us a proposal not just to send more money out the door that we do not have, but allow Governor Blagojevich to make that decision. What a great idea. Ladies and Gentlemen, 2009 ought to be the year when we start asking the question of what kind of money do we have and we what -- what do we want to spend it on. And we ought to figure out how much money we have before we decide what to spend it on and give the executive branch even more authority to do so. With all due respect, Mr. President and Senator Clayborne, I urge a No vote on the motion.

Thank you. Senator Luechtefeld, are you seeking

You know, he's created all these programs and we can't pay them. It's his fault. But with something like this, we simply enable -- enable that to happen. Am I right about this? I mean, does the payment cycle just go out a little farther than what it is right now? And we are endorsing it. We are saying its okay. Is that basically what we're doing?

Senator Clayborne.

### SENATOR CLAYBORNE:

Well, not really, Senator. What happens, if you look at this, those families that aren't covered, they go to the hospitals anyway. And, then, the hospitals eat that loss. So, you know, we -- what we're trying to do is provide a mechanism to cover these -- these individuals. So, you know, it just depends on how you look at it.

This Body in particular - the Senate - has enabled most of that to happen, whether it be -- you know, whether it be spend money or take money or not pay the bills. It -- and -- and this is one more time where you are -- you're -- we are actually doing that right up front. And I -- I admire you for that part at least. Thank you.

Senator Lauzen, for the Family Care, the one eighty-five percent has already been appropriated.

Then, what's the necessity of the bill?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator James Clayborne.

## SENATOR CLAYBORNE:

To -- to clarify that -- it was -- it was created by rule, and to put it in statute to clarify it.

But one last question, is there any proof of citizenship for eligibility for Family Care?

I'm not sure.

We currently have forty thousand citizens here in -- in Illinois who are jeopardize -- in jeopardy of losing their health care if we don't pass this. As my colleagues -- one of my colleagues raised the -- the issue, is that in -- in my district I've lost a hospital because of the number of people who did not have any kind of health care insurance. So, to -- to begin to address the health care needs of people, to make 'em more productive and to make their families and children more productive, we need to make sure that they have -- they have good health.
