SENATOR CULLERTON:

Thank you, Mr. President, Members of the Senate. This is a bill sponsored by myself and Senator Radogno. It's virtually identical to a bill that we passed in the last Session that did not get called in the House. It's obviously an important bill; it's Senate Bill 1. Senate Bill 1 applies to appointees who are nominated by the Governor and who are subject to Senate confirmation, who are either holding over in office after the expiration of their terms or who are temporarily or acting Senate Bill 1 limits the ability of future appointees. appointees to hold over after the expiration of their terms to thirty days, unless, of course, they're reappointed. appointees who are currently holding over, Senate Bill 1 ends the terms of salaried appointees immediately. It ends the terms of non-salaried appointees thirty days after the effective date of the Act. This bill mirrors the Illinois Constitution and limits temporary or recess appointments to the next meeting of the Senate. Senate Bill 1 limits future acting appointments to

thirty days. It ends the terms of the current acting appointees immediately. It does not apply to the Governor's appointments to the State Board of Elections. I would be happy to answer any questions and ask for an Aye vote.

The Governor goes to the Reference Bureau, prepares a -- a -- a bill, the bill is introduced. And our practice will be, soon as the Secretary receives it, the next -- as soon as possible, that will be read into the record and the sixty-day clock will -- will begin. I don't think that this bill deals with that issue, but it's -- it's related in that it is -- deals with appointments. And that will be our practice and there will be no more delays in reading into the record appointments by the Governor.

Is there any further discussion? Seeing none, Senator Cullerton, to close.

SENATOR CULLERTON:

I would just ask that we protect the Senate as an institution. We have identified what is really a loophole, where even though folks are supposed to be subject to Senate confirmation, if they're holding over, there's no process by which we can compel this Governor or future Governors to submit those names. That's why this bill is so important. And I would urge everyone to please support it.

SENATOR RADOGNO:

Thank you, Mr. President. I'd like to speak to the resolution. I appreciate the opportunity that we can come together today to mark the centennial of Ronald Reagan's birth, or as he probably would have called it, the sixty-first anniversary of his thirty-ninth birthday. It's hard to believe that Reagan's been gone for almost seven years now, but his legacy remains with -- with us. One of our former colleagues in

the Illinois Senate, a guy by the name of President Barack Obama, recently wrote an op-ed piece in USA Today, and I think that what he wrote captures what many Americans remember about President Reagan. And what he wrote is this: When the future looks darkest and the way ahead seems uncertain, President Reagan understood both the hardships we faced and the hopes we held for the future. He understood that it is always "Morning in America." That was his gift, and we will remain grateful forever. {sic} And I think sometimes we forget the daunting challenges that President Reagan faced. America had just been through the turbulent sixties and the seventies. We had had assassinations. We were at war. There were protests, and there was economic despair. And we also were in a time of scandal. Now some of that may sound familiar. Many people were even questioning whether America's best days were behind her, but then President Reagan took office and things began to turn around. As a nation, we began to recapture our confidence and our spirit - not only because of his legendary optimism, but also because of his great determination. As you recall, he didn't just wish that the Soviet Union would be relegated to the ashtray -- ash heap of history; he actually made it happen. He didn't just hope for better opportunity for the next generation; he actually created it. And he didn't just wish that America's best days were yet to come; he actually made those better days come. He stood up for his principles unequivocally. We didn't need to question where he stood. He stood for more responsible government. He stood for freedom for every single person in every nation. And he stood for economic growth and opportunity. But as determined as he was, he also had an unwavering belief in

the goodness of the American people - not just Republicans, not just conservatives, all the people of America. And as President, he didn't make political opponents enemies. He didn't demonize people that disagreed with him. At the end of the day, he respected those differences and he recognized that they were an essential part of the democratic process. So as we move ahead, past President Reagan's centennial, let us remember the lessons he taught us. He taught us to be strong and determined, to be hopeful and confident, and to also be respectful of dissent. Because of -- if we do these things, we'll rise to the occasion and face down those fiscal and economic conditions that we have, the national security challenges we face today. And most pertinent for us in this Chamber, that same attitude will allow us to solve the very daunting problems that we're facing. Thank you.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Bivins.

SENATOR BIVINS:

Thank you, Mr. President, and thank you, President Cullerton and Leader Radogno, for this resolution. And I'd like to talk a little bit about our hometown hero from Dixon, Illinois, my hometown, where I grew up. You know, the first time I ever knew anything about Ronald Reagan was in the late fifties when I was visiting with my grandmother and she had a stack of newspaper articles and she even had one on the Lindbergh baby kidnapping, and I came across one article that had this picture of Ronald Reagan and Bob Hope, Jerry Colonna, Joe E. Brown, Louella Parsons, at Walgreen's estates in Dixon, where the first Walgreen's drugstore was -- was also built. And

I asked her about that picture and she told me he was an actor. And it didn't mean a lot to me at that time, but I -- remember about a year later watching a television show on a Saturday afternoon and we had a choice of three channels - golf, baseball, or -- or Ronald Reagan movie. So I watched the Reagan movie. And the interesting thing to me was, as I was watching that, he was in the South Pacific in World War II and he was in a hospital bed and somebody asked him, "Where are you from?" Well, the original line was, he was supposed to say, I'm from a river -- along a town on -- somewhere on the East Coast. he changed the line to say, "I'm from a little town along the Rock River, called Dixon, Illinois", which got my attention when I heard our hometown mentioned on a television set back then. Well, Ronald Reagan, during my career, my law enforcement career, came back four times and visited Dixon, Illinois. Although he was born in Tampico, his formative years were in Dixon, where he grew up, and he was very fond and loved Dixon very much and loved to come back there. He came back the first time he ran and -- and was not successful in the primary. second time, after his primary, when he was the nominee, he came back. And -- well, I was on security detail each time that he came back. In 1984, he came back and we had a birthday for -party for him on February 6th and we had a parade. I don't know whose idea that was, because it was zero degrees that day and many of us came away with frostbite. But we had a parade and it was -- it was quite an event to behold and it was probably the first time -- I know the first time and only time in the history of Dixon, Illinois, that the airspace was restricted above Dixon, Illinois. In 1990, after becoming -- after leaving the

Presidency, President Reagan came back to Dixon, Illinois. picked him up that morning, and I was sheriff at the time, and the police chief and myself picked him up at Whiteside County Airport. We spent the entire day with him and that evening, watched him visit Lowell Park, where he was a lifeguard, saved seventy-seven lives; went to his school, where he threw the football around with the high school team, gave a speech; went to his old school; went to his boyhood home. And I can tell you that Ronald Reagan, if there's one quality that he had, I think, that made him stand above all the rest, aside from his great communication skills, was that of sincerity. It's something you can't fake, and he didn't have to. He was a very sincere individual. He was no different whether it was you and him or thousands of people and television cameras. He was the same And I attribute a lot of that to his small-town upbringing, growing up in Dixon, Illinois. I know what it was like in the -- in the fifties and in the sixties when we grew up there and -- and it was a place where you could leave your doors unlocked and your cars and your homes and your neighbors knew you, and if you needed help, somebody was always there. And it was quite a place. And -- and if -- you got in trouble, everybody knew it. And Reagan got in trouble once when he was a young man. He was shooting off fireworks and he got -- actually got arrested and got a ticket for that and paid guite a hefty fine for the time. I believe it was about fourteen or fifteen dollars. And he -- he talks about that to this day. And as he concluded his visit, the next day, the Dixon Police Chief gave him a plaque and told him who he was and -- "I'm the Police Chief and" this -- "on behalf of the City of Dixon and the

Police Department, here's this plaque", and Ronald Reagan -- the Chief did not know the story about the fireworks, but the --Ronald Reagan says, "Well," he says, "you know, I finally got my money back from the police department I guess." So -- and the Chief was quite stunned. He had -- he had no idea what he was talking about. But Reagan had a great sense of humor. He was -- I think, as they talk about his formative years in Dixon, Illinois, I think what that means to me is, having grown up there, and I'm no Ronald Reagan - I'll say it before someone else does - I -- I think he -- he -- he went through hardship. His father was an alcoholic. They moved a lot. He actually lived in five different homes in Dixon. He worked, as we know, as a lifeguard. His mother took care of him and made him go to church, made him read his Bible, and neighbors looked after him, and it was -- it was a great place to grow up. And I think that's what helped him become the man he was. And I appreciate so much having the privilege and honor of being here and serving as State Senator and being from the same hometown as Ronald Reagan. Thank you very much, Mr. President.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Cullerton.

SENATOR CULLERTON:

Yes, thank you, Mr. President, Members of the Senate. It's very appropriate for us to honor the only President of the United States who was born in Illinois, and I understand, of course, why, for many Republicans, he's been described as a hero, but I think it's worth noting that there are many, many Democrats who admire Ronald Reagan as well, including our former colleague, the President of the United States, Barack Obama. He

had mentioned Governor Reagan -- former Governor Reagan and President Reagan in very positive terms. And I recently read an article about his record and I think I was reminded of how practical a man President Reagan was. Eugene Robinson wrote an article in The Washington Post and described him as pragmatist who respected objective reality". We should not forget that he was the Governor of California, and back in 1967, the entire state budget in California was six billion dollars. They had a big deficit and he worked with the Democrats and, yes, raised taxes to -- by a billion dollars to help balance that budget. And when he became the President, we all remember, of course, the Economic Recovery (Tax) Act of 1981, where he recognized that the state -- or the -- the federal taxes, some of which were in the seventy percent range, had to be reduced, and he worked with the Congress to lower those taxes. But later on, when it turned out that there was a -- a need for cooperation, he worked with Tip O'Neill, he worked with Dan Rostenkowski, and as Alan Simpson, a former U.S. Senator from Wyoming, said recently, ended up raising taxes and added back about half of what had been cut back in 1981. Well he did it because he realized that there were basic services that the government had to provide and that deficits were a bad thing. So, with that in mind, I think it's appropriate for all of us in both parties to think of his memory and the lessons that he taught all of us, that the -- as Senator Radogno said, he -- he would be an -- the great communicator, someone that could state his conservative positions, and yet still have respect from everybody in the land. So with that, I think it's very appropriate that we honor him today.

Senator Radogno, for what purpose you seek recognition? SENATOR RADOGNO:

Thank you. You know, some of these retirement resolutions

are harder to do than others and this one is really, really It's interesting when we think of people that we've worked with for a long time, how our view of them changes over And Brad's been here since I got here and was here actually before that. When I first came in, you know, you're kind of quiet and you observe people and sort of figure out, you know, what their place in the system is. And my first impression of Brad was, he -- he was kind of quirky, shall we say, and funny, and so made light of a lot of situations. he can make a lot of funny noises with his mouth that are basically musical instruments - and we don't need elaboration from the animal house folks of other noises - but he was just sort of goofy in many ways. But as I got to know him, it became more and more clear that he really, first of all, had a very good understanding of issues, particularly education and higher education; that he not only knew the issues, but he had a very consistent framework from which he made decisions. You -was predicable and he was able to explain his positions, so whether you agreed with him or not, he always made sense. But most importantly, the thing that I've learned about Brad, and especially in the last few years as Leader, is that he is an incredibly good people person. You can count on him to smooth a situation, both with humor and with reasonableness. And he does it in such a manner that no matter what news he's giving you, no matter how much you don't want to hear it, you never feel hurt or offended or bad. And in this environment, when we operate under stress all the time, when there's always issues coming up that you just want to smack someone or you're frustrated, I can always count on Brad to help smooth that situation over and he

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. To the resolution, if I might. Ladies and Gentlemen of the Senate, I began my relationship with Senator Burzynski when I was first elected to the Senate in 2002, and not unlike the speaker, when I first encountered Brad, I thought, well, here's a -- seems like a decent fellow who has a handle on a number of the issues, particularly education issues; he seems a little different in some ways, which then we get to know that everyone's got their differences in -- in several ways. He's made his mark in this Chamber and in this State on a number of issues, most notably education. But when I think -- when we get into next week and the next month and however long after that and I think back about my service with Senator Burzynski, I'm not going to think about issues; what I am going to think about is -- is that Brad Burzynski was always someone who was willing to stand up in this Chamber, even if he was the only one, to say, "You know what, maybe we shouldn't do this. Sometimes the answer isn't for government to do something new or try to do something else. Sometimes government should

And that is a governance theme that I have always tried to adhere to and my struggle to adhere to that has been made easier with my relationship with Brad Burzynski. Brad, we are going to miss you. This Chamber is going to miss you. This institution is going to miss you. Thank you for sharing your time with us by serving here. Thank you, Mr. President.

Senator Murphy.

SENATOR MURPHY:

To the resolution, Mr. President.

SENATOR MURPHY:

As Leader Radogno said, some of these are a little bit harder than others, and we've certainly had a lot of 'em lately and they've been difficult for me. Personally, this one is

harder for a couple of reasons. The first is, Brad, in the four years I've been here, has probably been my best friend here and I'm going to miss him. Senator Bivins.

SENATOR BIVINS:

Thank you, Mr. President. Twice in one day. Brad Burzynski and I go way back to my sheriffin' days and we've known each other for a really long time, and since we've -- I've come to the Senate, gotten to know him a lot -- a whole lot better. And, you know, I thought it would be kind of neat to do like a roast, but it suddenly dawned on me that -- that I've never roasted anybody before. So, I kind of went to the Internet and did what everybody does today and I put in "how to roast". And the first webpage that came up, it said, under how to roast -- and the first webpage, it said -- said this, under

So thank -- thank you, Brad, I appreciate that to this day. It was my Minnie Pearl moment. I looked there and it was gone Well, so I summoned all my investigative skills and followed the trail of evidence and had an informant and found out that Senator Burzynski -- in his bottom drawer was my sack of candy, along with about five others. And, Brad, I can tell you that -- now, that Syverson didn't tell me that, but he had as many bags in his drawer as you did. Brad, I'm not going to say I miss you, because you call me every day or I call you and I know that's going to continue. I know that we'll probably be going out to dinner in the future here. And -- but I'll probably just close by quoting Mr. Spock from -- from Star Trek in The Wrath of Khan when he said: Jim - Brad - you have been and always will be my friend. Live long and prosper. God bless you, buddy.

Senator McCarter.

SENATOR McCARTER:

To the resolution. I felt fortunate when Senator Burzynski called me before he made this official announcement to -- when he called me and let me know what he was going to do and, you know, explained it, but he -- in the conversation, he said -- he said, "Kyle, what have I always told you?" And I -- I -- just for a little bit, I thought and I -- and I -- and my response was - always vote No? And he said, "No, that's not it." And

then he gave me one -- some other, you know, pearl of wisdom, which I think I've forgotten already. But, you know, your -- your greatness in life is -- is many times determined by the people that you associate with, the people that you choose to associate with, and -- and you only become as great as -- as they are many times. So, I'm -- I'm very fortunate to have been able to be counseled by him in the couple of years that I've been here. And just say that my -- my -- my greatness potential has increased by my association with him and my -- I - I know my life and my career has been enriched. Thank you.

Staying on that row, Senator Risinger.

SENATOR RISINGER:

Thank you, Mr. President. To the resolution. You know, Senator Burzynski is an interesting quy. I first met him when I got elected in 2002 and I kind of characterize him as having a -- mothering, you know. He -- he is a guy that, you know, comes up to you and says, "Are you okay?" You know, "How's things going?" He was a guy that you could talk to, confide in. You know, he never really made any judgment on -- on what you were talking about or -- or -- but he -- but he allowed you to vent. He also allowed you to reflect on what you were saying and -and -- and always did it in a light way and -- and made you feel good about it. I don't know whether they -- you know, when you're -- when you're here for the first time and you're -- you get -- you know, it's an awesome Body. But when you're here for the first time, it's like, "Oh, my gosh, can I really even do this?" and so forth. And I think Burzynski may have been put kind of in charge of me to make sure that, you know, that I was

-- I got through the first Session okay. We got near the portion of the -- of the first Session where I had not had my first bill and -- and Burzynski was concerned about that, and so he allowed me - I know you remember this, Brad - but he allowed me to pick up one of his bills and he gave me one that I can tell you that anybody in this Chamber or anybody on the street or anybody could have passed, because it was a nothing bill. And -- and I'm sure that he thought, "You know, here's this engineer and I know he can't do a very good job of this, so I'm going to give him something to make him feel successful." And -- and then he turned around and wrote on the sheet, "What a great job you did!" You know, all that. Well, you know, it was really pretty simply. But I -- Brad Burzynski is the Senator for my daughter who lives up north, and I asked her, I said, "You know, what do you -- what do you think about Senator Burzynski?" I said, "We've got a -- a young lady that's going to come in", and I said, "you know, I've -- I've met her and I -- I'm very impressed by her." I said, "I think that she's going to do a good job, but what do -- what do you think? You know, you live in his district." And -- and she said, "You know, Senator Burzynski has a -- has a track record," she said, "and we're very proud of him. He's done a great job for his district. He's represented the people in the district like we feel that they should be represented. And his replacement, I'm sure she'll do a good job, but, you know what, she hasn't proved herself yet. That -- that yet remains to be seen, you know. So, you know, we'll withhold judgment on that, but" she said, "Senator Burzynski has a done a -- a really good job and -- and we're going to miss him." I -- I guess I'll close by saying,

And the one thing that I know you feel strongly about is spending more time with the grandkids and I can relate to that. And we've talked about the race that we were having and -- you're having a grandchild, I'm having a grandchild. So in -- in all of this, this Session, you had come to me and said that you gave your one and your only quick-take vote to me, so -- for that, I rise. And I thank you very much for all the time that we've shared and the laughs that we've had. And you are going to be missed, so make sure you come back and visit. Thanks, Brad.

Chris Brooks with WICS-TV requests permission to videotape. Seeing no objection, leave is granted. Senator Schoenberg. SENATOR SCHOENBERG:

To the resolution. Mr. President and Ladies and Gentlemen of the Senate, twenty years ago, I went to new Member orientation and sat down at lunch at a table of eight, a round table, to the right of Brad Burzynski. That's probably the only time in twenty years I've been to the right of Brad Burzynski. But I had just come here and I found myself sitting next to somebody who just reinforced over the years what my -- one of my favorite parts about my job here is, and that is, I learn so much every day from people from different parts of the State, different points of view, different ethnic or cultural backgrounds. We're all brought together towards a common purpose. It wouldn't be interesting if we all thought the same.

It wouldn't be -- we wouldn't grow personally if we all came from the same place and shared the same views and weren't challenged intellectually to reconcile that towards a common purpose. And I really think it's possible to -- to achieve compromise without relinquishing your principles. delicate balance, admittedly. But what I learned that day -- it was the first time I sat -- Brad Burzynski was from the -- had a close relationship with the Illinois Farm Bureau. He was the Farm Bureau guy. Well, I was from Chicago's northern suburbs and the closest I came to a farm was either at the Lincoln Park Zoo or watching Green Acres on television. But, yet, Brad Burzynski had a different range of experience, a different point of view, and, to me, that was really an awakening, at that new Member orientation, of some of the great challenges that we'd all face in our work. So for all the insights and humor and, yes, even those noises that have been alluded to earlier, but more importantly, for your perspective, for your values, for your commitment to making this institution such a wonderful place, I want to extend my thanks for all the professional courtesies and the personal courtesies that you've provided over the years as we've traveled from across the building to here. Thank you very much.

Senator Syverson.

SENATOR SYVERSON:

Thank you, Mr. President. You know, I first met Senator Burzynski about twenty years ago. Interesting enough, I had first met him in my lawyer's office. I'm not sure what he was doing there and I've never asked him that -- that question. But -- but since that time, we have become very good friends with -- with Brad and his -- his bride, Judy, and we have done a lot of

things together. Our districts intertwine and so our offices in -- in Rockford are in the same building. We've done events and parades, too numerous to count, over the years. And it's interesting, due to gerrymandering - and I think the Senate President can appreciate the gerrymandering issue - but thanks to gerrymandering, my wife actually got to vote for Brad Burzynski more times then she voted for me in the first -- in that first term, and Brad likes to bring that up that she supports him more than -- more than I do. The last fifteen years, however, Brad has lived with us in "animal house", along with Senator Murphy and Senator Hawkinson and Rauschenberger and Representative Bost. And any time people back home think that being in the Senate is so glamorous, they just need to come and spend a couple days at "animal house" and they'll have a better -- they'll have a better appreciation of what's happening. -- but as far as Brad goes, I mean, Brad is a giver. Last speaker, Senator Cullerton.

SENATOR CULLERTON:

Well, thank you, Mr. President, Members of the Senate. When one of our Members leaves after serving for twenty years, I believe, it reminds me of why I personally am opposed to term limits. Now, obviously, having been the -- the Dean of the Senate - I was in the House twelve years; I've been here thirtytwo years - you'd -- you'd say, of course, you're against term limits, but term limits are something that would deprive us of having people who have an institutional memory like Senator And it turns out, by the way, before this last election, before the number of retirements that we had and people who lost elections, I did a count, and in my twenty years in the Senate, there were a hundred and four Senators who had come and gone - fifty-two Democrats and fifty-two Republicans now, of course, there's -- there's more. And, so, Senator Burzynski, I -- I checked the records and I -- I realized that I actually served with you in the House for two weeks before I was appointed to the Senate to fill an unexpired term. And I think that it is an advantage for the few of us who've served in the House to fully appreciate how great the Senate is. And that's something which I think is a -- is a great benefit for -

- for us. I know that you were not part of the "Fab Five". A lot of people here might not remember the "Fab Five" or know the "Fab Five". I think it was Senator O'Malley, Rauschenberger, Fitzgerald, Syverson and Lauzen. So you were at least their mentor when you -- when you came over and you -- you were their inspiration. Now you are leaving under the best circumstance. We've talked about the way you leave here, right? You lose, you die, you -- you run for another office. I think maybe the best way is to retire at a full pension. Now, there are people here who want to take away your pension the day you walk out of here. I think that would be unconstitutional and I will fight to make sure that you continue to have it, but that might come up. would certainly, though -- I don't find it ironic that we honor Ronald Reagan and Brad Burzynski on the same day, because if Ronald Reagan was known, as I said earlier, as a conservative person, well-respected and well-liked by everyone, including the Democrats on the other side of the aisle, then that's Brad Burzynski. Congratulations. You're always welcome back.

You know, before I make my comments, maybe you better vote on the resolution. No, I'll tell you, I -- I just want to thank all of you for those kind comments. But more importantly, I want to thank those of you who had the good sense not to say what you really think. That's important today and I -- I do appreciate that. You know, I -- I have to tell this story - and -- and Senator Forby's not here --

I -- I -- I've been sought out and people want me to run for State Rep." And I mean it was silent on the other end of the phone and my dad said, "Oh, Brad, what do you want to do that for?" And I'm going, well, he's thinking, you know, I'm going to spend time away from my family, I'm giving up a good job, I'm going to take a pay cut, all of these kinds of things. First words out of my dad's mouth - and by the way my dad's passed away now but the first words out of my dad's mouth, "Brad, now everyone down here will know you're a Republican!" First words, true story. So, you know, it's -- it's an interesting life that we live. And I want to tell you, before I decided to make this -this step in my life, I thought I'd call some of my former colleagues and just ask them a little bit about retirement. So I called, as you might guess, my good friend, Senator Petka; my good friend, Senator Sieben; Senator Peterson, who I came over with from the House; and -- and Senator Dudycz. And I asked the following questions: I said, "How many days are there in a week now?" And Senator Petka said, "Easy, Brad," he said, "six Saturdays and one Sunday." I thought, well, that's a pretty good thing. And then next I asked, I said, "When's a retiree's bedtime?" And Senator Sieben said, "It's three hours after you fall asleep in the recliner." Yeah, that -- that was pretty good. So I -- you know. And then I said, "Well how many retirees does it take to change a light bulb?" And Senator

Dudycz answered, "Brad, it just takes one, but it might take all day." And then last I asked, "Why don't retirees mind being called seniors?" To which Senator Peterson replied, "Well, being a senior citizen comes with a ten percent discount." So, you know, those are some of the words of wisdom I had from those guys, but, as you all know, that's not why I decided to retire. I want to spend a little more time with my grandchildren - three in Cincinnati, two in -- in northeastern Illinois - so we can have that opportunity. And to be quite honest, I think there comes a time in all of our lives, regardless of what our ages are, and I'm relatively young yet, that we know it's time to move on, to move to a new chapter in our life, to take care of our family. My wife and I have been married thirty-five years. I've never had a job where we could plan weekends, where we could plan, you know, evenings. Summers, the last few years, we couldn't even plan. So this is going to be a -- an opportunity to really become more familiar, and -- and, you know, we have so many things to be thankful for. There have been so many nice comments said today, I -- I just can't begin to respond to them, but I do appreciate them. And some of these guys that have made comments are -- are a lot like the little brothers that I'm glad I never had - Syverson. But, anyway, I really do appreciate I think that it's important to really talk about some of the things that go on here. And, you know, in this Body and on the Floor, in committees, we become very, very partisan. But I want to tell you, one of the highlights of my career has been serving on JCAR for the last fifteen and a half years, getting to know people across the aisle even better, and recognizing that we can come together in -- I'm not going to say a

bipartisan, I'm going to say a nonpartisan atmosphere, to do our jobs and to address the needs of the citizens of the State of Illinois and to hold agencies accountable as well, for what they And I think in the fifteen and a half years I've been there, I -- I can only think of a couple of times when issues have become somewhat partisan - and, folks, it didn't start with the Members of this Body. Came from across the aisle. So I'm very proud of that fact, that we all have worked so extremely well together on JCAR over the years. And I -- I really relish that and I wish that that attitude of cooperation could carry over into the General Assembly. A lot of reasons, perhaps, why it can't, but I really think that that should be one of our goals to do that. You know, there are so many people that we -when we leave here that we need to thank, and, you know, first of all, I -- of course, all of my colleagues for putting up with some of my antics over the years and for recognizing that kind of what you see is what you get with me. And I -- I do really, truly appreciate that. For staff members. And, you know, as I look around and as I think about all the staff that I've seen come and gone in the -- in the last few years. And -- I see Jeanette back there. Hi, Jeanette. And that, you know, a lot of these staffers, in the twenty years I've been here, I've seen them come on staff, I've seen 'em get married, I've seen them have children, you know. That's another reason -- reason sometimes when it's time for you to go, you know you've been through a whole new generation. But, anyway, I have really appreciated the support that I've seen from our staff and I think we have the best staff out there. I know that if you were speaking, you'd say you have, and that's understandable.

ought to feel that way, because we have good people on both sides trying to do the things that they think are important for their Members. And I appreciate the fact that the citizens of the 35th Senate District have seen fit to let me represent them here over the last twenty years. Now I'm going to do something that I've always wanted to do on the Senate Floor, Jeanette. And those of you that know me -- and -- and I go about my district and I speak to a lot of groups and everything else, but a lot of times I leave with just a word of hope. A word of advice and it goes something like this: "Oh, America keep holding to God's hand. Keep the light of freedom shining bright to every land.
