The Fund is primarily supported by the fee that is already assessed by the clerk of the circuit court of each county to support State Police operations. This fee, which cannot exceed fifteen dollars, is charged to a defendant convicted of or granted supervision for any felony, traffic, misdemeanor, conservation, or local ordinance violation. It would apply --it would apply the fee assessed for certain conservation violations to the Conservation Police Operations Assistance Fund, instead of the State Police Operations Assistance Fund. This is a -- this is an agreement between the Natural Resources

Department and the State Police, and I ask for your consideration.

SENATOR MARTINEZ:

Senate Bill 1612 clarifies that the Department of Healthcare and Family Services may put a lien on assets of a responsible parent with overdue support obligations despite any contrary provision of State or local law. This bill also amends the Public Act {sic} (Aid) Code to allow HFS to certify to the Department of Health and Human Services that a responsible parent is past due on child support and, therefore, can now be denied a passport. bill provides that the responsible parent must exhaust all administrative remedies before proceeding to judicial review. This is an initiative of the Department of HFS. I'll be happy to answer any questions.
