Senator Righter, excuse me, just one second. Ladies and Gentlemen, if we could have your attention. Please -- please lower the sound level in the Chamber. It's too noisy. Please lower it, please. Senator Righter, continue if you would, please.

SENATOR RIGHTER:

Thank you, Mr. President. Senator Jacobs, it's my understanding, as the bill sits before the Chamber, that the tax credit for the animated films is structured a little bit differently than the traditional tax credit we think of when we think of for the movie industry or whatnot. Is that correct? And can you -- can you tell me a little bit about that?

Senator Jacobs.

PRESIDING OFFICER: (SENATOR SULLIVAN)

SENATOR JACOBS:

Yes, Senator. In a traditional film, they shoot the film in like a seven-month period and then they're eligible for the tax credits. Animation film, because it's new and more technical and doesn't just involve actors, but involves a lot of engineers and a lot of new engineering factories, it provides for payment in -- in quarters and -- you know, on completion of

the film, 'cause it takes three years to complete the film. So your suggestion in committee was a good one; that it ought to be a once-a-year payment. And I think that's probably the way that we'll move in the House, but, you know, the Film Office of Illinois will probably weigh in on that too.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Thank -- thank you, Mr. President. So, Senator, if -- it's my understanding the reason that the bill is drafted the way it is, is because the production time for one of these animated films can be four or five times as long as it would be for the typical movie industry, and to string someone out that long, without getting any benefit of the -- of the tax credit, is the real issue here. That creates a real problem for them. And it's your intention to see that over in the House that language is massaged somehow to make it workable for everyone and allow us to attract the -- the commerce that you're hoping to, to your district and other parts of the State, correct?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Jacobs.

SENATOR JACOBS:

...sir, and you know, when we started this bill, it was just a -- a little local group. But it's turned into the broadcast -- the groups and the Motion Picture Association. So we think they're going to have a simple answer so that we can produce more films in Illinois, because -- especially animation. In my district, the company's bought an animation studio and they're hiring ninety people and they're going to hire them as

engineers. And they're going to stay in the district. They're going to buy houses and they'll be there for three to four years.

SENATOR RIGHTER:

To the bill.

SENATOR RIGHTER:

Thank you, Mr. President. Thank you, Senator Jacobs. I simply rise in support of the bill. Clearly, this bill is not done yet, but it's -- it's near done and this is something that needs to be addressed with regards to the tax credit to ensure that we have the opportunity to bring these more high-end longer-lasting positions into this -- into Senator Jacobs' district and the rest of the State. So I urge an Aye vote. Thank you, Mr. President.

In some areas where there is not currently renewable energy products, it would create those. But this is similar to municipal-owned electric companies. Most specifically, the interest has been around wind farms.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Now you used a municipal utility as a -- as an example. I mean, is -- is this going to be a district whereby there's going to be energy sufficient {sic} produced to take a certain area, a municipality, or part of a county, off the grid? Or I -- I guess -- what -- what incentives -- or, are there incentives being put forth by the -- does this allow the local area to put forth incentives by being a district? I -- I guess I'm trying to figure out what's the draw. What makes that area then more attractive to put a renewable energy center in?

So your first question was about taking off the grid. No, they won't come off of the grid. I mean, the -- especially if it was wind-generated, there are times that it can't support utilities. But it'd be part of another mix on to the grid. The

real incentive here came from a township supervisor in northern Champaign County who sees great potential to perhaps reduce property tax burdens for people if we are able to generate revenue through these districts in order to help support local governments.

Senator Frerichs made a good point, Mr. President, pointing out I butchered that last question. If I could try one more time. That's what I'm asking is.

Thank you, Mr. President. Senate Bill 1357, as amended, makes several changes to Compliance Commitment Agreements under the Environmental Protection Act. Those include the following: imposes a three-thousand-dollar penalty for Number 1, it violation of a Compliance Commitment Agreement; number 2, it provides that if there's no response to a proposed Compliance Commitment Agreement within thirty days, it's deemed rejected; number 3, it provides that either a -- a CCA or notice should be given to the violator in the event that the Illinois Environmental Protection Agency does not want to go forward with a CCA; and finally, it makes successful completion of a Compliance Commitment Agreement a factor to be considered by the Attorney General's Office when she is deciding, and her office is deciding, whether to bring a lawsuit against the violator. I want the Body to know that we engaged in extensive negotiations and discussions with the regulated community, with the Attorney General's Office, with the Illinois Environmental Protection Agency. I think this is a good solid bill. All the -- the folks that are not listed as proponents are neutral and -- and therefore, I think, this a good bill. We should all vote a green and I'd be happy to answer any questions.

SENATOR WILHELMI:

Senator Righter, the regulated community has slipped the bill -- or the amendment, in committee, as neutral. Been dealing with folks like Todd Maisch from the Illinois Chamber, Patrick Evans from the Illinois Energy Association, the refineries that are located near my district, which would be ExxonMobil and CITGO; talked to folks from Dynegy and Midwest Generation. We really did engage in meaningful and -- and extensive negotiations. Their biggest concern, and what we were able to provide in this bill, is that the Attorney General will have to look at compliance with -- with these agreements as a factor in determining whether to file a lawsuit after a CCA is negotiated and entered into.

It's my understanding, Senator, that in compliance -- that one of these cannot be resolved without the involvement of the Attorney General. And I want to ask, a, if that's true, and if it is, why? If -- why can't the agency deal directly with, you know, someone who may be an alleged violator?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Senator. There's two issues, actually. I want to make sure the Body is aware that the amendment -- the bill, as amended, says three-thousand-dollar penalty. We are going to take that over in the House, if it passes today, and reduce that to two thousand dollars. So I want to make that point clear. And number 2, with regard to the negotiations between the regulated communities - so let's say the alleged violator and the agency - those are the only two parties that are engaged in negotiations with regard to a Compliance Commitment Agreement. And if there is, in fact, a negotiated CCA, then the agency is prohibited from sending that on to the Attorney General. It's only when there's a violation of the CCA that the Attorney General's Office can come in and file a lawsuit. So I hope I've answered your question. And -- and again, this is very sensitive because we want to be supportive of our employers, we want to be supportive of our businesses. But as even some of the folks in the regulated community have said to me, if we violate the CCA, then it's fair to move that issue to the Attorney General's Office and it's also fair to assess a reasonable penalty. We were at ten thousand when we started; we're down to two thousand. We'll make that change in the House.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Mike Jacobs.

SENATOR JACOBS:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will yield. Senator Jacobs.

SENATOR JACOBS:

Senator, is there anything that the Attorney General doesn't do in Illinois? I mean, it's becoming apparent to me that she's -- or, whoever is there is going to be a very busy person. They're in charge of regulating utilities, they're in charge of seniors. I mean, it's coming close to the -- the -- Governor -- Office of the Governor. Do you think this is really an appropriate time to expand a statewide constitutional office when we've really kind of cut back on those kind of dollars? PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Wilhelmi.

SENATOR WILHELMI:

Senator, under current law, the Attorney General's Office has jurisdiction on this issue and on these alleged violations. So, under current law, if a CCA is negotiated and entered into between the Illinois Environmental Protection Agency and the -- and the employer, the alleged violator, she is -- the Office of the Attorney General is not involved in those negotiations, currently. So what this does is it modifies the Act so that CCAs are actually more meaningful, so that they have more of an impact. It sends the right message to the US EPA, which is also a concern for our State. And -- and so, at the end of the day, I don't believe that this is expanding the -- the authority or the powers of the Attorney General's Office. And, in fact, with that last provision that I mentioned, that the Office must take into consideration compliance with these agreements as a factor, is something that the regulated community favors.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Pankau. SENATOR PANKAU:

SENATOR PANKAU:

If I remember this correctly from committee, if -- if a business has a violation of some sort and the business says "Yes, I'm going to clean it up" and the EPA and the business agree they're going to clean it up and this is how they're going to do it, the penalty you're talking about only comes into play if they don't clean it up. Is that correct?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Wilhelmi.

SENATOR WILHELMI:

Yes, Senator. So if there's continuing violations after the CCA is executed and negotiated, then the two-thousand-dollar penalty would kick in, not before.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Pankau.

SENATOR PANKAU:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill.

SENATOR PANKAU:

I urge an Aye vote on this bill. We want business to clean things up, and if they agree to do it, then they should do it. Right now there's no hammer to say you got to do it - you agreed to do it, so now do it. And I believe this is a really good bill. I urge an Aye vote.

Continuing on the Calendar is Senate Bill 1360. Senator Mulroe. Senator Mulroe seeks -- Senator Mulroe seeks leave of the Body to return Senate Bill 1360 to the Order of 2nd Reading. Leave is granted. Now on the Order of 2nd Reading is Senate Bill 1360. Mr. Secretary, are there any Floor amendments approved for consideration?

ACTING SECRETARY KAISER:

Yes. Floor Amendment 2, offered by Senator Mulroe.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Mulroe, on Amendment 2.

SENATOR MULROE:

Senate Bill 1361.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Mr. President and Members of the Senate, I rise today in support of 1361. This bill is a continuation of the Illinois Motor Vehicle Theft Prevention Act. This Act was passed in 1990 and has been in place for approximately twenty years. It is currently set to sunset in January of 2012. This bill extends the Act for another four years. This particular legislation is funded by a one-dollar fee on every automobile policy in the State. That money is then put into a fund to help fight auto theft. There is a council put together that is made up of law enforcement and prosecutors and insurance companies. That council meets regularly to disburse this money throughout the State to help fight auto theft and the prosecution of people that commit auto theft. I would be happy to entertain any questions or comments from my colleagues.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Is there any discussion on Senator LaHood's first bill? Senator Koehler, for what purpose do you rise? SENATOR KOEHLER:

Thank you, Mr. President. Question of the sponsor.

Indicates he will yield. Senator Koehler.

SENATOR KOEHLER:

So help me understand this. This has to do with auto

thefts, so it's -- it's based on cars?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Yes, Senator Koehler, this is a bill that helps prevent auto thefts in the State of Illinois.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Koehler.

SENATOR KOEHLER:

And, Senator, where -- where do cars travel? What -- what do they use to travel on?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

In my Senate district, they usually travel on roads.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Koehler.

SENATOR KOEHLER:

And what kind of roads might be included? Would they be local county roads or even State roads or federal highway systems?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I think all of the above, Senator Koehler.

Senator Koehler.

SENATOR KOEHLER:

Would this perhaps be a conflict of interest? Isn't -- isn't there a family member who is in charge of federal highways and transportation systems?

Senator LaHood.

SENATOR LaHOOD:

Yes, there may be a conflict there and I -- maybe you want to refer that to somebody, Senator Koehler, to have 'em look into it.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Koehler.

SENATOR KOEHLER:

To the bill, Mr. President. I think we need an investigation on this. But I just want to welcome my -- my colleague and my good friend, Darin LaHood, to the Senate.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Bill Haine. Senator Haine. SENATOR HAINE:

Thank you, Mr. President. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will, reluctantly, yes. Senator Haine.

SENATOR HAINE:

So we have a bill here, and you're from Peoria. Is that correct, Senator?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood. Senator Haine.

SENATOR HAINE:

It says that this -- this establishes an eleven-member council and this council is appointed by the Governor, but it requires various police agencies to belong. And it says that they shall serve without compensation, right?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

That's my understanding.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

SENATOR HAINE:

As we read further, as always in Illinois, it says, "however", and that's always the best part of every bill - "however". They will be reimbursed for quote, "reasonable expenses incurred". Senator, I -- Senator, the people of Illinois demand a cap on these expenses. Do you have any plan to define reasonable expenses? We know how things are in Peoria, with your current State's Attorney and your former Sheriff George Shadid. We know how things go in Peoria. People of Illinois want a cap. They want a definition. Do you have any?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Senator, there is no cap in this particular legislation. However, my understanding is that, over the last twenty years, those expenses have not been unreasonable.

PRESIDING OFFICER: (SENATOR SULLIVAN)

SENATOR HAINE:

Well, Senator LaHood, I appreciate that vague answer. You will make a fine Member of this Senate and I will do everything I can to assist you in defining the word "reasonable" in the coming years. Thank you, sir.

Thank you, Senator. Further discussion? Senator Murphy.

SENATOR MURPHY:

A question of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will yield. Senator Murphy.

SENATOR MURPHY:

Thank you. Thank you. Now, Senator LaHood, this is -- this is an auto theft bill? Do you have some area of expertise with regard to auto theft?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I do not.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy.

SENATOR MURPHY:

Well, if you're not an expert on the bill, why are you carrying a bill about auto theft?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

The bill came through my Transportation Committee. And in

terms of law enforcement being supportive of this, the -- there are seven task forces around the State setup to fight auto theft, and there is one in Peoria. It's headed by the Bartonville Police Chief. He has contacted me and expressed his support for the bill. And so I became familiar with it through him and also through Senator Millner on the Transportation Committee.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy.

SENATOR MURPHY:

Senator, I can recall my first bill and being nervous and I -- I can appreciate why you might be. You know, I just feel compelled, though, to remind you you're under oath and just want to give you one last chance, if there's something you want to get off your chest about this whole your history with auto theft issue.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I don't have anything to get off my chest at this time, Senator Murphy.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy.

SENATOR MURPHY:

One last area, I thought it was interesting your response to Senator Koehler's question about what -- what cars are driven on -- auto are driven on. And you said, in response to Senator Koehler's question - in my district, they're ridden on roads. And I was wondering if you were suggesting, somehow, that in

Senator Koehler's district - which if I recall correctly, in the current map, is right next to yours, but may in the next map include yours - if you were suggesting somehow that the people of Senator Koehler's district don't drive on roads.

SENATOR LaHOOD:

That's a very good point and I may want to reconsider those comments in the future, Senator Murphy.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Murphy.

SENATOR MURPHY:

To the bill: Darin we are glad to have you here, you're a tremendous addition. We miss your predecessor, as we miss a lot of the people who have left here. But you're a breath of fresh air for this place. We're glad to have you with us. And I encourage an Aye vote on the Senator's first bill.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Bivins.

SENATOR BIVINS:

Thank you, Mr. President. Question of the sponsor.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will yield. Senator Bivins.

SENATOR BIVINS:

Senator, don't you think it's a little presumptuous to hold a press conference before you've even passed your bill?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I have not held a press conference thus far, Senator Bivins.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

Apparently you have scheduled one, because I've got an email right here. It says "Join LaHood, Quinn and other Leaders at the Illinois Distracted Driving Summit."

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins. Excuse me, Senator LaHood.

SENATOR LaHOOD:

I will not be participating in that press conference.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

So, you're going to blow off the Governor then? You're just going to ignore him? Is that -- that the problem?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I stand by my statement. I will not be participating in the press conference.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

But this does have your name here, Senator LaHood. You're hanging out with the Governor, holding a press conference. Distracted driving - is -- is that not what the bill's about?

PRESIDING OFFICER: (SENATOR SULLIVAN)

SENATOR LaHOOD:

This bill is about auto theft and I'll be happy to talk to you later about that other press conference.

Senator Bivins.

What LaHood are they talking about?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

There's -- there's many LaHood's in Peoria. It could be -- it could be a lot of different ones.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

Could you be a little more specific?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

I'll have to look a little further at what your press release says there, but I -- I think I may know who you're talking about.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

And -- and who would I be talking about?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

It may be the Secretary of Transportation.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

Whose name is what?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Last name is LaHood, yes.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Bivins.

SENATOR BIVINS:

Never heard of him. Senator, welcome, you're a great asset to the Senate. Enjoy working with you and look forward to working in the future.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Kotowski.

SENATOR KOTOWSKI:

Thank you very much. Thank you, Mr. President. To the bill, please.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill.

SENATOR KOTOWSKI:

You know, I -- I'm very troubled by this legislation here, just for a number of reasons. You seem like a really decent person. We've talked and you just -- people say great things about you, but the Chief, Senator Millner, never gives up bills. I've never seen him give up a bill once. And if it's a bill

that's to someone's advantage, I've never seen him do that. So I'm worried about that, that he's given you a bill that's going to hurt your career. Sometimes Millner's been known to do that - kind of a secret. Look, he's got his back turned to you. He's not even covering you right now. He doesn't care. See? That's an example of Millner not caring. The other thing is, I'm really worried about this bill 'cause it just seems like a big government, pro-tax, additional expenditure bill. There's eleven members on the council. I think that's too much. Why are there eleven members on the council? Why not six? You got a lot of members of bureaucracies involved here. You got -- so look at this, you got the State's Attorney of Cook County, the police department, you got -- you have just a whole group of seven people appointed by the Governor. Why seven people? Why not four? Why not -- I don't understand, why eleven?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Senator Kotowski, I appreciate your comments on that. The eleven-member council was setup in 1990 when the bill was originally passed. And as I mentioned before, this is a very good public-private partnership, because there are no taxpayer funds used at all. This is money that comes from the insurance companies and -- and so the -- my understanding is, the elevenmember council has worked effectively and efficiently over the last twenty years.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Kotowski.

SENATOR KOTOWSKI:

I'm glad you brought that up, because I have a question for you about -- about the number of vehicles -- thefts that have been reduced. Do you have figures on that? Since this bill has been your -- you want to continue it, but have we reduced vehicle theft in the State of Illinois?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

When the task force was established in 1990 - 1991, there was close to eighty thousand vehicle thefts in the State of Illinois. Since that time, the last figures we used, 2009, we reduced it by sixty-eight percent. We're now at a figure of about thirty-four thousand auto thefts in the State of Illinois. So it's drastically come down. We're obviously not there yet and still have a ways to go.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Kotowski.

SENATOR KOTOWSKI:

I just think that's false. I -- I don't know where you get your information from. I don't know where -- you know, I had a car that was stolen just a couple of weeks ago. I know a lot of people get cars taken. I -- I don't know where your figures are coming from. Did COGFA look at this? I mean, what kind of analysis was done? Did the Auditor General look at this bill? This is very troubling to me and I want theft to be reduced. And to the previous point about reasonable expense, did you say the insurance industry is paying for the reasonable expense or is taxpayers?

PRESIDING OFFICER: (SENATOR SULLIVAN)

SENATOR LaHOOD:

The -- the expenses that Senator Haine mentioned, those reasonable expenses, are paid for by taxpayers.

Senator Kotowski.

SENATOR KOTOWSKI:

That's what I thought, another big government, pro-tax bill proposed by your side of the aisle. Well, I, for one, am not going to stand for it. All right? Not going to support -- more revenue, more big government, more spending. I like you; I just can't stand this bill. Okay? You're a good man. Good luck to you. Welcome to the General Assembly.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Jacobs.

SENATOR JACOBS:

Point of information, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Please ask your question.

SENATOR JACOBS:

I want everyone to realize that young Senator LaHood is a resident of my district. He grew up in Rock Island County. His father was my catechism teacher. He later went on to work for Bob Michel. And then later, he was elected to the Congress himself. Was standing with the gavel, the last time I saw him. Then he was appointed by the President to the head of Transportation. And thank God that the LaHood family moved out of Rock Island County, because I wouldn't want to face you. But I would ask one solid question. Is there a single road in

Peoria that hasn't been paved?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

There are several roads in Peoria County that have not been paved.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Raoul.

SENATOR RAOUL:

Hi, Senator. How are you?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he's okay. Senator Raoul.

SENATOR RAOUL:

You know, Senator Millner is a friend of mine. I'm wondering, is there a provision in your bill to prevent bill theft? Is there?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

SENATOR LaHOOD:

Not that I'm aware of.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Raoul.

SENATOR RAOUL:

Would you consider pulling your bill out of the record so we can get that provision in there? Or do we have to make a change in the rules because of your bill theft of Senator Millner's bill?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator LaHood.

The answer is no.

Senator Raoul.

SENATOR RAOUL:

I've got about five more questions. No, I've -- I've got a question about the council and its composition. I see that there's a member from the State's Attorney, the Superintendent of Police and -- and Director of State Police. Is there anybody from the chop shop industry on the council?

By the chop shop industry, what are you referring to?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Raoul.

SENATOR RAOUL:

Well, I -- I -- I assume that when automobiles are stolen, they go somewhere and there's an industry in the State of Illinois. And being on your side of the aisle, I know you're for keeping business in the State of Illinois and -- and I know you don't want all the chop shops to move to Indiana, Missouri or Wisconsin. You want to keep them here in the State of Illinois. Is your bill a bad business bill for the State of Illinois?

I think my bill is a very good business bill and I don't

And I hear it time and time again, and you've heard me talk about it again and again, this is pure hypocrisy. We cannot chase these jobs out of the State of Illinois. I encourage a No vote on this bill.

The -- the information that I received shows -- is giving the examples of bids that have been itemized to where, for instance, the general contracting of seven, heating of eleven, electrical six, totaling about thirty bids, could be reduced to as few as two and the cost would increase. Now, I -- I mean, is somebody -- you know, in this one case, for the University of Illinois molecular biological lab, it was a difference of over two million dollars. Is -- have I got bad information or is this correct?

Senator Schoenberg.

SENATOR SCHOENBERG:

First of all, I want to apologize. I'm -- on a couple of

occasions mentioned design-build; I meant to say single prime. I've a separate bill that deals with design-build. This initiative, to address your question more directly, the Capital Development Board has pointed out that during this brief period that we've done this, over a four-year period, we've had several projects totaling thirty-five million dollars in value, which have come in on schedule with no claims. And as a result of using this procurement method, the change orders -- the amounts have been as low as one to three percent. And, you know, in contrast, the current multiple prime bidding project delivery method tends to average seven and a half percent. So, in order to drive down the number of change orders, in order to drive -- which will in turn drive down the overall costs, we have had several successful illustrations of this and we would like to expand this -- scope of this a bit more.

Senator McCarter.

SENATOR McCARTER:

To the bill: It -- it just appears to me that we -- we're putting ourselves in a position of less -- less competition, rather than more. Competition is always good, especially in a market like we have today. And I think perhaps we're looking at different information, but the information I've seen shows that there -- this will reduce competition and increase costs and I think this is not a good time to be doing this. I just urge a No vote. Thank you.

The Act sets standards of practice and provides that existing appraisal management companies may continue to practice until the Department adopts rules implementing the Act. The current rule says that the House sponsor of a bill originating in the House may request substitute Senate sponsorship of that bill by filing a notice with the Secretary; that notice shall automatically be referred to the Committee on Assignments and deemed adopted if approved by the Committee on Assignments. So right now we have situation where if a House sponsor wants to change sponsorship, they can do so by requesting the Committee on Assignment to make that change. This rule changes that rule so that it will be identical to the practice that the House has already adopted. So it requires the Committee on Assignments to act on any request to substitute a Senate sponsor of a House bill within three Session days, excluding perfunctory Session days. If the Committee on Assignments fails to act within three Session days, the request is deemed approved and the Senate sponsorship shall be switched to the substitute Senate sponsor

designated by the House sponsor. Now what this rule change means is, for us in the Senate, if you pass a Senate bill, right now you -- you're at the mercy of the House Rules Committee as to whether or not you can get a change in sponsorship. Under this rule being adopted, you as a Senate sponsor can pick your House sponsor. And with that, I'll be happy to answer any questions and urge that we pass the bill.

And I did notice that when our bills go to this new committee that the only person who can decide if it moves forward or doesn't move forward is the President. If it's good enough for the President of the Illinois Senate to decide what bills should proceed, it's good enough for every Member in this Body.

You think you're going to make an impact and somebody on the other side decides that they don't agree and one person, unilaterally, in one Chamber or another, gets to thwart the will of the majority of the other Chamber. Whether it's us doing it to them or them doing it to us, it's not right. It's not consistent with democracy. It's the kind of game playing that people back home are tired of. I commend the President and the Speaker for getting together on this 'cause I -- it's the right thing to do. And I encourage, on our side, an Aye vote.
