You know, Senator Rezin, I heard you make a comment earlier that intrigued me and that was that muskrats are considered predators. Are they considered predators to you or is there some outdoorsmen trapping association that -- that -- that deems them to be predators? Is that what the Director of the

Muskrats are considered a rodent. And with their ability to burrow into the lake systems, into dams that are protecting us from rivers, they are considered more of a nuisance and being that they are more -- they're -- yes, they are considered a predator in our area.

And -- and to make you more musk cologne, Senator Rezin? Senator Righter.

## SENATOR RIGHTER:

Now, Senator Rezin, as you've also learned in your brief time here, oftentimes Members carry bills with which they've had a personal experience. Many times you have people who are former prosecutors here carrying bills related to criminal law or you have former local officials carrying bills with regards to counties or municipalities or townships. I'm going to make some assumption here, but please correct me if I'm wrong, that you have some personal experience in trapping muskrats. Is that fair to say?

I have no experience trapping a muskrat. However, I can tell you that I do happen to have muskrats that are causing problems within my property since I do live on the side of a

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR RIGHTER:

Thank you very much. Senator Rezin, I stand in total support of this, what is an important conservation effort. What I would -- what I would do in closing, though, is ask simply this, is that if you were going to take advantage on your property of this extended open season or new open season to trap these critters, that -- that you personally engage in that, that there be a picture taken and that picture be disseminated among the Members of the Senate, please. Thank you, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

You're welcome, Senator Righter. Further discussion? Senator Haine, for what purpose do you rise? SENATOR HAINE:

Would the sponsor yield, please, Madam President?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She indicates she will, Senator. Senator Haine.

SENATOR HAINE:

So, Senator Rezin, as -- as -- as a result of the inquiry, the colloquy with Senator Righter, this bill is part of a vendetta by you against muskrats?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

SENATOR REZIN:

Senator, I -- I assure you that it is not.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

SENATOR HAINE:

Are muskrats a native American species, such as trial lawyers?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

SENATOR REZIN:

Yes, Senator, they are.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

SENATOR HAINE:

And apart from your personal animus toward the muskrat, the -- the trapping is a -- is an effort to control their population, right?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Yes, Senator, it is. The muskrat typically have two to three families per year. And because of the -- the dry season that we've had, they've caused to -- they've caused overpopulation in our area.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

### SENATOR HAINE:

It's -- it's fair to conclude that muskrats are a real problem to some people, right? To you and to others?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

#### SENATOR REZIN:

Senator, again, this bill is purely to extend the open season that already exists for muskrat trappers.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

## SENATOR HAINE:

But if muskrats are a problem, if they are a rodent, if they are -- a destructive rodent, why are we restricting the trapping of them at any time?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

That is a very good question, Senator, and I'd be happy to bring that back or look at that in the future.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

### SENATOR HAINE:

If this bill passes then and I have a parcel of real estate and it has a nice pond on it with a berm and the muskrats are destroying the berm and it's not during the muskrat trapping season, I am prevented from protecting my property by the terms of your bill. Is that correct?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Senator, again, this bill is purely to extend the season for trapping to help with the overpopulation of the muskrats.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

#### SENATOR HAINE:

Wouldn't it be a lot easier to prescribe contraceptives to them? Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Hunter, for what purpose do you rise?

### SENATOR HUNTER:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

### SENATOR HUNTER:

Senator Rezin, I had a question, several questions, actually...

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Like the sponsor to yield or to the bill?

#### SENATOR HUNTER:

Please yield. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She indicates she will. Senator Hunter.

### SENATOR HUNTER:

Thank you. Why does people trap and kill these -- I mean, what do they do with them once they are trapped and killed -- killed and trapped?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

They -- Senator, they serve several purposes. They can -- they're hunted or they're trapped for their fur and they're sold as that, but they're also used as a source of food, being that it's an aquatic rodent, some consider that, you know, as fish. So it is used in -- in their dietary -- in their meal.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Ewww. Senator Hunter.

### SENATOR HUNTER:

I am so happy you mentioned that, because I was wondering if it was considered as a delicatessen {sic} and whether people ate them, and so you've just confirmed that. So how -- how is this muskrat -- how is this meal prepared? Is it fried with flour, like chicken or... What does it taste like? Have you ever indulged in such a thing?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

#### SENATOR REZIN:

Senator, that's a great question. I honestly have not

enjoyed muskrat. However, I can tell you that in certain states, such as Michigan, that the Archdiocese does view muskrat as a substitution for fish. So it is accepted on Ash Wednesday and on Fridays of Lent.

Senator Hunter.

### SENATOR HUNTER:

Now you heard it from her and not from me. So once you travel to Michigan, you all, make sure you do not have -- stop by the Archdiocese to have lunch, because you know what's being served to you. Now, Senator Rezin, when I buy my coats, I love to have matching hats. Is it possible that I can get me a muskrat coat and a hat to match?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

## SENATOR REZIN:

Senator, I am sure that that is a possibility. We can get you a muskrat hat.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Dillard, for what purpose do you rise?

#### SENATOR DILLARD:

Thank you, if the -- if the lady would yield for a question or two.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She indicates she will. Senator Dillard.

## SENATOR DILLARD:

Thank you. Senator Rezin, when I was a boy, I always had two great questions in life. I'd always ask my mom and dad who

created God, and that second big question, which I think you can answer for me now, is what in the world were the Captain & Tennille talking about when they sang about "Muskrat Love"? What in the heck is muskrat love?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Senator, I look at "Muskrat Love" as a one-hit wonder. So -- and in honor of all of the one-hit wonders at that particular time, I asked my research assistant, Mr. Deloria, also to research other one-hit wonders that were popular at that time, if my -- if I may present them on the Floor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator, go right ahead. You want us to eat muskrats? SENATOR REZIN:

So, in his research, he -- he found the five top one-hit wonders. Of course, "Muskrat Love -- Love" was number five. Number four during that time, something you may have heard about, the name of it is "I Gave Her My Heart and a Diamond and She Clubbed Me With a Spade". Number three one-hit wonder of the time, "How Can I Miss You If You Don't {sic} (Won't) Go Away?" Number two, which actually happens to be my favorite, "My Wife Ran Away {sic} (Off) with My Best Friend and I Sure Do Miss Him". And the most popular one-hit wonder during the eighties, along with "Muskrat Love", is "Mama Get a Hammer, There's a Fly on Daddy's {sic} (Papa's) Head". So to answer your question, there were many one-hit wonders in the eighties, many of which we cannot remember the words to, but they were very popular at the time.

Senator Dillard.

### SENATOR DILLARD:

Senator Rezin, I -- I -- you know, that -- that's a song that, you know, all of us here remember. Madam Secretary, down there, you know, clearly, we were talking about the "Muskrat Love" song a few minutes ago. I'll give you the lyrics. They're -- they're still on the Internet today. You know, "They whirled and they twirled and they tangoed, singin' and jingled and jangled {sic} (jingin' the jango)" you know, "looks like muskrat love". Great stuff. I'm not sure it's a one-hit wonder. Senator, have you -- have you thought about amending Senator Steans' sex ed bill to include muskrats, if we have an overpopulation problem?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Senator, that's a very good question, something I'd be happy to bring back next year as an amendment.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Dillard.

## SENATOR DILLARD:

Have you -- I heard a rumor and maybe you can squelch this for me, but I heard that former Senator Brad Burzynski - since slaughtering is an economic development tool in northern Illinois sometimes - are we going to have a muskrat slaughtering house showing up somewhere in your district?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

#### SENATOR REZIN:

Senator, any way that I can promote business in my district, I would be happy to.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Dillard.

#### SENATOR DILLARD:

And one last question, and I know I'm going to vote for your bill, Senator Rezin, 'cause I like you a lot and you're a great new Member to this Chamber, but I'm only going to do so on one condition, and that's that you promise me that in next year's COWL show that I can dress up like a muskrat.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

## SENATOR REZIN:

Senator, I will keep that promise. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Hutchinson, for what purpose do you rise?

### SENATOR HUTCHINSON:

Thank you, Madam President. Will the Senator yield?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She indicates she will. Senator Hutchinson.

#### SENATOR HUTCHINSON:

Senator Rezin, one of the most important things we can do in this Body is to build consensus and to try to include, you know, proponents and opponents and things like that to various important issues that we carry. So I'm just wondering whether or not you had had any discussions with muskrats about whether or not they, you know, are really a nemesis. I mean, you are --

this bill does go directly to the liberty of muskrats and I'm assuming they would at least have a chance to weigh in on, you know, the whole scale of destruction that you are implying.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

SENATOR REZIN:

Senator, to ask {sic} your question, I have not.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Hutchinson.

## SENATOR HUTCHINSON:

Well, you know, I -- I am known to be a protector of the downtrodden and people who are not, you know, talked to when it comes to affecting, you know, something that we all hold very dear, our liberty and freedom of movement. I think it'd be really important to at least talk to someone from a muskrat society or, you know, the muskrat protection, order of the chiefs of muskrats, or something like that that could come down and testify as to whether or not this is really fair.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Thank you, Senator. This bill has been passed through committee and there has been nobody testifying against it.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Hutchinson.

### SENATOR HUTCHINSON:

It's my understanding that muskrats can't afford lobbyists. So, I mean, it's very difficult to come and, you know, oppose something when you don't have representation. So I just wanted

to say, on another note, you're doing -- you're handling this fabulously and welcome to this Body. I look forward to working with you. It's been a joy so far.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She's got two votes, Dillard and Hutchinson. Senator Steans, for what purpose do you rise?

SENATOR STEANS:

Just quickly to the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Absolutely. To the bill, Senator.

#### SENATOR STEANS:

I just wanted to note to a previous speaker and to the sponsor that, if they would, in fact, like to make an amendment to the comprehensive sex education bill I'm carrying, if that will bring on your support, I would be very open to making an amendment to -- in regard to muskrat love and I think it may also go a step further to address some of the challenges your side of the aisle may have. As noted in last night's show, we do know that the Senate Republicans are missing a heart. We'd love to have you on board. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Murphy. Senator Schoenberg, for what purpose do you rise?

SENATOR SCHOENBERG:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

She indicates she'll yield.

SENATOR SCHOENBERG:

Senator, I'm -- while I'm proud to be an Okie from north

Skokie, I know very little about muskrats. And before I go into my questions, I just have to say that I find the remarks that were addressed about Captain & Tennille to be incredibly offensive, because the Captain & Tennille, unlike any of the other performers of those one-hit wonders, had a great variety show that was on television every week. And I think, at the very minimum, to make amends for that statement -- I'm not going to ask us to put a formal apology into the record, but -- I -- I -- personally I'd be happy if you would wear your hair like Toni Tennille for a week, as a way of doing penance for that transgression. So speaking about transgressions, you made an earlier statement that for the purposes of Ash Wednesday and Lent, that muskrat could indeed be considered by the Archdiocese as a substitute for fish. Is that correct?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Yes, Senator, it is correct.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

## SENATOR SCHOENBERG:

So, Senator Rezin, that doesn't help me at all, because I keep kosher. So what I'd like to know is, under what rabbinical authority can you speak to as to whether or not muskrat is, one, kosher and, number two, whether or not -- one of the fundamental principles of Jewish dietary laws -- and don't take my word for it. You can ask Senator Silverstein, if we can find him. You could ask him as well. He'd speak to the same thing. One of the fundamental principles of Jewish dietary laws is the

separation of meat and dairy. What the Archdiocese has to say on this is irrelevant to Jewish dietary laws. How would this --would muskrat, one, be kosher, based on what the Old Testament has to say? Number two, would it be -- if it is kosher, would it be considered meat or dairy?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Senator, I don't have an answer for that. All I can tell you that -- but the Archdiocese views muskrat as they do fish, because they are an aquatic rodent.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

## SENATOR SCHOENBERG:

So, has the Archdiocese taken it upon itself to determine that muskrat would be pareve, meaning neither meat nor dairy?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

### SENATOR REZIN:

Senator, let -- let me clarify. I meant the Archdiocese of Michigan. Again, it was determined by the Archdiocese of Michigan that it was viewed as fish. How the other Archdioceses view it, I cannot answer that.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

### SENATOR SCHOENBERG:

Actually, I think you're missing a fundamental point. The Archdiocese doesn't offer up an opinion on what's kosher. I was asking if there was a rabbinical authority that could speak to

whether or not when I'm -- the only time I go to Michigan, to tell you the truth, is to visit a friend's summer home in southwest Michigan. But if I were to do that, would there be a rabbinical authority that could speak to whether or not I could have muskrat?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

SENATOR REZIN:

Senator, I don't know the answer to that question.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

### SENATOR SCHOENBERG:

Then -- then I'd like to move on. I'm relatively uninitiated at muskrat hunting. When I see something that comes up on the board, I see hunting, first of all, there's a "g" at the end. I've been sitting in front of Forby for what seems like a whole lifetime and I always understood that word to be huntin', not hunting, but huntin', as in huntin' -- huntin' and fishin'. So, do we have to correct the title of the bill?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

#### SENATOR REZIN:

Senator, I -- I believe you do not. I believe that the title of the bill is correct.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

## SENATOR SCHOENBERG:

So when I think of huntin', I think of a firearm. So is it -- do you need a firearm to hunt for muskrats?

Senator Rezin.

### SENATOR REZIN:

Senator, this bill only allows for an extension of the trapping season. I do not believe that -- that it includes firearms. It's only purely for the trapping season.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

### SENATOR SCHOENBERG:

So I could vote for a hunting bill that's going to do nothing to correct my F+ rating with the Rifle Association?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

## SENATOR REZIN:

Yes, Senator, you are correct.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Schoenberg.

## SENATOR SCHOENBERG:

Well, that was the only incentive I had to vote for it, to tell you the truth, because it's so rare that I'm able to vote for a bill that will actually be on the other side of the gun issue. I'm diametrically opposed on most everything else that the Rifle Association stands for. I see this up on the board and I'm thinking: This is a first. This is an incentive. This is a way to build a bridge, to seek consensus, as Senator Hutchinson alluded to. To go search for -- to make it possible to bring this delicacy, assuming I can find a rabbinical authority who will tell me it's kosher in Illinois and not in Michigan, to my dinner table. There are a lot of unanswered

questions. I'm hoping that your subsequent legislative efforts will be more comprehensive in their answers, better researched, less gratuitous about the criticism of one of my favorite childhood television shows. And I want to wish you well in the future. Thank you.

That's two and half votes for Senator Rezin. Is there any further discussion? Seeing none, Senator Rezin, to close.

SENATOR REZIN:

Thank you. Again, this is a very simple bill that clearly allows the Department of Natural Resources to extend the length of the trapping season for muskrats to spring. I know of no opposition and I would ask for an Aye vote.

The question is, shall Members of the General Assembly kill more muskrats, so we can eat 'em and we can wear 'em and we can smell 'em. The question is, shall House Bill 6 pass. All those in favor will vote Aye. Opposed, Nay. Opposed, Nay. voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 voting Yea, 0 voting Nay, 0 voting Present. House Bill 6, having received the required constitutional majority, is declared passed. Ladies Gentlemen of the Senate, Senator Rezin neglected to vote on her own first bill. Ladies and Gentlemen of the Senate, we welcome her proudly. Senator Rezin, for what purpose do you rise? SENATOR REZIN:

Thank you. I would like to correct and add my vote as a Yes vote to the bill. I was so involved in this conversation.

Take the record. On that question, there are 54 voting Yea, 0 voting Nay, 0 voting Present. House Bill 12, having received the required constitutional majority, is declared passed. Senator Link, on House Bill 91. He indicates he wish to proceed. Madam Secretary, please read the bill.

House Bill 91, having received the required constitutional majority, is declared passed. Senator Trotter, on House Bill 106. Senator Trotter. Out of the record. Senator Steans, on House Bill 132. Senator Steans. Out of the record. Senator Collins. Senator A. Collins, on House Bill 139. She indicates she wish to proceed. Madam Secretary, please read the bill.

### SECRETARY ROCK:

House Bill 139.

(Secretary reads title of bill)

Is there any discussion? Seeing none, the question is, shall House Bill 139 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 voting Yea, 0 voting Nay, 0 voting Present. House Bill 139, having received the required constitutional majority, is declared passed. Senator Haine, on House Bill 141. Senator Haine. He indicates he wish to proceed. Madam Secretary, please read the bill.

#### SECRETARY ROCK:

House Bill 141.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Haine.

### SENATOR HAINE:

Thanks, Madam President and Ladies and Gentlemen of the Senate. This bill requires, for leased property, a landlord must disclose to a renter the existence of a radon hazard if the

landlord does know about one, conducts a test and the test indicates that the hazard exists. It's used primarily for soil conservation, forage production, game cover, an ornamental grass, or, more recently, as a biomass crop for both ethanol and butanol. Other common names for switchgrass include tall panic grass, Wobsqua grass, blackbent, tall prairiegrass, wild redtop, thatchgrass, and, ironically, Virginia switchgrass.
