Commerce and Economic Opportunity, Dept. of

Enterprise Zone, High Impact Business, Blue Collar Jobs Act, and River Edge Redevelopment Zone Programs annual report, 2022

DECO received no enterprise zone or Blue Collar Jobs Act project applications to review in 2022. The Illinois Department of Revenue reported \$164.7 million in forgone state tax revenue from enterprise zones in 2022; \$36.2 million from the High Impact Business Program; and \$204,000 from the River Edge Redevelopment Zone Program. Businesses participating in the enterprise zone program reported investing \$2.3 billion and creating 16,146 jobs; High Impact Business participants reported investing \$662.7 million and creating 2,886 jobs; and River Edge Redevelopment participants reported no new capital investments and the loss of one job. Restore Illinois Collaborative Commission report, Sept. 2023 The report describes actions under the Restore Illinois plan for responding to COVID-19, including support to businesses, residents, and local governments. Out of \$175 million in Back to Business funding announced in March, \$37.9 million has been awarded to 999 restaurants, and \$72.2 million to 728 hotels; awards to arts businesses were expected by the end of September. Community Navigators grant agreements have been extended through 2023 and budgets have been increased by over \$3 million to fund their activities in 2024. Payments for a sixth round of Child Care Restoration Grants has begun. The state has awarded some \$10 million in grants to apprenticeship programs since 2019, and more than 60 new apprenticeship programs have registered since then. The Illinois Housing Development Authority has completed three rounds of emergency mortgage assistance that has

provided \$344.6 million to help 23,801 homeowners; it is still accepting applications through the Illinois Homeowner Assistance Fund program. (20 ILCS 605/605-1045.1(c); Sept. 2023, rec'd Nov. 2023, 7 pp.)

Data Governance and Organization to Support Equity and Racial Justice Act annual report, 2023

Under the Act, agencies must report demographic information of participants in each of their major programs. This report gives data on race, ethnicity, age, primary or preferred language, sex, and disability status of participants in the Department's Child Support Services and Medical Assistance programs. The Department will continue to work on collecting data on indigeneity, gender identity, sexual orientation, and more specific race and ethnicity categories. Human Services, Dept. of

Customized Employment for Individuals with Disabilities Act annual report, 2022 Under the Act, DHS is to establish a 5-year pilot program to help individuals with disabilities find employment suited to their interests and abilities. In its third year, the pilot program had 13 customized employment contracts (up from 8 in year two) that served 52 customers (up from 24 in year two). The report says that DHS will evaluate the pilot program after it ends to determine whether to recommend it become permanent. (820 ILCS 97/30; Nov. 2023, rec'd Dec. 2023, 4 pp.)

The State Police received

Locally-held benefit funds quarterly report, July-Sept. 2023
