May 13, 2025

Co-Chair Cunningham called the meeting to order and announced that the policy of the Committee is to allow only representatives of State agencies to testify orally on any rule under consideration at Committee meetings. APPROVAL OF THE MINUTES OF THE APRIL 8, 2025 MEETING

Rep. Reick moved, seconded by Sen. Castro, that the minutes of the April 8, 2025 meeting be approved. The motion passed unanimously (11-0-0).

AGENCY RESPONSES

Pollution Control Board – Groundwater Quality (35 Ill. Adm. Code 620; 48 Ill. Reg. 4608)

Department of Revenue – Income Tax (86 Ill. Adm. Code 100; 48 Ill. Reg. 17848) and Illinois Gives Tax Credit Act (86 Ill. Adm. Code 1050; 48 Ill. Reg. 18291)

Due to the appropriateness of the agency's response, no further action.

REVIEW OF AGENCY RULEMAKINGS

State Board of Education – Educator Licensure (23 Ill. Adm. Code 25; 49 Ill. Reg. 964)

Rep. Delgado moved, seconded by Sen. Fowler, that JCAR, with the concurrence of the State Board of Education, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (11-0-0).

State Board of Elections – Campaign Financing (26 Ill. Adm. Code 100; 49 Ill. Reg. 1642) and Practice and Procedure (26 Ill. Adm. Code 125; 49 Ill. Reg. 1657)

Sen. DeWitte moved, seconded by Rep. Haas, that JCAR, with the concurrence of the State Board of Elections, extend the second notice period for these rulemakings for an additional 45 days. The motion passed unanimously (11-0-0).

Purchased Care Review Board – Illinois Purchased Care Review Board (89 Ill. Adm. Code 900; 49 Ill. Reg. 3028)

Dana Stoerger represented PCRB.

Sen. Fowler moved, seconded by Rep. Delgado, that JCAR, with the concurrence of the Purchased Care Review Board, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (11-0-0).

Department of Revenue – Illinois Gives Tax Credit Act (86 Ill. Adm. Code 1050; 49 Ill. Reg. 1532)

Brian Fliflet represented DOR.

Rep. Reick asked if it was the Department's intent to clean up the Act to provide more flexibility in its implementation. DOR affirmed that intent.

CERTIFICATION OF NO OBJECTION

Co-Chair Cunningham announced that no action will be taken on the Illinois Gaming Board titled Video Gaming (General) (11 Ill. Adm. Code 1800; 48 Ill. Reg. 8252) and the emergency rule from the Department of Healthcare and Family Services titled Special Eligibility Groups (Emergency Amendment to Emergency Rules) (89 Ill. Adm. Code 118; 49 Ill. Reg. 3562).

Sen. Harris moved, seconded by Rep. Vella, that the Committee inform the agencies to whose rulemakings the Committee has not voted an Objection or Extension, or did not remove from the No Objection List, that the Committee considered their respective rulemakings at the monthly meeting and, based upon the Agreements for modification of the rulemaking made by the agency, no Objections will be issued. The motion passed unanimously (11-0-0).

Co-Chair Cunningham announced that the next JCAR meeting will be Tuesday, June 17, 2025, at 11:00 a.m. in Room C-600 of the Bilandic Building, Chicago.
