ReyesKurson:

40 hours per month for a total of 480 hours a year
The rate per hour is the Exelon rate depending on the work

Here is the rub...

The administrative fee shall be \$7500 per month

BUT why unless I am just not getting it why do we keep subtracting 15 hours of that work into the 40 hours which goes to 25? Cannot we do something here? Can we split the baby?

Administrative fee of \$7500 per month

7.5 hours of that work anticipated to be 15 hours per month shall be attributed to the 40 hours of the month so promised

40 hours a month, which includes the 7.5 so stated above, shall be guaranteed ReyesKurson for a total of 480 hours per year at the Exelon legal rate
