Re: Illinois House of Representatives Special Investigating Committee

Dear Mr. Doherty:

The Illinois House of Representatives has convened a Special Investigating Committee (the "SIC") pursuant to House Rule 91, following the filing of a Petition by Leader Jim Durkin, State Representative Ryan Spain, and State Representative Andrew Chesney on August 31, 2020.

The charge the Committee is tasked to investigate is that Speaker Madigan engaged in conduct unbecoming to a legislator or which constitutes breach of public trust, as detailed in the Deferred Prosecution Agreement ("DPA") entered into by Commonwealth Edison Company ("ComEd") and the United States Attorney's Office for the Northern District, including engaging in a bribery scheme, an extortion scheme, conspiracy to violate federal and state laws, among other misconduct and misuse of office.<sup>1</sup>

Due to the fact that the charge is inextricably tied to the facts and circumstances underlying the DPA, the Committee is tasked with investigating those facts and circumstances thoroughly and impartially, while ensuring it does not interfere with any ongoing federal investigation related to the DPA.

By this letter, we invite you to appear before the committee at the next hearing, which will be held on Tuesday, September 29th, 2020 at 2 p.m. in Room 114 of the State Capitol Building located at 301 S. 2nd Street, Springfield, Illinois 62706.

This Committee is cognizant of the ongoing federal investigation on this matter, this request should not be construed as a request for any "government produced materials" or otherwise non-public information you provided to or obtained from the federal government in connection with its investigation. Please see the attached letter from the United States Attorney for the Northern District for more information on this issue.
