HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 696

Offered by Representative Slaughter:

WHEREAS, Alpha Phi Alpha Fraternity, Incorporated was founded on December 4, 1906 by seven college men, respectfully known as the "Seven Jewels", on the campus of Cornell University in Ithaca, New York and became the first intercollegiate Greek-letter fraternity established by and for African Americans; and

WHEREAS, The Seven Jewels of the fraternity, Henry Arthur Callis, Charles Henry Chapman, Eugene Kinckle Jones, George Biddle Kelley, Nathaniel Allison Murray, Robert Harold Ogle, and Vertner Woodson Tandy, recognized the need for a strong bond of brotherhood among African descendants in this country and the need to help correct the educational, economic, political, and social injustices faced by African Americans and other people of color; and

WHEREAS, Alpha Phi Alpha initially served as a study and support group for minority students who faced racial prejudice, both educationally and socially, at Cornell University; the Jewel founders and early leaders of the fraternity succeeded in laying a firm foundation for Alpha Phi Alpha's principles of scholarship, fellowship, good character, and the uplifting of humanity; and

WHEREAS, While stressing academic excellence among its members since its founding, Alpha Phi Alpha has consistently supplied its voice and vision to the struggle of African Americans and people of color and to issues of civil rights around the world; and

WHEREAS, The aims of Alpha Phi Alpha are manly deeds, scholarship, and love for all mankind; and

WHEREAS, The mission of Alpha Phi Alpha is to develop leaders, promote brotherhood and academic excellence, and provide service and advocacy for communities, as exemplified through its national programs, including "Go to High School, Go to College", which focuses on the educational achievement of students in elementary, secondary, and post-secondary schools and has given thousands of dollars in scholarship funds to deserving students, "Project Alpha", which teaches teenage pregnancy prevention and sexually transmitted disease prevention to young males, and its "A Voteless People is a Hopeless People" campaign, a voter registration and education program through which thousands of voters have been educated and registered; the fraternity also focuses on providing service through its strategic partnerships with Big Brothers Big Sisters, the Boy Scouts of America, the March of Dimes, the American Heart/American Stroke Association, and the American Cancer Society; and

WHEREAS, For more than 117 years, Alpha Phi Alpha has played a fundamental role in the positive development of the character and education of more than 200,000 men around the world; and

WHEREAS, Alpha Phi Alpha has over 700 college and alumni chapters in the U.S., Africa, Asia, the Caribbean, and Europe; this total includes 141 chapters in the Midwestern Region, and 32 of those chapters are in Illinois; the fraternity's presence started in Illinois with the founding of the first college chapter in Illinois, the Theta Chapter, in 1910 and the first alumni chapter, the Xi Lambda Chapter, in 1924, both in Chicago; and

WHEREAS, Members of Alpha Phi Alpha include many noteworthy leaders in the areas of government, business, entertainment, science, and higher education, including Dr. Martin Luther King Jr., Thurgood Marshall, W.E.B. DuBois, John Hope Franklin, John H. Johnson, Adam Clayton Powell, Andrew Young, Robert Smith, and Cornel West; its membership also includes federal, State, and local elected officials, including U.S. Representative Danny K. Davis, former U.S. Senators Edward Brook and Roland Burris, former State Senator Donne E. Trotter, former State Representative Al Riley, former State Representative Art Turner Jr., former Cook County Board Presidents John and Todd Stroger, and former Mayor of Chicago Eugene Sawyer, among countless others who have long stood at the forefront of the fight for civil and human rights and social change for all Americans; and

WHEREAS, Several Alpha Phi Alpha members have served in the Illinois General Assembly, and members currently serving in the 103rd General Assembly are Speaker of the House of Representatives Emanuel "Chris" Welch, Representative Justin Slaughter, and Senator Elgie R. Sims Jr., who also served as the 26th Vice President of the Midwestern Region; and

WHEREAS, Alpha Phi Alpha continues to enrich the lives of its members, who, in turn, provide service and advocacy for the communities they serve; and

WHEREAS, On May 1, 2024, Illinois members of Alpha Phi Alpha Fraternity, Inc. will participate in Alpha Day at the Illinois State Capital; and

WHEREAS, Alpha Phi Alpha Fraternity, Inc. and Alpha Kappa Alpha Sorority, Inc. have joined together for this year's Alpha Day at the Capitol in a collective effort to advance the priorities of the communities they serve; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the 2024 Alpha Phi Alpha Day held at the Illinois State Capitol and welcome the members of Alpha Phi Alpha to the Capitol; and be it further

RESOLVED, That we declare May 1, 2024 as Alpha Phi Alpha Day in the State of Illinois in honor of Alpha Phi Alpha Fraternity, Incorporated and its continued impact on the communities it serves.

HOUSE RESOLUTION 700

Offered by Representative Moylan:

WHEREAS, Recreational marijuana was legalized on January 1, 2020; and

WHEREAS, Delta-9-tetrahydrocannabinol (THC) is the principal psychoactive component in marijuana; and

WHEREAS, Marijuana of the 1960s and 1970s contained around 2 to 3% THC; today, marijuana contains THC levels of 80% or more, making it very dangerous; and

WHEREAS, The evidence of harm regarding high-potency marijuana use is overwhelming; and

WHEREAS, According to the National Highway Traffic Safety Administration (NHTSA), there were 1,009 car fatalities in Illinois in 2019; after marijuana legalization, there were 1,337 car fatalities in Illinois in 2021, the highest death toll since 2005; and

WHEREAS, In 2013, the year after Colorado legalized recreational marijuana, traffic deaths where drivers tested positive for THC increased by 138% while traffic deaths in Colorado overall increased by 29%; and

WHEREAS, In January 2024, The Wall Street Journal reported that more potent cannabis and more frequent use are contributing to higher rates of psychosis, especially in young people; and

WHEREAS, A 2017 study in the American Journal of Psychiatry found that one psychotic episode following cannabis use was associated with a 47% chance of developing schizophrenia and bipolar disorder, while the risk of developing bipolar or schizophrenic disorders was highest for cannabis users aged 16 to 25 and had a greater influence than alcohol, opioids, amphetamines, and hallucinogens; and

WHEREAS, Dr. Deepali Gershan, an addiction psychiatrist at Compass Health Center in Northbrook, stated that up to 20% of her caseload consists of patients whom she suspects experienced psychotic episodes that were triggered by marijuana use; and

WHEREAS, Examples of individuals who experienced cannabis-induced psychosis include foreign exchange student Levi Thamba Pongi from the Republic of Congo, who ate one pot-laced cookie and jumped to his death from a 4-story balcony in Colorado on March 11, 2014, Richard Kirk of Colorado, a father of three who threatened suicide after eating marijuana-laced candy and then shooting his wife in the head while she spoke to a 911 operator on April 17, 2014, and Bryn Spejcher of California, who suffered a psychotic incident after getting high on high potency marijuana and stabbed her boyfriend 108 times in 2018; and

WHEREAS, Multiple acts of mass shootings and domestic terrorism have occurred by habitual or heavy users of today's typically high THC-level marijuana, including, but certainly not limited to, shooter Jared Loughner, who killed six and injured 14 at then-U.S. Representative Gabrielle Gifford's constituent meeting in Tucson, Arizona in 2011, shooter James Holmes, who killed 12 and injured dozens at a movie theater in Aurora, Colorado in 2012, bombers Dzhokhar and Tamerlan Tsarnaev, who killed four and injured over 250 at the Boston Marathon in 2013, and shooter Devin Patrick Kelly, who killed 27 and injured 20 people attending First Baptist Church in Sutherland Springs, Texas in 2017; and

WHEREAS, The Illinois Department of Public Health states that marijuana use affects the parts of the brain responsible for memory, learning, attention, decision-making, coordination, emotions, and reaction time; and

WHEREAS, In 2020, Psychology Today reported that individuals who began marijuana use the earliest and continued throughout adulthood lose, on average, eight IQ points, which is sufficient enough to alter academic success and job opportunities; and

WHEREAS, The 2022 Marijuana Legalization Illinois Impact Report found that some marijuana products are infused with up to 500 milligrams of THC; and

WHEREAS, By comparison, Vermont has set potency limits of 5 milligrams of THC per serving, and Connecticut has limited edibles containing THC to 5 milligrams per serving; and

WHEREAS, Citing the dramatic surge in vehicle crashes, increased THC levels, and a rise in diagnoses of psychosis linked to marijuana use, the Illinois State Medical Society supports capping THC levels at 10%; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois General Assembly to cap THC levels in marijuana by placing limits on the amount of THC contained in retail products, placing limits on the amount of cannabis a retailer can sell to an individual in a single transaction or over a period of time based on the amount of THC contained, and implementing a seed-to-sale tracking system, allowing regulatory agencies to view every gram of legal cannabis as it migrates through the supply chain, including monitoring ingredients added to cannabis that are eventually sold in retail stores.
