HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

Representative Franks introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 10

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 25 to Article I of the Illinois Constitution as follows:

ARTICLE I BILL OF RIGHTS

SECTION 25. TAXPAYER SUITS

Notwithstanding any other provision of this Constitution or any law or judicial decision to the contrary, each taxpayer of this State or of any taxing district in this State has standing to bring suit in the circuit court to enforce the rights of taxpayers of the State or of that taxing district, as the case may be. These rights of taxpayers include, but are not limited to, the right, on behalf of the State or a taxing district, to enjoin the illegal disbursement of public funds, to recover public funds illegally expended, to recover anything of value obtained through the breach of a public official's fiduciary duty, and to enforce any rights of taxpayers recognized at common law or created by the General Assembly by law. Standing is subject to (i) giving any prior notice to or making any prior demand on a public official that is required by law to bring suit and (ii) complying with any procedures that are required by law.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 12

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article IV of the Illinois Constitution as follows:

ARTICLE IV THE LEGISLATURE

(ILCON Art. IV, Sec. 2)

SECTION 2. LEGISLATIVE COMPOSITION

(a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.

(b) Each Legislative District shall be divided into two Representative Districts. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years.

(c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.

(d) If a vacancy in the office of Senator or Representative occurs 180 or fewer days before the next general election, the vacancy shall be filled at the next general election. If a vacancy in the office of Senator or Representative occurs more than 180 days before the next general election, the vacancy shall be filled at a special election as provided by law. A person elected to fill a vacancy in office shall serve for the remainder of the term. Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.

(e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term. (Source: Amendment adopted at general election November 4, 1980.)

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

WHEREAS, Published reports indicate anywhere between 500 and 1,500 State positions are affected by these rule changes; and

WHEREAS, In addition to changes to administrative rules affecting a broad class of term appointments, changes have recently been made to individual position descriptions, resulting in the incumbents gaining civil service protection for their jobs; and

WHEREAS, The necessity for and cost of these fundamental changes to the manner in which the State fills certain positions have not been studied; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a management audit of the impact of these significant changes in State appointment practices made during recent months; and be it further

RESOLVED, That the audit include, but need not be limited to, the following determinations:

(1) The number of positions affected by these changes;

(2) The nature of the duties of such positions;

(3) The documented management necessity for such changes;

(4) The fiscal cost of such positions; and

(5) The name, date of appointment, and salary of each appointee to any of these positions; and be it further

RESOLVED, That any State agency or other entity that may have relevant information pertaining to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report his findings and recommendations upon completion to the Legislative Audit Commission, the Governor, and the General Assembly; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Legislative Audit Commission, the Auditor General, the Governor, the Speaker and Minority Leader of the House of Representatives, and the President and Minority Leader of the Senate.

WHEREAS, Ethanol production uses at least one out of every six rows of corn grown in Illinois; and

WHEREAS, E85 blended fuel consists of up to 85% ethanol and 15% gasoline; and

WHEREAS, Ethanol is an environmentally friendly fuel that enhances the nation's economy and helps provide energy security; and

WHEREAS, A flexible fuel vehicle (FFV) allows a driver to use any combination of gasoline or ethanol, from 100% unleaded gasoline to 85% ethanol; and

WHEREAS, Flexible fuel vehicles may be identified by certain characters in their vehicle identification numbers; and

WHEREAS, Flexible fuel vehicles are able to use E85 fuel or gasoline in any combination from a single tank; and

WHEREAS, Vehicles utilizing E85 help reduce hydrocarbon and benzene emissions compared to vehicles using gasoline; and

WHEREAS, E85 produces around 30% to 40% less tailpipe emissions than are produced by gasoline; and

WHEREAS, The members of the Illinois House of Representatives understand the importance of the continued development and expansion of markets for E85 and other bio-fuels in Illinois; therefore be it

HOUSE RESOLUTION 33

Offered by Representative Mulligan:

WHEREAS, The General Assembly supports the sentiments set forth by the Olmstead Decision which held states responsible for providing for persons with disabilities in the most integrated setting, and therefore states are required to reasonably modify their service delivery systems to maintain a range of placement and service options for the care and treatment of diverse disabilities and to effectively administer those options; and

WHEREAS, Expansion of community-based programs was first encouraged nationally by a growing number of individuals with developmental disabilities awaiting services; and

WHEREAS, Illinois was one of the first states in the nation to fund community-based services for individuals with developmental disabilities; and

WHEREAS, There is an estimated 144,540 Illinois citizens who have substantial developmental disabilities that have occurred before the age of 18; and

WHEREAS, According to the most recently published statistics, Illinois is currently ranked 39th in the nation in the proportion of a state's aggregate income that is committed to financing community-based services for individuals with developmental disabilities; and

WHEREAS, Illinois is one of four states that does not currently maintain a statewide waiting list to determine the level of unmet need; and

WHEREAS, The General Assembly recognizes the discrepancy between the State's economic wellbeing (Illinois is currently ranked 9th nationally in personal income per capita) and the lack of funding dedicated to improving the community-based service system for individuals with developmental disabilities in Illinois; and

WHEREAS, The General Assembly further recognizes the need to address this discrepancy and improve the State's community-based services for individuals with developmental disabilities to meet the rising level of need; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL

ASSEMBLY OF THE STATE OF ILLINOIS, that a Task Force be established to study services for the developmentally disabled; and be it further

RESOLVED, That under the auspices of the Office of the Governor, the task force shall be responsible for doing the following:

1. Studying the level of need for community-based services; and

2. Studying the status of community-based services for the developmentally disabled throughout the State; and

3. Assessing the level of services and their adequacy in meeting the level of need; and

4. Developing recommendations for improving the community-based service delivery system and addressing gaps in these services; and

5. Developing recommendations for the State to expand funding sources for these services; and

6. Developing recommendations to anticipate the level of need for these services or alternatives to a waiting list; and be it further

RESOLVED, The Task Force shall have a total of 20 members consisting of 2 members appointed by the Majority and Minority Leaders in the House of Representatives and 16 members to be appointed by the Governor to represent the Department of Human Services, providers of community-based services for individuals with developmental disabilities; and experts on the State service system for individuals with developmental disabilities; and be it further

RESOLVED, The Task Force shall present a report of their findings and recommendations to the General Assembly and the Governor no later than October 1, 2004; and be it further

RESOLVED, That a suitable copy of this resolution be provided to the Office of the Governor and the Secretary of the Department of Human Services.

WHEREAS, He taught biology and zoology at several colleges, serving as dean at two colleges prior to being elected president of Illinois Wesleyan in 1957; he served as a science consultant to Ewha Women's University in Seoul, South Korea in 1969 and 1970; and

WHEREAS, He was Illinois Wesleyan's 14th president and during his presidency, Illinois Wesleyan experienced significant growth in enrollment, faculty, academics, and campus value; the University's School of Nursing was established during his presidency; he pioneered the May Term, and worked closely with students, introducing policies that gave the Student Senate full authority over student activity fees and initiated student membership on university committees; and

WHEREAS, Following his retirement from Illinois Wesleyan, he was president for one year of the Central States College Association, a consortium of 11 Midwest campuses; he was a member of four academic honor societies: Phi Beta Kappa, Sigma Xi, Phi Kappa Phi, and Beta Beta Beta, the national biology honorary, serving as the group's national president from 1946 to 1953; he was the recipient of an honorary doctor of humanities degree from Illinois Wesleyan in 1975; and

WHEREAS, He was active in Methodist activities; he was a member of the Wesley Methodist Church in Bloomington and served on its Board of Stewards and the Commission on Stewardship and Finance; he was also a member of the General Board of Lay activities of the Methodist General Conference; in 1966, he was a delegate to the World Methodist Conference in London; and

WHEREAS, He served as president of Region 3-B, Comprehensive Health Planning Agency, an organization encompassing 16 counties in east-central Illinois, was a member of the board of directors of the Rotary Club in Bloomington, and was president of the IWU Federal Credit Union; and

WHEREAS, The passing of Lloyd M. Bertholf will be deeply felt by all who knew him, especially his daughter, Dr. Lynn B. Westcot; his son, Dr. Max E. (Nancy) Bertholf; his six grandchildren; his eight great-grandchildren; and his sister, Faye McCoy; therefore, be it

WHEREAS, Dr. Burrough is the Principal Founder of the DuSable Museums of African-American history in Chicago, which is the first black museum in the United States; and

WHEREAS, In the world of visual arts, Dr. Burrough is a printmaker, oil painter, sculptress, and pen and ink artist; her work has been exhibited in galleries, art fairs, exhibitions, colleges, and universities in the United States, Mexico, Poland, Germany, China, and Russia; and

WHEREAS, Dr. Burrough envisioned an organization devoted to the growth and stimulation of art for Black people; in 1939, she was one of the founders of the South Side Community Art Center which introduced sculptor Richard Hunt; photographer and author, Gordon Parks; and featured the works of Archibald Motley, Charles White, and poet Gwendolyn Brooks; and

WHEREAS, In 1947, Dr. Burrough's writing talents emerged when she published "Jasper, the Drummin' Boy"; other published articles she has written include, "His Name was DuSable and He was the First" and "What Shall I Tell My Children Who Are Black?"; they have been translated into African languages, Russian, Chinese, Arabic, and Spanish; her articles on art, culture, and history have been published in journals such as Freedomways, The Chicago School Journal, and in Time magazine; and

WHEREAS, The Ravinia Festival will celebrate its 100th anniversary in 2004; and

WHEREAS, The Ravinia Festival has achieved a worldwide reputation as a concert venue of distinction for both classical music and popular entertainers from the world of jazz, folk, pop, country, opera, and dance; and

WHEREAS, The Ravinia Festival began as a carnival intended to attract riders to the 3-year-old Chicago and Milwaukee Electric Railroad; and

WHEREAS, The original Ravinia Park opened on August 15, 1904 as a year-round amusement park that featured an electric air swing, skating rink, toboggan slide, electric fountain, pavilion, casino, and even a small hotel; and

WHEREAS, In 1906, classical music made its debut at Ravinia when Walter Damrosch conducted the New York Symphony at the park, setting the tone for nearly a century of stellar musical entertainment; and

WHEREAS, All these attractions failed to lure enough riders to the fledgling rail line, and in 1908, the Chicago and Milwaukee Railroad fell into receivership; and

WHEREAS, The Ravinia Park Association raised \$15,000 to keep the park open; and

WHEREAS, In 1911, the Ravinia Park Company purchased the park from the floundering railroad company; and

WHEREAS, On opening night in 1918, Ravinia abandoned its usual format of presenting arias or individual acts and presented a full-length production of the opera "Aida"; and

WHEREAS, During the darkest days of the Great Depression, Ravinia closed its doors from 1932 to 1936 rather than continue operation with diminished-quality performances; and

WHEREAS, In 1936, Ravinia reopened as the Ravinia Festival, an Illinois not-for-profit corporation, and the Chicago Symphony Orchestra signed to play a five-week program; and

WHEREAS, In 1944, the park was deeded to the Ravinia Festival Association, which still operates the Festival today; and

WHEREAS, In 1949, the original wooden pavilion burned down and a new concrete pavilion doubled the capacity of the burned-down structure and remains with some modifications the centerpiece of the Festival today; and

WHEREAS, In 1969, the London Symphony Orchestra made its Ravinia premiere and a new sound system was installed; and

WHEREAS, In the 1970s, the first rock concerts were staged at Ravinia and featured such performers as Janis Joplin and attracted crowds of upwards of 25,000 people; and

WHEREAS, Many jazz greats performed at Ravinia, including Benny Goodman and his band, Louis Armstrong, Miles Davis, Duke Ellington, Ella Fitzgerald, Dizzy Gillespie, Thelonious Monk, Wynton Marsalis, Herbie Hancock, and Oscar Peterson; and

WHEREAS, In 1993, Ravinia began an intensive overhaul of the park and state-of-the-art facilities were open to the public in time for the 60th anniversary of Ravinia's reopening in 1995; and

WHEREAS, These changes brought expanded customer service and enhanced dining opportunities; and

WHEREAS, Today, Ravinia Festival offers an ambitious schedule of concerts and educational programs year-round; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we congratulate the Ravinia Festival on its upcoming one-hundredth anniversary in 2004 and the many musical and educational programs it provides to its community; and be it further
